#### Area Assembly - March 28, 2010

#### 1. OPENING

#### Introduction

The A.A. Service manual combined with the Twelve Concepts for World Service defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." This is the first Assembly of four that will be held over the length of this term. Over the next two years, we will work together to keep Alcoholics Anonymous vibrant and strong in Area 83, Eastern Ontario International as well as around the world. Just as your District and your home Group meet, usually once a month, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83. Area 83 stretches from Oakville to Ottawa and from Upper New York State to northern Algonquin Park and the Ottawa Valley.

Some of us have been here before – as the Groups General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some of us, it will be our first Assembly and it will seem pretty overwhelming! How many of you are here today attending your first Assembly? Could you raise your hand? Amazing. And see, you are not alone!

That said; remember that this is just a regular business meeting of Alcoholics Anonymous. We are all here representing the group conscience of those who elected us. #### **SMOKING AREA**

THE ONLY SMOKING AREA is outside, please use the butt containers provided by the hotel. It's unfair for us to have the hotel staff clean up after us. If you leave this room for a smoke (or any other reason) please do so quietly, and please do not congregate just outside the doors.

#### NAMETAG HOLDERS

When you leave for home this afternoon or evening, please leave your name tag holders in the boxes provided near the doors. We re-use them to save money.

#### FREQUENCY OF MEETINGS

I think it's worthwhile to review the schedule of meetings for this term, for both this Assembly and the Area Committee:

The Assembly meets twice a year – in March and October. This afternoon we will decide on a date for this fall's <u>ELECTION</u> Assembly. The Area committee, which is comprised of the Area officers, DCM's and Past Delegate will meet four times this year. We met in Quinte West in January 9th of this year and we will meet again on June 5th, September 11th and December 4, 2010.

#### SEVENTH TRADITION

I know that it seems as if the coffee and drinks provided this weekend may be free, but the hotel charges us a flat rate per person for the weekend. Rather than have honour buckets beside the coffee urns, we have chosen to use the Seventh Tradition to cover these costs. Please keep these costs in mind when the 7th is being passed around later.

#### WHO VOTES?

Only members of the Assembly may vote.

These are:

All Area Officers, including the immediate past Delegate, but not the Chair.

All Area sub-committee Chairs

All DCM's of Districts in Area 83; in their absence, the Alternate DCM may vote.

All GSR's of Groups in Area 83, in their absence, the Group's Alternate GSR. In their absence a member of the registered Group. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ◆ There is one vote per person.
- ♦ After lunch, which is when we would expect to conduct old & new Business, I would ask those with voting privileges to sit at the front, others near the back. This will make it much easier for us to count votes.

#### A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion. This next part may unique to A.A. If, after the minority has spoken, if one member of the Assembly who had voted for the majority on the issue stands at a microphone, and says, "I wish to change my vote", we start all over again.

The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

#### WHO MAY ADDRESS THE ASSEMBLY?

Only voting members of the Assembly have a voice. This is important for two reasons:

- ✓ It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
- ✓ And it maximizes the time available for those members to voice their Groups' opinions and needs.
- ♦ All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- On the topic of staying until the end, I'd like to mention at this, our second Assembly of the term that our last Assembly, in the Fall of 2010 is known as the election Assembly. It's but one day every two years and on that day, we generally stay a little longer to facilitate voting by way of our third-legacy procedure. If you put it in your calendars now you might come to look forward to it! Perhaps you might even think about letting your name stand for a position! It's an important day and we hope you'll come prepared to stay.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones dotted around the room, and identify yourself by name, position and Group (I'm Bill W., GSR of the Serenity Group in District 99).
- If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would
  write your motion out and give it to our secretary Joyce before standing at the microphone. Thank you for that.

#### HOW DO WE VOTE?

- ♦ Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.
- ♦ I believe that the early part of the agenda today can be handled under simple majority 1 vote more than 50%. I will advise you when I believe we should move to 2/3. If any of you think we should switch before I indicate it, remember it's your meeting make the motion.
- To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.
- At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his
  or her hand.
- ♦ Again, when you are ready to speak can I ask that you identify yourself by name, position and Group.

#### 4. DISTRICT COMMITTEE MEMBERS' REPORTS

To help keep things moving along, we have 5 chairs up here at the front

and I would ask that as the District reports are given, the District Committee Members who are "on deck" come up and enjoy our "Green Room". Again I would request that all please respect the time.

#### **District 02 Malton**

Hello friends, I'm an alcoholic, a member of the Brampton Recovery Group and the DCM for District 02 Malton, and my name is Dareena B.

Our committee meets every second Sunday of the month at the St. Paul Apostle Church on 2182 Kipling Ave @ 7pm.

Our district meetings have been well attended with approximately 90% of the groups represented. We have welcomed back a group which had left some time ago, The Reaching Out Group, who sent there newly elected GSR to the table last meeting.

Also, I'm pleased to report that all our Committee Chair positions are filled for the first time in years, leaving only 1 Alt. Chair position open.

Dan N, Alt DCM and I continue to visit groups. This has generated participation from the Bolton Group that has been a part of our district since last December.

All of our commitments are being met at present both service and financially, thanks to the generous donations of time and monies from the groups in our District as we continue to carry the message responsibly.

Our Treatment chair Keith P is still carrying the message into the "Gift of Life" meeting held in Humber River Regional hospital as we are still looking for volunteers to facilitate this meeting. So if you are free Tues afternoons, please consider volunteering your time and give me your number and I will pass it on to Keith. Keith also reports that the Detox and Shelter meetings in our District are doing well.

Our Corrections chair, Alacoque C., has reported that OCI is back on track. She reports that we now have sufficient volunteers to hold the meetings and she is planning on holding another Big Book Study within the next few weeks. Alacoque communicates with Elaine Barns, the volunteer coordinator, as needed on a regular basis to keep the lines of communication open as per her request.

There has been no activity in Roy McMurtry for the past 3 weeks with the females and none what-so-ever from the males. AA has provided materials for them so that it can be viewed privately away from prying eyes. It seems there is a great deal of gang related violence as well as peer pressure on the young men keeping them away from any self help programs. We are working on conducting one on one meetings in the near future. It is unfortunate, however, we will continue to standby ready to support when requested.

The rest of our Committee chairs continue to work hard to carry the message to the still suffering alcoholic.

We have had some changes since our last assembly. We have a new Secretary/Registrar. The Grapevine position has been filled and he is currently updating our Grapevine material and making a new display board.

A new group, the One-Twelve has joined our district giving us a total of 9 groups.

The Downsview Dells, a men's transition house that we have been servicing for some time has requested that their weekly meeting be men only, and we continue to serve this meeting in accordance with the changes they have requested. Also, they asked if we could provide their facility with the Big Book in 6 different languages, and we were able to fill their need with the cooperative efforts and financial aid of the GTA Treatment Committee and Toronto Intergroup. It was wonderful to be able to deliver these books to the facility to help the still suffering alcoholic. This was possible because of joint efforts of people wanting to serve

We are currently working on a joint effort with Malton, District 02 and GTA Treatment Committee to service a meeting at Humber Hospital once a week.

It gives me great joy to be part of a process of coming together to carry the message.

#### District 06 Mississauga

Thank you for this great gift and letting me report on the best District in Area 83. We travel the furthest and enjoyed a 60% plus attendance here at Assembly, as many of our GSR's are active and seem to love it.

The District 6 meeting location has moved to a new location while the Port Credit Arena is undergoing renovations. We've had the first meeting at the new Community Centre on Mississauga Valley Blvd and it is great with coffee and set up supplied. Under the Self Support – Advisory Action, to use literature profits to fund services, or should there be a limit, or what if there is a contributions shortfall, created good discussion with the Groups - the GSRs were eager to voice several good ideas from their Group discussions all boiling down to, no limit should be imposed and that when contributions are not sufficient, income from literature sales should continue to be used.

We have noticed a slight decrease in the number of Groups contributing in the District. We still continue to meet our obligations and provide assistance to the Groups, GSRs and Sub Committees as needed.

All Sub Committee Chairs are active in our District and the GTA as a whole, communicating monthly at the District Table including a new monthly report from the District Web master. There is a new CPC Chair, Karen D, the GSR from the Six Points Group and a new Intergroup Liaison, Marvyn W the GSR at the Mississauga Group. The Archives Chair Jim W of the Long Branch Group is on fire with a number of Group histories and long timer interviews already completed and stored at the Intergroup Archives Repository. He's currently working on a catalogue with pictures of all District 6 Group locations and Group Banners.

Hello and good morning friends:

I am an alcoholic, a member of the Church Street Group and currently serve as the DCM for District 10-Toronto South Central and my name is Tony A.. At the beginning of this year, we have commenced a study of 12 traditions – studying one tradition per month and the discussions have been lively, informative and enlightening. And, a big heart-felt thank you to all of the area chairs that visited district 10 and presented to us last year.

As of our last district meeting, attendance to the district table by our member groups remains consistent with about 60 % of member groups attending. Currently, all of our sub-committee positions are filled with the exception of Self Support, Accessability and Grapevine. Financially, we meet our district obligations, are self sustaining and maintain slightly above our prudent reserve.

We now have 2 weekly service commitments servicing the Centre for Addiction & Mental Health. Our more recent commitment on Saturday mornings in the CAMH withdrawal management unit has really taken off quite nicely and has been well attended by the patients. Please note this is a locked unit and is not open to the general AA membership.

Our treatment facilities chair has reported that with regards to the Bridging the Gap program, the districts need to provide better education to the facilities regarding this service. The TF chair will bring a package that GSRs can take to their home groups in the hopes of soliciting some volunteers who might be a temporary contact for individuals coming out of treatment facilities who wish to utilize AA in their recovery. Our Archives chair is diligently working on obtaining oral histories of long timers in our district.

I have distributed flyers for the upcoming annual Gratitude roundup. Gratitude is a conference hosted by the GLBT AA/Alanon community in downtown Toronto. This year's theme is "We are Not Saints" and it promises to be very exciting. The conference meets the weekend after our Thanksgiving weekend. Last month, a couple of members from a "diversity committee" that has been struck provided a wonderful presentation to us regarding initiatives to carry the message to minority groups in the Toronto area. A few months ago, I had a moment of clarity when my own home group completely dismissed the idea of an eastern Canada service conference, saying that they didn't want to spend money on an AA elite to travel to somewhere in eastern Canada. I was appalled at the idea that they thought there was an AA elite, where did they get that idea – and then I realized that almost no one of my business meeting of 20 people had ever been to an assembly, they had never had the opportunity to see how marvelous it

was to be amongst a group of people who love the service structure of AA, how there is so much more to AA than a single AA group.

Although I and the 7 GSRs in Bytown have worked hard to communicate how terrific this assembly is, it is kind of like sobriety, it isn't real until you try it yourself. Two weeks ago, at Ottawa's very first traditions workshop, similar to the traditions workshop that was held yesterday, almost 80 people attended. That is more than the number of Ottawans' at this assembly – so there is a thirst for service knowledge in Ottawa, then why is there such a poor turnout here?

There are groups in Ottawa Bytown who struggle to pay rent, so paying over \$200 for a GSR to come to Kingston is beyond them. There are GSRs who are unable to afford child care or who do not have the credit card that is required to reserve a hotel room. All of these difficulties can be overcome, but these continuous difficulties, year after year because the assembly is always in the same place, these difficulties are currently keeping the majority of groups, well over half, away from this assembly. As an area, I believe that we could benefit from the experience of other areas who have succeeded in attracting people to the most important job in AA.

From this annual report, I know that other areas work directly with districts that are having difficulties with an adequate representation of groups. I would like to suggest that our area look at doing the same

It took me a dozen tries to stay in this program, I was in and out for four years before my last sobriety day, through God's Grace 14 years ago. That same determination is making me want to share the wonderful experience I have at this assembly, I believe that it should be shared, I believe that it should be made more attractive to more people in eastern Ontario, and I believe that this should be the assembly's primary responsibility today.

Thank you to all who attended the Treasurer/Self-Support workshop yesterday. I hope the information was useful. Thank you to Rodney for his technical support and to Robert, Juan, and Gerry for helping sell banquet tickets.

Thank you for sending in your District and Group contributions. As of March 19<sup>th</sup> all cheques received have been deposited and all receipts were mailed. Self-addressed envelopes were available at the workshop yesterday. Future issued receipts will contain a return envelope to make contributions easier.

The following is a breakdown of our financial situation as of March 19, 2010:

Our reserve account, which is set aside as a GIC for unforeseen circumstances, had an opening balance of \$20,678.59. Actual Interest earned is 1% \$206.79 as GIC was redeemed to comply with the Assemblies wishes to remain as a \$20,000.00 balance (see box below).

Received and deposited interest of \$265.82 and \$261.49 at 2.55% was returned. Interest of \$619.56 appears as Income plus Interest Income from December 31 statement of \$265.82 equals \$885.38. This represents \$678.59 interest compounded (2007 \$27.79, 2008 \$564.69 and 2009 \$86.11) and \$206.79 interest (March 16, 2009 to March 16, 2010).

The total expenses for the period ending March 19, 2010 were \$15,283.93. To date our expenses are expenses are \$2,304.02 higher than our income.

The bank opening balance as of January 1, 2010 was \$ 34,601.90 (this represents the balance without prepaid items from Dec 31, 2009 account information). Total income of \$12,979.91 less expenses of \$15,283.93, plus San Antonio other Areas \$1,611.22, plus Prepaid Banquet \$297.00, leaves an Operating account balance of \$34,206.10 as at March 19, 2010. The combined balance of accounts is \$54,206.10.

Our group contributions are up \$1,672.00 compared to this time last year.

Our proposed spending guidelines are \$69,690.12.

I was speaking to Doug R. at the Ontario Regional Conference last weekend and he was telling me that the number of people registered has surpassed any of the previous Conventions so it's looking like it will be a great party in San Antonio!

I would like to thank all of the Districts that send me minutes from their District meetings. It really is a great way to keep up to date on what's happening in the Districts in Area 83. #### **9.** DELEGATE'S REPORT SANDY S.

I am an alcoholic, a member of the Russell Goodwill Group in District #48 and my name is Sandy S. It is my privilege to serve this term as your Panel 59 Delegate.

Over the last couple of months I was busy gathering information and finalizing the planning and logistics for the Ontario Delegate's Committee meeting which was held in Ottawa the weekend of February 26<sup>th</sup> – 28<sup>th</sup>. I was a little disappointed with the turn-out, based on e-mail correspondence and confirmations that I had received, but as we know life happens and I know that those who were in attendance enjoyed the presentations and discussions. It was a good, interactive weekend regarding the upcoming General Service Conference process.

I would like to take the time to thank our Immediate Past Delegate, Dot D., for chairing the weekend, a past District Committee Member from District #48, Janet C., for taking up the task of recording secretary and Jim B., District Committee Member for District #54 for all the background work before and during the weekend.

I would also like to extend my gratitude to one of our past Delegates, Joe D., for providing the power point presentation on the entire General Service Conference process and to JoAnne L., our Trustee-at-Large, for her presentation and sharing during our question and answer periods.

The General Service Conference is taking place the week of April 18<sup>th</sup> – 24<sup>th</sup> at the Hilton Rye Town in Rye Brook, New York. I have been reading the various background information materials provided and have forwarded this information to each of the committee chairs for inclusion in their respective upcoming workshops and discussions this weekend. I anticipate receiving any relevant information from discussions on the various conference agenda items in order to have Area 83's thoughts and concerns to bring with me to the General Service Conference.

I have already received a number of e-mails from Chairs, Groups and Individual members regarding the finance question – Contributions & Literature Sales – which I have read and printed and plan to bring with me to the Conference for reference. The Remote Communities pre-conference meeting is taking place on Saturday, April 17<sup>th</sup> at 4:00 pm and the initial Delegate's Only meeting is at 7:30 p.m. The next day – the conference will be in full swing.

Again this year, I am on the Trustee's Committee and our agenda consists of the following:

On Sunday afternoon there is a Joint meeting of the Conference Committee on Trustees and Trustees Nominating Committee. We will review the Conference Committee composition, scope and procedure, the history of the Conference Committee, report of Trustees' Committee, discuss the report and any other related subjects that may arise.

The Conference Committee itself will meet on Monday and Tuesday mornings.

On Monday we will

- 1. Review the resumes for
  - a) Pacific Regional Trustee 14 Candidates of a possible total of 15
  - b) Eastern Canada Regional Trustee 9 Candidates of a possible total of 10 With Barb K., Panel 55 Delegate from this Area being one of the candidates as per our election at our Fall 2009 Assembly. I have the honor of providing a 2 minute verbal recommendation of Barb on behalf of our Area.
- 2. Review slates of trustees and officers of the General Service Board of Alcoholics Anonymous Inc.
- 3. Review the slate of directors of A.A. World Services Inc. With Joe Downey, Panel 51 Delegate from this Area being on the slate as he was successful in the interview process
- 4. Review slate of directors of A.A. Grapevine Inc.
- 5. Discuss a suggestion to clarify the language on page S65 in the AA Service Manual under the heading "Regional Trustee" regarding nominating a regional trustee candidate in the same year when nominating a trustee-at-large candidate Presently the section reads "... no area shall submit an individual as candidate for both regional trustee and trustee-at-large U.S./Canada in the same year." This sentence would be replaced with ".. no area should submit the same name for regional and at-large trustee in the same year" This change provides that the language in the service manual is the same for both the regional trustee and the trustee-at-large nominations.
- 6. Other subjects that may arise

On Tuesday we will review Monday's business, continue with any unfinished items, discuss any new items and elect the chairperson for this Committee for the 2011 Conference. The Chair will be elected from the panel 60 Delegates who will attend next year's conference.

I received my "loving invitation" to give a presentation during the Conference on "General Service Conference Agenda Selection Process – How It Works". I was kind of hoping to be a little more back-ground involved, like maybe ballots (which when I thought about it wouldn't be possible because I will be voting) – but something more background anyways.

Here is the report that I have already submitted and will be presenting at the Conference –

When I first received my "loving invitation" I thought about the topic and read through our literature to ensure that I knew what I was talking about. Then I thought again and decided to take the simple, direct approach rather than quoting from our literature and / or providing a history lesson. I took the "keep it simple" approach to this presentation – so here goes.

Our process works well when and if we let it. We all have our individual personalities and, at times, need to keep ourselves in check – all, of course, based on working our Steps and practicing their principles.

Our practice of allowing each and every individual member the right to a voice is how we stay unified. All opinions and concerns are, or should be, considered as valid and valued – whether this means general discussion or a requirement to vote.

This is how our Agenda becomes a reality. A member, Group, District, Area or Trustee has an idea or suggestion. This can travel through our service structure or can be provided directly – either way it ends up with our General Service Office Conference Coordinator . The GSO Conference Coordinator reviews the submissions in the light of previous Conference actions then passes it on to either the Trustee's Conference Committee or the appropriate Conference Committee – whichever may be relevant given the nature of the submission. The idea or suggestion then becomes a workshop or presentation topic (such as what I am doing now), a proposal or a committee concern.

The Conference Agenda items are to deal with policy for Alcoholics Anonymous as a whole, so if something that has been submitted does not fall into that category it then gets routed for general discussion as workshops or presentations.

When the item does deal with policy it becomes a Committee agenda item for discussion, and it turn possible recommendation on the General Service Conference floor.

Our process may appear slow – but in fact it is deliberate. It protects us from ourselves in that it does not allow for hasty or emotional decisions so that at the end of the day – the good of A.A. as a whole is served. (the end)

#### 10. ROLL CALL AND REGISTRAR'S REPORT

For those that are new to the Assembly, my job is to pass group information the General Service Office. This includes any group changes. I do this by entering the group change form and new group forms directly on the GSO database. Since the start of the this new year I have been getting consistently busier as more new GSR's enter this wonderful world of service. I do receive a lot of change forms that are incomplete. I cannot enter any information without complete addresses and this includes postal code. I do continue to receive many forms that I can read or understand.

I have been receiving group change forms many weeks or even months after a GSR or Alternate has taken the position. Please try to forward me the group change form as soon as possible. Not only will the not receive the GSO mailings such as Box 459 but they will not receive their GSR kit. After registering a new GSR, they should be receiving their kit within 20 working days. If a GSR has not received their kit within 2 months of assuming the position, please contact me and I will investigate.

I have group change forms, new group change forms in front of me at the table. I also have self addressed envelopes if you wish to send me the forms by postal mail. If you wish an electronic copy it is available from the Area 83 website for download.

I also have cut my printing costs. I did not put a District list in the DCM's slots. I have all the current Districts on my computer. I am able to give some districts a report on a CD. Please let me know if you wish a CD and I can give you one today. I do not have enough for each district though. I will be email a complete excel District list to all the Districts. This will save approximately \$300.00 per Assembly. I did find when I distributed the sheets, two thirds were not returned. This seems to be a lot of money for printing that is not returned.

There will be a 2010 Regional Directory. The deadline for group changes to appear in the directory is May 6, 2010. Please ensure that I receive these changes in a timely manner so that I can make the changes. Please remember, I am the only one making the changes, so I do need a bit of time prior to the deadline.

Groups with the status of Unknown, Inactive, Pending Inactive, Pending Active or Incomplete or Vacant on May 7th, 2010 cannot be published in the Regional Directories.

Contact information without a phone number cannot be included in the directories. The directories are published to assist traveling AA's reach out to find a meeting where ever they may be. That makes a phone number a very important piece of information we provide in the directories.

Permission to include a group contacts name and phone number in the directories must indicated on Group change forms. A request not to list or no indication at all will exclude that particular contact person and possibly the group from being published in the regional directories.

This is a monumental task. Please do not send your group changes in at the final second. If you take anything back to your groups and Districts from today, please let everyone know about directory and the guidelines I spoke about. This is a classic "when the hand of AA reaches out" and it is important that groups are represented.

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. Many of you may have questions that I can answer now. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote have the right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being that the numbers will often not look at all like what was written on the sheets. For example, a district might have five people signed in as visitors, but when I announce the roll call, I might say that there was only one. The reason is that I check each visitor against his or her group, and if the group does not have a GSR that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as a GSR. Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the assembly, is really as their group's representative. It is very important if you sign in as a visitor that you also write the name of your group. You could be voting for your group but I do not that if you do not indicate this on the sign in sheet.

I hope I have not confused you more but have given you an understanding of the tally process. It is the vote that is the primary consideration not the position.

Before I give the tally results I would like to thank Sheheen for her help last night in tabulating the tally. The tally is really a job that requires more than one person. Last night was challenging. Many people signed in on sheets in the wrong districts. There were groups I had not heard of nor were they in the GSO database.

I would like to thank all the great volunteers from District 36 for their help with manning the Registration table this weekend. Lynne H. from District 36 deserves a huge thank you for volunteering to take on task of the Registration table management, getting the volunteers and greeters. To all the volunteers that manned the table and greeted...thank you so much!

#### Appendix C – Area Webmaster & Alternate Webmaster Position Descriptions

#### **AREA WEBMASTER**

To be appointed (or re-appointed) for a two year term by the Area Committee, on a recommendation of the Area 83 Chairperson after consultation with any other members of Area 83 deemed suitable for advice by the Area 83 Chairperson. Total term length not to exceed 4 years. Resumes for consideration shall be submitted to the Area 83 Chairperson. The Webmaster shall also be a member of Alcoholics Anonymous in Area 83.

The Area Webmaster holds primary authority and responsibility for the oversight of the Area 83 Website. The primary duty is to maintain the website, in terms of additions, deletions, updates, email address forwarding for Area 83 contacts and to track web site usage. The Webmaster shall assure the 12 Traditions and Concepts, GSO guidelines and policies and Area 83 Web Site Guidelines are followed relating to the World Wide Web.

The Webmaster, a non-voting appointed committee member will report to the Area 83 Chairperson regularly, and to the Area Committee and the Assembly as necessary about new material received and give updates about ongoing projects.

The Area Committee shall be ultimately responsible for and give direction regarding the Area 83 Web Page contents and policy thus requiring attendance of the Area Webmaster at Area Committee. Attendance at Assembly is voluntary, however, the Service Information Committee may require the webmaster to do a workshop or participate in a panel or in presenting displays at Assembly. All expenses, including but not limited to transportation, travel expense (including room and meals for the Webmaster), shall be paid by Area 83 or in the case of other requests, the requesting party or organization.

A separate line-item on the Area Spending Guidelines and Expense worksheet shall reflect expected Area Webmaster expenses including the costs to maintain the Web Page.

#### ALTERNATE AREA WEBMASTER

An Alternate Webmaster will be appointed (or re-appointed) for a 2 year term by the Area 83 Chairperson from candidates recommended by the Webmaster from resumes submitted to the Area Chairperson. The Alternate Webmaster shall also be a member of Alcoholics Anonymous and assist in the design and maintenance of the Website and be available for Area Committee/Assembly when the Area Webmaster is not able to attend. The overall position summary for the Area Webmaster shall apply to the Alternate Area Webmaster.
