Food:

Our Treasurer, Jim, has made arrangements with Shirley at the church for a BBQ today. There will hamburgers & hot dogs for a price of \$8.00. This includes drinks and deserts. Jim has placed the collection buckets at the back of the room for those of you who are participating. Jim will also be passing the buckets around at the first break.

Seating:

As much as possible – DCM's and Sub-Committee chairs on the outside. Alternate DCM's on the inside. Visitors at the back. This seating arrangement helps facilitate our voting procedures.

Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs All DCM's of Districts in Area 83; in their absence, the Alternate DCM may act on behalf of the District. There is one vote per person.

How do we vote?

Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority, the items under new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get there. If for any reason you think that we should be under 2/3 before then, please make the motion.

Voice of the Minority

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, he or she may make a motion to reconsider. If this is seconded and passes by a two-thirds majority, we start discussion again on the *original* motion.

Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who may address the committee meeting?

It has been the *practice* at the Area committee level to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons:

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly members are representing their District's positions or Area's in the case of our Officers, rather than their own.
- It also maximizes the time available for those members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I just described, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcomed to participate and their opinions will be heard.

d) Treatment Report

Rodney S.

Good mornign, my name is Rodney S and I am an alcoholic. I am honored and priveledged to serve as your area Treatment Chair for 2011-2012 Term. Since taking on this position I have been trying to get District information concerning TF Facilities in each district. Some have Treatment Centers and some don't. Most have hospitals and some have detox centers. From what I can gather most districts that have hospital meetings are meeting their commitments as they should and the whole deal is pretty much understood. With the exception of setting up new meeting in such facilities there is very little that the Area has been asked to do in this regard.

Gary from NY called me one day and asked about protocol of starting a meeting in a sex offendors unit in a state hospital. I looked into it a bit and found that there is not a lot of precedence in this. New York told me that they were unaware of such. It was their hope that such a meeting, if started, would be similar to any other meeting. I tried to contact Gary by email and included our CF Chair Deirdre because it couldn't figure out if this was more of a CF issue than a TF issue. I have not heard back from Gary so I called him but have not heard back by phone either. I have been informed by David T that this is a long standing issue. Of concern is how to get members to volunteer in such a facility. Also of concern is can we, AA, meet such a commitment. I understand there is dificulty getting volunteers for the regular prison meeting. So far this issue is unresolved.

I have made it known from the beginning when I began to look into the needs of TF that there is a big hole in the BTG program. For all intense and purpose it almost doesn't exist. Just for a quick idea, how many districts present have at least one Treatment Center in their district.

______COUNT THE HANDS. Some of you may have more than one like district 12 in Toronto that has 12 or so. BTG locally is pretty informal. You meet a person at a local meeting and show them around the district when then get out. BTG for those who are returning to some other town is more involved.

So far, out of all 28 district only one district is formally forwarding BTG requests to their local TF Chair. That district being Bellville. I have had 11 contact requests since the last assembly 9 of which came from the center in Bellville. What are all the other centers in Eastern Ontario doing. Some, like Renescent in toronto, have their own contact program where they match the person being released with an alumni near their home town. I don't know how effictive this is. I do know that not every member of every centers stays sober and I have hear tales of contacts being assigned who are back to drinking. The possible truth is that such centers may, or may not have a way of establishing each contacts current sobriety. However, when a BTG request is made, the TF chair in the receiving district pretty much makes sure that a sober member will be making the call.

We need to get out there and approach the Treatment Facilities to see if we can help in this area. I am unsure but I suspect there has been some issues in the past. If we have a proper program in place, with documented follow up and feedback we are in a better position to be successful.

Below is a copy of my current database of contacts. Each contact is followed through until contact is made and a brief synopsis of how that contact went is communicated back to the originating TF chair who then communicates it to the originating center. So far we have done well.

There will be a full day of informative workshops, with a potluck lunch, and a visit to the Queen's University Archives to complete the day. The roll call for today is 15 Area Officers (including Webmaster & Area Archivist), 1 Immediate Past Delegate, 4 Past Delegates, 20 District Committee Members, 12 Alternate District Committee Members and 5 visitors. For voting purposes there are: 17 Area Officers eligible to vote (including 1 Immediate Past Delegate and 4 Past Delegates) and 23 District Committee Members or Alternate District Committee Members for a total of 40 votes. Total delegation for this meeting is 57 people.

Since my last report at the Spring Assembly, I feel like I truly have my bearings with this position. To all of the table officers that have been submitting your group changes, I thank you for your patience while I was in the learning curve.

The cutoff for group changes to be submitted for the upcoming regional directory was yesterday as indicated by Karen H., Manager of Administrative Services at the General Service Office. All group change forms submitted up until yesterday have been processed and are up to date. I trust that all incoming general service reps have received their kits.

I have emailed the district committee members a copy of the updated spreadsheet roster for their districts and have sorted this spreadsheet by group status for your convenience. 8. TREASURER'S REPORT

Jim A.

Happy New Year's to you and your groups everyone. I am an alcoholic and my name is Jim A. Thank you for the opportunity to serve you as the Area Treasurer for this term

I would like to start by thanking the 10 districts and 87 groups for their generous support of Eastern Ontario International Area 83.

I have recently sent the contribution split information to the current DCM's again. I will be sending it again with an updated address. I am in the process of moving by the end of July. You will all be informed as events unfold. AS such I did bring some pre-addressed envelopes. Could I ask, please, that groups dispose of all old envelopes, as it eliminates the possibility of stale dated cheques if sent to previous addresses in error. So far this year I have received an envelope from the 2005/6 treasurer, and 2 that were sent to Joyce who was the 2007/8 treasurer.

Some groups are taking anonymity to extreme. I get an envelope with a cheque but no return address. So that I may be able to send a receipt, a return address is needed. Otherwise, I will be enlisting the help of DCM's to hand deliver some envelopes for groups in their district. I made this comment at the assembly and thankfully I was able to put the lone receipt in a group members hand. Keep Canada Post in your prayers, that the simmering labour dispute does not cause a disruption of mail service in the very near future.

And now for the present. This year's financial results to May 31st. I have placed a copy of this report for you and your ADCM in each of your folders.

The first page is a summary of the entire year's receipts and expenses. The reserve account remains at \$20,000.00 as per the directive of the Oct 2008 Assembly. A GIC for the entire amount will mature on March 16, 2012. The next interest payment will be in October. Moving to the income section, you can see the the 7th tradition collected from the Jan 2011 ACM and the March 2011 Area Assembly, \$2300.94; group/district contributions of \$18,946.07, down very slightly from this time last year, \$40.00 for one group's GSO flow through. Cost recoveries of \$356 are from the sale of service manuals, PI kits and some Archives materials. Total inflows to the operating account were \$21XXX.

To the expenses section, which total \$25,971.11 YTD. The first grouping of items are the committee expenses for 2011. The YTD total is significantly lower than the previous year. The improvement is more a matter of timing than of planning. Travel costs for the Info AA day in Toronto last week end have not been included yet. As usual, at this time of year the significant expenses Notable figures are the \$5500 contributions to GSO for this years General Service conference, \$1010.09 for attendance at this years Ontario Delegates Conference in Brantford; \$1500.00 travel advance for the Alt delegate to attend the 1st Eastern Arctic conference in June at Igualit.

At the bottom of the page you can see the change in the Operating Account for the year. A beginning balance of \$32, 987.90 plus inflows \$21,267.00 less expenditures of \$25,971.11 leaves a balance of \$29,897.79.

All invoices are paid, and all checks received to date have been deposited. The total of the operating account and the reserve account is \$49, .

The second page is a detailed breakdown of the expenditures summarized on the first page. The biggest single number on this page so far is the spring Assembly costs, which include \$3196.00 listed under meals. That is the charge for coffee at the Assembly.

At the bottom are two boxes. The one on the left shows a breakdown of the cash receipts to date. The box on the right compares 2011 with 2010. As you can see the group and district contributions are just about equal, and expenses are lower.

Page 3 is the Contributions by Group. Last week Deirdre sent each District an email statement showing the annual contributions by group for that district. This is a practice I will continue.

The last page of your package is a comparison of the Group/District contributions for the years 2007 to 2011 by month. You can see that 2011 contributions are almost the same as 2010. Good things continue to happen in Area 83, this is the Responsibility Declaration in Action.

See you in September. Have a great summer.
