Introduction

The A.A. Service manual combined with the Twelve Concepts for World Service defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." This is the first assembly of four that will be held over the length of this term. Over these two years, we will work together to keep Alcoholics Anonymous vibrant and strong in Area 83, Eastern Ontario International and by doing that, around the world as well. THE ONLY SMOKING AREA is outside, please use the butt containers provided by the hotel. It's unfair for us to have the hotel staff clean up after us. If you leave this room for a smoke (or any other reason) please do so quietly, and please do not congregate just outside the doors.

NAMETAG HOLDERS

When you leave for home this afternoon or evening, please leave your name tag holders in the boxes provided near the doors. We re-use them to save money.

FREQUENCY OF MEETINGS

I think it's worthwhile to review the schedule of meetings for this term, for both this Assembly and the Area Committee:
The Assembly meets twice a year – the last full weekend in March and October. This afternoon we will decide on a date for the Fall Assembly. The Area committee, which is comprised of the Area Officers, District Committee Member's and Past Delegate's will meet three times this year. We have already met in Quinte West in January and will meet again in June and September.

SEVENTH TRADITION

I know that it seems as if the coffee and drinks provided this weekend may be free, but the hotel charges us a flat rate of \$8.00 per person for the weekend. Rather than have honour buckets beside the coffee urns, we have chosen to use the Seventh Tradition to cover these costs. We had a Seventh Tradition Friday night, again at the speaker meeting last night and we will have another one today. Please keep these costs in mind when the 7th is being passed around.

WHO VOTES?

Only members of the Assembly may vote.

These are:

All Area Officers, including the immediate past Delegate, but not the Chair.

All Area sub-committee Chairs

All DCM's of Districts in Area 83; in their absence, the Alternate DCM may vote.

All GSR's of Groups in Area 83, in their absence, the Group's Alternate GSR. In their absence a member of the registered Group. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ♦ There is one vote per person.
- After lunch, which is when we would expect to conduct old & new Business, I would ask those with voting privileges to sit at the front, others near the back. This will make it easier for us to count votes.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

- When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion. This next part may unique to A.A. If, after the minority has spoken, one member of the Assembly who had voted for the majority on the issue stands at a microphone, and says, "I wish to change my vote", we start all over again.
- ♦ The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

CALLING THE QUESTION

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
 - ✓ It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - ✓ And it maximizes the time available for those members to voice their Groups' opinions and needs.
- ♦ All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones dotted around the room, and identify yourself by name, position, Group and District number.
- ♦ IF you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary Kim before standing at the microphone. I am sure Kim will appreciate it.

How do we vote?

- ♦ Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.
- ♦ I believe that the early part of the agenda today can be handled under simple majority 1 vote more than 50%. I will advise you when I believe we should move to 2/3. If, at any time, you think we should move to a 2/3 majority before I indicate it, remember it's your meeting. Don't hesitate to make the motion.
- ◆ To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.
- At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his
 or her hand
- Again, when you are ready to speak I respectfully ask that you identify yourself by name, position, Group and District number.

d) Treatment Report

My name is Rodney S. and I am proud to serve as your Treatment Facilities Chair for this term. Of all the positions I could have hoped to get it never occurred to me that I would be in this job. I honestly did not know what I was going to do when I got it. I thought I would simply fill in the chair as it were and carry around the display.

As I started to look into what needed to be done it didn't take long before I found something to do. Bridging The Gap, a program of temporary contacts for Treatment, seems to have slipped under the radar and needs attention. **We are not alone,** I have since learned that there is no formal Bridging The Gap program in Ontario never mind Eastern Ontario International. So there is work to do and I am prepared to work hard to do it. It is my intention to give 100% of the time I have to do this work and with district support we can make BTG a formal program in Area 83.

I have received minutes from several districts and I have read each one. I tend to focus on TF activities in each district as I would like to know what is going on in that area.

Yesterday's workshop went well. We had some technical issues with sound and one member stood up to the plate and read the subtitles on the HOPE video. I presented some ideas concerning bridging the gap explaining how I see this program working going forward. I explained that for Bridging the Gap to work the Districts (Intergroup where applicable) play a key central role in its functionality. We presented a BTG Video Skit that was recorded by AA members and was both informative, effective and lots of fun to make.

This morning's TF meeting held in the Windsor Room at 7am was well attended. There were 14 people in attendance and we briefly discussed what is going on in various district. There were a few TF Chairs and some concerns were brought up. In the end it was thought that a centrally managed list of District contact is simpler to maintain and that each district is to be responsible for their own contact list as well as getting contact requests from the centers in their district.

In an effort to open up the lines of communication and realizing that we cannot meet face to face I have mentioned that our Webmaster has told me that our Website can host a **chat room** for a TF Meeting. I have asked those present to bring this to their district as such a meeting would be beneficial to communicate Bridging The Gap and other Treatment issues in each district. Such a meeting could be convened at a convenient time in our own homes provide we have the technology at home. It is a worthwhile thing and I formally request that our Area Webmaster do whatever is required to set that up.

I have revamped the TF display to include French English and Spanish information. I am fluent in French and English and do my best with Spanish. So far the Spanish is limited to a display of available literature in Spanish. There is so much literature

that can be displayed in the racks that French and English fill them up completely with no room for any Spanish. I have to make available only some of the pamphlets. For now I will let the pamphlet inventory drop a bit before I get any Spanish.

- I listened and asked questions where appropriate
- I was given the opportunity to discuss BTG with Area 84 delegate on our way back to the airport. Our discussion was informative and rewarding. Area 84 is interested in seeing where BTG goes in our Area and how we can help get things improved in their area. Much discussion and action is still needed.

I have been in contact with

New York Treatment Facilities Desk

- New York put me in touch with BTGWW.
- I contacted the people who put this workshop on last year and they immediately gave me information of where it is being held this year.
- I made the decision to attend the Bridging the Gap Weekend Workshop in Sacremento CA during the weekend of Sept 11-13.
- I have put my name down to present something at this workshop so I am working towards building BTG back up in our area so I can talk on our new efforts
- I have been in touch with Area 86 TF Chair and we have briefly discussed BTG in his area. His is much like ours and needs as much work. We have discussed developing a simple process that both areas can use that way when we talk about the BTG plan in southern Ontario we are all on the same page. Next step is to reach out to our northern neighbors and see if we can get them on the same page.

6. TREASURER'S REPORT

Good morning everyone, I am an alcoholic a member of the St Andrews (Scarborough) Group, my name is Jim A. I have the honour and privilege of standing with you and before you as Area 83 Treasurer.

Thank you to all who attended the Treasurer/Self-Support workshop yesterday. I hope the information was useful. Thank you to Rodney for his technical support and to all the wonderful volunteers who helped sell banquet tickets, count loonies and twoonies, and the five bucketeers for last night and today. Thank you for your time. No names preserves your anonimity and doesn't tax my memory.

Thank you for sending in your District and Group contributions. As of March 20th all cheques received have been deposited and all but one receipt have been sent back with a self-addressed return envelope. A gentle reminder to put your group's service number on the envelope and the cheque. I have received a cheque from one of the three Freedom groups in 83. No return address or group number, so I ma not quite sur with no return address or group number. Either of these two vital bits of info will ensure that receipts go to the right group. Thanks to the DCM's for delivering mail for me too.

Please note that the receipt was subsequently hand delivered to the correct Freedom Group. (from Peterborough).

The following is a breakdown of our financial affairs as of March 20, 2010:

Our reserve account has a current balance of \$20,000.00 It is currently set aside for unforeseen circumstances, and is in the form of a GIC paying 1.5% maturing March 16th, 2012., Semi annual interest of !48.77 was paid by cheque and deposited to the operating account on March 16th, 2011.

Thank you & muchos gracias goes out to the 64 groups and five districts that have made contributions totaling \$11,515.47 year to date. And to those who have handed me cheques this weekend as well! This amount is lower than 2010 by \$1,195. The decline in contributions that started in late 2010 continues.

The total expenses for the period ending March 20, 2011 were \$10, 051.99. To date our expenses are expenses are \$ \$1,850.71 lower than our income. The drop in expenses is mostly the difference of hosting the ODC in Ottawa last year (\$4400.00), and just participating at this years ODC in Brantford. All invoices received have been paid including \$5,500.00 USD for the 2011 General Service Conference that will be attended by our Delegate in April.

At this point, I do not recommend that Area 83 make a contribution to GSO in light of the declining contributions. I will be reviewing this in August, in order to make a presentation at the September Area meeting.

The bank opening balance as of January 1, 2011 was \$ 32,897.79. Total income of \$11,902.70 less expenses of \$10,416.34, leaves an Operating account balance of \$34,384.15 as at March 20, 2011.

The sum of the Prudent reserve and the Operating account is \$54,384.15. As per the GSO guidelines, the suggested amount in an Area's prudent reserve is the equivalent of one year's expenses. This represents approximately 93.8% of the proposed spending for 2011.

Our proposed spending guidelines are \$57,945.

This is the first report I've done in a long while and it's good to be able to stand here – in my previous job as Chairperson, you don't give reports.

I thought I'd start out by relating what it says in our Service Manual about being the Alternate Delegate. First, a little about the other positions:

The Service Manual spends a full chapter on the Area Committee, its composition and duties. The Chairperson gets pretty much a full page all to herself and her duties, apparently, are very important. The Secretary and Registrar are likewise. The Service Manual goes to great lengths to say how key these positions are to the effective running of the Area.

The Delegate, well he or she gets a whole Chapter in the Service Manual to themselves. It's Chapter 6! More space devoted to that than is given to the whole Area committee! The Delegate clearly is a very important person.

And then, there's the Alternate Delegate. I get one paragraph tucked into the Delegate's section – 5 sentences.

Essentially it says that Area's should have one and that I can be a valuable assistant to the Delegate (show towel).

It says in some places there are Area's that actually gives the Alternate some special tasks and some are even assign a line item in the spending guidelines.

I have learned that each Area has had to come to some decision around whom to apply the Remote Communities tag to – is a community remote because of its language, culture or geography or is it because of its language, culture AND geography. I've helped the leader of the Workgroup (Bob P.) out on a couple of occasions for work he is doing in our Area, especially around Ottawa and I am very much looking forward to my trip to Iqaluit in June to attend the First Canadian Eastern Arctic Convention of AA on our Area's behalf. I will try to represent us well. I am even practicing some Inuktitut words (this from a guy who can't say Rideau River). "Ai" (like "eh") is hello and "qujannamiik" (ka-jan-a-mik) is thank you. I apologise to any Inuit in the room and if there are any – I'd be grateful to talk to you after!

On the Intergroup front (my other stated responsibility) I have a great story about the recent Toronto Intergroup-District Sharing session that took place in February. On the District/Area side we talked it up, made it exciting and invited all the DCM's and others for dinner before-hand and lo and behold we had complete representation of the nine geographical Districts in the Toronto area at the meeting. It was powerful from an Area perspective and I was so proud. I am working now to develop relationships with the other Intergroups in our Area. If you happen to BE the Intergroup in your Area, please give me a call if you need assistance or support and I'll do what I can to help!

On individual fronts I attended and presented at the D02, 04 and 06's Service Information Day and that was a huge success by all accounts. Finally, I attended the Ontario Delegates Conference weekend in Brantford in early March and had the time of my life there. I got to hear Robb give the two minute report he is going to give at the General Service Conference and if he does it as well as he did in Brantford; we have nothing to worry about.

What an honor it is to have been elected to this position. Another leg on this wonderful journey called service. I have to begin by saying what a great time I've had so far this weekend. I've had the opportunity to speak with many of you over the last couple of days and I'm even more certain than ever that Alcoholics Anonymous has a strong and vibrant presence in Eastern Ontario. For those of you that are here for the first time, please return to your Districts and Groups with the same enthusiasm that you've exhibited here. Service is contagious and your attitude will go a long way in ensuring that we remain active and strong in Area 83.

Over the past three months, I have attended the District 2, 4 & 6 Service Day and the Ontario Delegates Committee Meeting. These are the only "official" Delegate commitments that I have had so far. The rest of the 83 days have been spent trying to assimilate all of the information that I have received from the General Service Office. I have the agendas and background information for both of the committees that I'm on, Cooperation with the Professional Community and Archives and I am trying to become intimately familiar with it. While I also have all of the agendas and background material on all of the other committees, I will only attempt to have an understanding of what's going on there. Thank you to everyone that has received and passed on information for the 61st General Service Conference. I expect that, over the next five weeks I will be getting some feedback and will take that information with me to New York.

Once back from the General Service Conference, I will be visiting a number of District Service Days to give my Conference Report. Please, please, if you haven't already spoken to me to book a date for the report, let me know of any dates that you may be planning. I currently have a number of commitments and a few tentative dates booked: I will be in Peterborough on May 15th, Toronto's Information AA Day on the 28th of May. On the 4th of June I'll be attending the Area Committee Meeting in Quinte West; the 11th of June is tentatively booked for District 48 or District 26 & 28. That will be a first come, first confirmed booking. June 18th I will be in Canton, New York for the District 42 Service Day and then the 25th of June I'll be in Ottawa for the District 54, 58 & 62 Service Day. As you can see, a number of Districts have got together to put on a Service Day so that the Delegate does not have to visit each District separately. If you have had a look at the Archives display in the Frontenac room, you may have seen the map of the Service Zones in our Area. This was an idea that came up a number of years ago so that we could keep travel expenses down by Districts cooperating to have multi-district service days and the Delegate could reach more people in one shot. This does not mean that I won't visit an individual District, I'm happy to go wherever I'm asked... but you have to ask! If it's not in my little black book, I won't be showing up! If you think that you've invited me to your service day and I haven't mentioned it, please talk to me after and confirm that I have the date in my book.

I would like to share with you some of the information that I've received over the last three months from other Delegates in North America. We have a distribution list that we're using to share questions that a Delegate might have and to encourage communication throughout North America.

One of the first emails was regarding attendance at Service functions in our Areas, at Assemblies and Districts. I thought about this for a while as Area 83 has, what I think is reasonable attendance at around 40% representation at our Assemblies and Districts reporting anywhere from 90% attendance to some that are struggling at 20% attendance. While I was mulling this over, I received a number of responses from other Areas quoting numbers of 20% representation at Assemblies. This amazed me as I thought that we must have been near the bottom of the list! While these numbers tell me that participation generally is not that great, Area 83 still comes out near the top of the heap. I feel that it is our responsibility, all of us here, to encourage people to come out and allow their group to have a voice in the business of Alcoholics Anonymous. Encourage people to read the Service Manual and the book "The Home Group, Heartbeat of AA". Joining a group, getting sober and helping other to get and stay sober is our primary purpose but, if we aren't a part of A.A. as a whole, we're missing out on so much. Encourage people with your actions and deeds, be enthusiastic and let people know that service is just another benefit of getting and staying sober.

Another email was sent out asking about participation of Young People in our Area. Some areas have young people in AA committees that interact with General Service regarding things like Young Peoples conventions. In my history with Area 83, such that it is, I haven't seen any interaction with a specific "young people's" associations or committees but, I have noticed this weekend that there are a lot of "young people" here at the Assembly! Now, that could just be because I'm a lot older that I was when I first came here!

I will attend the Conference in May and report back to all of you what's happening in Alcoholics Anonymous as a whole. If, for any reason, you cannot attend a service day in your area, please feel free to drop me an email and I will send you a written report about the goings on at the conference.

To wrap things up, I would like to thank you all for the opportunity to serve Alcoholics Anonymous in this capacity and for the support that you've given me over the years. I thank all those that have come before me and blazed the trail that I'm following. I am blessed.

As always, there is no place that I would rather be than here with you, serving the fellowship that, in the beginning, gave me hope and to date has given me a life beyond my wildest dreams.

10. ROLL CALL AND REGISTRAR'S REPORT

TONY A.

Good day, I am an alcoholic, a member of the Church Street Group and currently serve as your Panel 61 Registrar for Area 83 International and my name is Tony A. I am delighted to be here with you all and it is great to be of service to Alcoholics Anonymous.

As the area registrar, I am responsible for compiling and updating group registration and records; distributing lists to District Committee Members or DCMs at least once a year and forwarding group information to the General Service Office. I also prepare roll call forms for Assemblies and area committee meetings and call the roll call.

My digital certification which is needed to access the Fellowship New Vision database aka FNV from General Service Office or GSO was received just shy of 2 weeks ago. The FNV is the database which all of the group information is stored at the GSO office. I need this certificate to enter the database to make changes and update group information.

In January, all area registrars received a comprehensive 3 session training via webinar to show the incoming registrars how to navigate the FNV as well as how to enter, extrapolate and export data from the FNV database. GSO had decided in an effort to reduce data entry errors, it would be best to provide ample training prior to the issue of the digital certificates.

All group change forms and new group forms submitted prior to my receiving FNV access were faxed directly to GSO for processing. GSO tells me that all group change forms submitted were entered by GSO staff. General Service Representatives or GSRs that had submitted these changes should have received their kits which are usually mailed out within 2 weeks of GSO receiving the updated group information.

Group Change and New Group forms have been with my mailing address and email so you can send me group changes. I'd like these sent to me where possible by email in a Word formatted document for easier transcription. These are easily downloadable from our Area 83 website under the District Resources tab and.

This year, a new Regional Directory will be made available to the membership. The Regional Directory is a compiled listing of AA contacts for people who are travelling. The GSR and Alt GSR who have given permission are listed in this directory. The directory is usually made available sometime in July. This directory can be ordered from GSO by calling them directly (212-870-3400) or by visiting their website.

It is the responsibility of the area registrars to ensure this directory is up to date. The cut off for submissions for this directory will be the first week of May of this year. To all DCMs, District Secretaries/Registrars, please ensure that I have all of the group changes by the end of April as anything received after that will not go into this year's directory.

All DCMs will be receiving their updated group lists in an Excel spreadsheet format within the next couple of weeks. I have also placed a printed copy of all of all District's group sheets in your respective District folders. You will notice that your groups are listed by service type which is located right next to the group's service number at the top left area of the sheets.

Generally, we will only relate to "Active" groups but I have included all of the group listings in your district. Some groups might be listed as "Unknown" or "Inactive". I ask that you cross-reference the unknowns and inactive service types to validate accuracy. Please review them and send me the edits/changes only.

Active - group has a primary mail or GSR contact on the record along with meeting information

Unknown - group is still active but record does not have a GSR or primary contact attached to it indicating no one available to receive mail from GSO

Inactive - GSO records department has received information that group has disbanded or is not currently meeting

To submit new/group change forms, have queries relating to GSR kits, or you have any further questions or comments regarding the registrar process including group status issues, send me an email to registrar@area83aa.org. I will follow up for you as to not take up assembly time addressing these types of concerns. I kindly request that DCMs and district secretary/registrars to please use this email to forward district minutes.

I attended the Ontario Delegates Committee meeting for my first time and I loved it. Being surrounded by members that have such love, enthusiasm and passion for Alcoholics Anonymous was indeed very heart warming and guite the experience.

I would be remiss if I did not give a huge thank you to the team from District 36 who was most generous with their time and help manning the registration table and others who aided with this process this weekend.

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote have the right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being that the numbers will often not look at all like what was written on the sheets.

For example, a district might have five people signed in as visitors, but when I announce the roll call, I might see that there was only one. The reason is that I check each visitor against his or her group, and if the group does not have a GSR that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as a GSR.

Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the assembly, is really as their group's representative. It is very important if you sign in as a visitor that you also write the name of your group. You could be voting for your group but I do not that if you do not indicate this on the sign in sheet.

In closing, I will make myself available to districts and groups to assist you with registrar related issues where I can and please remember that communication is essential. Thank you for the trust that you have placed in me and it has been my honour to be of service to Area 83 International.

12-b) Auditors Report

Dan N. DCM & Auditors Committee

Our operating procedures require that the current Treasurer and two (or more) appointed Area committee members audit the previous term's financial documents. We performed this obligation for the years 2009 and 2010. The object of the review was to satisfy ourselves and to be accountable to Area 83 members that the revenues and expenses were properly recorded and balanced, and that there were no major discrepancies in the practices that were in place. Specifically, the Audit committee reviewed the financial documents covering the period of Jan 1, 2009 to Dec 31, 2010 in order to ascertain:

- 1) Completeness and accuracy of recording of transactions.
- 2) Completeness and accuracy of reporting.
- That all recommendations from previous audit Review committees were implemented.

Each committee member reviewed an entire month's transactions from each year, covering 6 of the 24 months in the term. The months selected were carefully chosen to reflect various types of situations: a month with an assembly, a month with an Area Committee meeting and the last month at random. During this process; large items like GSO Assessments, Ontario Delegate's conference expenses, Ambassador Hotel bills, Grapevine seasonals were reviewed.

Bank reconciliations were reviewed, with income items traced back to bank deposits and to group and district contribution files. Expenses in a given month were reviewed and traced back to the Area 83 cheque register.

The expenses for both years, for the following trusted servants were reviewed for accuracy, reasonability and completeness: Archivist; Archives; PI; CPC; TF; CF; Treasurer; Secretary; Chair; alt Delegate; Delegate. This sample covered the widest array of expenses.

The findings of the Audit Committee are that the expenses claimed were within the guidelines of the Area Assembly and were reported properly and consolidated appropriately. Further, the 2009/10 audit committee did not make any recommendations that needed to be implemented.

12-c) 2011 Financial Guidelines

Jim A., Area 83 Treasurer

Good afternoon:

I am an alcoholic, a member of the St. Andrew's (Scarborough)Group. My name is Jim A. I have the honour of serving you as your Area Treasurer.

As per our Operating Procedures -

"The Treasurer shall prepare annual financial guidelines for Area 83, in such detail that is acceptable to the Area Committee and the Assembly."

I would like to mention at this time that this is only forecasted income and expense. These are spending guidelines, not a budget. It is merely to give an overview of the estimated amount of money required to effectively carry the message throughout Area 83 as mandated by the historical group conscience of Area 83.

In keeping with the above guideline, I have presented a DRAFT version of the spending guideline to the Area Committee at the end of February, and to the DCM's on March 7th 2011. Today I present to you .

The proposed guideline for this year is based on the average expenses from the past four years 2007 to 2010. Expenditure of the various chair can vary widely from year to year due to number of events attended and the distances they travel to carryout their functions. Projections of expenses are also based on feedback provided by Area officers and committee chairs. Large one time only expenses such as the 2008 Website start up that distort the average have been adjusted. In some instances, I have used the actual 2011 expense amounts where AVAILABLE in order to keep the forecasted expense total as accurate as possible. (i.e., – expenses for the March 5th, 2011 Ontario Delegates Conference in Brantford is shown as actual the guideline).

Expenses

In order to follow Tradition 5, it takes three things to carry the message: time talent and treasure. (Thanks Mel).

There two types of expenses, those for committees and officers and committee chairs as shown in the top section, Reading left to right you can see each trusted servants proposed spending for individual items. Reading from top to bottom shows the total spent on a particular item, ie travel, stationary, printing etc

The second type of expenses shown in the lower section represent, events and flow through expenditures, A flow through expenditure that has a corresponding flow through income item therefore it nets to \$0.00. In and out. The best two examples of this would be the Grapevine seasonals your groups buy every fall, and the occasional contribution with an attached request to forward some of it to GSO, This is called a flow through contribution.

Event expenses includes, the ODC, any forums, our area meeting costs. This is also where any potential GSO contribution is listed.

Total proposed expenses for 2011, are \$57,945, plus \$5000 in Grapevine seasonals for a total of forcasted expenditure \$62,945.00.

Income

So where does it come from? That would be from us, as per the 7th tradition.

A 7th is taken at every Area committee meeting and every Assembly meeting, and this is represented by the \$5900 figure, same as last year's actual.

Our reserve account of \$20,000 is currently in a 2 year GIC maturing March 16th 2012. earning 1.5% interest. That is the \$300.00 amount. A standing instruction is in place to pay interest out semi annually by cheque, which is then deposited to the operating account.

Cost recoveries represents monies return to Area for proceeds from the sale of literature Service manuals, Pi Kits are good examples. And from time currency gain and or loss from Grapevine seasonal sale is part of this figure.

Grapevine seasonals as mentioned before, in and then out, net \$0.00.

So this brings the one figure that ties everything together, contributions from the other levels of the service structure. And for 2011, that figure is \$51,195.00 which is the approximate midpoint between actual 2009'contribution figure \$54,4000 and 2010's \$49,014 actual contributions.

Total income of \$57,945.00 plus \$5,000.00 Grapevine seasonals = \$62,945.00

12-e) Voting Eligibility Recommended changes to Operating Procedures – Kim, our Secretary has sent these recommendations out by email and has included copies in your folders. I trust everyone has had a chance to review them.

At this time I call upon Kim, the Chair of the Ad-Hoc committee to give us a brief history as to why these amendments came to be.

Hi everyone, my name is Kim, I am alcoholic and I was serving on the Ad-Hoc Committee reviewing the Area 83 voting eligibility procedures. On November 1, 2009 Mel C, the Area 83 Chair invited Roy R., Robb W. and myself to form a committee to examine voting rights and eligibility for our Area Committee.

The Ad-Hoc committee was formed as a result of a motion made by Rodney S., who at the time was DCM of District 14. Rodney's motion was, "Recommend to the Area Assembly that both the Assembly and Area Committee Operating Procedures be amended to allow the Alternate DCM to vote in the absence of the DCM, by ensuring the "If a District Committee Member is not present, the Alternate District Committee Member may vote" is contained in each of the relevant items with sections that deal with voting rights and privileges." Rodney's motion was made as the result of the December 2008 election meeting of the Area Committee, a number of Alt DCM's, who were representing their Districts, were not allowed to vote in the elections because of an

interpretation of the Operating Procedures. In that particular election because the District Committee Member was not present and the Alternate District Committee Member was not allowed to vote in his/her place it meant that the District was not represented. What we attempted to do is to remove those ambiguities. To make it crystal clear who has the right to vote.

Our scope was to make an assessment of and recommendations around Area 83 Eastern Ontario International voting rights and privileges as they apply to our Assemblies and Area Committee Meetings. Our mandate was to report to the Area Committee. It was suggested by the Chair, Mel to give our final report and recommendations to Area Committee meeting and because the Fall Assembly 2010 was an election Assembly, we suggest bringing our recommendations to the Spring 2011 Assembly.

We reported to the Area Committee on January 9, 2010, June 5, 2010 and September 11, 2010.

We researched other Area's voting procedures throughout Canada and the United States. We also looked through our own procedure archives.

We felt that modifying the Area Procedures (where applicable) to include the Alternate District Committee Member as a voting member of the Assembly or Area Committee Meeting in the absence of the District Committee Member is the correct way to proceed. This will give Districts one vote per District similar to the "one vote per group" logic. Our intent is not to change the Area 83 procedures but rather to make very clear who is entitled to vote. We feel we have done that in our recommended changes.

That said, we have made sure that the Alternate District Committee Member is listed as an alternative should the DCM not be available to vote. These recommended changes are shown on the copies that have been sent out to the Districts.

Another recommendation for change is that we wish to clarify that voting is at the meeting of the Assembly and not just the Assembly as is the current wording in the Area 83 procedures.

We have tried to keep it simple and understandable for everyone.

We presented these changes to be approved by the Area Committee on Sept 11, 2010. Also we recommended that if approved that the Recommended Changes to Operating Procedures be presented to the Spring 2011 Assembly to be approved, as the Fall 2010 Assembly was an election Assembly. A motion was made and seconded to bring these Area 83 Amended Operating Procedures to this Spring Assembly. The motion passed unanimously.
