The Area committee, which is comprised of the Area Officers, District Committee Member's and Past Delegate's has already met three times this year. Next year the Area Committee will meet in Quinte West in January, June, September and December.

SEVENTH TRADITION

I know that it seems as if the coffee and drinks provided this weekend may be free, but the hotel charges us a flat rate of \$8.00 per person for the weekend. Rather than have honour buckets beside the coffee urns, we have chosen to use the Seventh Tradition to cover these costs. We had a Seventh Tradition Friday night, again at the speaker meeting last night and we will have another one today. Please keep these costs in mind when the 7th is being passed around.

WHO VOTES?

Only members of the Assembly may vote.

These are:

All Area Officers, including the Immediate Past Delegate, but not the Chair.

All Area sub-committee Chairs

All DCM's of Districts in Area 83; in their absence, the Alternate DCM may vote.

All GSR's of Groups in Area 83, in their absence, the Group's Alternate GSR. In their absence a member of the registered Group. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ◆ There is one vote per person.
- ◆ After lunch, which is when we would expect to conduct old & new Business, I would ask those with voting privileges to sit at the front, others near the back. This will make it easier for us to count votes.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

- ◆ When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion. This next part may be unique to A.A. If, after the minority has spoken, one member of the Assembly who had voted for the majority on the issue stands at a microphone, and says, "I wish to change my vote", we start all over again.
- ◆ The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

CALLING THE QUESTION

- ◆ During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many good points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- ◆ **Only voting members of the Assembly have a voice. This is important for two reasons:**
 - ✓ It keeps the focus on the fact that the Assembly is the business meeting of the Area – Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - ✓ And it maximizes the time available for those members to voice their Groups' opinions and needs.
- ◆ All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.
- ◆ On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- ◆ To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones dotted around the room, and identify yourself by name, position, Group and District number.
- ◆ **IF you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary Kim before standing at the microphone. I am sure Kim will appreciate it.**

How do we vote?

- ♦ Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority – 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.
- ♦ I believe that the early part of the agenda today can be handled under simple majority – 1 vote more than 50%. I will advise you when I believe we should move to 2/3. If, at any time, you think we should move to a 2/3 majority before I indicate it, remember it's your meeting. Don't hesitate to make the motion.
- ♦ To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.
- ♦ At times, I may ask for a show of hands to get a '**sense of the meeting**'. This is not a vote, and anyone can raise his or her hand.
- ♦ Again, when you are ready to speak I respectfully ask that you identify yourself by name, position, Group and District number.

Hello friends, I'm an alcoholic, a member of the Royal York Group, the DCM for District 02, Malton and my name is Dan N. Our committee meets on the second Sunday of each month at St. Paul Apostle Church on 2182 Kipling Ave @ 7pm.

Our district meetings are being attended by approximately 65- 70% of the groups represented. At one point in time this year, all positions at District were full but it is becoming a challenge to keep all the chair positions filled. Currently, Grapevine and Accessibility chairs and alternate sub-committee CPC, Literature and Accessibility chair positions are vacant and we will be having elections for these at our next District meeting.

Our District has a focus on Corrections and Treatment as we have 4 facilities. Our Corrections Chair Robert and Alternate Chair Jim are doing a terrific job fulfilling the meeting requirements but volunteers are regularly needed in the short term to meet the demands. We are reaching out to neighboring Districts in lending support. Obligations for Treatment are being met with groups committing to taking on monthly responsibilities in chairing and speaking for these meetings. It appears there has been a lull in CPC activity at Intergroup and our CPC chair, Naveen is focusing his work within our District and soliciting interest for a CPC team in carrying the message. For PI, along with District 6, we are seeing if we could piggy-back on the good work that District 14 has accomplished with Police stations and literature racks.

As DCM, I've just started to focus attention on Groups within District that are not currently at the Table to let them know all the good things we are doing and to invite them to attend. If other DCMs have ventured out to non-attending groups and have been successful in new participation at the District table, I'm certainly eager to learn how you accomplished this.

We are working with other Districts in the GTA for the 2012 Information AA Service Day with a new venue. Our theme is "Let it begin with us" and with the change in location it's going to be important to ensure continued support and interest for this important service day in Toronto.

Our treatment chair has moved, so until we get a new one, we have pooled together to make sure we keep up our commitments to the two facilities that we carry the message to.

It has been a good exercise in humility for us to reach out for help and to receive that help. This reinforces my belief that this is a WE program. If any other smaller districts have faced challenges of low participation, we would love to hear about your experience, strength and hope.

We managed to obtain contacts for all our 33 groups for the Canadian directory & for sending monthly meeting minutes.

The proposed changes to our Operating Procedures are in draft and await presentation at the table in November. We still wish to revise our District website guidelines as well. Since the start of the term, 19 Bridging the Gap requests have been received, Area 83 is helping Correctional Clients meet up with AA on the outside, our primary purpose in action. Many of the Districts are doing Bridging The Gap. Ottawa District has stated that the requests for Bridging The Gap have really increased this year.

GSO Corrections office welcomes Tracey O to the position of G.S.O. Corrections Coordinator. They are still looking for male Correctional Correspondence Service volunteers to share by mail their experience, strength, and hope with AA member's who are on the "inside".

On page 39 of the 61st *Annual Meeting of The General Service Conference of Alcoholics Anonymous* under Corrections states "Based on recommendations in three Advisory Actions from 2010 General Service Conference, new text is being added to the Conference-approved pamphlets "Carrying the message Into Correctional Facilities", "A.A. in Correctional Facilities" and "A Message to Corrections Professionals" regarding clear information and good communication between A.A. members and corrections professionals. The committee also continued it's work on the revision of the pamphlet "It Sure Beats Sitting in a Cell" new stories have been reviewed and selected stories were forwarded to the Publications Department. The committee also sent suggestions for the new wording describing Big Book Studies as a possible meeting format, to be considered as changes to the pamphlet "A.A. in Correctional Facilities".

Thank you to all the District Secretaries who send me out their district meetings, this has kept me up to date with Corrections in the districts.

d) Treatment Report

My name is Rodney S. and I am proud to serve as your Treatment Facilities Chair for this term. Since the spring assembly much has taken place in Treatment. I have done my utmost to perform my duties as best I can and as time permits.

There have been little or no requests from any districts to participate in any events with the exception of Belleville's service day which, given the number of Area committee members attending I chose to opt out at the last minute in favor of a personal opportunity.

I have had a total of 21 bridging the gap requests since the beginning of the year 15 of which have been fully completed with feedback going back to the originating centers. Two of the 6 incomplete are still pending contact date which is set for next Sunday.

No matter where I go I try to represent our Area as best I can. I am involved in other things that get me to conferences and allow me to interact with the people in other districts and areas. In that capacity I have been to Pembroke, Strathroy, London, Woodstock, several locations in the GTA. Soon it will take me to Orillia and Bellville. While there I try to make myself available for any treatment related discussion or function if needed.

A while ago I decided to attend a Bridge the Gap weekend workshop in Sacramento California. Having never been to California before, I was looking forward to the trip. It was a pretty good weekend and I learned several things about bridge the gap programs in other places. Some of the things I learned are:

1. Many areas, districts, struggle with BTG
2. Most areas have no formal process
3. Some areas are extremely active with BTG

4. Some of those same areas maintain vast contact databases. This comes with security issues, anonymity issues and other headaches.
5. All those in attendance are extremely enthusiastic about BTG

In preparation for this trip I decided to make up some pins that I could hand out to people I meet in my travels. I had an idea for a pin, based on the buttons I brought down to San Antonio last year. Given my lack of graphical creativity I asked our Area Webmaster, Todd S, if he would help me make a pin with our Area Logo, Name and both the US and Canadian flags in the background. What he came up with, in no time at all, was amazing and I loved it immediately. They are unofficial yet attractive looking pins and everywhere I travel outside our Area I give these away to people that I meet as a greeting and memento from Area 83. It is probably a good idea to point out that these pins were manufactured at no cost to the Area.

At the BTG Weekend Workshop in Sacramento, at Founder's day in Akron Ohio, at the Pacific Group in Los Angeles California and in San Juan Puerto Rico I have handed out these pins to various people and took a moment to talk to them about our Area and the things we are doing. The pins were very popular at the Bridge the Gap conference. I was the only Canadian in attendance and that was something of a novelty to some in attendance. I taught them all the say eh! A lot.

Upon return from Sacramento I attended Unity Day for the third time which was held in Bradford this time. I was given the opportunity to present a little bit of what went on at the BTG conference.

Yesterday in the TF workshop I presented the presentation that I was asked to give in Sacramento in its entirety, added on some notes about what went on at the conference, including some items that I heard from Mary D, our GSO Staffer assigned to the Treatment desk. I then talked about what TF would like to do going forward.

What TF would like to do I try to find a way to regain what we once may have had. We need to get ourselves back into the centers, perhaps under different conditions, helping people who wish to have the help. To do this we need the help of the districts that have centers in their districts.

Starting with the centers that were most active I would like to gather information of where we stand, what had changed, what we think may have happened and what we have already tried to do to restore some of it. I then would like to come up with a plan of action to revisit these centers and try one more time to rebuild the relationship as a resource for their clients. Between TF and CPC we should be able to find a way to get back in some of these centers so we can help the alcoholic who is leaving.

I think if we work at it hard enough we can regain some of what we had. However it is with great caution that I say that in circumstances such as these, what we do, and how we do it will make a world of difference. Although AA as such has no opinion on Drugs and other medication, it is absolutely imperative that if we are to sit in front of a Treatment Facility administrator, we do so in a drug free manner.

The workshop meeting we held this morning discussed these issues in detail. Attendance was small which allowed in depth discussion. We wish it to be known that Harm Reduction Policy is not our enemy but simply a challenge to find a work around. Collectively AA needs to find a way to rebuild any and all relationships that may have existed in the past. It is thought that using Bridge the Gap as a means of gaining audience with the administrators.

It is important that each district understand that I am willing to help but my assistance needs to be requested. The Area wishes to work in cooperation at all times. I would ask any district that wishes to get the process started either work with their CPC folks locally or contact Area for assistance. We are here to help.

New ideas were expressed in which centers that are AA friendly may benefit from a BTG program. Until now it was never thought that such places could benefit from such a program.

put in on Sept. 12, and was delivered to me on Sept. 27. The total of our order was 707 Pocket Planners and 212 Calendars for a total cost in Canadian \$ 4411.31 and our total money was \$ 4413.83.

Last Year's order was 685 Pocket Planners and 310 Calendar. The Grapevine move to California was a cost saving move. As some may know the Grapevine has been declining in sales over the last few years. There was a survey taken in 2010 in which 8,000 responded. Of those that did answer 93% said the Grapevine had value. What was interesting was that 60% of those responding were not subscribers and the overall 96% said it should be supported and was of value to the fellowship.

We have just over 2 million members in A.A. and the circulation of our monthly Grapevine is 93,104 copies and LaVina 8741 by monthly.

The Grapevine continues to print new book with the latest being "Step by Step" and "Emotional Sobriety". As a reader we know how this literature enhances our sobriety and enriches of lives and gives measures of peace of mind. The Grapevine, like other publishing companies has to change its consumption habits as of now the majority reader profile is 50 years and 20 years sobriety. As of May 2011, the Grapevine has become a Multi Media Corporation, with a new website and other media applications to get in touch with a wider population.

In closing I would like to encourage everyone to think about purchasing a magazine subscription or on line and other items from the Grapevine. This can make a difference to the new comer and the old timers.

6 . TREASURER'S REPORT

JIM A.

Good morning everyone, I am an alcoholic a member of the St. Andrew's Group in Toronto, my name is Jim A. It is an honour and privilege of serving you, as Area 83 Treasurer.

Firstly, I would like to thank everyone who volunteered to help this weekend. Those on the bucket brigade who helped collect the 7th tradition, and count it, and those who helped sell banquet tickets. Thank you to those who attended the Treasurer/Self-Support production of the Traditions Skit and workshop yesterday. I hope the information was useful and that the skit was as much fun for you as it was for the cast.

Next thank you goes to the 12 districts and the 135 groups from 27 districts that have supported Area 83 to date. I am happy to report that this includes District 38 Thousand Islands and its one participating group who give credence to the expression, "Never say never". The lights in that District are not so dim anymore.

If you had the opportunity to see Mel's workshop and remote communities, and meet Nuk and Peter, whom he met in Iqaluit, then you witnessed the magic of the 12th step call. We as an Area did go to any length to make this happen. If you ever wonder where the funds go, then you saw it firsthand. One cannot put a value in monetary terms on the hope and inspiration that have come from this undertaking. Thank you Mel for representing Area 83, and showing we care.

As per my motion at the March 2011 Assembly and passed by those present, paper based financial documents for the 2007-08 term have been saved to a memory stick prior to being shredded.

My winter project is to upload all the financial data for 2009 to 2011 into a duly registered copy of Quicken. Using this software will be easier than our current Excel based system. I will maintain both systems for 2012.

Our financials as of October 15, 2011 are as follows:

Our reserve account has a balance of \$20,000.00 this is set aside as a GIC which matures March 16, 2012. Interest is 1.5% and is payable semi-annual. I will have completed the transaction to replace this GIC, just before our next Assembly in March 2012.

Income for the period from, 7th Tradition is \$2,694.64; cost recoveries Grapevine \$121.28, Group & District Contributions \$31,459.73, GSO Flow Through \$40.00, Interest of \$300 earned from the Reserve account GIC has been deposited to the Operating account. Total income for the period ending October 15, 2011 is \$39,026.96.

The total expenses for the period ending October 15, 2010 were \$41,067.71. To date, our expenses are \$2040.75 higher than our income. Our group contributions are down \$5,947.73 compared to this time last year.

The bank opening balance as of January 1, 2010 was \$ 32,897.79. Total income of \$39,026.96 less expenses of \$41,067.71 leaves an Operating account balance of \$30,857.04 as at October 15, 2011. The **combined balance** of accounts is **\$50,857.04**. **Net change is -\$2,040.75 YTD.**

This is the detailed expense report, showing expenses by activity for each trusted servant in the Committee Expenses section at the top. The yellow column is the Proposed Spending guideline passed at our last Assembly.

The lower section labeled "Other expenses" is for specific onetime events such as forums and conferences. Spending in this section is complete except for any bank charges over the next two months, which will be minimal.

The box at the lower left is the summary of the income items I have just spoken of. The small box in the middle summarizes income, expenses, and contributions for the past two years.

The % of groups contributing to Area 83 to GSO for the year to date is 23.65% compared to 24.69% for the same period last year. Both of these figures are well below the number of groups that contribute to GSO. The recent GSC Report indicated that 46% of groups and districts in Area 83 made a contribution in 2010. For all of 2010, 28.13% (162 of 575) of groups financially supported this Area.

I would like to issue a friendly challenge to groups and districts to raise that percentage to 35% or 201 groups contributing. This challenge is about increasing participation and the focus is about getting more groups involved in the service structure, not so much on fundraising which would be the natural by-product.

As of Oct 31st, 17 districts and 142 groups have participated financially.

Contributions by District and its groups.

Contributions Comparison for 2007-2011 for the period ending Oct 15th.

You can see that the downward trend of contributions started in 2009. Very similar to how our economy is these days. And now for some projections. Our Oct 15th Operating account balance of almost \$31,000 is somewhat misleading. After this weekend, when all expenses are tallied, and deposits made, the balance will be likely be around \$24,000.

I estimate that expenses will be about \$54,000.00 for 2011, not the \$58,000 as in the proposed spending guidelines. Total income for 2011 is estimated at \$49,000, which indicated that another \$3,000 will leave the bank account by year end. The operating account will have just over \$28,000 on Dec 31st. Contributions are running at about \$42,000 per year, not the \$52,000 as in the Proposed Spending Guidelines.

Again I hope the groups and districts prove me wrong, by picking up the challenge.

As per GSO guideline, an area is encouraged to have a prudent reserve equal to one year's spending. We are currently at 10 months.

It is my recommendation that Area 83 does not make a contribution to G.S.O at present, given the current level of contributions.

The bank reconciliation has been done to Oct 15th and the balance in the operating account is accurate. All invoices have been paid. All contribution receipts have been mailed, hand delivered where possible, or placed with the respective DCM for those contributions sent with no return address.

10. ROLL CALL AND REGISTRAR'S REPORT

TONY A.

*** Secretary's Note: An updated version of the Tally (Tally #2) is attached after the Tally that was reported at the Fall Assembly as promised by our Area Registrar.**

Good day, I am an alcoholic, a member of the Church Street Group and currently serve as your Panel 61 Registrar for Area 83 International and my name is Tony A. I am delighted to be here with you all and it is great to be of service to Alcoholics Anonymous.

As the area registrar, I am responsible for compiling and updating group registration and records; distributing lists to District Committee Members or DCMs at least once a year and forwarding group information to the General Service Office. I also prepare roll call forms for Assemblies and area committee meetings and call the roll call. The registrar is responsible for the group information and the area secretary is responsible for the districts and area committee information.

Most recently, I attended the Area 83-86 Unity Day back in September and this truly was a wonderful day. A huge thanks to all for getting the group change forms prior to the cut-off date for the regional directories. This directory can now be ordered from GSO by calling them directly (212-870-3400) or by visiting their website. They are also available through your local intergroups if you are part of larger cities.

All group change forms submitted have been processed and I trust that all incoming general service reps have received their kits. If there are any issues regarding your not receiving your kits, please let me know and I will follow up for you promptly. If District Committee Members are in need of an updated excel spreadsheet containing your district's roster of registered groups, please contact me and I will send this to you.

As of this report, there are 947 registered groups in Area 83 and the breakdown for these are: 489 groups are listed as active groups; 325 groups are listed as inactive groups; 108 groups are listed with an unknown status; 2 groups are listed with a pending active (new group) status; 21 groups are listed with a merged status and 2 groups are listed with an incomplete status.

A reminder about group status – active status means there is a contact associated with this group and the General Service Office is able to send information to this group. Unknown status means the group is **still active** but does not have contact associated with the group record. Inactive means the General Service Office has received information that the group has disbanded or is not currently meeting – this might be due to returned mail or no meeting time is specified.

New groups registered with GSO will sit on a pending status for 30 days prior to being listed as an active group. Also, groups that are registered through your local intergroup does not mean it necessarily makes it to GSO. I kindly request that you submit a New Group form to me to ensure your group is properly registered.

To submit new/group change forms, have queries relating to GSR kits, or you have any further questions or comments regarding the registrar process including group status issues, send me an email to registrar@area83aa.org. I will follow up for you as to not take up assembly time addressing these types of concerns. Group Change and New Group forms are easily downloadable from our Area 83 website under the District Resources tab.

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote have the right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being that the numbers will often not look at all like what was written on the sheets.

For example, a district might have five people signed in as visitors, but when I announce the roll call, I might see that there was only one. The reason is that I check each visitor against his or her group, and if the group does not have a GSR that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as a GSR.

Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the assembly, is really as their group's representative. It is very important if you sign in as a visitor that you also write the name of your group. You could be voting for your group but I do not that if you do not indicate this on the sign in sheet.

In closing, I will make myself available to districts and groups to assist you with registrar related issues where I can and please remember that communication is essential. Thank you to the team from District 36 who has helped tirelessly throughout this weekend and thank you for the trust that you have placed in me and it has been my honour to be of service to Area 83 International.

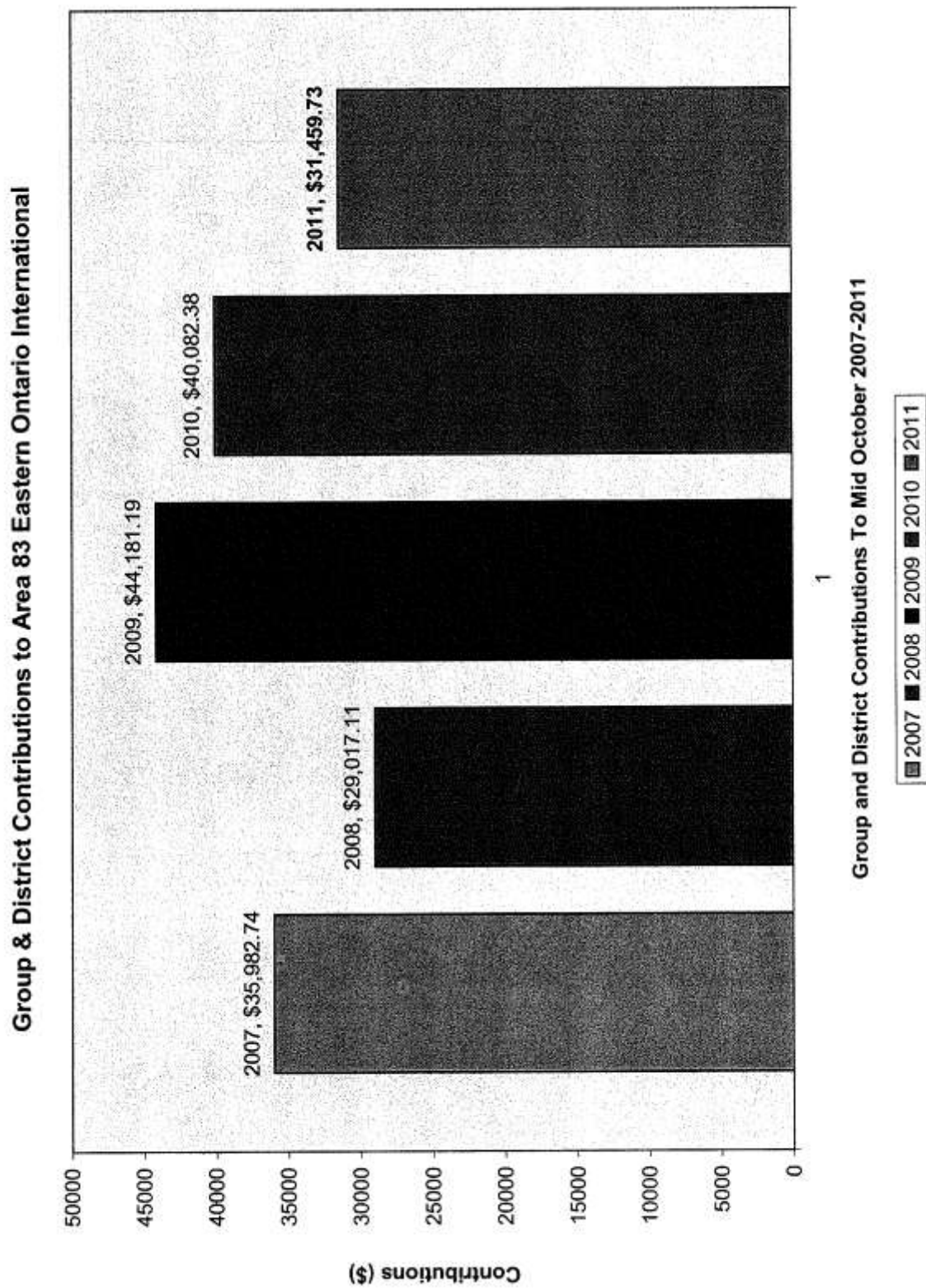
