1. OPENING

Welcome, it is so good to see you all so bright and early! Did everyone enjoy the Service Day yesterday? Perhaps we can give a hand for the Service Information Day Committee.

Introduction

The A.A. Service manual combined with the Twelve Concepts for World Service defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." This is the fourth assembly of four that will be held over the length of this term. Just as your District and your home Group meet, usually once a month, to handle matters that require a group conscience decision, the Assembly is the Business meeting of Alcoholics Anonymous in Area 83. Area 83 stretches from Oakville to Ottawa and from Upper New York State to northern Algonquin Park and the Ottawa Valley.

Some of us have been here before – as the Groups General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some of us, it will be our first Assembly and it will seem pretty overwhelming! How many of you are here today attending your first Assembly? Could you raise your hand? That's great – welcome – we are glad you are here. This day promises to be electrifying.

THE ONLY SMOKING AREA is outside, please use the butt containers provided by the hotel. It's unfair for us to have the hotel staff, clean up after us. If you leave this room for any reason, please do so quietly, and please do not congregate just outside the doors. The noise can be distracting to those giving their reports.

NAMETAG HOLDERS

When you leave for home at the end of the assembly, please leave your name tag holders in the boxes provided near the doors. We recycle them to keep our costs down.

FREQUENCY OF MEETINGS

This is the last assembly for the term 2011-2012. However, the Area committee, which is comprised of the Area Officers, District Committee Member's and Past Delegate's will be meeting in Quinte West this December 1th. At this meeting the incoming Sub-Committee Chairs will be elected for the term 2013-2014.

Visitors are welcome and encouraged to attend.

SEVENTH TRADITION

I know that it seems as if the coffee and drinks provided this weekend may be free, but the hotel charges us a flat rate of \$8.50 per person for the weekend. Rather than have honour buckets beside the coffee urns, we have chosen to use the Seventh Tradition to cover these costs. We had a Seventh Tradition Friday night, again at the speaker meeting last night and we will have another one today. Please keep these costs in mind when the 7th is being passed around.

WHO VOTES?

Only members of the Assembly may vote.

These are:

All Area Officers, including the Immediate Past Delegate, but not the Chair.

All Area sub-committee Chairs

All DCM's of Districts in Area 83; in their absence, the Alternate DCM may vote.

All General Service Representative's of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ♦ There is one vote per person.
- After lunch, which is when we would expect to conduct old & new Business, I would ask those with voting privileges to sit at the front, others near the back. This will make it easier for us to count votes.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

- When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority (defeated side) on the motion. This next part may be unique to A.A. If, after the minority (winning side) has spoken, if one member of the Assembly who had voted for the majority on the issue stands at a microphone, and says, "I wish to change my vote", he or she may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the original motion.
- ♦ The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

CALLING THE QUESTION

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
 - ✓ It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - ✓ And it maximizes the time available for those members to voice their Groups' opinions and needs.
- ♦ All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.

- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones dotted around the room, and identify yourself by name, position, Group and District number.
- ♦ IF you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary Kim before standing at the microphone.

How do we vote?

- ♦ Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.
- ◆ I believe that the early part of the agenda today can be handled under simple majority 1 vote more than 50%. I will advise you when I believe we should move to 2/3. If, at any time, you think we should move to a 2/3 majority before I indicate it, remember it's your meeting. Don't hesitate to make the motion.
- ◆ To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.
- ♦ At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his or her hand.
- Again, when you are ready to speak I respectfully ask that you identify yourself by name, position, Group and District number.

a) Public Information Report

Hi friends. I'm an alcoholic, a member of the Kedron Group in District 28 and my name is Rob M. I have the privilege to serve Area 83 as Public Information chair.

Thank you to everyone who attended the Public Information workshop yesterday, and a special thanks to those who were up early this morning for the 7AM combined PI/CPC meeting. There was a good turnout for both and lots of great discussion. The District Public Information committees in Area 83 are very enthusiastic, and doing a great job of carrying the message by taking literature, giving presentations, and speaking at schools, senior centers, libraries, and police stations. Several Newspapers and Radio Stations in Area 83 have started airing our Public Service Announcements this term thanks to the efforts of our local PI Committees.

The 2011 Membership Survey pamphlet is now available. Something I find encouraging is that newcomers are still being introduced to our program through another AA Member more than any other method. One Alcoholic carrying the message to another. Membership Survey pamphlets are available at the PI display in the atrium and a table top version of the pamphlet can be viewed at the display.

Our General Service Office has received several requests to change the wording of Tradition Eleven to include current media such as the Internet and Social Media. The Trustees' Public Information Committee concluded that the spirit and principle of anonymity at the public level is conveyed adequately in the long form of Tradition Eleven but is asking for Fellowship sharing regarding the effectiveness of the language of the short form of Tradition Eleven in addressing the needs of the Fellowship today. The District PI Chairs have received this request and I have copies available for anyone who would like to send their opinions to the Trustees' Public Information Committee.

Also from GSO the Trustees' Public Information Committee has considered favorably that AA establishes a presence on Facebook for the purpose of providing information about AA to the public. This presence would serve as an informational resource only with no interpersonal communication capabilities. Before proceeding, however, the committee requested that the General Service Board explore all aspects of the social media page and, if feasible within our Traditions provide the 2013 Conference Committee on Public Information an implementation plan that addresses the implications of such a page, including sample content and estimates for implementation costs and maintenance.

Daily Reflections is now available on GSO's Web site aa.org. This page updates daily so visitors can view the reading for that calendar day. The page can be reached by clicking the "Daily Reflections" link on the upper left corner of the home page. All five of the AA Videos for Young People can also now be viewed on GSO's Web site. Lots of exciting information coming from our General Service Office.

Thank you to all who attended the Corrections Workshop yesterday our hope is that you enjoyed our resident Area 83 Correctional Facilities Chairs' District 82-Cathy McQ, District 28-Vic McC, and District 2-Robert B., share their experiences during their term. Their talks were well received and they shared with enthusiasm, passion, and love of a position they enjoyed doing. Our hope is this will encourage people to volunteer for correctional work in their districts.

Thank you to the District 36 Kingston Young Peoples Group, District 2, District 14, and District 18 for purchasing tickets to the banquet for 4 Correctional Clients from Pittsburgh Institution and thank you to Ann K for escorting them here. Thank you to District 50 Century Group for the \$40 contribution towards corrections literature. Thank you to District 14 Get a Grip group for contributing and distributing 60 soft cover pocket sized big books at the Corrections Workshop.

Our Saturday time slot for the Corrections Sub-Committee meeting was well received. We all shared for almost 1 ½ hours. The turnout was the best we had for the term 2011/2012. There were quite a few people who came to hear about the requirements for volunteering in Corrections. Our hope is that these new people become active in Corrections.

This from and email I received from Tacey O GSO Corrections Desk – "GSO Corrections desk has advised that the Corrections Correspondence Service, setup for inmates to contact "outside" A.A. members here in the United States or, on occasion, in Canada accepts "outside" volunteers from the U.S. for U.S. inmates, primarily because the prison population is so impoverished that even securing domestic stamps can be a problem. Also, most facilities will not allow inmates to receive stamps or self-addressed, stamped envelopes. GSO receives a Canadian request once every 6 months versus 600 requests received from U.S. Future requests received from Canadians wishing to volunteer for Correctional Correspondence will be held until a Canadian inmate makes a request." We are in the early stages of discovering what the needs are in Canada. At our Sub-Committee Corrections Workshop the

ask for the Corrections Chairs of the district was to go back to the Correctional facilities in their districts and find out if they are interested in their residence receiving correspondence from A.A. with pre-stamped, self-addressed envelopes, or if they are even interested in the program.

Joyce brought us in old tapes that were donated. These were given to District 36 as they responded to the email that was sent if any Institutions accept tapes to be brought into the institutions. District 54 Corrections Chair Darlene K brought in over 90 tapes. These were given to Janet C BTG contact for the 5 districts in and around Ottawa and District 36 DCM Roxane T.

Since taking on the Correctional Chair position there have been a total of 54 Bridging The Gap requests. 19 were for 2011 and 35 were for 2012.

Grapevine is published both as a monthly, print magazine and frequently updated website.

WRITING ARTICLES

Before writing, you might want to leaf through a few issues to see what kinds of articles are published. Most are first-person accounts of the writer's experience with alcoholism and Alcoholics Anonymous. Grapevine publishes stories for special departments such as Emotional Sobriety, Sponsorship, Newcomers, Youth Enjoying Sobriety, Old-Timers and Home Group, as well as articles about the Steps and Traditions, jokes for "At Wit's End" and letters for "Dear Grapevine." But you are not confined to these topics. The editors are always looking for innovative material, as long as it relates to AA experience and reflects an awareness of AA's singleness of purpose. Articles are reviewed by the editorial staff and selected by consensus. You will be notified if your story or photo is selected for publication.

WHAT THE GRAPEVINE DOES NOT PUBLISH

Poems, prayers, song lyrics, tributes to individuals, plays, previously published material or anything unrelated to AA or that violates the principles of AA.

LENGTH AND FORMAT

The magazine publishes work of different lengths, from snappy one-liners and one-paragraph anecdotes to five- or six-page articles. Suggested manuscript length is 300 to 1,500 words or three to five double-spaced typed pages. Handwritten manuscripts should be written clearly on one side of the paper.

g) Archives Report

Peter N.

Good morning friends. My name is Peter N. I am an alcoholic and a member of the Bayview Group in District 14, Toronto North Central. I have the honour and privilege of serving as your Archives Chair.

Since I last reported to you, here are some of the some of the activities which in David T., our Archivist and I have been involved on your behalf. Thank for all the invitations and the hard work that goes into making these events a success.

April 21, I attended the Archives Workshop Day in Ottawa at the Bronson Centre.

May 5, I attended a meeting at GTA Archives with Eddy G. GTA Archivist, Katrina (a member with professional expertise in this Area), David T. and Marrey from District 6, regarding standardizing the new Archives Database. We have already received a sample of what is being used in District 82 Kawartha from Gary C. and are looking to implement and system that will eventually standardize our work and allow remote access from across the Area.

May 6, I attended the East Toronto Archives Breakfast. Congratulations to Districts 18 and 22.

May 12, I attended the District 30 Quinte West Service Roundup in Brighton. As a result of attending the Roundup, I fell into a discussion with Pierre B., Alt DCM and Les C. who take a meeting into the Warkworth Institution.

A.A. has been sponsoring a meeting in Warkworth for many years. Pierre and Les were looking to do a history of A.A.'s presence in the institution. To that end, I sent a generic Short and Long Group History form to them.

This led to a new initiative where we contacted all the District Archives Chairs and DCMs with an idea and an opportunity. Due to changes in the federal and provincial prison systems, many old institutions such as the Cornwall, Brockville and Don Jails, and the Kingston Pen have closed or are closing. We need to record the local history of A.A. service work before it is lost forever. Thanks to Murray O. for his connections to the Volunteer Service Coordinators in Ontario and David T. for his contacts with Corrections Canada. They have been instrumental.

We were also able to arrange this weekend for Eddy G. and David to do an Oral History of the Kingston Correctional Conference, which ran for 25 years, with Keith F., the former Chair of the Committee.

June 2 and September 8 I attended the Area Committee meeting in Belleville.

June 23 I presented a workshop at the Tri-District Service/Information Day in Cornwall hosted by Districts 42, 48 and 50.

July 6-8, Kim and I attended the Eastern Canada Regional Forum in St. Catherines. I posed the question to the GSO Board Chair Ward Ewing as to when Archives would become a full Conference Committee as opposed to being a secondary Conference Committee. We are closer but do not have a firm date yet.

I attended the Archives Workshop in French on the Saturday night and listened to what the 4 Quebec Delegate Areas are doing with Archives. This led to a discussion with our Delegate Robb W. and with Pierre C., Panel 62 Delegate for Area 87, Southwest Quebec about the idea of our presenting an Archives Workshop at CERAASA (Canadian Eastern Region Alcoholics Anonymous Service Assembly) to be held in Longueuil, QC February 22-24, 2013 so that we could share the experience of the Area 83 and GTA Archives Committees with the 10 Delegate Areas in Eastern Canada. In additional, I was approached by Russ, a DCM from Area 82 Nova Scotia/Newfoundland/Labrador and they are just starting out. They have a box full of material. I have been in regular contact with Pierre V., who is the Archivist for Area 87 in Quebec, about presenting a joint workshop at CERAASA.

Our workshop yesterday, was the first step in creating a Power Point Presentation for CERAASA. We are looking to create an uniform data base, and system, which could be used for any and all District and Area archives committees, no matter where they are in the process whether manual or digital. GTA Intergroup purchased a laptop, software and a printer/scanner to digitize information. Katrina E., a professional, alcoholic as well as programmer, is writing software that will enable us to standardize input. When ready, any District Archivist in the Area could communicate with a central database. There is already a physical Repository in Toronto where we rent storage space. If we can work in conjunction with all 10 Delegate Areas in Eastern Canada, and the 4 in Western Canada, we could create a Canadian system. That would be fantastic.

September 29 Kim and I were in District 42 for their Service Day to share our experience on service beyond the Group and District, at the Area level.

October 10 I participated in the District 12 Elections and on October 15 I participated in the District 14 Elections. In both cases, despite some missteps on my part, with much help from the members present, the elections were a great success.

From the General Service Conference, under Additional Considerations to the 2012 Conference Advisory Actions, "the Committee requested that the trustees' Archives Committee develop that the Archives Workbook on digitizing archival collections intended to provide guidance to local archivists and archives committees responsible for maintaining Area or District archival collections". As reported above we are already working on this. The theme of the Conference was "Anonymity: Our Spiritual Responsibility in the Digital Age."

GSO Archives are requesting success stories from District and Area Archivists.

We are going to recommend sending our Archivist, David T., to the National Archives Workshop in 2013. The Archivist attends this Workshop once during their 3 year term.

We continue to look for stories for our Area Newsletter, The Eighty-Three.

Finally, David and I met in February, 2011 and created a 13 point Agenda of what we hoped to accomplish in that year. The list expanded to 17 items, most of which were achieved. In 2012 our list Agenda started with 8 items, and grew.

I am happy to report that we completed almost all of what we set out to do, and yet there is more and more to do. This is a hugely exciting time for Archives. As we continue this work, we carry on the legacy that was passed down to us not only by the early members of A.A. in Canada, but by Bill Wilson, who in the 1950's foresaw Archives as way to accurately carry the message of Alcoholics Anonymous in the present, through our past experience.

5. TREASURER'S REPORT

JIM A.

[See Appendix A - Treasurer's Financial Reports.]

Good morning everyone, I am an alcoholic a member of the St. Andrew's Group in Toronto, my name is Jim A. It is an honour and privilege of serving you, as Area 83 Treasurer.

Firstly, I would like to thank everyone who volunteered to Help this weekend. Those on the bucket brigade who helped collect the 7th tradition, and count it, and those who helped sell banquet tickets. Thank you to those who attended the Treasurer/Self-Support workshop yesterday. I hope the information was enlightening and useful. I can't believe two years has gone by so fast. And thanks also to my fellow officers and chairs, it has been a pleasure working with and getting to know all of you.

And now for the financial news. The last installment of Jimmy show me the money!

Our financials as of October 15, 2012 are as follows:

Note: 2011 figures in (brackets).

Our reserve account has a balance of \$20,000.00. This is currently in the form of a GIC which matures Sept. 16, 2014. Interest is payable at maturity at the rate of 1.85% and is estimated at \$937.50.

Income for the period from, 7th Tradition is \$2,843.77 (\$2,694.64 in 2011), cost recoveries from the sale of service manuals, a Pi kit and Grapevine \$424.63 (\$121.28), Group & District Contributions \$36,236.75 (\$31,459.73); GSO Flow Through from five groups \$76.00 (\$40.00) with an equivalent expense amount. Interest of \$148.77 (\$300) earned from the Reserve account GIC has been deposited to the Operating account. Also included is your order for 2013 Grapevine planners 674 and calendars 211, as invoiced at \$4,117.65US. There is a corresponding entry on the expense side. This check cleared on Monday at \$4215.89 CAD, a difference of \$98.24

Total inflows to the operating account come for the period ending October 15, 2012 is \$43,837.57 (\$39,026.96 in 2011). This is an increase of \$4,810.61 and is almost entirely from increased contributions. The total expenses for the period ending October

15, 2012 were \$51,965.43 (\$47,294.89). This is an increase of \$4,670.54, which is entirely two items that did not occur last year, namely our \$4,000 contribution to GSO and the \$600 +HST charge to convert this room from banquet to conference seating.

Looking forward: Currently the PSG has \$11,228.00 remaining. The only remaining expenses for 2012 are the travel expenses for this assembly and the Dec. Area committee meeting. I estimate these to be \$7500 to \$8000. Total expenses for 2012 should be about \$55,000.00, so I estimate the total spending for 2012 to be \$55,000. This is a terrific statement about how prudent your trust servants have been this term.

To date, our expenses are \$8,127.63 (\$8,267.93 in 2011) higher than our income. Group and district contributions are up \$4,777.02 over 2011 (2011 was down \$5,947.73 compared to 2010). Net result is an improvement of \$140.07.

The bank opening balance as of January 1, 2011 was \$34,977.40. Total income of \$43, 837.57 (39,026.96in 2011) less expenses of \$51,965.43 (\$47,294.89) leaves an Operating account balance of \$26, 849.54 (30,857.04 as at October 15, 2011). The **combined balance** of accounts is **\$46,849.54 (\$44,630)** or about 10 months of proposed spending.

This is the detailed expense report, showing expenses by activity for each trusted servant in the top section, and for specific onetime events in the lower section.

The two biggest items are the cost for our two Assemblies. The Ambassador has released the 2013 Spring, and as usual the banquet and the room rate have been increased by \$1 each. And the coffee tab also rises.

When anyone anywhere in the Atrium reaches for a beverage this weekend, I want them to remember that we ought to be self supporting and for that we are all responsible.

Line items that are bolded have concluded for the year and can be considered as savings.

The box at the lower left is the summary of the income items I have just spoken of. Top section of the previous page.

The small box in the middle summarizes income, expenses, and contributions for the past two years.

Contributions have come from 131 groups and 17 districts including D04 Humber (136 groups and 12 districts in 2011). This represents the participation level of 22% as compared to 23.65% last year and 24.69% in 2010.

For all of 2010, 28.13%/161 of groups financially supported this Area, 27.95%/164 in 2011. I would like to issue a friendly challenge, to exceed, not just meet 30%. If every group that made a contribution to Area last year, did so again this year our participation would be 33%. The amount that gets put in the mail is not as important as the fact that it IS in the mail. Big or small, I will cash them all.

Both of these figures are well below the number of groups that contribute to GSO. The recent GSC Report indicated that 46% of groups and districts in 83 made a contribution. And as June 30th Delegates report 28% of Area 83 group have directly contributed to GSO.

The bank reconciliation has been done to Oct 15th and the balance in the operating account is accurate. All invoices have been paid. Receipts have been issued for all contributions up until Oct 24th, and some have been given to the respective DCM's to deliver. Thanks.

The third page shows what came from groups and districts by district

Thank you all for allowing me to have this wonderful opportunity to be of service. It has been a life changing experience, one I will remember forever.

7. ROLL CALL AND REGISTRAR'S REPORT (DEFERRED UNTIL AFTER LUNCH) [See Appendix B - Fall Assembly Tally.]

TONY A.

Good day, I am a member of Alcoholics Anonymous and belong to The Church Street Group in District 10 and currently serve as your Panel 61 Registrar for Area 83 International and my name is Tony A. I am delighted to be here with you all and it is great to be of service to you and this wonderful fellowship and I mean this sincerely.

As the area registrar, I am responsible for compiling and updating group registrations and records; distributing lists to District Committee Members or DCMs at least once a year and forward group information to the General Service Office. I also prepare the roll call forms for Assemblies and area committee meetings and call the roll call. The registrar is responsible for the group information and the area secretary is responsible for the districts and area committee information in Area 83.

Thank you to those of you that came out to the secretary/registrar presentation yesterday. It was great to see the presence of so many interested in learning about the process and your questions. I personally believe this is a very important function as the registrar is the main link between the groups and the GSO. The 2012-2013 regional directories are now available to the membership. There is a Canadian AA directory, a western US AA directory and an eastern US AA directory and these can be ordered from your local intergroups or from the GSO.

District 04 Humber has disbanded as a district earlier this year and currently there are active groups associated with this district. The district will stay in the GSO database and will not be eliminated much the same as groups that become inactive. However the groups that currently reside within D04 should consider moving to another district. If your group has decided to move to another district, please fill out the group change form and submit it to the area registrar for processing and updating. In an effort to clean up the GSO records database for Area 83, I have been concentrating on getting our records that contain an unknown group status updated. Several weeks ago, I sent out to the district a spreadsheet and group information sheets that contain these records only. I ask that you discuss these at your district meetings and provide me with a contact to associate with these groups. This will change the group status to an active status. I thank those districts that have been already quick to respond and have provided me with the necessary information.

Currently, Area 83 has 963 registered groups in the GSO database. The breakdown for these groups are: 515 groups listed as active groups; 90 groups listed with an unknown status (605 active groups); 337 groups listed as inactive groups and 21 groups are listed as merged.

All group change forms submitted have been processed including some changes received yesterday. If there are any issues regarding your not receiving your kits, please let me know and I will follow up for you promptly. GSR kits should be received within a 30 day time of my system entry and these kits are given to incoming GSRs only.

Many districts will be in the midst of elections for their upcoming rotation terms. Some districts have already begun to send me your changes and this is terrific. I am not sure if I can make these changes yet and will keep the change forms on file in the event that I am unable to make the changes at this time. Please continue to send them to me as you receive the changes regardless.

When submitting changes for group records, especially when updating contact info, I request to please include the full mailing address for these records. The GSO database will not accept incomplete addressing information. New groups registered with GSO will sit on a pending status for 30 days prior to being listed as an active group. Also, groups that are registered through your local intergroup does not necessarily mean it makes it to the GSO. To ensure the group becomes a registered group with GSO, kindly submit a New Group form to the area registrar.

To submit new/group change forms, have any queries relating to GSR kits, or you have any further questions or comments regarding the registrar process including group status issues, send me an email to registrar@area83aa.org. I will follow up for you as to not take up assembly time addressing these types of concerns. Group Change and New Group forms are easily downloadable from our Area 83 website under the District Resources tab. All changes submitted to the registrar or GSO must be submitted with these forms.

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote have the right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being that the numbers will often not look at all like what was written on the sheets. For this tally, I have placed all members signed in as they have indicated in the sign in sheets. However, some

committee members are actually signed in as GSRs as well but only given a delegation value of 1 even though you hold 2 or more positions. I have also listed all of the visitors in the tally but may have used a visitor for the GSR vote in the absence of a GSR or Alt GSR for their respective group. Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the assembly, is really as their group's representative. It is very important if you sign in as a visitor that you also write the name of your group. You could be voting for your group but I do not that if you do not indicate this on the sign in sheet. I have assumed that the visitor will be voting on behalf of their group and are aware of the absence of their groups' GSR or Alt GSR. Finally, when you leave, please place your name badge holders in the box located on the table outside as you leave to recycle them.

In closing, I will make myself available to districts and groups to assist you with registrar related issues where I can and please remember that communication is essential. Thank you to the team from District 36 who has helped tirelessly throughout this weekend and for the trust that you have placed in me. Serving as the registrar has indeed been an incredible experience and has enriched my recovery and service journey in a profound way. I am deeply humbled and thankful for the trust and confidence you have placed in me. Last note - please place your badges in the long cardboard boxes outside for recycling upon your leaving the assembly today.

9. DELEGATE'S REPORT ROBB W.

Good morning friends. I'm an alcoholic, an active member of the Streetsville group in Mississauga and I have had the opportunity to serve Alcoholics Anonymous as the Panel 61Delegate for Area 83 Eastern Ontario International and my name is Robb W. I would like to thank you all for being here this weekend. It's your dedication to service in Alcoholics Anonymous that helps keep AA vital and strong in Area 83. I'm sure that you're all as excited as I am to get to the elections so I'll try and keep this short.

I'd like to begin by thanking Jeryl for that great talk last night. I know that you all enjoyed it and got as much out of it as I did. Thanks as well for taking the time to put on a workshop for us. I'm not sure that it's common knowledge that we put guests to work in Area 83 when we invite them here so for the sake of future Service Information days, I'd appreciate it if you'd keep that little tidbit of information close to your chest.

Since our Assembly last spring, I've had the honor of attending the 62nd General Service Conference and then traveling hundreds and hundreds of miles around our Area sharing the Conference experience. I have also had the opportunity to visit many Districts and attend their service days. It's been a great experience seeing Alcoholics Anonymous work around our Area.

When I came to my first assembly, 15 years ago, I found a bunch of people that I very much wanted to hang around with. I learned that A.A. doesn't just "work", people in General Service make it work. People like you who give selflessly of your time to keep his great fellowship running so that the baby born today who is heading for trouble with alcohol will have a place to go and recover just as I did. Thank you.

One last thing I'd like to share with you is some information I received from the Public Information Chair at the General Service Office in India. You may recall that Lucky D. was a guest at the 62nd General Service Conference. Lucky sent me an email explaining how there had been a TV star in India who devoted one episode of his show to social issues such as alcoholism. A member of A.A. in India was a guest on the show (anonymously, of course!). Just before the show aired, Lucky wrote a piece in their local A.A. newsletter about the Jack Alexander article that gave A.A. in North America such a boost. Could it happen there?

They prepared by getting an automated phone number that could direct callers to someone that could speak one of the eight official languages for help. Well, 5 minutes after the show aired, they had received their first call. Within the first few hours, they had received thousands of calls. About a month and a half after the show aired, they had received over 250,000 calls! Since that time, Lucky says that he has traveled with other members around a specific area of India where there had been no meetings in the past. There are now 8 meetings being held there. Some of them being supported and run by alcoholics who are only 2 or 3 days sober! What a great success story. I believe that there is someone in District 06 Mississauga who is taking Lucky up on his offer of hospitality at their conference next month.

So this afternoon, we will elect another panel of trusted servants. The service manual tells us that good leadership is vital to A.A.'s growth. When the ballots go around this afternoon, choose well, for these candidates will be tasked with keeping A.A. strong during the next two years. For those of you that are eligible, I encourage you to let your name stand. In this group here today are people who will one day represent Area 83 as Delegate. All you need is a willingness to serve. Allow the body of the Assembly and God decide if it's your time.

I'd like to leave you with the last part of Dr. Bob's last talk...

"We know what A.A. has done in the past 77 years, but where do we go from here? Our membership at present is, I believe, conservatively estimated at 2,000,000. Will it increase from here on? Well, that will depend on every member of A.A. It is possible for us to grow or not to grow, as we elect. If we fight shy often tangling alliances, if we avoid getting messed up with controversial issues (religious or political or wet-dry), if we maintain unity through our central offices, if we preserve the simplicity of our program, if we remember that our job is to get sober and to stay sober and to help our less fortunate brother to do the same things, then we shall continue to grow and thrive and prosper."

Thank you from the bottom of my heart for allowing me the opportunity to server Alcoholics Anonymous in this manner. It has truly been the most fulfilling and gratifying era of my whole life.
