# Area Assembly - October 27, 2013

#### 1. OPENING

Good morning everyone. I am an alcoholic and name is Kim S. I have the honor and privilege of serving you as the Area Chairperson for the term 2013 - 2014.

Welcome everybody! Did everyone enjoy the Service Day and banquet yesterday?

Perhaps we can give a hand for the Service Information Day Committee?

A thank you as well to Deb and Keith for their talk last night.

### Introduction

This is our second Assembly of four in this term. During the next 14 months, we will be working together to provide continued strength and direction to A.A. in Area 83. Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together is the key for continued Unity in our Area. The A.A. Service manual defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." Just as your District table meets monthly to oversee the affairs of A.A. in your District, and your home Group meets, probably once a month, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83. For people that are new to the Assembly, Area 83 stretches from Oakville in the West to Ottawa in the East, down to upper New York State and up to Algonquin Park and the Ottawa Valley. At last count, we were about 533 Active Groups.

Some of us have been here before – as the Groups General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some, it will be their first Assembly and from personal experience it can seem pretty overwhelming! How many of you are here today attending your first Assembly? Could you raise your hand? That's great

I would like to repeat what I said at the Spring Assembly. Being in service is a huge opportunity, not everyone is so fortunate. You will not be expected to learn or understand everything the first time or even second time. It takes time but it will make sense. As you were new to AA and didn't understand the readings or what was going on during the meetings, you eventually understood. Service is much the same way. So please keep coming back. Welcome to all that are new and to those returning and enjoy the rest of the assembly.

We will make decisions on a variety of topics. The Area Assembly, like the General Service Conference, strives for substantial unanimity through ample discussion. Before a vote is held, plenty of time is taken for full discussion and questions. It is my hope that you all return home to your Groups and Districts with the feeling that you have done your part in keeping Alcoholics Anonymous strong and vibrant in your area and also that you have had a strong voice in our affairs where you've felt you ought to have it. #### **SEVENTH TRADITION**

I know that it seems as if the coffee and drinks provided this weekend may be free, but the hotel charges us a flat rate of \$8.75 per person for the weekend. Rather than have honour buckets beside the coffee urns, we have chosen to use the Seventh Tradition to cover these costs. We had a Seventh Tradition Friday night, again at the speaker meeting last night and we will have another one today. Please keep these costs in mind when the 7th is being passed around.

# WHO VOTES?

Only members of the Assembly may vote and these are:

All Area Officers, including the Immediate Past Delegate, but not the Chair

All Area Sub-Committee Chairs

All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.

All General Service Representative's of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ♦ There is one vote per person.
- ♦ After lunch, which is when we would expect to conduct Old & New Business, I would ask those with voting privileges to sit at the front, others at the back section. This will make it easier for us to count votes.

# A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

- When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion. This next part may unique to A.A. If, after the minority has spoken, one member of the Assembly who had voted for the majority on the issue stands at a microphone, and says, "I wish to change my vote" and they make a motion to reconsider, this motion must be seconded and I will ask for a show of hands (simple majority) on this question only: Should we go back to discussion?
- If a simple majority of the room says we should, the matter is back on the floor for discussion.

The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

# **CALLING THE QUESTION**

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many good points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

# WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
  - ✓ It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
  - ✓ And it maximizes the time available for those members to voice their Groups' opinions and needs.
- ♦ All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones around the room, and identify yourself by name, position, group and district number.
- ♦ If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary Tony before standing at the microphone. I am sure Tony will appreciate it.

#### **HOW DO WE VOTE?**

- ♦ Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.
- ♦ I believe that the early part of the agenda today can be handled under simple majority which is 1 vote more than 50%. I will advise you when I believe we should move to a 2/3 majority. If, at any time, you think that we should move to a 2/3 majority before I indicate it, remember this is your meeting and don't hesitate to make the motion.
- ◆ To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.
- At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his
  or her hand.
- Again, when you are ready to speak I respectfully ask that you identify yourself by name, position, group and district number.

We have finally found a new Treasurer in Donna Z who has returned to service at the table and we must express our deep gratitude to John M for keeping our books going well past his term. We also have a new Public Information Chair in Barb B and she is a welcome addition to the table's service energy and we are grateful to James D who stepped up from Alternate to fill the Correction Facilities Chair. We still have a few chairs and alternates to fill and we may need to revisit some chairs which seem to have gone quiet.

The groups are still meeting our service meeting commitments for Corrections and Treatment Facility meetings. We also are thankful to a few groups from District 22 who have reached out for opportunities to be of service and are lending a hand or two in District 18.

And perhaps most exciting, we have a few new groups officially or coming in. Officially we have the "We Are Not Saints" group which meets Friday at 8 pm at the Neighbourhood Unitarian Universalist Congregation, 79 Hiawatha Road, Toronto, ON M4L 2X7. This north off Gerrard and just west of Coxwell. The format is an "open" i.e. non alcoholics welcome, "open" topic discussion meaning open to any topic from the floor. They have sent a General Service Representative and Alternate General Service Representative already to the table so we welcomed Ed and Eric.

We hear also that there is a new group forming out of a service meeting in the Unionville/Markham area called the Thursday Noon meeting (who has already made a donation to District! Thank you!) Hi friends. I'm an alcoholic, a member of the Royal York Group in District 2 and my name is Dan. I have the privilege to serve Area 83 as Cooperation with the Professional Community Chair.

I'm happy to report that there is a lot happening in our Area. If you were at the Joint Cooperation with the Professional Community and Public Information session yesterday, you heard first-hand what 3 Districts are doing and how they are able to make things happen. Thank you Don M. District 14, Sandy D. District 22 and Deborah M. District 26 for your sharing. They have been working hard with medical students at the University of Toronto, the Addiction and Counselling students and Nurses at Durham College and Students at St. Augustine's seminary. Also in our Area, there were several Roundup and Service Days over the last few months with Cooperation with the Professional Community being represented. Some Districts continued their plan for sending out AA information - for example, sending out letters to lawyers and business cards and pamphlets to police stations.

On July 27th- July 31st, the 8 Cooperation with the Professional Community Chairs in Toronto volunteered to be part of the AA booth at the National Medical Association held at the Toronto Convention Centre. The National Medical Association represents the African American physicians in the U.S. and there were several thousand that attended this event. # e) Grapevine Report

Heather M.

I'm an alcoholic, member of Prince Edward, currently serving as Area83 Grapevine chair, my name is Heather M.

I placed the pocket planner and wall calendar order in September after waiting for responses from all districts. On Monday October 21, I emailed Grapevine because the treasurer had not gotten a bill and I had not gotten the order. The order had not been shipped – they were awaiting payment. Jeff at Grapevine released our order. It would not be delivered on time so I drove to Oakville to pick it up Friday morning. It saved \$30 shipping. Our treasurer got the invoice to pay.

The invoice from Grapevine came to less than what we had collected from the districts. We calculated the amount based on a less favourable exchange rate, and based on the application of Harmonized Sales Tax. Only New York tax was applied to our invoice. A past Grapevine chair indicated that Grapevine has forgotten to charge us applicable Canadian taxes in the past and may amend our bill later when they discover the error. I will speak to Jeff this coming week and clarify if the invoice received is correct or if it needs amending. There could be a refund available for districts depending on what is discovered. You will need to clarify with your districts whether or not your district would like their refund cheque or not. Some districts in the past when this has happened chose to consider the overage as 7<sup>th</sup> tradition contribution to area. Some have chosen to take their refund cheques. Once we know our treasurer will work out the math and advise us of the amount. It could be up to 50cents per pocket planner and per wall calendar.

For districts chairs that have picked up their Grapevine orders yesterday, please check the count of pocket planners. One district is short one. If you have an extra please mail it to me so that I can give it to District 2.

There is another new book that has come out "No Matter What – Dealing with Adversity in Sobriety". This is the second new book this year. There has been a Grapevine Newsletter sent to me every month via email which I have forwarded to district Grapevine chairs or their District Committee Member if there is no Grapevine Chair. I hope you are sharing its contents with your districts.

I was invited and presented at District 22's service day in September. Looking forward, I've been invited again to the February round-up in District 48 (invited last year). If your district has an event upcoming, especially if it will involve travel for me (I'm in west Toronto), please let me know well in advance so that I can allot the time to you. My calendar fills up quickly.

I'll be looking into a lighter display over the next several months as the one we have right now weighs a significant amount and I have trouble managing it. Other Grapevine chairs from the past have mentioned the same thing.

# f) Self-Support Report

Jim A.

Good morning everyone, it's nice see you al again. I am an alcoholic a grateful member of the East York group. It is an honor and privilege of serving you as the Area 83 Self-Support Chair, and my name is Jim A.

#### Literature:

I have brought some items that may be of interest: Birthday envelopes for individuals, and envelopes for Groups to make voluntary contributions to General Service Office, some Self-Support kits (obviously one per group), and some copies of the items that make up these kits. It may be indicative of the times we live in. When I ordered kits in March they came assembled. Not this time. It makes me appreciate how much work goes into providing services to the groups. I have also printed a few copies of recent General Service Office financial highlights. They are also on aa.org

# General comments

Is Area 83 Self-Supporting? Yes, no, and maybe - depending on the context. At our election here last October, or the subcommittee Chair election last December in Belleville, you would have seen a large number of members letting their name stand. Service rocks and those of us here today are proof.

With respect to Area 83's support of General Service Office, the per capita contribution in 2012 to General Service Office was \$6.29, and the cost of General Service Office services was \$6.43 per member. Missed it by that much, \$0.14 the sales tax on medium double-double I had this morning. Encouraging yes, but it came from 42.3% of our groups and districts down slightly from 42.7% in 2011. The average of all groups in North America is 42.4% I thought this was worth a look so I dug up the past four General Service Conference reports. We have more groups every year about 15,000 members, but fewer groups are supporting General Service Office. I have chart that will be posted to the Area website soon.

Participation by the groups and districts can change. And it may have done so already. The number of groups contributing to Area 83 is higher by 39 so far this year. Awesome! That is a 35% change. And since groups usually support General Service Office more strongly than Area I would guess that this increase in support would exist there too. If your group is worried that the amount is too small, stop worrying and buy a stamp. I have envelopes for that purpose. If your members are feeling grateful because they have had another sober birthday, help them by giving them a birthday envelope. I started the weekend with 500, about half have been picked. Let's hope some/most of them make it back to General Service Office along with a cheque. These are but two example s of the goods and services General Service Office provides on behalf of the membership. Free to membership but with production cost covered by literature profits and/or member contributions. But is not about the Money!

At this point, I would like to thank Greg K. the speaker at the corrections workshop for putting everything in the purest simplest perspective. Your story about life on the inside of a prison was the most profound and compelling story. Thank you for informing all of us of the importance of CF meetings, of the hope that is generated by those of us on the outside when we give of our time

by putting on meetings in correction institutions and for asking on behalf of all alcoholics inside, for more help and for more volunteers. That is what it's ALL about.

### Committee:

Thank you to the Self-Support chairs that gathered this morning at 7:30. Your comments ideas and enthusiasm is most inspiring. This report could not been written without you. The following is a summary of our meeting:

The District Chairs are participating in their respective service days and make the occasional presentation 2 on average. The most so far (9) out of 21 group have been done by District 28 SS chair Carl C. Carl has the distinction of being the first ever Chair from that district. And he uses the most interesting props a \$1 and a 2 dollar bill.

Rod of District 62 has seven presentations scheduled. District 66 has the largest committee, a grand total of two members. The number one questioned experienced by all chairs Is "How much should I put in the 7th? As per the green card "Until it feels good". Glen G. reported that the Self-Support can program is slowly gaining ground in D18. The next question is "where does the money go". Groups are unaware of activities/needs of others levels of service.

### Interesting comments:

- Suggest with enthusiasm" rather than Promote service.
- A birthday envelope is quiet way to commemorate an anniversary
- The 7th in the basket is not paying, but rather paying back.
- While we think we are preaching to the choir, it's the active members of a group that attend biz meetings, the ones that hear the SS presentation. And they have sponsees. That our sponsees need to hear about how AA works as a whole, not just the steps.
- Importance of the groups is emphasized with respect to of AA as a whole.
- No one reported hearing announcements being made about Service Position vacancies. That is where General Service Representatives can get active; please make known what service positions are available.

The answer to a lot of these questions may lie in educating our groups of all the ways that General Service Office and all levels of the service structure help make 12 step work possible, and as we go up and down the inverted service triangle, how each level of service connects compliments and supports the one above and below it, finally arriving at the groups who support the individual member.

#### Conclusion:

If one of the aspects of Self-Support is informing our membership of how AA works as per the Service manual, which is often referred to as the secret service manual, you might consider the district chairs as secret agents. You are now members of SPIES, sober people implementing and encouraging service. And no, District 86's Self-Support chair is not named Maxwell S, but would you believe Paul S. And there is no District 99. But unlike real spies, the District Chairs are suppose to reveal information, unlock the joy of service, and dispel myths and legends. Tradition 12 prevents me from blowing their cover. They are out there, and are waiting to come in from the cold.

Seriously, though, so if you want to find out more about Self-Support, stop by the display in the atrium and grab a self support kit, some birthday envelopes. Leave your ideas and comments. Or better yet, talk to your General Service Representative to arrange for a visit by your District's Self-Support Chair at your group's next business meeting. They all have a short presentation that explains what it's all about, the big picture of AA as a whole. Also you can always refer to the area website. Thanks again to Area Webmaster Todd for creating a page for Self-Support, and posting some great information and General Service Office items. This wealth of info was compiled by the previous chair, and I have digitized most of it. If there is anything you would like, contact me through the website.

Self-Support is not about fundraising. Take out the "d" and it becomes two words "fun-raising". The fun that comes from doing service work, meeting new people, and new challenges. And growing as a person as result of helping others recover from our common disease. And raising not raisins, our members up with our collective experience of strength and hope.

It is a pleasure and a privilege to serve you. I have had fun this weekend writing this and doing this. And I hope that your experience here this weekend has been fun and has raised your awareness about our greatest strength. The members of Area 83 and its people. Some of us may not have it all together, but together we have it all.

The archives display truly showed how AA started in Akron and left this member with several lumps in his throat.

After arriving at the Conference in Springfield, the first thing we were treated to was a presentation by one Abraham L on his talk to the Washingtonian Society on temperance. The following day the real conference got started with AA meetings, Presentations and Workshops on Preservation and Conservation; Archives, Where do we Begin; Archives Workbook; GSO Archives; Digital Archives; the Oxford Group and AA; Copyright Laws; Archival Software; Archive Retrieval and the History of the Big Book.

# 6. TREASURER'S REPORT

Hi friends. I'm an alcoholic, a member of the Kedron Group in District 28, and my name is Rob M.. It's an honor and a privilege to serve Area 83 as your Treasurer.

Thank you to everyone who attended the Treasurer/Self-Support workshop yesterday and a special thanks to Steve A, the GTA Intergroup treasurer for his amazing presentation at our workshop. I hope you found the information helpful. Thanks also to those who helped sell banquet tickets, total tickets sold was 234. I hope that you have all enjoyed the dinner.

In the District Committee Members mail folders I placed two Area 83 contribution envelopes. Please share these with your District Treasurer for future contributions. Several of the envelopes are available on the side table, please help yourselves. Also in the DCM mail folders, as well as the Area Committee Members folders I placed copies of the financial statements for the period ending October 23, 2013. Copies of these are available on the side table and I would like to go through the numbers now.

Page 1 is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a Guaranteed Investment Certificate (GIC) paying 1.5% interest maturing September 16th, 2014. Total income for the period is \$47,487.80 and total expenses for the period are \$43,676.33. To date income is \$3,811.47 higher than expenses. Thank you to the 151 groups and 14 districts that have made financial contributions to Area 83. As of October 23, 2013 all cheques received were deposited and receipts along with return contribution envelopes were sent out.

The bank opening balance as of January 1, 2013 was \$33,114.26. Total income of \$47,487.80 less expenses of \$43,676.33 leaves a balance in the operating account of \$36,925.73 as of October 23, 2013. The bank reconciliation has been done and the balance in the operating account is accurate.

Page 2 shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date. At the bottom of the page is a summary comparing this year to the same period of 2012.

Page 3 shows contributions by District. These amounts include contributions from the District, as well as Groups within the District.

This weekend's 7th Tradition was; Friday \$343.70, Saturday \$880.10, and Sunday \$812.80 for a total of **\$2,036.60** collected over the weekend. Thank for your generous contributions, and thanks to everyone who helped collect and count the 7<sup>th</sup> Tradition.

# 10. REGISTRAR'S REPORT

SCOTT M.

Good afternoon friends! I'm alcoholic; a member of the Bloordale Group in west end Toronto, part of District 06, Mississauga & my name is Scott M. Hi! I have the honour & privilege to serve as your Panel 63 Registrar for Area 83, Eastern Ontario International & grateful to do so.

If this is your first Area assembled business meeting, we welcome you. If you are a new General Service Representative this term and you have yet to receive your General Service Representative kit, that's the bad news. The good news is, while you are waiting for your kit to arrive in the mail, you can simply go online to your General Service Office website, that's www.aa.org and choose the heading "For Groups & Members", then by choosing the tab "Getting involved in General Service" there are 12 publications (including the ever popular A.A. Service Manual combined with the 12 Concepts for World Service) all listed here. There are actually 24 items that make up the kit. If you feel it's been too long since your change form was passed along to your District Registrar, have them send me an email & I'll check our database or with General Service Office. Alternates do not receive a kit. If your General Service Representative steps down, where possible, ask for their kit and send in a Group information change form indicating no kit is required. This will help keep the costs down.

As the Area Registrar, I am responsible for compiling and updating group registrations & records; distributing lists to your District Committee Members at least once a year and forwarding group information to the General Service Office. I also prepare sign in sheets for you, by District, to enable me to collect the data required to tally & provide the roll call or display here, at the four Assemblies and seven Area Committee Meetings this term. The way I am able to access your Group records is through the General Service Office's database, call Fellowship New Vision or FNV for short.

Most of the Registrars' know this, but they've been rotating as well, and I'll share that this terms' Group Information Change form and the New Group form have been updated with my mailing address so you can send me group changes. I'd like these sent to me where possible by email in a Word formatted document for easier transcription. Instructions on that are on the bottom of the forms. These are easily downloadable from our Area 83 website: www.area83aa.org under the "Resources" Heading & the "District Resources" tab or I can send you one if requested. It is essential that all information possible is filled out. If there is no postal code for example, a profile cannot be completed and that individual cannot represent their group in the directory.

I can, so I found out recently, still make a profile for someone with only their last initial. Highlighting any changes make it a whole lot easier on me. If you, as the General Service Representative, are making changes on a form, ask your District Registrar if they want a copy, as most keep accurate District records and are used to pass along your information. That way, they are fully aware of your changes. Moving? Change phone numbers? Please send in a form. There have been forms out in the atrium all weekend & will be at all the assemblies, if you wish to update your Group member counts. This way, we'll get a more accurate count for our Area as a whole & the next AA membership census.

It is the responsibility of the Area Registrars to ensure our Regional Directories are up to date. Like I mentioned in my report in March, your General Service Office will be cutting costs & tentatively not publishing a Canadian Directory this year. I'll keep you informed if I hear when the next deadline for submissions will be. The current Canadian Directory is the 2012-2013 version. If anyone wants to see it, it's here. I believe it is also part of the DCM kit.

To the DCM's & District Registrars: if you wish, at any time to know what information I have for each of your Groups in your District, just fire me off an email & I'll be happy to get you your information. I have had communication with quite a few of you over the last month & have updated many, many records. If I thought, that after the initial rush at the beginning of the term that I'd be coasting, I'd have been mistaken. It seems a Registrars' work is never done.

One of my/our objectives should be to reduce our Unknown groups to zero. In March, we had 95 Unknown Groups. Today, we have ... 105. These Unknown groups will become either Active or Inactive groups.

Active - group has a General Service Representative or primary mail contact on the record along with current meeting information

Unknown - group is still active but record does not have a General Service Representative or primary mail contact attached to it, indicating no one is available to receive mail from your General Service Office.

Inactive – The General Service Office records department has received information that group has disbanded or is not currently meeting

To submit New Group forms, Group Information Change forms, have queries relating to GSR kits, or you have any further questions or comments regarding the Registrar process including group status issues, send me an email to registrar@area83aa.org. I will follow up for you as to not take up your time here addressing these types of concerns. I kindly request that District Committee Members and District Secretary/Registrars (as some of you have double duty) to please use this email to forward your District minutes. Thank you to those that send minutes & please add me to your distribution list if you are not.

Thank you to those that attended the Secretary/Registrar workshop yesterday. It continues to be learning and sharing. We all win. I would get a failing grade here today if I did not give a HUGE Thank You once again to the team from District 36, who was most generous with their time and assistance with manning the Registration table, Greeting and others who aided with this process this weekend. Clap...

Before I give the roll call/display, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote, have that right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being, that the numbers will often not look at all like what was written on the sign in sheets.

For example, a District might have five people signed in as visitors, but when I announce the roll, I might see that there was only one. The reason is that I check each visitor against his or her group, and if the group does not have a General Service Representative that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as their Groups' General Service Representative.

Also, if an Alternate District Committee Member is the only person representing his or her group, I will count them as a General Service Representative as well, since Alternate District Committee Members do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate District Committee Member but their function, for the purposes of voting at the assembly, is really as their group's representative.

It is very important if you sign in as a visitor, that you also write the name of your group. You could be voting for your group, but if you fail to indicate your group name on the sign in sheet, you may not be eligible to vote. Please keep in mind that as you see the tally on the screen and/or hear the results, this is not a true reflection of who will be voting necessarily. For example, there are people who may have registered, but were only here yesterday and are not here with us now. So, the true reflection of who is voting is done by who is in the front of the room as a vote is cast and counted, if necessary.

In closing, I will make myself available to Districts and Groups to assist you with Registrar related issues where I can and please remember that communication is most important. Thank you for the confidence you have placed in me and for the opportunity to serve you, the folks at the top of the inverted triangle, on behalf of Alcoholics Anonymous as a whole.
