#### Introduction

This is our forth and final Assembly this term. During the remainder of the 2 year term, we will be working together to provide continued strength and direction to A.A. in Area 83. Our common goal is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together is the key for continued Unity in our Area. The A.A. #### WHO VOTES?

Only members of the Assembly may vote.

#### These are:

All Area Officers, including the Immediate Past Delegate, but not the Chair.

All Area Sub-Committee Chairs

All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.

All General Service Representative's of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ◆ There is one vote per person.
- ♦ After lunch, which is when we would expect to conduct Old & New Business, I would ask those with voting privileges to sit at the front, those without votes please sit at the back section. This will make it easier for us to count votes.

#### A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

- When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion. This next part may unique to A.A. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the original motion.
- ◆ The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

#### **CALLING THE QUESTION**

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

#### WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
  - ✓ It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
  - ✓ And it maximizes the time available for those members to voice their Groups' opinions and needs.
- All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also guite possible that something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones around the room, and identify yourself by name, position, Group and District number.
- If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary James before standing at the microphone.

**HOW DO WE VOTE?** 

♦ Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3

majority – 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is

impractical to use the roll-call as the basis for the 2/3 calculation.

♦ I believe that the early part of the agenda today can be handled under simple majority – 1 vote more than 50%. I will

advise you when I believe we should move to 2/3. If, at any time, you think that we should move to a 2/3 majority before I

indicate it, remember, this is your meeting. Don't hesitate to make the motion.

◆ To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help

me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at

the back. Ultimately, it will speed things up.

♦ At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his

or her hand.

Again, when you are ready to speak please identify yourself by name, position, Group and District number.

**Grapevine** Jim A

Hi friends, I am an alcoholic, my name is Jim A, I have had the honour and privilege of serving you as the /Area 83 Grapevine Chair

Many thanks to district secretaries for their minutes; D36 Grapevine chair Rocky P for setting up his display and selling lots of literature; and the district GV chairs. We had 10 dedicated diehards at the Sunday morning, including 4 incoming GV chairs. Working with them is the best part of serving in this position. The one big idea that came from this meeting is that GV needs more Canada. Print it here, price it in CDN\$ and have more Canadian content. That last one relies on you. And GV chairs

voiced an opinion that they need more support form the GSRs, the district tables and the groups. Too many GV chairs are a committee of one.

#### 2016 General Service Conference Report

2015 was a good year at GV/LV, as described in the annual General Service Report. Please see pages 32-35, and for you analyst/accounting types, the entire financial reporting package is at the back of the book too. The publishing industry is in decline about 5% a year, but GV print subscriptions only went down 2.5% last year. It is probably due to the 2015 subscription challenge. They made money and contributed \$260k to the Reserve fund, 3<sup>rd</sup> consecutive year for this happy event. And digital quote of the day goes out to nearly 40,000 subscribers. Go to the website, its free.

But his cannot last forever. AA membership is flat, so there are not as many new readers of GV as before. Going digital has helped but it is not enough.

#### A: Audio Strategy:

Short answer: it will continue, complete roll out still to be determined.

#### B: New books

Of the four new ideas for books the conference decided to not do a Beginners II and Young and Sober II, maybe later. They are going to proceed with new compilations on Steps 4&5, and a one on Stories by Atheistic/Agnostic/Freethinking members. These compilations will be released in 2017 and beyond. As with current practice, the material for these books comes from previously published stories that have appeared in the GV magazine, or on AAGrapevine.org.

#### C: Review of the GV Workbook:

Completed with some changes. This on the website under the resources tab. It is 102 pages of pure gold, everything you ever wanted and needed to know about being a GV rep.

#### Other bits and pieces:

Grow Your Grapevine: This promotional activity for 2016 encourages teams (groups, groups of groups, districts area etc) to complete tasks on a seasonal basis. Area with most cards completed gets a special section of a 2017 GV magazine. This started March 1 and goes until Feb 28<sup>th</sup> 2017. The card is downloadable from the website. And you make submissions online too. All detail on the website. Western Ontario is wining the whole thing.

I have submitted a request to the GV controller that the pocket planners and calendars be priced in \$CAD. Still no response given on that one.

At the last Assembly, a question was raised asking "What does it cost to produce a Grapevine? I have emailed and called both the Operations manager and the General manger on this one recently. I got an answer on Friday. According to the Executive Editor, paper, printing and postage comes out to 81 cents a copy. Please note that this does not include staffing and other overhead charges. This was all that I was allowed to have.

As always, please recycle your old Grapevine magazines by starting group or district collections for use as a lending library. Or give them to your districts service committees, especially Corrections. Each magazine represents hope. The July issue is always dedicated to Corrections. This one is needed behind the walls especially. Or you could pass on some to me for an Area collection. A distirct or group collection.

Other ideas: A group in Milton that has a discussion meeting based on the stories in the current Grapevine. Give a magazine away for a newbie getting 30 days, it becomes a keepsake.

At a recent roundup, an atheist member asked if I had any extra copies of the October 2016 issue dedicated to Atheist and Agnostics. 5. Treasurer Kimberley M

Hi friends, I'm an alcoholic, a member of the Ajax Area Group in District 26, and my name is Kimberley. It is my privilege to serve Area 83 as your Treasurer.

Last night there were 210 tickets sold at the banquet compared to 159 tickets sold in the Spring. Thank you to those who helped to sell tickets in the atrium yesterday and Friday.

In the District Committee Members mail folders you will find 2 Area 83 contribution envelopes. Please share these with your District and Group Treasurers for future contributions. More envelopes are available on the side table, please help yourselves. Please thank the groups that are including their service number either on the envelope or right on the cheque. It is helpful and appreciated.

Please continue to remind groups who would like to contribute using Paypal to include their 6 digit Group Service Number with any contributions using paypal so that the group can get credit for the contribution. The place to enter the group number is the screen after entering credit card information. Paypay charges a fee of 2.9% plus 30 cents per transaction. There have been 6 contributions using paypal this year so far.

Also in the District Committee Members mail folders, as well as the Area Committee Members folders you will find copies of the financial statement for the period ending October 18, 2016. Copies of these are available on the side table and let's go through the numbers now.

<u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest maturing September 11, 2017.

Income for the period: 7th tradition collected at the Assembly and Area Committee Meetings (\$3 969.33). Cost recoveries from the sale of grapevine materials and service manuals (\$371.00). Grapevine Seasonal (\$3 326.25). There are still some moneys to be collected to go towards this amount. I already have another \$546.50 to add in here after this weekend. Soon the total here should be very close to the amount below under expenses. There are typically differences between these 2 amounts due to having to guess months in advance what the exchange rate will be with the US however this year the difference will be quite small. Group and District contributions (\$42 007.85). Total income for the period is \$49 674.43.

Expenses for the period: Committee expenses are \$24 628.86. Area committee meeting – rent and refreshments (\$1 157.46). General Service Conference \$10 412.40. Bank service charges \$10.56. Paypal Fees \$13.84. Forum in Thunder Bay \$1 398.22. Grapevine Seasonals \$4 089.76. Ontario Delegates Conference \$1 514.37. International Conferences \$0. Total expenses for the period are \$43 225.47.

To date expenses are \$6 448.96 lower than income. The bank opening balance on January 1, 2016 was \$23 640.83. Total income less expenses leaves a balance in the operating account of \$30 089.79 as of October 18, 2016. Last year at this time, our balance in the operating account was \$31 091.07. The bank reconciliation has been done and the balance in the operating account is account is account.

Page 2 shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date. Just to clarify some of the numbers that you see here: The amount shown on the Webmaster line under miscellaneous, \$39.98, is the amount of website renewal for 2 years. The amount shown on the Archives line under miscellaneous, \$499.93, is for the Archives workshop in Ottawa. Beside Grapevine under Literature you see \$536.62, some of that has be recovered from sales of grapevine materials and shows up under cost recoveries on page 1. The amount recovered to date is \$252.25. Beside the Spring Assembly, under meals you see \$4000 which covers the coffee. In that same line under miscellaneous, the amount of \$1255.74 includes Archives room and DVD rental (\$322.05), data projectors (\$214.70)and the set up of the ballroom (\$678). (the extra 40.99 is for one banquet ticket owed to us by the Ambassador). Beside Area Committee Meetings, travel expenses were for a previous delegate to facilitate the election for the new self-support chair at the January ACM. Miscellaneous in that same line is for the rent and refreshments for the ACM's held so far this year meetings.

At the bottom of the page is a summary comparing year to date for 2016 and 2015. Here you can see that our income to date is up \$3 761.12 compared to last year at this time. Our expenses are up \$9 475.92. The resulting net change to our operating account is \$5 714.80. Contributions are up \$4 356.64 compared to last year at this time. 10 more groups have contributed and 1 less district has contributed so far this year compared to last year.

You may ask why expenses are up \$9 475 compared to last year. While some expenses are down, the three main items that contribute to this increase are: General Service Conference – we have paid the full amount which is approx. \$7800 more than we had paid last year at this time. Forums – approx. \$1 400 more due to being in Thunder Bay. There was no forum last year. ODC – was held in Sudbury vs Hamilton accounting for an additional approx. \$780

<u>Page 3</u> shows contributions by District. These amounts include contributions from the District, as well as Groups within the District. Thank you to the 161 Groups and 14 Districts that have made financial contributions to Area 83 this year. As of October 18, 2016 all cheques received were processed and receipts along with return contribution envelopes were sent out.

The 7th Tradition collected Friday at the open meeting was \$558.90, Saturday \$1 360.05, and the total contributions in the coffee cans were \$463.52. Sunday the 7<sup>th</sup> tradition collected was \$1 374.25. Therefore the total contributed this weekend which will go towards the coffee costs is \$3 756.72 compared to \$3199.28 in the Spring Assembly. Thank for your generous contributions. #### 7. ROLL CALL (DEFERRED TO AFTER LUNCH) AND REGISTRAR

SUE B

I am an Alcoholic, a member of the Parkwood Hills Group in Ottawa – West, District 62. My name is Sue B.

It is wonderful to be here with all of you this weekend, and to be of service to you and this wonderful fellowship, of which I truly love.

Thank you to those of you who were able to attend the Secretary/Registrar Workshop yesterday. It was great to see the presence of so many interested in learning about the process and your questions. It has been my pleasure working alongside our Secretary, James, in these presentations. We all had fun, along with learning the importance of the information being passed from the District Registrar to the Area Registrar, who is the main link between the groups and the General Service Office (GSO). Thank you to Jim S, DCM for D82, for his great presentation.

As your Area Registrar, I am responsible for compiling and updating group registration and records on the GSO database called the Fellowship New Vison (FNV); and distributing lists to District Committee Members (DCM's) and Registrar's at least twice per year. I also prepare the roll call forms for Assemblies and Area Committee meetings. The Area Registrar is responsible for all Group information, and the Area Secretary is responsible for both the Districts and Area Committee information.

Currently, Area 83 has 581 registered groups; 554 with an active status, and 27 with an unknown status.

If this is your first Area Business Meeting, we welcome you. If you are a new General Service Representative (GSR) and have yet to receive your GSR kit, while you are waiting for it to arrive in the mail, you can simply go online to your GSO website, which is **www.aa.org** and choose the heading "For Groups & Members"; then by choosing the tab "Getting involved in General Service" there are 12 publications all listed here (including the ever popular A.A. Service Manual combined with the 12 Concepts for World Service). There are actually 24 items that make up your kit.

GSR kits are usually mailed out within 3 weeks of the GSO receiving the updated group information. These kits are delivered by courier. If the GSR is not at home, they will receive a mail pick up card to collect the kit from the post office listed on the card. If the GSR does not pick up the package within the allotted time on the card, it will be returned to the GSO as undeliverable. If GSO cannot make contact with the GSR by phone or email, then they will mark the group as unknown as they no longer have a contact person for the group.

If you feel it's been too long since your change form was passed along to your District Registrar, and have still not received your kit, then please have them send me an email & I'll check our database or with GSO to see what is happening. Alternates do not receive a kit.

As many of our DCM's, Alt/DCM's and Registrar's know one of my projects throughout the term was to reduce the number of Unknown groups in Area 83; we have gone from 89 and are now down to 27. Some of the groups were no longer meeting and were made inactive, and the rest, now having a postal mail contact for their group, have become active. This allows them to share, once again with the group, information on Alcoholics Anonymous world-wide. The rest of the 27 unknown groups will either still be active and will require a GSR, Alt/GSR, or a postal mail contact to change the group's status with the GSO to active, or they will have closed and no longer meet, therefore changing their status to inactive. Some may even wish to become a meeting only, and in this case, the District Registrar would send me an email letting me know, so I may then email the GSO to have them change the status of the group from unknown to inactive.

I wish to give a HUGE thank you once again to the team from District 36, who was most generous with their time and assistance in manning the Registration table, for Greeting and to all the others who aided with this process all weekend.

Before I give the roll call/display, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call/display, much care is put into interpreting the sign-in sheets. The result being, that the numbers will often not look at all like what was originally written on them.

Most important to remember is that there is only one vote per Group. Also, no matter how many positions you hold here today, in the total delegation count (total persons) for your district, you are only counted once, as you are only one person.

When preparing the count for the tally, please note:

- 1. All members have been placed in the appropriate columns as they indicated when they signed in on the sign in sheets.
- 2. For Committee Members who have also marked yourselves in as your group's GSR, you have also been indicated under the GSR column for your District.
- For Alt/GSR's whose GSR is not present, you have also been indicated under the GSR column for your District.
- 4. For visitors in the absence of a GSR or Alt/GSR from your home group, you have also been indicated under the GSR column for your District as it is assumed you will be voting for your home group today.

- 5. Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting privileges, but Group Representatives do.
- 6. Please note that Correction Groups have not been included in the total number of Groups per District as there is a separate entry on the roll call/display for Corrections.

**Before you leave here today**, please place your name badge holders in the box located on the table outside this room. This way we may recycle them so as to keep our costs down.

I wish to thank all Districts that send me their Minutes. As you all know, I love receiving them and to see what is going within your District.

At our first Assembly, while discussing a motion, there were 4 friendly amendments, the question was called three times, the voice of the minority spoke three times, and a motion to reconsider was passed. After all this, the motion was passed, almost as it was originally presented. At that same Assembly, three recommendations from the ad-hoc committee on the Service Information Day guidelines were accepted. It was quite an introduction to chairing an Assembly; you really kept me on my toes.

As Chairperson, I witnessed our service structure at its very best, keeping principles before personalities, and knowing that, while I had an informed opinion, I didn't have a voice.

At our Assembly last fall, a motion was passed to enable online contributions through our website. As a result, PayPal contributions are now accepted.

We conducted an Area inventory this term, and a committee is continuing to look into the results.

A committee looking at our Assembly location was formed and will report later today.

A new Alternate Webmaster was appointed near the beginning of our term, and a Webmaster and Alternate Webmaster should be appointed at our December Area Committee meeting.

## APPENDIX E - ASK-IT-BASKET Q&A

### Ask it Basket- Spring Assembly 2015

- **Q:** AA Functions such as this Assembly, are we not to have receipts? Room, dinner, gas etc. \$450.00 has been given to GSR for weekend and told "Trusted Servant" and to put remaining balance of money in the 7th Tradition Box.
- A: Each group is autonomous, some groups require that you collect a receipt, and some do not. In short, we have to do what our groups expects from us.
- Q: What do donations to the Area cover at the Assembly?
- **A:** The 7th that is collected at the Assembly goes toward coffee. (Coffee charges are estimated by the Hotel as \$11.00/person~roughly \$4,400/Assembly)
- Q: Why was Kingston chosen as a spot for the Assembly?
- A: Kingston is the [geographic] "Center" to the Area.
- Q: For PIC and CPC, should we be handing out materials directly or should we be going door to door?
- **A:** For PI/CPC we work with the concept of attraction rather than promotion. Put pamphlets in places where suffering alcoholic is likely to see it. Door to door is not practical.
- Q: How do I get more people to come to business meetings? Only 3 or 4 others regularly attend.
- A: Enthusiasm and Passion are attractive. Put out a proactive proposal that will up the attendance.
- Q: What is Intergroup? How is it different than Area?
- **A:** There are guidelines for Intergroup. The Area is represented at the General Service Conference, and Intergroup does not have such representation. Intergroups are where groups pool their resources to reduce cost for services offered by AA (e.g., literature, phone lines).
- Q: Should PIC and CPC be separate roles at the District? Why aren't they?
- **A:** GSO regards them as separate roles. When there is not enough service volunteers, better to have one do both jobs instead of no one doing either.
- **Q:** this morning the presenter said that the LaViña organization gave a financial contribution to A.A. Isn't that an outside contribution that should be refused because it breaks our 7th Tradition?
- A: As a group of AA members doing AA work, there is nothing wrong with accepting a donation.
- **Q:** If the Conference approved that it was okay to include a flyer for LaViña (French speaking equivalent of Grapevine, but not governed by GSB) in the GSR kit, how would the conference reconcile that with Tradition 6 and its caution against endorsing, Financing or Lending AA's name to outside Enterprises?
- **A:** A person in the audience said that they received the pamphlet in their GSR kit. This prompted the Delegate to ask folks to let her know if they received/did not receive this pamphlet in the GSR kit, as this is what is being considered at the GSC this year. Some in the audience have said that it was inserted in their CPC and PI kits.
- **Q**: How does a Group split into 2 groups? What is the Protocol? Does the other half of the group apply for a group service number? **A**: It is suggested that they [the one splitting off group] apply for a group service number.
- **Q:** Now that Access Ability has been added to the role of Treatment, when will we see the name of this committee change to Treatment/Access Ability? Considering they are two separate service entities being managed by one Chairperson.
- **Q:** When will we see more Special Needs Access Ability items added to the Treatment display? Such as American Sign Language on DVD, Big book in Brail, Large Print Literature.
- **A:** Herb W. (Treatment/Access ability chair) answered both question with this response, that if you think something should be out there, tell me and I will get the material.
- Q: What are the spiritual rights of Concept 3?
- A: Trust

- Q: Why is there a fee for the Service Manuals? Why is there an increase in the cost?
- **A:** This is the newest Service manual and the cost (\$4.25) covers the cost of the manual, shipping, and taxes that the Area had to pay New York. The Area is not making any money on the manuals.
- Q: Why isn't there a fee for the Service Assembly?
- A: This weekend includes a Service information day and a business meeting. Groups, by contributing to the Area are helping to cover the cost of this event.
- Q: What is a realistic estimate of the time spent in these positions? GSR, DCM, Area Officer (Delegate), Subcommittee chairs,
- A: We are all passionate and how long do the jobs take will differ from person to person and from job to job?

GSR: meetings approximately 12 times a year plus 2 Assemblies.

DCM: involves more time, as there are 4 Area Committee meetings plus the 2 Assemblies.

Area Officer: I can only speak for the Secretary position, it is very time consuming.

Subcommittee chair: I found it interesting and got more involved that probably most would.

<u>Delegate</u>: most time consuming position. Delegate is away many weekends, takes a lot of prep time to prepare for the GSC once a year. Also there are numerous phone calls and emails.

Regional Trustee: 3 General Service Board meetings, plus General Service Conference. Also attend Regional meetings, Delegate committee and Conference Committee.

There are 4 meetings every 6 weeks in preparation for the General Service Conference. That means lots of reading and time spent at home.

Trustee at Large: they have to travel internationally

<u>Class A Trustee</u>: much like the Trustee at Large and may be involved to a greater extent since a Class A Trustee (non Alcoholic Trustee) can show their face and speak about AA where <u>Class B Trustees</u> (Alcoholic Trustees) cannot.

TAKE HOME message: Need to try and find a balance, it is time consuming, but very rewarding.

- **Q:** Corrections: with a 40% success rate how is Bridging the Gap successful in carrying the message? Why is Bridging the Gap (BTG) so different than helping someone with the same fear of walking through the doors?
- A: Statistics might not look too good, but BTG serves as a controlled transition- we know the transition puts many in a high risk to relapse.
- Q: Are we breaking tradition by calling a group "the Agnostic Group" "women/men only", Gay/lesbian".....
- A: It's not the name of the group, it is the members that make up AA. When we change our names to sound attractive.

With regard to special interest groups, there is a unique need. It take a substantial number of AAs to vote for the change-unanimity.

Bill said we'd rather you not call yourself a special group, we ask you not to do this but we do not demand that (Bill Wilson speaking on Tradition 4).

#### Ask it Basket- Fall Assembly 2016

Delegate–Joyce S.

- Q: From the Delegate's workshop, the membership survey says under marital status, "Other 6%". What is considered "other"?
- A: It doesn't specify on the survey results, I suspect it might be widow or widower. Delegate will confirm what this "other" category includes.
- Q: When will we find out about which pamphlets are in need of updating next?
  - Is it always about the same time of year?
  - Or does it come up at a particular conference?
- **A:** There is no specific timing or conference. They come up for updating when someone brings it to the attention of the literature committee. The literature committee will review the recommendation and take it to the General Service Conference.
- Q: Can an AA member have an opinion on how another group carries the message if they are NOT a member of that group?
- **A:** Everyone can have an opinion, but groups are autonomous.
- Q: A district in Area 83 is trying to de-list or kick out a new group that is secular
  - They read a modified version of the 12 steps without the word "God" and don't pray.

- They do this in their group only. They do not publish their steps and respect the steps as written when at other groups.
  - 1. Are secular groups allowed in AA?
  - 2. Should districts be kicking them out?
  - 3. Do you support the district in not including a secular group in their district?
- A: Just as groups are autonomous, so are Districts; the Delegate should not have an opinion. We must trust the process.
- Q: How can I get a hard copy of the Delegate's report if I don't have internet or a printer?
- A: Contact me and I will mail you a copy.
- Q: Who can visit the GSO in New York? Who do I contact at GSO for a visit?
- A: It is not necessary to make an appointment. GSO is happy to have guests, it is your office.

### Chairperson-Rob M.

- Q: Why is there a can next to the coffee and its NOT the 7th tradition? People may confuse it for coffee donations or the 7th.
- A: Most AA events charge for coffee, the Area does not do that, but rather relies on passing the basket around. Coffee costs continue to go up, and it is about covering those costs and giving people every opportunity to contribute and to be fully self-supporting [Coffee at the Assembly is over \$4K-roughly \$11/person]. What the 7th doesn't cover, the Area must pick up the deficit.
- Q: The doors in the West Ballroom are distracting, what can be done about the "clanging" noise?
- **A:** We have propped the center door in the ball room open. We ask people to get to their workshops early and stay to the end. If you must leave early or come late, be considerate and quiet.

### Alternate Delegate-Kim S.

- Q: Do I have the right to stop closed meeting when a non-member is present?
- A: This is a decision for group conscience. Does the group mention in their opening remarks that it is a closed meeting?

#### Treasurer-Kimberley M.

- Q: Does the Area have a US dollar account to transfer funds? Or, do we only have a Canadian dollar account?
- **A:** We have only a Canadian dollar account. We send US dollars via a bank draft. This is not done very often, and the only need for US dollars is for the General Service Conference assessment, Grapevine, and literature for committee chairs.
- Q: Are the envelopes for sending contributions to the Area with prepaid postage?
- **A:** Envelopes are not prepaid. Groups must pay for postage.
- **Q:** Considering Church rent in Toronto is very expensive is there any consideration to contribution amount being *forgiven* or lowered or waived?
- **A:** Up to each group where they meet. Groups look after the group, and the District and Area.

## Self support-James O.

- Q: How much should each member contribute to AA per meeting in order to meet the financial needs and costs for the Area?
- A: No exact number. I used to give a \$2- After I learned what it was used for I started to give \$5.
- **Q:** Why was the 12 Traditions passed along in the Self-Support workshop?
- **A:** It was an example of a 12 Tradition workshop. The document passed around has been posted on the Self-support page of the Area's website.
- **Q:** Answering Service: Is it permissible or acceptable to partner with Al-anon and share the cost of the answering service? Our district say's No, another neighbouring district has a shared cost arrangement.
  - If no, please provide the reason on why not
  - We do not have an intergroup for call service.
- **A:** We do not affiliate, and every group and District are autonomous. In smaller communities must do what you have to do to get the message out.

### Sponsorship workshop-David T.

- Q: What does temporary sponsor mean? What is the difference between "temporary sponsor" and "sponsor"?
  - Why is it used?
  - Where did it come from?
- **A:** It is a fairly new concept, it is an attempt to provide stepping stones to get a person to a permanent sponsor. Some temporary sponsors become a permanent sponsor. It is a Bridging the Gap measure for what some feel is a big decision.
- Q: Opposite Sex sponsorship.
  - I have difficulty connecting with women in my area. I live in a small town.
  - What are your thoughts on opposite sex sponsorship?
- **A:** Men should be with men; women with women. I am emphatic about this. Some women pick men because they can be easily manipulated.
- Q: If a spouse is concerned about their partner's recovery, can they call the sponsor of the spouse for help? Is that crossing the line?
- **A:** It depends on the situation. Is there concerns about harm or someone's safety? Take it to the appropriate authority. Calling the sponsor really depends on the sponsor. It is a very private relationship.
- Q: How many sponsors can I have?
- A: As many as you want but if you have more than 1, you have to ask, why-are you looking for the answers you want to hear?
- Q: How can we prevent sponsors from carrying an abusive message?
- **A:** Up to the group (group conscience) to warn people that this is not acceptable.
- Q: What do you do [with the sponsor/sponsee] when you finish step 12?
- A: We are never finished with the steps. Furthermore, we will always need someone to talk to.

### Ask it Basket- Spring Assembly 2016

- Q: I have two 50th year commemorative Australia Big Books-one has the same personal stories as are in the North American Big Book. The second Big Book has different stories that reflect the Australian lifestyle. Both Big Books are different, why?
- **A:** One could have been produced locally, and the other by GSO. Sometimes ones that are done locally are produced because we don't have enough resources.
- Q: If a person has a criminal record, can they still speak at a correctional facility?
- **A:** Yes, but....We have 21 correctional institutions in our Area, and each one has different rules. For some, all that is required is a name, others may have different requirements.
  - Each facility is different, youth detentions centres will have criminal records looked at in greater detail. It also depends on what the crime was.

### **GRAPEVINE**

- Q: How much does it actually cost to print one Grapevine?
- A: I don't know, one could contact grapevine.org.
  - I will ask on the behalf of the person asking the question.
- **Q:** Is there a demand for publishing the 4 titles proposed:
  - Young and sober, v 2
  - Beginners v 2
  - Fourth and fifth step
  - Stories previous published in grapevine for agnostic, atheist and free thinkers.
- A: Yes, there is a demand, but the publications are yet to be seen.

#### **CO-OPERATION WITH THE PROFESSIONAL COMMUNITY**

Q: Is there a meeting for Dr.'s only?

A: General meetings are listed in NY, and given on meeting list.

Tradition 3 says the only requirement is a desire to stop drinking.

I have met professional people at open and closed meetings.

I am aware that there are special interest meetings (e.g., police)

In other cases there are informal meetings, don't know who attends them or where they are.

Might be in someone's house.

### **PUBLIC INFORMATION**

- **Q:** When updated pamphlets are ready for the Groups, do GSRs or Districts get advance notice so we know which pamphlets to replace, or do we just wait until literature is replaced when we run out?
- A: When the supply runs out, the new ones are issued. The newer ones will be posted on the AA.org website.

#### **TREATMENT**

- Q: At a treatment centre, can they advertise that there is an AA meeting in the building?
- A: Yes, they can. But they cannot advertise any phone numbers or contacts for the meeting.
- **Q**: How does Anonymity apply to the American Sign Language (ASL) translators?
- A: ASL-translators are probably bound to a code of conduct. It wouldn't hurt for us to explain to them about our traditions when their services are used.
- Q: Do people who smoke weed in AA have sobriety?
- **A:** Singleness of purpose. AA has provided me a list of contacts if someone has another issue outside of AA, I can get them in touch with the appropriate group.

We cannot judge, if someone says they have a day of sobriety, then they have that.

#### **SELF SUPPORT**

- **Q:** How much should an AA member contribute to an AA meeting every month.
- A: The hard guidelines around what one should contribute is: contribute what you can. Contribute what the cost of their last drink was

If that was a while ago then contribute what the cost of that last drink would be today.

- Q: When the 7th is collected from the GSRs at a District meeting, who provides the GSRs with the 7th?
- A: The money that the GSRs are taking to the District would come from the collection of the 7th from the group.

#### ALTERNATE DELEGATE

- Q: How do we encourage "Traditions Meetings" to be filled at groups? We have a Traditions meeting every month and no one comes.
- A: I am not sure, food helps. Once they are in place, bring some sponsees and encourage others to come.
- Q: Is there ever a venue for all 68 GSOs from around the world to get together?
- **A:** A country will send a person to the World Service Meeting (WSM). This meeting was conceived as a forum where A.A. members from around the world could share with each other how A.A. operates in their respective countries. The WSM convenes every two years, alternating between New York and a site in a host country (See Pamphlet AA Around the Globe smf-165). This is completely different from the International World Conference.

#### **DELEGATE**

- Q: If you are appointed a position at the General Service Conference (GSC), can you decline?
- A: I have never heard of anyone declining a position/invitation. It is a honour to go to the conference, so whatever they ask me to do, I will do it.
- **Q:** What is Panel 65, what does it mean?
- **A:** When Bill was getting on in age, in 1950 he said we have to get a conference together so that we are all on the same page. 1951 was Panel 1, the first panel.
- Q: What is ODC?

- A: ODC stands for Ontario Delegates Committee meeting. We have 4 areas in Ontario: Area 83 (Eastern Ontario), Area 84 (Northeast Ontario), Area 85 (Northwest Ontario), Area 86 (Western Ontario). Before the GSC, the 4 delegates and alt delegates of each of these Areas get together to run through the GSC meeting content. We will discuss agenda items, how to behave, dress and this experience is especially great for the Alternate Delegate to attend in case they are pulled up to go to GSC instead of the Delegate.
- Q: Are GSR members expected to attend the Area Assembly?
- **A:** I don't like to say expected. We don't put any expectations on people. If you have been elected as GSR, you are representing your group, (this applies to the Alt GSRs too) They are at the top of the triangle, and that is where the link starts. We appreciate it when you come and we would like to see more of you.
- **Q:** Why can't we print some of the AA books in Canada?
- A: Our GSO has a printing service in the States, maybe too expensive to have a second one in Canada.
- **Q:** What is AA's Opinion on Atheists and Agnostic Groups who change the 12 steps and 12 traditions? Are they part of AA if they change them?
- **A:** AA does not have an Opinion on this subject.
- Q: What is the rationale for /against AA setting up a twitter or google-not-for profit account?
- A: It has been a subject of discussion for several years. Discussion is up again for Linkedin, Flicker, Twitter, and Facebook. Our GSO knows that the message is not getting out there that AA is here to help the still suffering alcoholic. It is not to convert, or promote the AA message. Not getting into chats
- **Q:** Other than a self-regulating or trust-based system, has there been or is there now an approach to formally challenge any individual who claims a "desire to stop drinking" and thus his/her AA membership?
- A: I have never heard of any self-regulating or trust based system, and I hope we never do.

#### **CHAIR PERSON**

- **Q:** Why are last names used [in some AA settings]? Newcomers may be afraid of [protecting their] anonymity when hearing others using the last names of others in print, presentations or speech?
- A: In service we need to be able to communicate with each other. There are a lot of Robs at the Assembly and you need to know who the Chair is.
- Nothing with last names should be left lying around. Everything that goes out over the email, has just last initials. Dr. Bob says that we do not have to be anonymous with each other.

Comment: Ensure that people with disabilities are consulted to know what their needs are?

Please contact me in advance, and I will try to accommodate with the help of the hotel.

#### **WEBMASTER**

- Q: Internet: if you have a unique first name, how can your anonymity be safe, even if your last name is not posted? Say for example if someone googles it?
- A: If you are concerned about your anonymity, make up an alias.
- Q: Why hasn't GSO made the ebooks compatible for android yet?
- A: I don't know. Might be due to technology.... Not sure.
- **Q:** Are there any limitations on either Area83 or AA.org when it comes to "world services" or involvement at other country's conference level involvement since we are only USA and Canada?
- A: GSO in New York is the head office for US and Canada. There are 63 other GSOs around the world. They are separate entities all over.
- Q: Is there a backup webmaster or a Friendly assistant to the webmaster in case there is a need?
- A: Yes there is. I was alternate webmaster for 3 years. In this term, the alternate is Aaron, he has the passwords and the security details. I have trained him to take over if there is a need.

### **SELF SUPPORT**

Q: Can you join a committee if you are not a GSR, and even if your group has a GSR.

A: Recently, the archives chair of District 10 was the GSR for a group that folded. He is still the archives chair.

If you are interested in serving on a committee -there are other Options

**Q**: Can a member belong to 2 groups?

A: The home group is the heart of AA. There is nothing in AA that says you can't have two home groups. Personally, my home group is where my foundation in AA is. If you belong to 2 home groups, and you are getting involved in service, you are participating and voting twice on AA issues.

Not a good idea.

Q: Can a person hold a position at the Home group level and at the District at the same time?

A: Each group is autonomous, each district autonomous, and I don't see any problem with it.

### Ask it Basket- Fall Assembly 2016

Q: (to the Delegate) What do they mean by "Plain Language" when indicating they requested "Develop a plain language of the Big Book"?

A: Someone sent in a letter to GSO, a different version of the BB. Change certain words to make it easier to read.

EXAMPLE, pg 5 a wholesale miracle has taken place. It is old language, and we don't talk that way today. Another Example...reference to John Barleycorn.

Pg 14-15 of the BB, "These facts .....about themselves" ..... what does that mean? Go to a dictionary and find out.

Why did it not pass? Because we would have 2 version of the BB, which one should we work with. What happened to the days of sitting down with BB and a sponsor with a dictionary?

Q: (Roy R-Past Delegate) How many Delegates go to the General Service Conference from Canada?

A: 14-and Alaska is not part of this group.

**Q**: (Sandy S-Past Delegate) How do we create enthusiasm to attend District Meetings?

**A:** Be enthusiastic. Easiest way..... Often times people audibly dread certain things, and people hear that. We should be excited that so many people want to stand. How is your behavior...?

If your district is not enthusiastic...might ask what are putting out there?

**Q:** (Kimberly-Treasurer) Why is it that a tax receipt is not given when a donation is made to GSO, however one is provided for a donation to intergroup?

A: Intergroup has a charitable status with CRA and thus gets a tax receipt.

**Q:** (Rob M-Chairperson) When the 7th tradition is collected at the district meeting, does both alternate GSR and GSR contribute? Does this come from the GSR or Alt GSR's pocket or from the group?

**A:** Personal decision, whether one or both contribute at a district meeting. Whether it comes out of their pocket should be a group conscience. Discuss at group business meeting. Contributions are voluntary...

Q: (Kim S-Alternate Delegate) Why is the Service Manual not handed out for free at the Area Assembly?

The Annual General Service Mtg booklet was handed out for free, as the workshops makes reference to the AA Service Manual, and the GSR's are lost

**A:** The reason they aren't handed out for free is because the GSR kits come with the most recent up to date service manual. The Area sells them at cost; it would be very expensive if we gave away service manuals for free at the Assembly.

It is an opportunity for people to purchase an updated version for themselves, buy extras for home groups or sponsees.

Q: (Barry W-Past Delegate) Barry W. in his talk indicated there are 14 Area's in Canada, does this include Alaska...Area 2? A: No.

Q: (Jim A-Grapevine) Why do we pay for events such as the ORC, and the Assembly is free?

Why do we pay for service day in Toronto, but not in Kingston?

**A:** The Ontario Regional Conference is completely outside of the AA structure. The event has expenses that it must recover.

It is true, nothing is free. Group donations cover the Assembly....which is essentially a business meeting for all of the Districts in Area 83.

**Q:** (Herb-Treatment/Accessibility) I went to the correctional facilities, and treatment committee @ Bronsen Centre. I was surprised to see a lack of attendance, even from their regular chairperson? It is discouraging—is this typical?

A: Service takes bends, and to the person who observed this, you may be part of the solution.

Q: (Robb W-Past Delegate) Can an Area Delegate move to a new Area, and get elected Area Delegate for the new Area?

**A:** If a delegate has served you can only be a delegate once at the GSC. There are 3000 delegates, 1.25 million alcoholics, let someone else have a turn.

Q: (from the floor) Why are these acronyms used instead of full terms? It is very frustrating for newer people and some older people like me.

**A:** Going through reports some positions or activities (GSR, GSC, GSO) tend to get repeated so many times in a report or document that the writer or presenter tends to move toward acronyms to save time.

Most of the committee chairs try not to use acronyms, good to get this question out, as it brings some awareness. Acronyms are great for one on one conversation, but not for presentations.

Q: (Dot D-Past Delegate) Do DCMs have to chair a district meeting, or can anyone chair the District meeting?

**A:** Up to your district. Most districts do have the DCM chair. DCM in that case does not have an opinion unless there is a tie. By the way, if there is a tie then the DCM should vote no, because there has not been enough information.

Q: (Fredy-Panel 66 Delegate Area 86) How, and what steps does a member take to become a delegate?

**A:** One of the known facts is that delegates come in any shape and size. First to get sober. Get into service, and if you start liking it, if you are willing to, raise your hand and the rest is in your higher power's hand. First GSR, then service at the District ultimately to the position of DCM, then at the Area. Not everyone gets to a Delegate position the same way. If you are going to get into service, make sure you develop thick skin; this will allow you can handle criticism and remain diplomatic so that I could put some of my opinions aside. Huge commitment, and I was told that I had to make 46 weekends available.

**Q:** Service at some Districts is troubling- people are mailing their reports in. People take on the commitments and don't show up. It is a poor excuse for taking on a job. When it becomes a habitat to send in reports, others will do the same.

A: When the GSRs weren't showing up. Only the GSRs in attendance got the meeting minutes.

DCMs and ADCMs go out and visit groups that are not attending. Do DCMs still go to all of the meetings? Some DCMs hit a good number of the meetings, this should be part of the Districts' OP. Most DCMs try to get around to all of the groups. Also, Service sponsor is someone who has experience in service work. Service sponsors should pass on the enthusiasm. We sometimes forget to pass along the enthusiasm.

**Q:** Toronto Intergroup puts on a Seasonal event that receives contributions and sponsorships from outside organizations. Then the event is announced in meetings of AA. Has anyone else encountered this, and what have you done?

A: Groups that have a conference, anything that is not a service function, or AA event

Will not be announced in a group. The problem is no one is talking about it. In your business meeting ask, "Why are we talking about this in our meetings?" Go through your Traditions about affiliations and outside issues.

Q: (Treatment Herb) for an AA event or special function if accessibility requirements are not met, can the event still continue?

A: Yes, the event would still be held, whether or not we advertise that it is fully accessible is another matter.
