He was the "go to" guy, certainly for me, and also for many others. He was always a reliable resource about past Area decisions. Joe presented clear and informative workshops and presentations. Countless members have benefited from is experience, strength and hope. Joe will be greatly missed by the many lives he has touched both in, and outside of Alcoholics Anonymous. We cannot let this Assembly weekend pass without taking a moment to remember Joe's life and contribution to AA. Can we have that moment now? Thank you.

Introduction

This is our first Assembly of four in this term. During the next two years, we will be working together to provide continued strength and direction to A.A. in Area 83.

Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together is the key for continued Unity in our Area.

The A.A. Service manual defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." Just as most District tables meet monthly to oversee the affairs of A.A. in the District, and home Groups usually have regular business meetings, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83.

Area 83 stretches from Oakville in the West to Ottawa in the East, down to upper New York State and up to Algonquin Park and the Ottawa Valley. At last count, we have 578 Active Groups.

SEVENTH TRADITION

I know it seems that the coffee and drinks provided this weekend are free, but the hotel charges us a flat rate of \$14.00 per person for the weekend which works out to \$5600. At recent Assemblies the total 7th collected improved but is still significantly less than the amount paid for refreshments. There are contribution cans beside the coffee urns. Contributions are absolutely voluntary. We had a Seventh Tradition Friday night, again at the banquet last night and we will have another one today. Please keep these costs in mind when the 7th is being passed around.

WHO VOTES?

Only members of the Assembly may vote.

These are:

- All Area Officers, including the Immediate Past Delegate, but not the Chair.
- All Area Sub-Committee Chairs
- All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.

All General Service Representative's of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups. There is one vote per person.

After lunch, which is when we would expect to conduct Old & New Business, I would ask those with voting privileges to sit at the front, and those without votes please sit at the back section. This will make it easier for us to count votes.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion.

This next part may unique to A.A. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this motion is seconded and passes by a simple majority, we start discussion again on the original motion.

The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to

achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

CALLING THE QUESTION

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
 - It keeps the focus on the fact that the Assembly is the business meeting of the Area –
 Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - And it maximizes the time available for those members to voice their Groups' opinions and needs.
- All who are attending may say their piece during sharing time. I would ask for your cooperation on
 this. If you don't have a vote, as I just described, please keep your input for sharing time, which is
 scheduled for later this afternoon. At that time everyone is welcome to participate and their
 opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that
 many of us drive a long way to get home, and that Monday morning comes early, but the Assembly
 truly isn't over until it's over. We have asked our guests and visitors to have their say during
 sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that
 something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones around the room, and identify yourself by name, position, Group and District number.

If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary, James, before standing at the microphone.

HOW DO WE VOTE?

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority which is 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.

I believe that the early part of the agenda today can be handled under simple majority – 1 vote more than 50%. I will advise you when I believe we should move to 2/3. If, at any time, you think that we should move to a 2/3 majority before I indicate it, remember, this is your meeting. Don't hesitate to make the motion.

To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.

At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can

Correctional Facilities

Good afternoon friends, I'm an alcoholic, a grateful member of the Get Well Group in Kingston and I have the honour and privilege of serving as Correctional Facilities Chair for Area 83 and my name is Mac.

I want to give a warm welcome to all the newly elected Trusted Servants, especially the new CF chairs and the new Bridging the Gap (BTG) contact person for each of the Districts.

Bridging the Gap is still updating the CF chair list with the corrections BTG contacts for your District. Please let me know of any updated info about BTG contacts for your District.

We in the CF Chairs world are very excited about the new Corrections Correspondence Service (CCS) in Canada. This service has been operating in the U.S. for 30 years but has only just begun in Canada thanks to the efforts of David T. working tirelessly with Corrections Canada for over 3 years to make this possible. Now we can carry the message through snail mail and perhaps by email someday.

We are in need of A.A. members on the outside to correspond with A.A. members in correctional facilities. If you would like to share your experience, strength and hope with A.A.s who are confined, please get one of these pamphlets from your CF chair, and mail the tear-off form to GSOs Corrections Desk, or e-mail the information on the form to corrections@aa.org. The name of an inmate will be sent to you from your General Service Office and you will make the initial contact through the mail.

The KEY right now is to have Canadian AA members aware, ready, and willing and on Correspondence list at GSO

At the Eastern Canada Regional Forum in July 2016 there was a discussion about the disproportionately large number of First Nations People in Federal and Provincial Facilities in Canada and the need to establish more trust between the AA community and incarcerated First Nations People.

Many of our incarcerated First Nations members have had terrible experiences with sexual and violent abuses and misconduct by some church influences in the past. Therefore, the mention of God in our AA readings is a very contentious issue. Too often, they done;t stick around long enough to find out the difference between spirituality and religion. This has been a prominent difficulty in having them return to the meetings after the first visit. Some are desperate enough to stick around, some donèt have difficulties with God being mentioned, and some dismiss it as issue and continue to come anyway.

Many do not say the Lordès Prayer.

So this seems to be the single most difficult problem in retaining First Nations inmates in the meeting rooms over the long haul. Yet they are proportionally high in prison population and substance abuse is the reason most are serving time.

Many of the First Nations offenders have great support from their community elders or support staff that come into the prisons. Some outside support have AA background and help them work through the difficulties related to religious discrepancies of the past and reinforce their cultural heritage. Many are involved with the swear lodge ceremonies on and off the correctional property. It really seems to help them come to terms with the confusion they must be experiencing. This allows them to participate in AA and maintain and grow with their true heritage identity. All of the Atlantic penitentiaries provide this opportunity and support for those who want to explore it. And I believe at least some, if not all, Federal institutions in Ontario also provide such a service. I helped start a Sweat Lodge at Warkworth Institution.

I have personally worked with incarcerated First Nations offenders and I firmly believe they have been born with an innate spirituality. And when they are able to distinguish between spirituality and religion they have no problem with the spirituality of the A.A. program of recovery.

In summary: We have a number of challenges but we have even more successes in carrying the A.A. message to incarcerated offenders in our Jails and Federal prisons.

Emailing these to you costs the Area nothing, whereas mailing them requires a stamp, envelope, paper and ink. Please encourage your Treasurers to include an email address with your contributions, and I can email you your letter of receipt which you will also receive in a timelier fashion. Please make cheques payable to "Eastern Ontario International Area 83".

Contributions can also be made using PayPal. Please be sure to include your six-digit Group Service Number with any contributions using PayPal to ensure your group will receive credit for the contribution. The place to enter your group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. To date, \$449.00 has been contributed through PayPal.

Also in the DCM mail folders, as well as the Area Committee Members folders, I have placed copies of the Proposed Spending Guidelines. You will also find copies of the Financial Statement for the period ending March 2, 2017. Copies of these are also available on the side table. I would like to go over the numbers with you now.

Page 1 is a Financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest. It will mature on September 11, 2017.

Income for the period as of March 2, 2017:

- 7th tradition collected at the January 7th Area Committee Meeting \$276.45
- Flow through to GSO \$60.00
- Group and District contributions \$8.867.40

Total income for the period is \$9,203.85.

Expenses for the period as of March 2, 2017:

- Committee expenses are \$3,060.61
- Area Committee Meeting, Jan 7th rent and refreshments \$323.00
- General Service Conference Assessment \$5,359.50
- Bank service charges \$154.14

- PayPal Fees \$2.17
- GSO Flow Through \$60.00
- CERAASA \$2,437.53

Total expenses for the period are \$11,396.95.

The opening bank balance as of January 1, 2017, was \$29,496.89. Total income of \$9,203.85 less expenses of \$11,396.95 leaves a balance in the operating account of \$27,303.79. As of March 2, 2017, our expenses were \$2,193.10 higher than our income. As a side note - as of March 23, 2017, all contributions received have been deposited, and letters of receipt, along with return contribution envelopes were sent out. Therefore, our total income is now \$11,928.60, less expenses of \$11,408.85, which places our income \$519.75 higher than our expenses. The bank reconciliation has been done and the balance in the operating account is accurate.

Page 2 shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date.

Just to clarify some of the numbers that you see here:

- The amount shown for the Service Information Day Committee under Literature, \$911.32, is for the Service Manuals which were purchased from the GSO. This expense will be recovered once all the Service Manuals have been sold. Future Financial Statements will reflect this under Income, in Cost Recoveries.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to attend the General Service Conference." Therefore, the \$5,359.50 is the amount in CDN funds paid so far towards the Conference for our Delegate to attend. The total cost is approx \$6,500.00 US, and I have paid \$4,084.33 US (\$5,359.50 CDN at 1.3398) so far. There is a balance owing of \$2,415.67 US or approx. \$3,165.49.
- Bank charges \$154.14 includes an order of 100 cheques at a cost of \$141.42.
- Canadian Eastern Regional Alcoholics Anonymous Service Assembly (CERAASA) \$2,437.53. A separate budget line has been added to show the expenses for CERAASA as it has now become an established Service Assembly. The costs reflect the reimbursement for the Delegate and Alt/Delegate to attend as per the Area's Operating Procedure. Our Immediate Past Delegate has also been reimbursed this year as it was decided at last year's Ontario Delegates Conference (ODC) to combine this year's ODC with CERAASA. As per the Area's Operating Procedures, the Immediate Past Delegate is to be reimbursed for the first ODC of their term, which has been done. The Immediate Past Delegate will not be reimbursed for the ODC is 2018.

Page 3 shows contributions by District. These amounts include contributions from the District, as well as Groups within the District. As of March 23, 2017, contributions have been made by 60 Groups and 9 Districts. I would like to thank you for your generous contributions to the Area.

This weekend's 7th Tradition was: Friday \$603.30, Saturday \$1,383.25, and Sunday \$1,170.82, for a total of \$3,157.37 collected over the weekend. Total contributions in the coffee cans was \$384.25, for a combined weekend total of \$3,541.62. I would like to thank everyone for their generous contributions.

8. Roll call And Registrar

Good afternoon friends! I'm alcoholic, a member of the Liverpool Group, in District 26 & my name is Amy. I have the honour & privilege to serve as your Panel 67 Registrar for Area 83, Eastern Ontario International and I am so grateful to be of service.

If this is your first Assembly, we welcome you. If you are a new G.S.R. & you are without your GSR kit, that's the bad news. The good news is, while you are waiting for your kit I have asked the Webmaster, Jim to set up quick links to the contents of the kit, if you go to the Registrar's Resource tab on the <u>Area83 website</u>. Alternate GSR's do not receive a kit. If your GSR steps down, ask for their kit & send in a new form indicating no kit is required. This will keep the costs down. It is important that you keep your contact information current. If your mailing address changes or your phone number or email, please send me an email (<u>Registrar@Area83aa.org</u>) so that I can keep it up to date in the system. GSO spends hundreds of dollars on return postage for mailings that are not picked up by the recipients.

I am responsible for updating group records & liaising with GSO. I have been busying doing. Like some of you have heard me say, it is like herding cats trying to keep everything up to date.

The forms required to change Group info. or add New Groups have been updated with my mailing address. Instructions are on the bottom of the forms. These forms are available on our Area 83 website, under "Resources" then by choosing the "Registrar" tab. It is essential that all information is filled out. If the mailing address is incomplete a profile cannot be completed and that individual cannot represent their group in the directory. Highlighting all changes make it so much easier for me. If you, as the GSR, are making changes on a form, send it to your District Registrar first to keep accurate District records. Group distribution lists are sent to your District Registrars and DCM's in order to check for accuracy. The last one I did of these was sent on March 22, 2017. Some of the groups listed have been identified by GSO as Unknown. Unknown means the group does not have a primary contact; primary contact may be a GSR or someone who has agreed to be the mail contact. Area 83 has whittled the number of Unknown Groups down to 20 thanks to the hard work of my predecessor Sue and some enthusiastic registrars that I have been working with over the last 3 months.

Another objective is to update membership counts for every group. There have been Group Information Change forms out in the atrium all weekend & will be at all the assemblies so you can update your Group member counts. This way, we'll get a more accurate count for our Area.

It is also my responsibility to prepare the sign-in sheets to enable me to collect the data required to tally & provide the roll call here, at the Assemblies & at the Area Committee Meetings this term.

It is the responsibility of the Area Registrars to have as much if not all of the Area Group information up to date in time for the AA directory release. The General Service Office has informed me that the cut off date for changes will be **May 12, 2017.** So, between now and then I hope to be receiving details for all 577 groups in the Area.

Thank you to those Districts that send me their minutes, if you do not please add me to your distribution list. Not only do I like to know what is going on in your District, I also use the minutes to check some of the contact information and make sure the GSRs are up to date in the database. My email address is: registrar@area83aa.org

I would like to give a HUGE "Thank You" to the team from District 36, who were most generous with their time and assistance this weekend as greeters & behind the registration tables. Donna C and Monique H have brought a huge sense of ease and comfort as I try to carry out the responsibilities of the Registrar at my first assembly. Thank you!

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote, have that right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being, that the numbers will often not look, at all, like what was written on the sign in sheets.

For example, a District might have five people signed in as visitors, but when I announce the roll call, I might say there was only one. The reason is that I check each visitor against his or her group, and if the group does not have a GSR that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as a GSR.

Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the assembly, is to serve as their group's representative. It is very important if you sign in as a visitor, that you also write the name of your group. You could be voting for your group, but if you fail to indicate your group name on the sign in sheet, you may not be eligible to vote. Please keep in mind that as you see the tally on the screen & hear the results, this is not a true reflection of who will be voting necessarily. For example, there are people who may have registered, but were only here yesterday & are not here with us now. So, the true reflection of who is voting is done by who is in the front of the room as a vote is cast & counted, if necessary.

In closing, I will make myself available to Districts and Groups to assist you with Registrar related issues where I can, and please remember that communication is most important. Thank you for the confidence you have placed in me and for the opportunity to serve you,

I attended the District 6 & 12 service day on February 18 where I did a presentation on all 12 concepts.

I also attended CERAASA in Moncton from February 24-26. Since there was CERAASA this year the Ontario Delegate's Conference was cancelled this year. The ODC is for the 4 Ontario areas to help prepare the Delegate for the Conference and CERAASA did that for me. The Eastern Canada Regional Delegates were asked to give their 2 minute highlights that they will give at the Conference. I will share mine with you at the end of my report. During the business meeting of CERAASA District 90 bid for the next CERAASA in 2019 and there were no other bids. So, the next CERAASA will probably be in Laval.

There is more but I just wanted to give you a small report on CERAASA. I will forward on the minutes to everyone once I receive them.

We completed an area inventory last year and are in the process of implementing the AdHoc committee's recommendations. We hold 4 assemblies a term with both Spring Assemblies being Conference Assemblies. We also have 7 Area Committee meetings within our term.

Despite attendance being down at our election assembly and Area Committee meeting, we have elected a great team. I am proud to represent Area 83 anywhere and anytime.

The Operating Procedures for Area 83 require that the Current Treasurer and auditors approved by the Area Committee shall audit the previous term's financial documents.

Documents for the years 2015 and 2016 were reviewed on January 29, 2017. The purpose of the review is to satisfy ourselves, and to be accountable to Area 83 members that the revenues and expenses reported have been recorded properly, they balance, and that there were no discrepancies in these practices.

Specifically, the Audit committee reviews the financial documents from January 1, 2015 to December 31, 2016 in order to evaluate:

- 1) Completeness and accuracy of the recorded transactions,
- 2) Completeness and accuracy of the reporting,
- 3) That all recommendations from previous audit Review Committees were implemented.

Each of the committee members reviewed various transactions from each year. The months chosen were selected to reflect various types of situations: a month with an Assembly, a month with an Area Committee meeting and the last month at random. During this process, large items such as General Service Office Assessments, Ontario Delegate's Conference expenses, Ambassador Hotel bills, and Grapevine Seasonals were reviewed.

Bank reconciliations were reviewed with income items traced back to bank deposits and to Group and District Contribution files. Expenses in a given month were reviewed and traced back to the Area 83 Cheque Register.

The expenses for trusted servants were reviewed for accuracy.

To the best of the Audit Committee's ability, all records which were reviewed were found to be in order, with no discrepancies noted.

The only recommendation that the committee has is to remind subcommittee chairs and officers to include all receipts for expenses claimed with their expense sheet, and - computers are great, but hand written notes are useful too.

We now move to Agenda item 12(b) 2017 Financial Guidelines Sue B, Treasurer

The purpose of the proposed spending guidelines is simply to give us a rough idea of what the expenses for the year might be, and the income required to carry out the services provided by Area 83. Some actual amounts will turn out to be higher than the guideline, and some lower. Predicting expenses is difficult because of several factors.

Typically, the proposed guideline has been forecasted using the average expenses of the past four years. This was also what I used as a starting point. I made some adjustments based on last year's actual amounts.

On page one, under Income:

- Beside Contributions to match expenses is an amount that is NOT based on the four-year average.
 The amount here is the Contributions from Groups and Districts that would be required to cover the
 proposed amounts to effectively carry the message to the still suffering alcoholic throughout Area
 83.
- Grapevine Seasonals values may vary slightly as the Grapevine Chair must determine costs for Pocket Planners and Calendars months before the payment is actually made to Grapevine Inc. In that time, it is possible for the exchange rate to change drastically which has happened in the past.

AREA 83 EASTERN ONTARIO INTERNATIONAL

Under Expenses:

- The General Service Office (GSO) full assessment is estimated to be \$6,500.00 US which works
 out to be approximately \$8,600.00 CDN at a recent exchange rate. Assuming we are able to pay
 the full amount by the end of the year, the actual amount will depend on the exchange rate at the
 time of payment.
- CERAASA expenses are not proposed, but are actual, as the event took place in Moncton, New Brunswick, this past February 24-26, 2017.

On page two, under Accommodation, Meals and Travel:

- for the various positions, it is very difficult to predict accurately, so these are just a guestimate.
 Some actuals will surely be higher and others lower. Some Districts may absorb some of these costs by financially supporting Area Officers and/or Committee Chairs that they invite to Service Days etc.
- Spring and Fall Assembly, under meals, the \$5,600.00 reflects the cost of coffee/tea/pop.
- Spring and Fall Assembly, looking across to Miscellaneous, are the amounts for the projectors and AV equipment used this weekend, for the set-up of this room and for the Archives Room.
