Area Assembly - March 31, 2019

OPENING

Meeting opened at 9:00 am

Good morning everyone. I'm an alcoholic, a member of the Morning Discussion Group in District 10, and my name is James O'D. I have the honor and privilege of serving as Area 83 Chairperson for the 2019 – 2020 term.

Welcome everybody to the Spring Assembly. Did everyone enjoy the Service Information Day yesterday? And how about the banquet, last night? Perhaps we can give a hand for the Service Information Day Committee and for the catering staff. And thank you Jan for your wonderful talk last night.

Introduction

This is our first Assembly of four in this term. During the next two years, we will be working together to provide continued strength and direction to A.A. in Area 83.

Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong with a special focus in the area of communication. Working together is the key for continued Unity in our Area.

The A.A. Service manual defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." Just as most District tables meet monthly to oversee the affairs of A.A. in the District, and home Groups usually have regular business meetings, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83.

Area 83 stretches from Oakville in the West to Ottawa in the East, down to upper New York State and up to Algonquin Park and the Ottawa Valley. At last count, we have 569 Active Groups.

Some of us have been here before as General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some, it will be their first Assembly and from personal experience it can seem overwhelming!

How many of you are here today attending your first Assembly? Could you raise your hand? That's great!!

Being in service is a great way to give back to AA. You will not be expected to learn or understand everything the first time or even second time. It takes time but it will make sense. Many of us didn't understand what was going on at meetings at first, but in time, we started to understand. Service is much the same way. So please keep coming back – welcome and enjoy the rest of the Assembly.

Over these two years, we will make decisions on a variety of topics. The Area Assembly, like the General Service Conference, strives for substantial unanimity through ample discussion. Before a vote is held, plenty of time is taken for full discussion and questions.

It is my hope that you will return to your Groups and Districts with the feeling that you have done your part in keeping Alcoholics Anonymous strong and vibrant in your area and that you have had a strong voice in Area 83. SEVENTH TRADITION

I know it seems that the coffee and drinks provided this weekend are free, but the hotel charges us a flat rate of \$17.25 per person for the weekend which works out to approximately \$5600. At recent Assemblies the total 7th collected improved but is still significantly less than the amount paid for refreshments. There are contribution (cans)/boxes beside the coffee urns. Contributions are absolutely voluntary. We had a Seventh Tradition Friday night, again at the banquet last night and we will have another one today. Please keep these costs in mind when the 7th is being passed around.

WHO VOTES?

Only members of the Assembly may vote.

These are:

- All Area Officers, including the Immediate Past Delegate, but not the Chair.
- All Area Sub-Committee Chairs
- All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.
- All General Service Representatives of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups. There is one vote per person.

After lunch, which is when we would expect to conduct Old & New Business, I would ask those with voting privileges to sit at the front, and those without votes please sit at the back section. This will make it easier for us to count votes.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion.

This next part may unique to A.A. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this motion is seconded and passes by a simple majority, we start discussion again on the original motion.

The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

CALLING THE QUESTION

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
 - o It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - o And it maximizes the time available for those members to voice their Groups' opinions and needs.
- All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't
 have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon.
 At that time everyone is welcome to participate, and their opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones around the room, and identify yourself by name, position, Group and District number.

***If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary, Amy, before standing at the microphone.

HOW DO WE VOTE?

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority which is 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.

I believe that the early part of the agenda today can be handled under simple majority -1 vote more than 50%. I will advise you when I believe we should move to 2/3. If, at any time, you think that we should move to a 2/3 majority before I indicate it, remember, this is your meeting. Don't hesitate to make the motion.

To facilitate the voting, which today will be by a show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.

At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his or her hand.

Again, when you are ready to speak please identify yourself by name, position, Group and District number.

6. TREASURER'S REPORT

Hello friends, I am an alcoholic, a member of Courtice 12 and 12 Group in District 28, and my name is JoAnn. It is both an honour and a privilege to serve as your Panel 69 Eastern Ontario International Area 83 Treasurer.

Thank you to everyone who attended the Treasurer/Self Support workshop yesterday; I hope you found the information useful. Thank you to those who helped sell banquet tickets, total tickets sold were 265.

I was invited to participate in Area 86 Western Ontario Financial Review on Saturday, February 16th in Oakville by Dean T, Financial Committee Chairperson 2019, Panel 60 Delegate. Thank you to the committee for inviting me.

The Ambassador Hotel charges us \$17.25 per person which covers much more than the cost of coffee/ tea/pop. We are not charged for the majority of our room rentals, cleaning of the atrium, staff, etc. The total of the 7th Tradition we collect this weekend goes toward this cost; please keep this in mind when the 7th comes around.

In each of the District Committee Member mail folders, I have provided the District Quarterly Report regarding contributions from each group received by the General Service Office. There are also two Area 83 contribution envelopes. Please share these with your District Treasurer for future contributions. There are several more

envelopes available on the side table. I would like to thank all the groups that provide your Group Service Number and a return address either on the envelope or the cheque or in a note attached to the cheque. This is helpful and appreciated as a letter of receipt will be sent to your Group or District.

Please continue to remind groups who would like to contribute using PayPal to include their six-digit Group Service Number with any contributions using PayPal so that the group may get credit for their contribution. The place to enter the group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. There have not been any contributions, so far, this year using PayPal.

When a Group or District sends in a contribution, they will receive, in return, a thank-you letter of receipt. Emailing these to you costs the Area nothing, whereas mailing them requires a stamp, envelope, paper and ink. Please encourage your Treasurers to include an email address with your contributions, and I can email your letter of receipt. Please make your cheques payable to "Eastern Ontario International Area 83". You can find contact information on the Area 83 website: area83aa.org under the tab "About Area 83" click on Area Contributions.

Also, in the District Committee Member (DCM) mail folders, as well as the Area Committee Members folders, I have placed copies of the Proposed Spending Guidelines which will de discussed under New Business Item 12, b. You will also find copies of the Financial Statements for the period ending March 22nd, 2019. Copies of these are also available on the side table. I would like to go over the numbers for the Financial Statements with you now.

Page 1 (**Appendix A**) is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 in the form of a GIC which matures in September 2020.

Income for the period as at March 22, 2019:

- 7th Tradition collected at the January 5th Area Committee Meeting \$264.40
- Group and District Contributions \$13,452.98

Total Income for the period is \$13,717.38

Expenses for the period as at March 22, 2019:

- Committee expenses are \$3,275.32
- Area Committee Meeting, January 5th rent and refreshments \$383.57
- General Service Conference Assessment \$11,170.14
- Bank Service Charges \$27.50
- CERAASA \$2,801.79

Total Expenses for the period are \$17,658.32

The opening bank balance at January 1, 2019 was \$41,820.83. Total income of \$13,717.38 less expenses of \$17,658.32 leaves a balance in the operating account of \$37,879.89. As of March 22, 2019, our expenses were \$3,940.94 higher than our income. Thank you to the 49 Groups and 8 Districts for your generous contributions to Area 83.

Page 2 (**Appendix B**) shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member as well as all other expenses to date.

Some of the numbers you see here:

- The amount shown under Literature is for various items ordered by Corrections, Treasurer and Service Information Day (Service Manuals) for a total of \$878.76. The money related to Service Manuals that are sold will show under Cost Recoveries next period.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating
 that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our
 Delegate to attend the General Service Conference". The assessment for our Delegate to attend this year is
 \$8,300.00 USD, or \$11,170.14 CDN, which has been paid in full. The GSC Assessment covers the total cost of
 the General Service Conference divided by the 93 Delegate Areas. These costs include expenses for

Delegates, Trustees, and GSO staff to attend, as well as meeting rooms, A/V equipment, printing (includes the final conference report sent to each group) and miscellaneous expenses.

• Canadian Eastern Region Alcoholics Anonymous Service Assembly \$2,801.79 was held in Laval, PQ from February 22 – 24. The costs reflect reimbursement for the Delegate, Alternate Delegate and Immediate Past Delegate to attend as per the Area's Operating Procedure.

Page 3 (**Appendix C**) shows contributions by District. These amounts include contributions from Districts, as well as Groups.

This weekend's 7th Tradition was; Friday \$558.45, Saturday \$1262.30 and Sunday \$1551.40, for a total of \$3372.15 collected over the weekend. Total contributions in the coffee cans over the weekend was \$437.55, for a combined weekend total of \$3809.70. I would like to thank everyone for their generous contributions.

In closing, thank you to Panel 67 Treasurer Sue B for your direction. Questions from the floor

QUESTION 1: Hotel charges \$17.25 per person, this number is different from what was announced yesterday, as \$14.00. ANSWER: The quoted \$14.00 amount was in error. It is \$17.25 per person.

QUESTION 2: On Page 3, of the 49 groups that made contributions to the Area, if a group makes a contribution, is that 49 groups in only 8 districts?

ANSWER: The contributions are captured by groups alone and within Districts, District contributions are listed only by District.

QUESTION 3: Is there a way to do electronic transfers (*E-transfers*) to Area or GSO?

ANSWER: Currently it is not set up for E-transfers, but this is something I can look into.

QUESTION 4: You have reported that we have lost \$5K at this time compared to last year, what is the overall trending of our spending?

Answer: I am going to ask that you wait until we go through the Proposed Spending Guidelines in New Business. However, I can say in general we are pretty close to what is expected at this time.

QUESTION 5: Of the possible options on the Area 83 website for making online contribution, PayPal and pay by a card (e.g., Visa) appear to be available. However, when I tried to use the Visa, I was not able to continue on with the transaction.

ANSWER: I will check with the webmaster and disable the credit card button. We only accept payments by PayPal.

7. SECRETARY'S REPORT

Good morning friends, I am a member of the Liverpool Group in Pickering in District 26 and my name is Amy. I have the privilege of serving Area 83 as your Secretary. I am very much enjoying this position. My favorite part so far has been all of the contact I am having with members across the Area. 8. Roll Call and REGISTRAR'S REPORT

Dave L.

Good afternoon friends. I'm an alcoholic, a member of the Liverpool Group, in District 26 & my name is Dave. I have the honour and privilege to serve as your Panel 69 Registrar for Area 83, Eastern Ontario International and I am very grateful to be of service.

If this is your first Assembly, we welcome you. If you are a new General Service Representative and you are without your GSR kit, that's the bad news. The good news is, while you are waiting for your kit you can access the contents of your kit through the Area 83 website. If you go to the Registrar's Resource tab on the Area 83 website there is a link to the contents. If your mailing address, phone number or email changes, please send me an email (Registrar@Area83aa.org) so that I can keep your information up to date in the system. General Service Office (GSO) spends hundreds of dollars on return postage for mailings that are not picked up by the recipients.

I am responsible for updating group records & liaising with GSO and I have been busy doing that. The forms required to change Group information or add New Groups have been updated with my mailing address. Instructions are on the bottom of the forms. These forms are available on our Area 83 website, under "Resources" then by choosing the "Registrar" tab. It is essential that all information is filled out. If the mailing address is incomplete a profile cannot be completed and that individual cannot represent their group in the directory. Highlighting all changes make it so much easier for me. If you, as the GSR, are making changes on a form, send it to your District Registrar first to keep accurate District records.

District Group Information Sheets are sent to your District Registrars and DCM's in order to check for accuracy. I will be sending out updated Sheets by mid-April. Some of the groups listed have been identified by GSO as Unknown. Unknown means the group does not have a primary contact; primary contact may be a GSR or someone who has agreed to be the mail contact. Area 83 has whittled the number of Unknown Groups down to 2 thanks to the hard work of my predecessors, Amy and Sue, as well as some enthusiastic District Registrars and DCMs that I have been working with over the last 3 months.

The planned transition of the General Service Office's database, called Fellowship New Vision (FNV), to the new system, called the Enterprise Resource Planning system (ERP) has been delayed. GSO staff are still testing the new system and once they are comfortable with it, a roll out plan and date will be communicated to Area Registrars.

I would like to give a HUGE "Thank You" to the team from District 36, who were most generous with their time and assistance this weekend as greeters & behind the registration tables. Donna C has brought a huge sense of ease and comfort as I try to carry out the responsibilities of the Registrar at my first Assembly. Thank you!

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. When compiling the roll call, a lot of consideration is given to the vote, and ensuring that those who are entitled to vote, have that right. For this reason, a lot of care is put into interpreting the sign-in sheets. The result being, that the numbers will often not look, at all, like what was written on the sign in sheets.

For example, a District might have five people signed in as visitors, but when I announce the roll call, I might say there was only one. The reason is that I check each visitor against his or her group, and if the group does not have a GSR that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as a GSR.

Also, if an Alternate DCM is the only person representing his or her group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the assembly, is to serve as their group's representative.

It is very important if you sign in as a visitor, that you also write the name of your group. You could be voting for your group, but if you fail to indicate your group name on the sign in sheet, you may not be eligible to vote. Please

keep in mind that as you see the tally on the screen & hear the results, this is not a true reflection of who will be voting necessarily. For example, there are people who may have registered, but were only here yesterday & are not here with us now. So, the true reflection of who is voting is done by who is in the front of the room as a vote is cast & counted, if necessary.

In closing, I will make myself available to Districts and Groups to assist you with Registrar-related issues where I can, and please remember that communication is most important. Thank you for the opportunity to serve you. Yours in Love and Service, Dave L

Good morning, I am an alcoholic, a member of the Ajax Area Group in District 26. It is an honor and a privilege to be serving you this term as your Panel 69 Alternate Delegate for Area 83 Eastern Ontario International. My name is Kimberley.

As Intergroup Liaison Officer for Area 83 I participated in a Joint Sharing meeting at GTA Intergroup on Feb 5th and the Durham Intergroup meeting on March 9th. I plan to attend these meeting regularly to learn and provide support wherever possible. I phoned and had wonderful conversations with the Intergroup chairs for Ottawa and Peterborough. They explained how each of their Intergroups operate and I will follow up with them every few months to keep the communication lines open.

In January, I had the pleasure to facilitate a Group Inventory for the Hill Group in Toronto. What an incredible day of sharing.

Last month, I was thrilled to be invited to chair a workshop at the Canadian Eastern Regional Alcoholics Anonymous Service Assembly, aka CERAASA, in Laval, Quebec. It was great to meet the other 9 Delegates in the Eastern Canada Region and their Alternates. The Delegates gave their 2-minute Area Highlights which they will be sharing at the General Service Conference. Many of the Delegates presented on one or more Conference agenda items and the workshop attendees had a chance to provide feedback on these items. The discussions were quite interesting and informative. Our Eastern Regional Trustee, Jan Lemke, shared her story after the banquet on Saturday night and gave a brief presentation as our Trustee on Sunday morning. There were approximately 350 people in attendance on Saturday and many were attending their first CERAASA. Some held service positions, and some didn't. Several shared at the mic how heartwarming it was to meet AA family members from across the region. The next CERAASA will be hosted by Area 86 in Western Ontario in 2021. If you like the feel of being here this weekend with your AA family, then you would enjoy attending the next CERAASA.

The Alternate Delegate is the single point of contact and responsible for all matters relating to Remote Communities initiatives across Area 83. I represent our area in the inter-Area Remote Communities workgroup which meets by teleconference every other month. This workgroup includes 10 areas in Canada as well as Area 2, Alaska and Area 3, Arizona. In preparation to participate in the first teleconference, I read over the minutes from the past 2 years. In the report from area 78, Alberta/NWT it said: if anyone from your area would like to join our video meeting, click here. So, I clicked!! I attended the Spirit of the North meeting which used *Zoom* video for their open discussion meeting. Compared to phone meetings, I found that seeing faces and expressions made if feel more like a face to face meeting. Area 78 launched the Spirit of the North on line meeting in August of 2015. Although up to 50 members can join the call at a time, the night I participated there were about 12 members.

My goal in participating in the video meeting was to determine if these meetings, set up for Remote Communities, could use the support of our Area. It turns out that yes, these meetings need support and would welcome any members from our area that would be willing to participate. I was told that they currently have 2 weekly *Zoom* video open meetings. If you are willing and able, please consider participating in one of these meetings - even if you can drop in once. It's free – it just costs an hour of your time. In addition to supporting the meeting with your experience, strength and hope which is much needed, you would be conducting a little research to see how this type of meeting works. If enough of you had a chance to experience this type of meeting at least once say in the next 6 months, then

we would be in a better position, as an area, to discuss how we might be able to assist other Areas and remote communities in a more involved or formal way making use of this technology.

So how do you attend one of these meetings??

These 2 weekly open meetings take place on Sunday and Wednesday night at 10pm our time. I have permission to invite you to participate in this meeting and to give you the *Zoom* number for the meeting. If you are concerned about anonymity, you can use just your first name and disable the video option. *Zoom* is free to download, and I believe you can use a laptop, phone or tablet. Once downloaded, click "join a meeting" and enter this number: 8864590234. This information is also posted on our Area 83 website under the Resources tab — under Alternate Delegate.

How many of you have ever participated in a video AA meeting on line before? (less than 10 hands went up)

It turned out that the January teleconference meeting was rescheduled, and I couldn't attend the new date. The next meeting was held on March 18th where we used *Zoom* and it was great to be able to see the other members of the workgroup. Two members phoned in to be a part of the call. Area 2 Alaska is looking for one to one remote sponsorship. If you are interested, please contact me.

Thank you to those who attended the Concepts workshop yesterday. If you were unable to attend but would have liked to, then I would like to give an online version of the workshop next month. I would present the same workshop as yesterday, but it would be online. After the workshop we would have a question and answer period. A. Auditors Report for the Term 2017-2018

Joyce S., Panel 65 Delegate

Our Operating Procedures require that the current Area 83 Treasurer and two appointed auditors approved by the Area Committee shall audit the previous term's financial documents. The committee performed this obligation for the years 2017 and 2018 on Saturday, January 26, 2019. The committee was very pleased with the impeccable filing system of the previous Treasurer. It made this task all the more enjoyable.

The object of the review was to satisfy ourselves and to be accountable to Area 83 members that the revenue and expenses were property recorded and balanced. Also, that there were no major discrepancies in the practices that were in place.

Specifically, the Audit Committee reviewed the financial documents covering the period January 1, 2017 to December 31, 2018 in order to evaluate:

- 1) Completeness and accuracy of the recorded transactions.
- 2) Completeness and accuracy of the reporting.
- 3) That all recommendations from previous audit Review Committees were implemented.

Each committee member reviewed for each of 2017 and 2018, an entire month's transactions to reflect various types of situations such as: a month with an assembly, a month with an Area Committee meeting and the last month at random. During this process; large transactions like General Service Office Assessments, Ontario Delegates Committee Meeting expenses, Ambassador Hotel bills, and Grapevine seasonal's were reviewed.

Bank reconciliations were reviewed, with income transactions traced back to bank deposits and to group and district contribution files. Expenses in random months were reviewed and traced back to the cheque register.

The expenses for both years, for the following Trusted Servants were reviewed for accuracy, reasonability and completeness: Archivist, Archives, Public Information, Cooperation with the Professional Community,

Treatment/Accessibility, Grapevine, Self-Support, Corrections, Treasurer, Secretary, Chair, Alternate Delegate, Delegate and Immediate Past Delegate.

This sample covered the widest array of expenses.

To the best of the Audit Committee's ability, all records which were reviewed were found to be in order, with no discrepancies noted.

The following are the recommendations of this Audit Committee:

- 1) When dealing with cash transactions a detailed explanation of the source of funds should be reflected in the records.
- 2) Whenever possible, receipts should be attached to all expense reports. This recommendation has been made by several previous Audit Committees.
- 3) It is strongly recommended that when literature is purchased that Area 83 support our General Service Office rather than local Intergroup Offices.
- 4) Before contributions are forwarded to our General Service Office, a motion should be made, discussed and voted on at Area Assemblies, if the Treasurer deems the Area has sufficient funds to pass on.

B. 2019 Financial Guidelines

JoAnn P., Area Treasurer

The purpose of the proposed spending guidelines is to give members of Area 83 a rough idea of what the expenses for the year might be and the income required to carry out the services provided by Area 83. As with any projection, some amounts will turn out to be higher or lower than the proposed spending guideline. Predicting expenses is difficult because of several factors.

Typically, the proposed spending guideline has been forecasted using the average expense for the past four years. Step one in this process is to use these average figures as a starting point. Next, I adjust some of the category amounts that I am sure of at this point in time (CERAASA, GSC Assessment, Deposit for ODC). Third, I use the 2019 rates for accommodations and Assembly costs and lastly, adjustments based on 2018 actual amounts.

On Page one (Appendix E), under Income:

- Beside <u>Contributions to Match Expenses</u> is an amount that is NOT based on the four-year average. The
 amount here is the required Contributions from Groups and Districts that would be required to cover
 the proposed amounts to effectively carry the message to the still suffering alcoholic throughout Area
 83.
- Grapevine Seasonal values may vary slightly as the Grapevine Chair must determine costs for Pocket Planners and Calendars months before the payment is actually made to Grapevine Inc. In the interim, it is possible for the exchange rate to fluctuate drastically which has happened in the past.

Under Expenses:

- Committee expenses are grouped by category, a detailed breakdown is on page two (Appendix F).
 Miscellaneous expenses include setting up the ball room for both Assemblies, any Audio/visual
 equipment we may need, and a small amount for all Area Committee positions. Again, this amount may
 or may not be used.
- The General Service Conference (GSC) Assessment is an actual amount. As voted on by the Area Assembly in the spring of 2007, that we become fully self-supporting in sending our Delegate to the GSC, I remitted, on behalf of Area 83, the total amount of \$8,300.00 US which at the time came to \$11,177.64 CDN.
- CERAASA (Canadian Eastern Region Alcoholics Anonymous Service Assembly) expenses are final as the
 event took place in Laval, PQ February 22 24, 2019. This amount is for Area 83 Delegate, Area 83
 Alternate Delegate and Area 83 Immediate Past Delegate to attend.
- Area 83 will be hosting the 2020 Ontario Delegate's Committee in March of 2020 and a facility has been booked (Airport Holiday Inn) which required a deposit of \$1200.00.

On Page two (Appendix F), under Accommodation, Meals and Travel:

- For the various positions, it is difficult to predict accurately. Area 83 covers a large area and Area Committee Members and Sub-Committee Chairs reside in all outlying outposts. Some actual amounts will be higher and or lower than the guideline. Districts may absorb some of these costs by financially supporting Area Officers and or Sub-Committee Chairs they invite to Service Days, etc.
- Spring Assembly, under meals, \$6,900.00. This amount is \$17.25 (actual) charge per person for Assembly weekend by the hotel for supplying coffee/tea/pop and various other items. We are not charged for the majority of meeting room rentals and cleaning of the atrium. Looking across to Miscellaneous are the amounts for the projectors and the AV equipment used this weekend, and for the setup of this room.

Fall Assembly, under meals \$7,200.00. This amount works out to \$18.00 (estimate) per person which again covers much more than the cost of refreshments. Over the course of the Assembly we use 11 meeting rooms and the room rental cost is factored in to the refreshment charge per person.

Total Other Expenses

Area Contribution to GSO (General Service Office) has been estimated at \$1,500.00. In 2018 we remitted \$5,000.00 to GSO and with the ODC (Ontario Delegate's Committee) being hosted by Area 83 next year, funds will be needed for that service opportunity.

MOTION: *To remove "*except the Area Chairperson" *from the Operating Procedures in* Section IV: A., II, 6 and B, II, 6 (see Page 11 and 13).

Note: Motions from the Area Committee Meeting (ACM) do not need to be moved or seconded at the Assembly. Kimberley originally made the motion at the Area Committee Meeting in January 2019, and here spoke to the motion for the Assembly.

Rationale for the motion:

Last October at the Fall Assembly we elected the Area Officers that you see here today (Secretary, Chair, Delegate, Alternate Delegate, Treasurer and Registrar). In December, at the Area Committee meeting, the Area Committee, except the Chair elected the subcommittee chairs, (i.e., Area Grapevine, Area Public Information Chair, etc.) that you heard reports from this morning. It was at the elections in December it was pointed out that there was an anomaly in the Operating Procedures.

The Operating procedures state that all members of the Area Assembly are eligible to vote in the elections of the Area Officers in October, this would include the Area Chair. This of course makes sense, because the Area Chair is eligible to stand for the positions, so they are eligible to vote. However, when it comes when it comes to the election of the Sub-Committee Chairs that takes place in December, the operating procedures state that members of the Area Committee except the Chair, are eligible to vote. This was the anomaly that was mentioned.

Some felt it referred to the chair of the elections, but it specifically says Area Chair. Let's suppose that the Area Chair stood for a position in October and did not get elected. Then they would be eligible to stand for a Sub-Committee Chair position at the election in December. However according to our operating procedures, they would not be eligible vote, not even for themselves.

I inquired with past Delegates and past minutes to see why this might be the case. So far, the best rationale I've found is that if the Chair is not eligible to vote, they then can facilitate the elections of the Sub-Committee Chairs. These elections typically take place once every 2 years. This could save the Area travel reimbursement costs for the facilitator.

Of the past 7 elections held for the Sub-Committee Chairs, only twice did Area Chairs choose to facilitate the elections themselves. For the other 5 elections, the Area Chair had a Past Delegate facilitate the elections. Some of these Delegates were reimbursed and some shared rides and did not need reimbursement.

After talking with some of the past Area Chairs, it is possible that they voted in the December elections at the end of their term. I of course did not vote, but then I got to thinking about this inconsistency and wondered if we wanted to address it.

To summarize, here are four reasons why we might permit the Area Chair to vote at the election of the Sub-Committee Chairs:

- 1. To create consistency between the elections of the Area Officers and the elections of the Sub-Committee Chairs so that all members of the Assembly vote at the first, and all members of the Area Committee vote at the second.
- 2. The Area Chair is a member of the Area Committee. Over the term, they have been working closely with and have come to know the other members who are standing for the positions. Their vote could be considered just as valuable as every other member of the Area Committee.
- 3. The Area Chair is eligible to stand for a position, and therefore should be eligible to vote.
- 4. As the operating procedures are now, there is a loop hole where it is conceivable that an Area Chair could decide to facilitate the Sub-Committee election and also stand for a position in that election. Although we hope this would not happen, it is possible.

One reason against this motion is of course is to permit the Area Chair to facilitate the December elections if they choose. This may or may not save the Area a small amount of money.

	This motion was passed at the January Area Committee Meeting with the elections still f minds. Because it does affect the Operating Procedures, it must be brought forward to t today.			
	In the motion there are 2 locations referenced in the Operating Procedures where this language would need to be changed. The first location refers to the section for the Bi-annual elections, which we just held in October. The second location refers to the section for interim elections. The interim elections take place when a Sub-Committee Chair or Officer steps down and another election is required to fill the vacancy before the conclusion of the term.

motion:	The Service Information Day Committee looks after and organizes our Friday night speaker meeting and the Saturday night Banquet speaker meeting and all the Workshops on Saturday.	
	According to the Chairpersons script for both speaker meetings when closing, the Chair asks, "For those who wish, please help us close the meeting with the Responsibility Declaration and the Lord's Prayer." The same request to close all workshops with the Responsibility Declaration only is also indicated on the individual Chairpersons scripts. I ooked back on the past 3 terms (6 years) to see what past practice was and the closings have been identical.	
	At the Area Committee Meeting on June 2-2018 our Panel 65 Delegate (Joyce S.) brought forward the following discussion on the agenda:	
	13b) "Discuss how to close all meetings held over the Assembly weekends "	
	There was a lengthy and passionate discussion held and everyone had an opportunity to weigh in on it. However, without a MOTION on the floor, all this was, was a discussion and no resolution could effectively come from it, and the discussion since no time limit was put on it could have gone on forever, still with no outcome one way or another.	
	In Alcoholics Anonymous we are all about ACTION and finding SOLUTIONS and recommendations and suggestions. This is also one of the roles of the Area Committee	

who are in fact the Steering Committee for the Area. With no end in sight to a discussion with no motion attached, I put forward the following motion,

"We close the Friday and Saturday night speaker meetings with the Responsibility Declaration AND the Lord's prayer. All the workshops close with the Responsibility Declaration only."

This motion was put forward by me and was seconded so we could have a structured discussion and if needed, the question could be called, and we could go to a vote and finally put this topic to rest with a resolution to it. And this is exactly what happened.

Here's how the vote went at the Area Committee Meeting in June of 2018,

In Favour - 22

Opposed-8

Abstained 3

The voice of the minority was given an opportunity to speak afterwards and those who voted in favour of the motion were asked if anyone wanted to change their vote and no one did. The Motion was carried and was to be brought to the Assembly floor. So here we are today.

When we talk about Prayer in AA it can be a sensitive subject for some and passionate debate can grow from it and that's a good thing. Today, I will be voting against this motion in hopes that it will be defeated, and our Service Information Day Committee can decide from year to year or term to term on how to close our meetings as has been past practice.

If this motion is passed, then we will by tying the hands of our Service Information Day Committee to follow our collective Group conscience and the Lord's Prayer and Responsibility Declaration will be recited. If the motion is defeated, then it leaves room for our Service Information Day Committee who are all Trusted Servants to listen to the spirit of our membership and make a decision as a Committee depending on what they hear during our discussion today.

I had the opportunity to serve on the past Service Information Day Committee and from my own experience the members of our Committee listened carefully to all and any suggestions made by our members and I have confidence that this Service Information Day Committee and future Committees will always listen and make decisions in the best interest of our membership and AA as a whole."

Discussion from the floor

- I would like to see AA stay the way it has been. The Lord's Prayer has been with AA since the beginning.
- Service day committee is going to have their hands tied. This takes the responsibility away from the committee.
- We are a fellowship that is a non-religious and non-Christian organization. I understand it is a tradition, although I believe this is 2019 and we are more diverse and need to be more inclusive.
- Instead of the Lord's Prayer, I would much rather say the declaration of unity, or responsibility, but not both.
- How do we hold our values in AA without excluding our membership?
- I have heard first hand that some who are not Christian are "afraid" to come into AA.
- If this motion makes one person feel unwelcome, are we fulfilling our mandate?
- This goes against the progressive actions of AA which has been working so hard to be more inclusive.
- Responsibility is what unites us all at the Assembly.

- Trusted Servants are trusted servants.... A letter from Bill W. from Russ to practice love and tolerance.
- It was a Hebrew Rabi who wrote the prayer, suggesting it is not a Christian prayer.
- For Groups that chose to recite the Lord's Prayer, I have an option to go to that meeting or find another meeting that doesn't recite the prayer. However, the Service Assembly I do not have a choice.
- Communications Audit from GSO- concluded that we are viewed as a religious organization and we are resistant to change. Here is an opportunity to work on both.

Concern - Remarks on women's appearance, inappropriate comments, nicknames, sending members away, no police. Has been asked to stay away, but a stroke victim and does not remember, continues to attend meeting and comments

Discussion - Love and tolerance, may think that he is giving confidence even though not being received that way. Explain perception of receiver

Has tried to discuss but has not worked & barring a member from meeting is difficult

Concern – Inappropriate Facebook messaging, started innocent then crossed the line. Women feel violated. Has been asked to stop but won't.

Discussion – starts out small but then snowballs when allowed to continue, announce at meeting to group, BLOCK OR DELETE, needs to NOT happen to newcomers – so must be addressed immediately

Concern – Harmful gossip, very critical of other members

Discussion – we vent as humans, personalities exist. We can share frustrations with a discreet member, no names or specifics need to be mentioned, just our part

Concern – female newcomer, men swarming – women can't even get close

Discussion – Push your way in "boot" them out of the way. Reinforce men to men / women to women. Discuss at business meetings

Concern – Common Sense, bad behaviour is expected. Fight between members at a meeting where police were called and arrived at a member's door after the fact. Most members that were present found that it should not have happened / was not necessary.

Discussion – read safety card and unfortunately common sense is not so common

Concern – Femi-Nazi "can't say anything" Young woman hit on by older men – need to protect victim. Mentioned at big meeting "opening a can of worms" Explain perspective / perception. Need to be brave enough to approach both sides

Discussion - need to be brave enough to approach both sides. Often better received from another man
