1. OPENING

Meeting opened at 9:00 am

Good morning everyone. I'm an alcoholic, a member of the

GSM in District 10, and my name is James O'D. I have the honor and privilege of serving as Area 83 Chairperson for the 2019 – 2020 term.

Let's begin with a moment of silence followed by the Declaration of Unity (which can be found on the second page of the Service Manual across from the title page). If we could have that moment now please.

Twelve Traditions read by Allie, Alt GSR 12 Traditions District 12; the Twelve Concept (Short Form) read by Jan M., GSR Sober Sisters, District 26. Welcome everybody to the Fall Assembly. This is day one of our two day historic first virtual Assembly.

Introduction

This is the final Assembly of this term. During the remainder of this two-year term, we will be working together to provide continued strength and direction to A.A. in Area 83. Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together is the key for continued Unity in our Area.

The A.A. Service manual defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." Just as most District tables meet monthly to oversee the affairs of A.A. in the District, and home Groups usually have regular business meetings to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83.

Area 83 Eastern Ontario International spans Eastern Ontario and Northern New York from Oakville to Cornwall and from North-Eastern New York State all the way to Pembroke. We are made up of 578 active groups, including 8 Correctional Institution Groups and 25 Districts.

Some of us have been here before as a General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some, it will be their first Assembly and from personal experience it can seem overwhelming! How many of you are here today attending your first Assembly? Could you raise your hand? Looks like about 15-20 waving hands. That's awesome!! Welcome!

Being in service is a great way to give back to AA. You will not be expected to learn or understand everything the first time or even second time. It takes time but it will make sense. Many of us didn't understand what was going on at meetings at first, but in time, we started to understand. Service is much the same way. So please keep coming back – welcome and enjoy the rest of the assembly.

Over these two years, we have made decisions on a variety of topics. The Area Assembly, like the General Service Conference, strives for substantial unanimity through ample discussion. Before a vote is held, plenty of time is taken for full discussion and questions. It is my hope that you will return to your Groups and Districts with the feeling that you have done your part in keeping Alcoholics Anonymous strong and vibrant in your area and that you have had a strong voice in Area 83. With a spirit of love and cooperation, we will be able to get things accomplished and have some fun while we're doing it.

Who May Address the Assembly?

Only voting members of the Assembly have a voice. These are:

- All Area Officers, including the Immediate Past Delegate, but not the Chair.
- All Area Sub-Committee Chairs
- All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.
- All General Service Representative's of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may approach the mic. This includes the General Service Representatives of recognized Correctional Facilities groups.

- members are carrying and presenting their Groups' wishes, rather than their own.
- And it maximizes the time available for those members to voice their Groups' opinions and needs.

District 02 Malton

Good morning all, I am an alcoholic, grateful member of the KF Group and have had the honour and privilege of serving as District Committee Member for District 02 – Malton and my name is De.

Pre-Covid, attendance at our business meeting was approximately 60%, however since April attendance has fallen to 20%. We continue to keep our General Service Reps informed by forwarding information from the Area and General Service Office, and various workshops made available to us. Perhaps our GSRs are having information and email overload. We have discussed how to improve attendance and hopefully we can encourage our GSRs to return to the District Table and subcommittees before end of term.

Financially, we are stable and have some contributions from our groups and 7th tradition.

Three of our groups have re-opened with suggested public health, and guidelines provided by the churches we are holding our meetings in. Even though masked and sitting and standing away from each other, it felt good to be at in-person meetings again. Although with so many masks I realized I rely heavily on lip-reading. District 06 Mississauga

Good Morning Friends, I'm an alcoholic, member of Daily Reflection Group in Oakville. I have the honor and privilege to serve as the DCM for District 06, my name is Susan.

Our virtual Business Meetings continue to be well attended with on average 27 GSR's, their alternates and guests. This represents 60% group participation. Online meetings continue plus three groups and one service group have opened in person meetings. Our Webmaster Ivy has been diligent in keeping the aamississauga.org website up to date.

Our finances remain in good shape. In August our Treasurer, Jill, put forth a motion to disburse funds beyond our prudent reserve with \$1000 to GSO and \$500 to Area. The motion was approved. In July we approved the motion to accept electronic contributions.

One of the Treatment facilities had opened their doors to us but with the upswing in COVID cases they have shut down again. Toronto South Detention Centre also remains shut to meetings. Robbie our Corrections Chair has collected used Grapevines and will be dropping those off.

In June we held elections for our 2021/22 DCM and ADCM positions: Nat S. from Bloordale is our incoming DCM and Jill B. from Erin Mills is our incoming ADCM. This month our elections were held for the positions of Secretary / Treasurer and it was thrilling to see two members stand and following our Third Legacy procedure we went to the third ballot. Ivy from the New Life group was elected into the position. We also voted in Bart from Credit Valley as our Webmaster / Registrar. District 6 has enthusiastic leadership coming into the new term.

Next month we will hold an information session at our business meeting. Amy L. our Area Secretary will share on "What is the role for the GSR" and Mel C. past delegate on "Service Position Opportunities". 2018 was the first time we held this workshop and there was standing room only!

I thank all of District 06 for their fellowship and service. It has been a tremendous opportunity and a pleasure to have served as their DCM over the past two years. Thank you for my sobriety.

District 10 Toronto South Central

Hi everyone. I'm an Alcoholic and my name is Ann. I'm a member of the Eglinton Park Group in Toronto and am honoured to be serving as your DCM for District 10.

<u>Overview of Groups and Participation</u>: District 10 is a vibrant and diverse district of 26 groups from a broad range of demographics. Currently, all but two of our groups have contacts and 19 have GSR's. We average 80%-90% GSR attendance at our monthly District meeting, with between 16-22 attendees, which is amazing. The GSR's reports are a highlight, including valuable exchanges of group experiences, ideas, and information.

<u>Group Activities</u>: Currently 24 of our 26 groups are holding about 45 online meetings a week. C three groups have moved back to in-person or hybrid meetings and they are going quite well. Barriers to reopening include venues not reopening, inadequate room sizes, and health and safety concerns. Some groups are looking for new homes.

Groups with an electronic 7th are up from about 30% in April to over 75% in October, and are still experimenting with processes and approaches that work for their membership. Many are now making contributions, with a focus on GSO and Intergroup, as they deem them the most in need at the moment

<u>People and Positions/ Service Commitments and Service Committees:</u>

We're so grateful to have so many people participating in District service in these unusual times. We do have 3 Committee Chairs open at the moment and will be holding elections for the 2021-22 Committee/Liaison positions at our November District Meeting, so who knows!

In September we resumed two of our six Treatment Service meetings on Zoom, CAMH and Women's Own. Attendance has started to pick up and become more consistent, which is encouraging. Our Treatment Chair is working with the other 4 to encourage them to restart with the objective to be back to our 24-26 service commitments a month in the new year.

<u>Finances & District Activities</u>: We currently have an ad hoc team working on updating and revising our District Operating Procedures, focusing on content, flow, and processes, as well as role descriptions. Our goal is to have a first version approved by the table in December to be followed by 2nd version in 2021. It's very exciting actually, and so important to have cohesive procedures and guidelines. Overall, D10 is currently financially stable. Contributions are down significantly from the same time last year, but so are expenses. Part of the Procedures

work is assessing our prudent reserve and expense requirements, as well as projected 2020 year-end balance. Once complete, in December we will put forward a motion for contributions to Area and GSO.

Summary

Our 2021-2022 officers were elected in October with the exception of Alt DCM, which we're confident will be filled in November along with the Committee Chairs. In 2021, as well as new faces at the table, some of our members are returning, a great mix of new and experienced.

Overall, 2020 has been a busy and challenging year. I'd like to thank the Area for providing us with so much guidance, information and support, in so many ways. And a special thanks to the members our District table, who have remained active, upbeat, and creative. I can't say enough how grateful I am to be part of such a dedicated and enthusiastic District.

District finances are healthy. Grupo Amistad keeps holding the meetings VIA ZOOM on Mondays, Wednesdays and Fridays from 8:00 pm to 10:00 pm. And the other days the in-person meetings are held at 1560 Dupont Street at the same time. The group follows the government's guidelines of cleanliness and social distance, and the maximum capacity is 10 members. B. Cooperation with the Professional Community

Bill C.

I am an Alcoholic, a member of The West End Group in District 74 Pembroke, and my name is Bill. It is my privilege to serve you as your Area Cooperation with the Professional Community Chair for this term of Panel 69.

Since our last Assembly CPC has been busy despite the restrictions imposed by COVID-19. We continued our regular CPC District Chairs meetings through the summer and early fall. Over the course of almost two years these Zoom meetings have served as a meeting point where we have had lots of great discussions and ideas regarding challenges and solutions to getting the message to professionals that AA in our communities and is there to help their clients with a drinking problem. We have been able to reach out and make inroads with Mental Health Centres, the Military (Military Family Resource Centre (MFRC)), local colleges and treatment facilities and various legal, medical and police departments throughout Area 83.

Our "Pay it Forward" project has moved along and evolved considerably. We have finalized a set of materials which, as CPC Chairs, we can pass along to the next incoming Chair. This Project documents our collective experience and provides suggestions for incoming Chairs. For example, two of the easy to implement actions, but with big impact, that emerged from this project are having a District-level email address that stays with the position rather than a personal email address and a simple spreadsheet (suggested template developed) that can be used to track contacts and follow-up over the service of an individual. Both of these actions make it much easier to have a more continuous level of service over different Chairs.

An article was published in Box 459 this summer outlining the ways in which CPC in Area 83 has been responding to carrying the message to professionals given the COVID-19 pandemic. I was invited to participate at a CPC meeting organized by the San Francisco Bay-Area CPC committee on 25 July 2020.

On the North American initiative, we have had three meetings since our Spring Assembly. About half of the 93 North American Area CPC chairs that joined in each of these meetings. The Google Groups forum we established is working well. We are building a resource which future CPC chairs will be able to access, build upon and improve. The working group to organize a CPC Conference has finalized the agenda. The Conference is scheduled to go on 22 and 23 May 2021 (our Victoria Day Holiday) in Montana. As currently organized, it is planned to be an in-person and virtual conference.

D. Treatment Facilities/ Accessibility

Hi Friends, I am an alcoholic and my name is Shane. Grateful member of the Reaching Out Group in Brampton and grateful to serve as your Treatment and Accessibility Chair.

Treatment: it is very institutional. Once Covid hit, things went pretty dark. There have been some districts that have been able to get meetings into Treatment Centres via Zoom. Very little luck, but some have been able to do that. The Bridging the Gap (BTG) requests are slowly starting to come back. Before Covid-19 hit, I placed 240 BTG requests. Since March, I have done approximately 43. I have had a lot of shared experience to give to GSO. They are thinking of doing a Bridging the Gap workbook, as some might have heard. As a result, they have been going around giving questionnaires to Area Chairs. I have been busy, so it took me 2 weeks to get those questions in, but they are in. Things are starting to look up. Once Covid starts to dissipate, we are going to see a lot more BTGs. I am already getting 1-2 a week, even with Covid.

4. TREASURER'S REPORT

JoAnn P.

Hello friends, I am an alcoholic, a member of Courtice 12 and 12 Group in District 28, and my name is JoAnn. It is both an honour and a privilege to serve as your Panel 69 Eastern Ontario International Area 83 Treasurer.

It seems that although we have been physically distancing and unable to meet in person, the legacy of service in Alcoholics Anonymous continues in Area 83 and beyond. I have had the pleasure of facilitating District 28 Lakeshore East elections on September 13th, I assisted our Area Secretary Amy with District 30 Quinte West and District 26 Lakeshore West elections in October. I attended the Area 83 Service Information Day Sessions held over the past 2 months, participated in Service Information Days where we heard our Delegate Rob M share his report of the virtual 70th General Service Conference, attended information sessions regarding virtual elections via Area 79 Yukon and BC and even went on a "tour" of GSO and Grapevine thanks to Area 11 Connecticut.

I am grateful that Area 83 Eastern Ontario International is navigating our current reality and continuing to serve the still suffering alcoholic. My tasks as Treasurer have slowed considerably. I know that for most of us, our Groups are meeting on video conferencing applications. Some groups have reached out regarding starting e-Transfer for their home Group. This mode of contributing to Area 83 is convenient and safe. If you would like assistance setting up e-Transfer, I would be happy to help. Our 7th Tradition is as equally important today as it was before the pandemic.

Before we talk about the numbers, I am going to again reference the integration of ERP (Enterprise Resource Planning) system has caused some difficulty in timely acknowledgement of Group and District contributions to GSO. Each Group (after integration) has 2 identification numbers — one is your 6-digit Legacy Group Number (Group Service Number), and one is a new 9-digit number which will be called a Group NetSuite Number. Any new Group will be assigned a NetSuite 9-digit number only. The Legacy Group number will be able to be used in all communications with GSO. While these Legacy Group numbers will not be used in new communications from GSO, your information as a Group will be accessible. In my communications with Groups, I have started to reference Legacy Group Numbers and NetSuite Numbers. There will be a time that only the NetSuite 9-digit number will be used, however, I have no timeline to report. Area Registrar Dave L will be reporting on this issue.

Please continue to remind groups who would like to contribute using PayPal to include their six-digit Group Service Number with any contributions using PayPal so that the group may get credit for their contribution. The place to enter the group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. There have been 2 contributions, so far, this year using PayPal.

There have been 45 contributions via e-Transfer so far in 2020. This method of contributing to Area 83 is proving to be uncomplicated for the Groups and straightforward to process Letters of Receipt. Please consider this payment method when your Group or District discusses contributing to Area 83. As with all contributions, please reference your Group and or District Name and Service Number in the memo field. We

will be addressing a motion tomorrow regarding accepting individual contributions to a maximum of \$1000.00 per year and I look forward to that discussion.

When a Group or District sends in a contribution, they will receive, in return, a thank-you letter of receipt. Emailing these to you costs the Area nothing, whereas mailing them requires a stamp, envelope, paper, and ink. Please encourage your Treasurers to include an email address with your contributions, and I can email your letter of receipt. Please make your cheques payable to "Eastern Ontario International Area 83". You can find contact information on the Area 83 website: area83aa.org under the tab "About Area 83" click on Area Contributions.

I have prepared the Proposed Spending Guidelines for 2020 which will be discussed Sunday during New Business.

Let's discuss the Financial Statements for the period ending October 17, 2020.

Page 1 (Appendix A) is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 in the form of a GIC which matures September 11, 2023.

Income for the period as of October 17, 2020:

- 7th Tradition collected at the January (in person), June (virtual) and September (virtual) Area Committee Meetings - \$827.05
- Cost Recoveries \$56.00
- GSO Flow Through \$1,110.00
- Grapevine Seasonal \$1,805.00
- Group and District Contributions \$21,745.35
- Interest transferred from Reserve \$300.66 (GIC Matured September 11, 2020)

Total Income for the period is \$25,844.06

Expenses for the period as of October 17, 2020:

- Committee expenses are \$5,977.43
- Area Committee Meeting, January 4th rent and refreshments \$477.19
- General Service Conference Assessment \$8,821.80 (US\$ 6,500.00)
- Bank Service Charges \$27.40
- PayPal Fees \$5.25
- Grapevine Seasonal \$1,456.09
- GSO Flow Through \$1110.00
- Ontario Delegates Committee \$5,663.02
- Refund regarding Eastern Canada Hospitality Suite at International Convention \$150.00

Total Expenses for the period are \$23,385.18.

The opening bank balance on January 1, 2020 was \$40,490.20. Total income of \$25,844.06 less expenses of \$23,385.18 leaves a balance in the operating account of \$42,498.08. As of October 17, 2020, our expenses were \$2,457.88 less than our income. Thank you to the 89 Groups and 11 Districts for your generous contributions to Area 83.

Page 2 (Appendix B) shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member as well as all other expenses to date.

Some of the numbers you see here:

- The amount shown under Miscellaneous for Alternate Delegate is \$417.66 which covers our annual Area 83 Zoom Standard Pro account until early June 2021 (\$235.70) and 3 large group add on charges (\$181.96).
- The amount shown under Printing (\$285.00) for Secretary is for September 2019 ACM minutes and January 2020 ACM Agenda.
- The amount shown under the Treasurer for Stationery is for a \$173.20 cheque reorder.
- \$701.54 for Service Manuals some of this may be recouped at the next physical Area Assembly.
- The amount shown under Registrar (\$192.21) is for an order for name badges.
- Spring Assembly amount of \$1,288.25 is the cancellation charge levied by the Ambassador Hotel. We will be receiving this amount as a credit in a future period when we are able to gather en masse.
- Fall Assembly amount \$916.64 (US \$677.70) is for a 20% deposit paid to Check 2 AV for the technical requirements for our virtual Assembly. The balance payable will be approximately \$2,710.80 USD, and this will be reflected in the next report.
- Rent and refreshments for the January 4th ACM is \$477.19. We met in Quinte West.
- Bank Charges and PayPal fees are \$32.65.
- Grapevine Seasonal cost is \$1454.09.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to attend the General Service Conference". Area 83 calculated \$6,500.00 US\$ (Canadian \$8,821.80). This amount was remitted to GSO in January of 2020. The GSC Assessment covers the total cost of the General Service Conference divided by the 93 Delegate Areas. Traditionally, these costs include expenses for Delegates, Trustees, and GSO staff to attend, as well as meeting rooms, A/V equipment, printing (includes the final conference report sent to each group) and miscellaneous expenses. With the 70th General Service Conference moving to a Virtual Conference, Eastern Canada Regional Trustee Jan L, reported that each Area contributed the required \$1,800 and some contributed more. The total amount received was \$14,000 less than the cost of the virtual GSC.
- Ontario Delegates Committee is \$5,663.02 for event hosted by Eastern Ontario International Area 83 in Toronto February 28-March 1. This event is to prepare the 4 Ontario Delegates and 4 Alternate Delegates for the 70th General Service Conference. These costs were for hotel meeting rooms and refreshments, organizing committee hotel rooms, meals and transportation, and guest presenter's hotel rooms, meals, transportation as well as the organizing committee's printing and stationery.
- Flow through amount forwarded to GSO on behalf of 3 Groups and 1 District in Area 83 (\$1,110.00).

To summarize, our financial position for year to date 2020 compared to year to date 2019 is as follows: Income for 2020 is \$26,105.21 less than the same period in 2019. Expenses to date for 2020 is \$28,178.56 less than the same period in 2019. The net change to the Operating Account is \$2073.35. The reduction of contributions in 2020 versus 2019 is \$20,763.07.

Page 3 (Appendix C) shows contributions by District. These amounts include contributions from Districts, as well as Groups. 89 Groups and 11 Districts have contributed to Area 83 in 2020. There are 47 less Groups and 4 less Districts contributing in 2020 versus 2019.

We will be collecting a 7th Tradition throughout the Assembly weekend. Please e-transfer your contribution and reference Fall Assembly in the memo field. Email address is treasurer@area83aa.org. I will group the contributions and report the total at the November 28th virtual Area Committee Meeting.

As we navigate the remaining 2 months in 2020, we will have very few expenses paired with a possible continued reduction of Group and District contributions.

Please rest assured that Area 83 Eastern Ontario International is financially stable and ready to withstand any challenges as they appear. Yours in Love and Service, JoAnn P.

Hello friends! I'm alcoholic, a member of the Liverpool Group in District 26 & my name is Dave. I have the honour & privilege to serve as your Panel 69 Registrar for Area 83, Eastern Ontario International and I am very grateful to be of service.

Thank you to those who attended the Registrar Workshop at the Service Information Day session on August 30. This has been a challenging term as Registrar.

The General Service Office transition to the NetSuite database continues to have some challenges with the quality of the data. Work continues on the "clean up" of the data. The backlog of data changes sent to GSO for inputting has reduced from 17-weeks down to 1-week. No timelines have been communicated about the further phased rollout of My Portal functionality to Area Registrars.

Since the NetSuite data is still not totally reliable, I continue to maintain a separate database with up to date Area 83 Group information. For now, all changes to Group, GSR and Alternate GSR information, should continue to be sent to me by way of GROUP INFORMATION CHANGE FORMS.

There has also been a lot of work to prepare for this Virtual Assembly. We had to rethink how the registration and roll call preparation could work in a virtual setting. I recruited and trained 26 AA Members to be the Virtual Registration Desk Volunteers who will register attendees and enter their District, Group & Position information into the Roll Call spreadsheet. These needs to all happen Sunday morning largely between 8 - 9:30 am. I greatly appreciate the commitment of these 26 individuals to make the registration process effective tomorrow.

As attendees pass through the Waiting Room, they will be sent to Breakout Rooms, manned by the Virtual Registration Volunteers. It is also critically important for attendees to log onto ZOOM as early as possible (starting at 8 am) on the Sunday (October 25) to be registered. Please log on at 8 am, then grab a coffee, have breakfast and or walk the dog.

It is also critically important that your Group has a representative who will vote on behalf of your Group tomorrow. If your Group General Service Representative is not attending tomorrow, clarify with them who will be voting for your Group.

Currently, Area 83 has 579 active registered groups. Every group should have a representative registered with GSO. That could be a GSR or a Primary contact for the group. When a group does not have a representative, they are considered Unknown To GSO. Area 83 currently has only 1 Unknown Account.

We are coming into a new term and I expect that many Groups are rotating their service representatives. If you are a new General Service Representative make sure that you pass your information on to the District Registrar. Your District Registrar will send the changes to me. I will then forward the information to the General Service Office for inputting. To the District Registrars. I am happy to receive group change information any time between now and January 1.

Once your data is entered, it takes approximately 3-4 weeks for your GSR kits to be mailed. While you are waiting for your kit to arrive we have a link to the contents of the GSR kit online, if you go to the Registrar's Resource tab on the Area83 website (http://area83aa.org/resources/area-registrar).

Tomorrow morning, before I give the roll call, I will give a brief explanation of the process of compiling the tally.

Thank you to those Districts that send me their minutes, it has been nice following your District's activities. Thank you for this opportunity to be of service to AA.

QUESTION: you mentioned a 9-digit number, what are you calling this? ANSWER: It is called a Net Suite number.

COMMENT: it is important that each group is represented at the Assembly, and if you do not see your GSR here, touch bases with them. And make sure they are or are not going to be here tomorrow. If they will not be there who will be the voting member of your group.

QUESTION: Ron C., GSR, D86: Where do we find the Net Suite number?

ANSWER: They haven't formally broadcast out to the groups yet, and you can still very easily use your service group number, also called the Legacy number. However, if you have an interest in getting this number, I can send it to you, just let me know.

7. AREA CHAIR'S REPORT

James O'D

Good morning everyone. My name is James O'D. and I'm an alcoholic. I have the privilege to serve you, Area 83, as your Chairperson.

The Chair doesn't have a voice or a vote for two years...TWO YEARS! And you would think that after all this time that I would be overflowing with things to say...but I am not. I will keep my report short and to the point.

While we as an Area have accomplished many things to date over the term, I would just like to stop and take a moment to acknowledge everyone in this room who has played any part in keeping Alcoholics Anonymous alive and strong through this very difficult time. I have watched our fellowship move from face to face meetings almost overnight to virtual platforms. Many of us had grave concerns and reservations – yet we persevered. We as a society did not skip a beat to continue to reach out to the still suffering alcoholic.

8. ALTERNATE DELEGATE'S REPORT

Good morning, I'm an alcoholic and a member of the Ajax Area Group. I am so grateful for this opportunity to serve as Panel 69 alternate Delegate for Area 83 Eastern Ontario International, and my name is Kimberley.

I miss seeing everyone in the Atrium of the Ambassador, in the workshop rooms and greeting you all at the entrance of the Ballroom. We are fortunate that we can still meet here virtually and continue to work together as an Area.

Here are some my activities since reporting to the Area Committee in September:

It was a pleasure to present Concepts 7 through 12 at the well organized and informative workshops facilitated by our Service Information Day Committee on Sept 20th, 27th, October 4th and 18th. This experience has given me a much better understanding of the Concepts. Hopefully, those in attendance learned as well.

On September 21st I chaired the Inter-Area Remote Community Workgroup. Here are some comments 3 regularly attending chairs: Area 80 Manitoba continues with Telehealth and Zoom meetings. Here's what I've been doing since our Area Committee Meeting last month.

On Sept 17th I participated in a discussion group hosted by the General Service Board Strategic Plan Ad Hoc Committee. The strategic plan is an evolving document that continues to be reviewed and was most recently updated in 2019. The Board uses the plan as its guidepost regarding all matters affecting the Fellowship's primary purpose of carrying the A.A. message to the still-suffering alcoholic and to develop a coherent working vision for the future. 10. WORKSHOP— THIRD LEGACY AND VOTING PROCEDURES Robb W. Panel 61 Delegate

Thank you for asking me to do this workshop. It is interesting, while listening to all the reports today I wanted to insert a slide in here about the principle of rotation. People have talked about what a great two years it has been, the fun that they have had, the learning experience.

Robb covered the **Principle of Rotation**, he displayed page 28 from the *The AA Group Pamphlet* on this topic.

Rotation is a lesson in humility. We can do a great job, but there comes a time to rotate out and we let someone else do a great job as well. To give others the same experience that we had. This assembly, we have heard many times that we are making history here in Area 83 with our first virtual Assembly. It is neat for me to be taking part in the elections tomorrow, 10 years after I was elected delegate and now to see all of the new people who have come up over the years. Area 83- is a very strong Area for service, and I am glad to be back.

Robb then covered a bit about the **History of AA Service**. I like to give a little history of AA Service and how we got to where we are. From the Grapevine in 1992, it talks about the humility of serving in Alcoholics Anonymous.

"In setting up services and make sure they worked well, it was tempting to forget the principle of rotation...How much more difficult it was to hold on to the principle of rotation and make sure humility (rather than power building) was at the center of our efforts. We learned that even though it was more difficult to rotate and have to constantly move through a period of learning, this was good for the individuals involved and for A.A....No one person or small group of people, needed to stay in particular serving positions... Many people got a change to serve rather than just a few"

AA. Grapevine, September 1992

In 1945, Bill W. was already thinking about how our fellowship would survive after he and Dr. Bob passed on. Bill was very forward thinking, and he knew that the fellowship needed to continue after the were gone. The fellowship grew so fast in those first 10 years, that Bill was concerned AA might not survive if there was not some sort of structure involved. We hear all the time that we are "not organized". We are not organized as such, but we are organized enough that we can keep going as a global fellowship. That is something that was due to Bill's thinking way back in the beginning.

Bill had a lot of trouble in the beginning. None of the trustees were interested in the whole representation from the fellowship thing. The Trustees felt they were running things just fine. Like leaders in AA, who really believe in something. If you read the service manual it says that a leader is not just someone who leads by example, but they have the passion to, when they have an idea that they feel is important, that they are willing to fight for that idea.

In 1950, we had our first international convention and Dr. Bob was pretty sick; he died shortly after the convention. Bill went and saw him before he died to talk to him about this Conference again. Dr. Bob was not necessarily too pro conference, but in the end, he suggested that it might be a good idea to try it.

Bernard Smith, a Class A Trustee and great friend of Alcoholics Anonymous. Bill always credited him with the creation of the Conference.

Robb played a short audio of Bernard Smith recorded in the 1970s, reflecting on the first General Service Conference. It is a little humorous, but it illustrates what type of people we have among our Class A trustees. These people are non-alcoholic and freely give of their time, knowledge, experience to Alcoholics Anonymous for whatever reason they do.... Our Class A trustees are really special.

I just wanted to share on the planning for the conference (GSC). I thought when JoAnn was doing her Treasurer's report and mentioning that Area 83 was covering the cost of almost \$10K for our delegate to attend the GSC. Back in 1950, Bill was worrying that it might cost \$20K to have all of the delegates come to the first conference. Turns out, it was really only a few cents per member. Even today, the number of members in North America, the cost to cover the GSC is a very small amount in proportion.

Bill also had to follow the Traditions in the Conference. We all know about the challenges of getting the Traditions approved in AA. To avoid political infighting-this is something our Third Legacy Procedure really covers well. It was my understanding that it was Bill and Bernard Smith that help put together this Third Legacy Procedure.

The Third Legacy Procedure is unique to Alcoholics Anonymous.

Before I go in and describe how the procedures actually works, because this is a zoom Assembly, I want to put in one slide that is going to give a view of how we are going to be voting tomorrow. I know that this is not part of the Third Legacy Procedure, but it is part of OUR voting procedure tomorrow.

There will be no paper ballots, it is going to be done via Zoom polling.

Robb then went into the minutia of how the Third Legacy works. See graphic on page S22 of the Service Manual. In essence, it is a pairing down of candidates until someone is able to get two-thirds of the votes cast.

On the third and fourth ballot, that the top names and all runners up (i.e., 2nd place [and those tied for 2nd place]) go to the next ballot. If after the 4th ballot, no one receives 2/3 of the votes, we will take a vote -decided by simple majority- whether we will go to a 5th ballot. If majority say yes, we will go to a 5th ballot, if majority say no, we will skip the 5th ballot and go to the hat. I caution everyone from voting to skip the 5th ballot. With the way we are running the voting this assembly, it should be quicker, and there will not be much saved by skipping the 5th ballot. If after the 5th ballot, still no one has 2/3rd of the votes cast, the two names will be put into a hat and pulled.

With our Third Legacy procedure, when we start narrowing the field down through the 4th and 5th ballots, we should remember that every person that is on that list is a good candidate for whatever position we are voting for. At this place in service, everyone's whose name is on the list is a good candidate.

1. OPENING

Meeting opened at 9:04 am

Good morning everyone. I' m an alcoholic, a member of the Morning Discussion Group in District 10, and my name is James O'D. I have the honor and privilege of serving as Area 83 Chairperson for the 2019 – 2020 term.

Let's begin with a moment of silence followed by the Declaration of Unity (which can be found on the second page of the Service Manual across from the title page). If we could have that moment now.

Welcome everybody to the second day of our Fall Virtual Assembly.

HOUSEKEEPING

Registration:

It is important that everyone has gone through the registration process. This should have taken place when you arrived and spoke with one of our registration team members who most likely changed your name to the proper naming convention. If by some chance you did not go through this process when you arrived, please message our tech team in the chat.

Accessibility:

Area 83 wants to make sure that everyone is able to participate equally.

If you need an accommodation to help with this, please message our tech team in chat. We will do everything to assist. If you are on the phone, for example, *6 to mute or unmute yourself, *9 to raise or lower hand.

Smoking area:

If you need to smoke or eat during our business meeting please turn off your video or wait for one of the upcoming breaks.

7th Tradition:

The 7th tradition will be collected today by digital means. Our Treasurer will be posting available contribution modalities as a virtual background at the breaks and also share the information in the chat.

Who Votes?

Only members of the Assembly may vote.

These are:

- All Area Officers, including the Immediate Past Delegate, but not the Chair.
- All Area Sub-Committee Chairs
- All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.
- All General Service Representatives of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups. There is one vote per person.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion.

This next part may be unique to A.A. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this motion is seconded and passes by a simple majority, we start discussion again on the original motion.

The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

Calling the Question

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who May Address the Assembly?

- Only voting members of the Assembly have a voice. This is important for two reasons:
 - o It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - o And it maximizes the time available for those members to voice their Groups' opinions and needs.
- All who are attending may say their piece during sharing time which is agenda item #8. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate, and their opinions will be listened to.
- On the topic of sharing time, please, if you can, stay until the end of the Assembly. The Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- To allow me to facilitate discussions, when you are ready to speak, please identify yourself by name, position, Group and District number.

How Do We Vote?

SENSE OF THE ROOM:

At the bottom of the participant window you will see a green YES button and a red NO button. We will use these buttons to gage the feeling of the room – this is not a vote. We will also use this function to second a motion. IF YOU WISH TO SECOND A MOTION USE THE "YES" BUTTON.

I would like take moment as ask everyone to click on the YES button. If anyone is having a problem, please raise your virtual hand.

VOTING:

For anything requiring voting we will be using the polling feature. There will be two options: For/Against. We are not recording abstentions.

DISCUSSION/RAISING HAND:

If you would like to approach the virtual mic and stand in virtual line to share a new perspective or ask a question, please raise your virtual hand using the RAISE HAND FUNCTION located at the bottom left of the participants window. Zoom will keep people in line in the order they raised their hand.

Reminder: **IF YOUR IDEA OR COMMENT HAS ALREADY BEEN PRESENTED PLEASE LOWER YOUR HAND**. Your humility and cooperation in this regard is appreciated.

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority which is 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll call as the basis for the 2/3 calculation.

I believe that for the purpose of this second day of our virtual Assembly that we can move directly to 2/3 majority for voting.

Website and Webmaster Ad Hoc Committee Chair—Robb W.

Report from Ad Hoc Committee on the Area 83 Website Guidelines and Webmaster Responsibilities Presented at January 4, 2020 ACM by Robb W., Ad Hoc Committee Chair

Hi friends, I am an alcoholic and my name is Robb. I have the honor of having served Area 83 as your Panel 61 delegate.

On December 4, 2019, the Area Chairperson, James O. struck an Ad Hoc Committee whose scope is: "to review the Area 83 Website Guidelines and the responsibilities of the Area 83 Webmaster and Alternate Webmaster".

The Ad Hoc committee comprised George McQ. (Area 83 Webmaster), David C. (Area 83 Alternate Webmaster) and me, Robb W. (Panel 61 Delegate).

We met via a Zoom video conference call on December 10th, 2019 for approximately an hour and a half. We had agreed to each review the documentation prior to the meeting and use the video conference as a time to discuss our findings and suggestions. Overall, we felt that the Website Guidelines and the Webmaster/Alternate Webmaster responsibilities were in good shape. Most of our recommendations around these documents are in the realm of house keeping. We have divided our recommendations into two sections in order that we may address each document separately.

This Ad Hoc committee recommends to the Area 83 committee the following regarding the <u>Area 83 Website Guidelines</u> (Appendix Seven of the Area 83 Operating Procedures)

Under the Section "Contents and Services – Describes the types of information approved for display"

> SECTION A SUB SECTION 1

Change the third sentence from: "The information will be limited to materials provided by other AA entities and will also be limited to display in PDF format only."

To: "The information will be limited to AA related materials and will also be limited to display in PDF format only."

> SECTION F

Change the wording from: "All website visitor messages should receive a timely reply, even if nothing more than a "Thank You" for the message"

To: "All valid A.A. inquires through the Area 83 Website shall receive a timely response, even if it is just a "Thank you for your question" message."

> SECTION G - SUB SECTION 1

Replace the first sentence in section 1: "Group meeting information for Groups and Meetings within Area 83 with type of meeting, time and location through links to websites sponsored by bona fide A.A. service entities (Districts/Intergroups) that will be provided as a service to the website visitor (we will not publish nor be responsible for updates of individual district or intergroup meeting lists)." with the wording: "Links to District websites within Area 83 with a header suggesting that meeting information may be found on these sites".

As a committee, we were unanimous in our support of this last recommendation:

The Ad Hoc committee recommends to the Area Committee that the position of Webmaster include the right of participation and as such, the Webmaster (or in their absence, the Alternate Webmaster) be given a voice and vote at the Area Committee Meetings in Area 83 and the Area 83 Assemblies.

Should these recommendations be accepted by the fellowship, we would respectfully ask our Area Secretary to reorganize and re-number any items as required.

A. 2020 Financial Guidelines

JoAnn P., Area 83 Treasurer

The purpose of the proposed spending guidelines is to give members of Area 83 a general idea of what the expenses for the year might be and the income required to carry out the services provided by Area 83. I had previously prepared spending guidelines for the March Assembly which was cancelled due to the pandemic. I once again revisited the guidelines in June and here we are in October. Area 83 Operating procedures state that the Treasurer shall prepare a financial guideline for Area 83, in such detail that is acceptable to the Area Committee and the Assembly. Each year, the Treasurer shall prepare Spending Guidelines to be presented to the Spring Assembly.

At this juncture, I present the spending guidelines that appear almost identical to the Area Financial Statements at October 17th which I presented to the Assembly yesterday. All things being equal, Area 83 will not be incurring many expenses in the next 2 months, but it is important to recognize and accept these guidelines.

Typically, the proposed spending guideline has been forecasted using the average expense for the past four years. Step one in this process is to use these average figures as a starting point. Next, I adjust some of the category amounts that I am sure of (General Service Conference (GSC) Assessment, Ontario Delegates Committee (ODC)). Since we have only had one Area Committee Meeting in person and very few expenses, the actual year to date amounts are the starting point.

On Page one (Appendix E), under Income:

- Beside <u>Contributions to Match Expenses</u> is an amount that is NOT based on the four-year average. The
 amount here is the required Contributions from Groups and Districts that would be required to cover the
 proposed amounts to effectively carry the message to the still suffering alcoholic throughout Area 83.
- Grapevine Seasonal values may vary slightly as the Grapevine Chair must determine costs for Pocket Planners and Calendars months before the payment is made to Grapevine Inc. This year the payment was in Canadian dollars.

Under Expenses:

- Committee expenses are grouped together by category a detailed breakdown is on page 2.
- Miscellaneous Expenses include technical services for the Fall Assembly, the Spring Assembly cancellation charge and the Area 83 Zoom account annual fee plus add on charges.
- I have increased the postage amount under Delegate expenses to reflect the cost to mail the 70th General Service Conference annual report. If you would like a hard copy of this report, please contact Rob M at delegate@area83aa.org.

Under Other Expenses:

- The General Service Conference (GSC) Assessment is an actual amount. As voted on by the Area Assembly in the spring of 2007 that we become fully self-supporting in sending our Delegate to the GSC, I remitted, on behalf of Area 83, the total amount of \$6,500.00 US which at the time came to \$8,821.80 CDN.
- ODC (Ontario Delegates Committee) expenses are final as the event took place in Toronto, ON February 28 March 1, 2020. Area 83 was the host for 2020. Expenses were for the meeting room, refreshments, hotel rooms committee (4) and guests (2), meals and mileage.

On Page two (Appendix F), under Accommodation, Meals and Travel:

• For the various positions, this is the actual amount for the January ACM. Since travel is restricted due to gathering limits, I do not anticipate any further expenses in 2020.

Total Other Expenses:

Area 83 Contribution to GSO (General Service Office) has been estimated at \$5,000.00. In 2019, Area 83 did not
contribute to GSO.

On a closing note, Area 83 is in good financial shape even considering the proposed \$5000.00 contribution to GSO. I have completed an analysis (see September 12, 2020 ACM minutes) and we should end the year with an Operating Account balance of approximately \$30,000.00.

I have followed the quidelines for what is expected, and I am passing these on to the membership for acceptance.

QUESTION: Why are we getting guidelines for 2020 in October?

Answer: it is 2020 because at the Spring Assembly, had we had an Assembly, I would have presented the Spending Guidelines. My duties require me to present the Guidelines at the Spring Assembly, this is our first gathering as an Assembly in 2020, I present to you the guidelines.

Kim S., Immed Past Delegate: We started this ad hoc committee investigation before Covid. At the beginning, not everyone was on board with making it a stand-alone committee. By the time we finished we saw such a great need for it. It wasn't that we wanted it, we saw that we needed it. Just want to say a couple of things that people may not have heard or realized: We voted unanimously to have a stand-alone accessibility chair. We feel truly that Area 83 would not only benefit from a stand-alone committee, that area 83 needs one. Accessibilities is much more than just a wheelchair bound person or a deaf individual. Accessibility is a NO BARRIER to attend and participate in Alcoholics Anonymous meetings. Many examples of making a meeting accessible can be found in a tool kit on the Accessibilities tab

This has come across the floor at the Area 3 times now, and now we are very much in need of this committee.

Glenn G., DCM D18: Voting in favour, we have discussed this at length at District 18. We are behind this motion.

Carrie C., D66 GSR: Accessibility is even more of an issue now that we are on zoom. There are even more people who do not have the ability to attend meetings in person. We are seeing people at meetings that we have not seen for years because they could not get to the in-person meetings.

Shane H, Treatment/Accessibility Chair: When I was first introduced to Accessibility it was in 2008. I went to one Accessibility meeting and I was won over. I was told that people with disabilities are great members of AA. I came into AA with a learning disability and I didn't feel like I had much to offer. In 2012 the Area set up a Treatment/Accessibility committee, and within four years of Accessibilities being paired with Treatment, there were 5 districts that made Accessibilities stand alone committees. We have had a workbook on Accessibilities since 1998. It seems that it is getting updated every couple of years with updates to wording as it is always changing.

Taylor, J. GSR D66: this is in the spirit of working the steps, especially the 12th. This would make service in Area 83 more accessible. There are multiple layers, and it is a really important need and it is in line with our steps and traditions. I really hope people are thinking hard about Accessibilities. If you have never had to think about Accessibilities, then it is a privilege that many of us have, but for some it is always on their mind, as it could be the barrier that keeps them from getting the message or getting involved in Service.

Marty M., Area Archives Chair: The Previous term I was the Archives/Treatment chair. It was challenging to be the chair of both committees. At the time I did the best I could. I thought I was doing pretty good

However, if I cannot get a hold them within that month, because all of the record keeping for the Area is done by months. I would put the contribution in the "Unspecified" section of our Contributions spreadsheet. It would sit there until I was sure- and if I find out they are not in AA, then I would have to contact the person and have the conversation that we do not accept individual contributions I would need to send the money back. This would require 2 signatures on a cheque, because the Area OPs state that all disbursements must be done by cheque signed by two authorized trusted servants. That is why, in the chat I have referenced for this Assembly that any 7th Traditions collected over this weekend to please reference "Fall Assembly" in the notation field of your etransfer.

The only real change was to eliminate "Other AA entities" to just AA related. The items in question might not come from an entity, it could come from an individual. The only criteria of consideration is that it is AA material.

SECTION F

Change the wording from: "All website visitor messages should receive a timely reply, even if nothing more than a "Thank You" for the message"

To: "All valid A.A. inquires through the Area 83 Website shall receive a timely response, even if it is just a "Thank you for your question" message."

We had a bit of discussion about this, and that sometimes the Webmaster gets spam to the website; not all mail received is AA related. We wanted to specify that he didn't have to respond to spamming the website. If it is not a valid question to the Area, he does not need to respond.

➤ SECTION G – SUB SECTION 1

Replace the first sentence in section 1: "Group meeting information for Groups and Meetings within Area 83 with type of meeting, time and location through links to websites sponsored by bona fide A.A. service entities (Districts/Intergroups) that will be provided as a service to the website visitor (we will not publish nor be responsible for updates of individual district or intergroup meeting lists)."

with the wording: "Links to District websites within Area 83 with a header suggesting that meeting information may be found on these sites".

This is in reference to information that is on the Area 83 website. We felt Area 83 is not responsible for posting and keeping up to date the meeting information for districts and intergroups. We expect that these entities would have their own list of meetings. Area 83 would have links to these sites, with the header on that page that says meeting information may be available on these pages.

SECTION G – SUB SECTION 2

Remove section 2 "Area 83 District meeting information. Time and location, mailing address, and answering service telephone number."

For the same reason as stated above.

> SECTION G - SUB SECTION 3

Replace section 3 "Area 83 Intergroups. Contact information, location and hours of operation." with the wording: "Links to Intergroup websites within Area 83 with a header suggesting that meeting information may be found on these sites"

For the same reason as stated above.

➢ SECTION G − SUB SECTION 9

Change section 9 from: "Any approved Area 83 newsletter"

To: "Area 83 newsletters including the Delegates Newsletter and "The 83", Area 83's Archives newsletter"

There are no *approved* Area 83 newsletters. The Delegate has been doing a newsletter at least 10 years now. The83, is the Area 83 Archives newsletter. Like Grapevine not being a "Conference Approved" piece of literature, Grapevine is autonomous, and its editorial board has a sort of blanket approval from Grapevine and GSB to publish their material. Similar situation here, there is no Area 83 approved newsletter.

This Ad Hoc committee recommends to the Area 83 committee the following regarding the <u>Area 83 Operating Procedures</u>

SECTION 3.19 WEBMASTER AND ALTERNATE WEBMASTER

Change the last sentence, in the second paragraph from: "The Webmaster shall assure the 12 Traditions and 12 Concepts, GSO guidelines and policies and Area 83 Website Guidelines (Appendix Seven) are followed relating to the World Wide Web."

To: "The Webmaster shall ensure that the Area 83 Website is aligned with the 12 Traditions, A.A. Guidelines on the Internet (MG-18), Frequently Asked Questions about A.A. Websites (SMF-101) and Area 83 Website Guidelines (Appendix Seven)."

Clarify that the Concepts don't really relate to the website. However, the website would adhere to the guidelines of AA and the Area.

- Change the wording of the last sentence in paragraph 3 from: "The Area Webmaster or Alternate Webmaster suggested to attend the Area Committee Meetings and the Area Assemblies."
 To: "It is suggested that the Area Webmaster or Alternate Webmaster attend Area 83 Committee Meetings and
 - To: "It is suggested that the Area Webmaster or Alternate Webmaster attend Area 83 Committee Meetings and Area 83 Assemblies."
- > The wording on that was a little strange, maybe there was a word left out, we thought we would clarify that it was suggested that they attend the Area Committee Meeting and Area 83 Assemblies. Currently, these are appointed positions and there is no suggestion that they HAVE to GO to these meetings, but it is suggested that they attend, if they can.
- > The Ad Hoc committee recommends to the Area Committee that the position of Webmaster include the right of participation and as such, the Webmaster (or in their absence, the Alternate Webmaster) be given a voice and vote at the Area Committee Meetings in Area 83 and the Area 83 Assemblies.

Going through the Operating Procedures and the Appendix on the Webmaster and job descriptions you find there is a lot of responsibility in the Webmaster position. We felt that there was not a matching authority. So, our suggestion is that the webmaster, or in their absence the Alternate Webmaster, be given a voice and a vote at the Area Committee Meetings and at the Assembly. We feel that it is important to match the authority with the responsibility of the Webmaster. We are asking a lot the people serving in these positions. There are many times that the Webmaster could and should have input to the discussion at the Area Committee meetings and Assemblies. So, a voice and vote are needed to match the responsibility that they hold in that position.

Discussion:

- Question: Kathy T, GSR D28: Your report says that you recommend they have a voice and vote and participation. Would they opportunity to give a report when required.
- Answer (RW): currently, they have the opportunity to give a report to the Chair, to be read at the Assembly or Committee Meetings. We had considered them giving a report. Certainly, they could be asked to give a report. The ability for them to give a report is there, but we didn't feel it necessary to put that in.
- James, the Chair added to that: over the last two years, there have been a few times I have asked the webmaster to speak.
- Comment: Bill C., CPC: the meeting guide app became a recognized asset, would it be possible to include this in the website, that it is there or how to get help. It is a very useful and up to date way to find out where meetings are.
- Question: Rob, M. Delegate, the last recommendation that the Webmaster have a vote and voice, would that not make the 2nd to last change moot; it is recommended that the Webmaster or Alternate attend the Area Committee meeting and Assembly. If they have a voice and vote, they are expected to be there.
- Answer (RW): I see what you are saying there, but there is really no expectation for anyone to attend the Assembly or ACMs. The hope is that you will attend; it is suggested. Just like the Service Manual suggests that the DCM attend the ACM and Assembly. There are no Musts. Does it make it moot? I don't really think it does; a little duplication maybe.
- Question: Milner G., GSR D42: If we give a vote to the Webmaster, then that would be the only appointed position with a vote. The archivist is also an appointed position and it does not have a vote. It is inconsistent either way. If the Webmaster gets a vote, then the Archivist should get a vote too.
- Answer (RW): The Area Archivist is really a functional position. Webmaster is as well, but the Website is also the public face of the Area 83. There is a lot of responsibility involved there. Not trying to detract from the archivist's job; their roll is to assist members of Area 83 with the process of archiving. Whereas the Webmaster is putting Area 83's face out there to the world.
- Question: Johnathan C., GSR D36: Clarification: removing meeting information from the Area website. Currently it does not list any meeting information.
- Answer (RW): that is correct. It does not list meeting information for district or intergroups. This language change is more of a point of clarification. This ensures that the next webmaster doesn't come in and think that they have to post all of the meeting information.

Question: Kathy M., GSR, D86: Concern wording for section F., all <u>valid</u> AA inquiries. If we do not have a definition for what is valid, this is left to the interpretation of the webmaster of the day. I might suggest an alternative phrasing—

Suggest: our goal is to provide a timely response to all AA inquiries.

Answer (RW): the word <u>Valid</u> was used to is to sift through real questions to Alcoholics Anonymous through the Area 83 website- in contrast to advertisements like Duct Cleaning. The webmaster was being directed to respond every email, with a *Thank you*.

Marty M. Archives Chair: This was discussed previously with the archives committee. If this does go through, it would be a good idea to have a conversation about having the archivist having a vote and a voice because it is something that could be important. They are expected to be at the Assembly and thus their expenses are paid. If a question is brought to the mic. Usually not having the same experience as the archivist, the archives chair might not necessarily be able to answer the question, but the archivist could. We do invest in the archivist. We pay to have them go to the National AA Archives workshop. I don't think it would be a bad idea to have a voice and a vote.

Bart B GSR, D06: I know that districts and intergroups are struggling with the definition of the Webmaster should be and how they should be directed. The Webmaster should be more functional. They should be working at the direction of a committee or the direction of some kind of feedback. In the GTA, we are looking to make the webmaster report to a committee. They are making the website and the use of technology another committee that reports to the executive. Technology is becoming so important these days it should have its own committee, like Institutions and dealing with professional community is a committee. At this point, if it were asked, who is responsible for giving the webmaster direction, I don't think we have a clear idea at this point.

Answer (RW): We *tried* to clarify the different roles and responsibilities of the Webmaster. It is a living document and as technology change and things happen, we will try to nail things down as we go. This was our first pass and our initial stab, and we likely will review this again.

Question: Milner G., GSR, D42: Would you consider electing a webmaster? Since it would be the only appointed position that has a vote.

Answer (RW): No, we would not consider electing, because like the archivist, it is a special service position that involves a special skill set.

Marrey P, GSR, D06: why are we looking at all of these recommendations as a block item, and not in pieces? What am I to do if I don't agree to all of these items? Should I then vote against it, even though I am okay with many of the items.

Answer (RW): committee feel that many of these were housekeeping items, with the exception of the Voice and Vote to the Webmaster. Our feeling is that it could be voted as a block. If it is a feeling of the Assembly, that you don't feel we can vote on all of these things as a block, we can put in off to the spring as it is not time sensitive.

Question: Neil P., DCM D66: I am looking for precedence in for a non-elected member having a voice and a vote in the Area?




