Area Assembly – March 29, 2015

1. OPENING

Good morning everyone. I'm an alcoholic, a member of The Kedron Group in District 28, and my name is Rob M. I have the honor and privilege of serving as Area 83 Chairperson for the term 2015 - 2016. Can we open this meeting with a moment of silence followed by the Serenity Prayer please.

Welcome everybody to the spring Assembly. Did everyone enjoy the Service Information Day yesterday? And how about the banquet last night? Perhaps we can give a hand for the Service Information Day Committee and for the catering staff. And thank you Julie for your wonderful talk last night.

Introduction

This is our first Assembly of four in this term. During the next two years, we will be working together to provide continued strength and direction to A.A. in Area 83. Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together is the key for continued Unity in our Area. The A.A. Service manual defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." Just as most District tables meet monthly to oversee the affairs of A.A. in the District, and home Groups usually have regular business meetings, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83. Area 83 stretches from Oakville in the West to Ottawa in the East, down to upper New York State and up to Algonquin Park and the Ottawa Valley. At last count, we have 597 Active Groups. Some of us have been here before as General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some, it will be their first Assembly and from personal experience it can seem overwhelming! How many of you are here today attending your first Assembly? Could you raise your hand? That's great. Being in service is a great way to give back to AA. You will not be expected to learn or understand everything the first time or even second time. It takes time but it will make sense. Many of us didn't understand what was going on at meetings at first, but in time it we started to understand. Service is much the same way. So please keep coming back. – welcome and enjoy the rest of the assembly.

Over these two years, we will make decisions on a variety of topics. The Area Assembly, like the General Service Conference, strives for substantial unanimity through ample discussion. Before a vote is held, plenty of time is taken for full discussion and questions. It is my hope that you will return to your Groups and Districts with the feeling that you have done your part in keeping Alcoholics Anonymous strong and vibrant in your area and that you have had a strong voice in Area 83. With a spirit of love and cooperation, we will be able to get things accomplished and have some fun while we're doing it. At the end of today, I hope that each of us returns home with a renewed belief that A.A. is alive and well in our Area and that our message of hope is being well carried to the still-suffering alcoholic.

THE ONLY SMOKING AREA is outside, please use the butt containers provided by the hotel. It's unfair to expect the hotel staff clean up after us. If you leave this room for a smoke or any other reason please do so quietly, and please do not congregate just outside the doors.

FREQUENCY OF MEETINGS

I think it's worthwhile to review the schedule of meetings for this term, for both this Assembly and the Area Committee:

The Assembly meets twice a year – Usually the last full weekend in March and October. This afternoon we will decide on a date for the Fall Assembly. The Area committee, which is comprised of the Area Officers, Sub-Committee Chairs, and District Committee Member's, will meet three times this year. We have already met in Quinte West in January and will meet again in June and September.

SEVENTH TRADITION

I know it seems that the coffee and drinks provided this weekend are free, but the hotel charges us a flat rate of \$11.00 per person for the weekend. Rather than have honour buckets beside the coffee urns, we have chosen to use the Seventh Tradition to cover these costs. We had a Seventh Tradition Friday night, again at the speaker meeting last night and we will have another one today. At recent Assemblies the total 7th collected has been significantly less than the amount paid for refreshments. Please keep these costs in mind when the 7th is being passed around.

WHO VOTES?

Only members of the Assembly may vote. These are:

All Area Officers, including the Immediate Past Delegate, but not the Chair.

All Area Sub-Committee Chairs

All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.

All General Service Representative's of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups.

- ◆ There is one vote per person.
- ◆ After lunch, which is when we would expect to conduct Old & New Business, I would ask those with voting privileges to sit at the front, those without votes please sit at the back section. This will make it easier for us to count votes.

A.A. HAS ALWAYS PROTECTED THE VOICE AND OPINION OF THE MINORITY

- ◆ When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone would like to speak to the minority. To be able to do this, you must have voted with the minority on the motion. This next part may unique to A.A. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the original motion.
- ◆ The pace at which A.A. makes decisions may seem slow, but in truth it is measured. The goal is always to achieve a substantial unanimity, and the process is in place to prevent hasty, emotional decisions.

CALLING THE QUESTION

- ◆ During the discussion on a motion, a member, once recognized by the Chair, may move to “call the question”. This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many good points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- ◆ **Only voting members of the Assembly have a voice. This is important for two reasons:**
It keeps the focus on the fact that the Assembly is the business meeting of the Area – Assembly members are carrying and presenting their Groups' wishes, rather than their own.
And it maximizes the time available for those members to voice their Groups' opinions and needs.
- ◆ All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled for later this afternoon. At that time everyone is welcome to participate and their opinions will be listened to.
- ◆ On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize that many of us drive a long way to get home, and that Monday morning comes early, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
- ◆ To allow me to facilitate discussions, when you are ready to speak, please use one of the microphones around the room, and identify yourself by name, position, Group and District number.
- ◆ **If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary Dan before standing at the microphone.**

HOW DO WE VOTE?

- ◆ Alcoholics Anonymous has traditionally made decisions by ‘substantial unanimity’. In practice, this has translated to 2/3 majority – 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.
- ◆ I believe that the early part of the agenda today can be handled under simple majority – 1 vote more than 50%. I will advise you when I believe we should move to 2/3. If, at any time, you think that we should move to a 2/3 majority before I indicate it, remember, this is your meeting. Don't hesitate to make the motion.
- ◆ To facilitate the voting, which today will be by show of hands, I have asked a number of non-voting attendees to help me as hand counters. When we return from lunch, I would ask those with a vote to sit in the front, those without to sit at the back. Ultimately, it will speed things up.
- ◆ At times, I may ask for a show of hands to get a ‘*sense of the meeting*’. This is not a vote, and anyone can raise his or her hand.
- ◆ Again, when you are ready to speak please identify yourself by name, position, Group and District number.

I'm an alcoholic, a member of the Last Chance Group, serving as the district committee member for Malton District 02, my name is Ray R. Our district is doing fairly well, with our table positions, and all chairs positions filled. All our Officer positions for the District were filled in the election in the fall. Our ADCM unfortunately had an accident last October and hasn't been able to attend our meetings since then. We hope he recovers and is able to return to the table soon as he has been an active member of the table for many years.

We elected chairs, and in some cases alternates for Accessibility, CPC, Corrections, PI, and Treatment since the start of the term. We are still looking for Chairs for Archives, Grapevine and Self-Support. Other members of the table, including myself are involved in GTA Archives activities, but we hope people will step up and take on the open chair positions soon.

Our Area is doing OK financially, and recently sent financial contributions to Area and GSO.

We have a number of service commitments in the District – 2 hospital service meetings, 1 detox, and a parole board meeting. All the commitments are covered but there is one hospital meeting which is on the north-eastern border of the district which has been difficult to keep covered. Good morning, bonjour and Buenos dais everyone. Or Giddy since I am back in Eastern Ontario. My name is Jim, and I am an alcoholic. I have the honour of serving as your Area Grapevine chair. And welcome to the world of Grapevine.

Thank you's go out to: Those who attended yesterday's work shop and for their input, to the SI Day committee and our Webmaster who made everything go smoothly, District Secretaries who include me on their distribution lists, and to the enthusiastic bunch known as district GV chairs, it was nice to finally meet you in person this morning. I look forward to working with all of you. It is a small bunch but I am hopeful that more districts will be finding GV chairs. We had a very productive meeting this morning. One idea was to have GV products in large print. Special thanks to two former GV chairs, your experience was tremendously valuable.

What is Grapevine?

"I heard it thru the grapevine" is a euphemism for overhearing a story; or a classic song by Marvin Gaye or CCR.

And with the Audio GV Project we can hear our grapevine too. See aagrapevine.org for the link. This is an initiative that started in 2013 as an effort to record our stories in 7 minute segments. Details on how to do this can be found on the website.

I read it in the Grapevine is something we are all more familiar with. Most would say it's a magazine. But it is more.

Grapevine = Twelfth Step. Our Area one of the District GV Chairs said this morning GV is our unsung hero.

It's a meeting set-up in every magazine - preamble, steps and traditions, all you need to chair a basic AA meeting.

How many have a subscription? And if not why not? How many have sent in a story or a photo? And it got published?

Ok here is the first challenge I wish to make: "Grab your pen or mouse, click your cameras, or do a 7 minute story thru the GV audio project. Let's take the shotgun approach and submit a multitude of material to GV, flood it with our stories. Please send your stories and pictures to gveditorial@aagrapevine.org or go thru the website.

Somehow somebody from 83 will get published during this term. If I know that a sobriety friend's material is going to be published in the near future, I might just buy a copy of the magazine.

And it's not just a magazine. It's books and now eBooks too. That's the one area we would like to focus on this term. "A rabbit walks in to a bar" a collection on our humour. Titles like Emotional Sobriety – The next frontier. No Star Trek fans, yours is "Space the final frontier". And like Star Trek it has a sequel Emotional sobriety 2, which boldly goes where you have not gone before! There are books and eBooks on sponsorship, daily quotes, early or long sobriety, compilations on previously published articles.

For a little history, go page S85 of the service manual, available at the back of the room for \$4.25. Since 1944 GV has been the International Journal of AA. Available in English form since then, and since 1995 it is also available in a Spanish issue known as La Vina. La Vigne, is a similar but unaffiliated publication in French, sold in Quebec.

Bill W. published about 150 articles and editorial in Grapevine, including two sets of essays introducing the Twelve Traditions. These writings have been compiled to create "Language of the Heart".

What is a Grapevine rep? And what do they do?

The GV rep for a group or a district is the GO TO person for all things Grapevine. One part of the position is to encourage group awareness of GV. Everything you wanted to know, a job description if you will can be found by going to the GVR tab of the website to see all the tools that are available to assist you to carry the message of GV, which is our stories of how the message was carried, and applied.

- The monthly GV Newsletter that announces new publications, details about event such as the subscription Drive (more on that later).
- Under tools and resources is a GV workbook, FAQs
- A display gallery, mostly of Area displays. The D18 display was used at the recent Ceraasa and a picture of it will be posted there soon. Gives GVRs ideas on what to put up on a display.
- There is downloadable poster, which I have some copies. I have filed one in each DCM's folder already. Photocopy as needed. I will be having Area Webmaster Jim R upload this and few other items soon.

So what do we do? We are available to answer questions about the magazine and all other GV products, promote the value of all this literature as a great tool for recovery; assist other committees especially Corrections. A GV mag has no staples. Promote the attraction. Raise awareness. Actions: Ask "did you read that article on blah blah in the newest GV. Or have you read the latest GV book you know the one that just came out "YAdda yadda YAdda". Or its sequel. Tell a joke you read in "a Rabbit walks into a bar" or AT Wits End. Follow the antics of the third most famous person in AA, Victor E.

A new GV is a tangible piece of hope on the inside. Time after time we hear about an inmate's eyes light up when they get a new copy of GV. Perhaps a lockdown has prevented the regularly scheduled meeting from happening. This magazine becomes a vital lifeline. Perhaps your group or district could follow the example of Toronto Intergroup, who has purchased 50 subscriptions to be used in GTA correction facilities.

Encourage recycling of old GV magazines in your district. Make group or district collection of GV, donate to other committees, or drop off a copy at your Dr's. One idea I picked up at Ceraasa was to give a newcomer a (current?) copy of GV if they all ready have a big book. Make the announcement at your home group or wherever you are asked to make a presentation i.e.: medallions or group anniversaries. Create more awareness, reaching out to group contact person or GSR. Even group librarians would be a great resource for info and becoming potential GvRs.

Where is GV going in the new age of media?

Publishing as we know it is experiencing a huge sea change. And GV is no different. According to Ami B., editor of GV our magazine is experiencing the industry average 5% drop in subscriptions annually.

Despite this environment, GV has been able to contribute \$250k to the Reserve fund for each of the past two years. So it is a viable business. It just has to keep pace with technology.

But there is no other magazine like it. No ads, our recovery in our words.

The subscription drive contest

I had the privilege of meeting Ami B. the chief editor of AA Grapevine at this year's ORC; and Linda B. Grapevine director at the recent Ceraasa. Both are passionate about GV and the tremendous role it plays in our sobriety and for those yet to come.

So, as Linda put it: "Let's see if the egos of Areas, of states and provinces can be harnessed in a friendly competition".

GV will be tracking new subscription and gift subscriptions of GV and LV geographically from Feb 1st to Dec 20th 2015. For the province or state that has the largest % increase, a special section of a 2016 magazine will be dedicated to story from that particular place.

As of Feb 28th, Ontario (all 4 areas) is showing an increase of 9 new Gv subscriptions for a paltry .33% increase. One of those is mine, and two were from Ottawa. We are lagging behind the rest of the country, so let's get moving. Get out the pens and start writing, snap some photos, and start clicking your mouse at aagrapevine.org at the "Subscribe" tab.

When you do that you will see that 3 types of subscriptions are available, the \$25 hardcover version mailed to you in a discreet black wrapper, for \$35 or an online version that gives you 5 stories a week exclusive to online subscribers and access to the GV archives of every issue since 1944 (a great research tool); or for \$50 and finally a hybrid of 1 and 2; something in the mail and something online AND La Vina online.

New products

End of March 2015: eBook version of Language of the Heart

General service conference topics w.r.t to GV

The spring Assembly is called a pre-conference Assembly. Our GV workshop was dedicated to topics for General Service conference in NYC this April. Joyce has sent me 60 pages of background material regarding Grapevine.

- A) Audio strategy: GV began collecting audio recordings of our experiences in recovery in January 2013. GV has phone software that allows a member to phone in and leave a 7 minute recording. By Jan 2015, 144 stories have been submitted thru the "Simply voice Dial-In" telephone service, and 66 have been sent in on disks. ICYPAA events include an audio get together for people to gather and record. The idea is to create compilations on various subject matters, with a resale price of

\$9.99 or \$130-\$1.75 each. Sold in form of a CD which can be reformatted to MP3, downloaded to a PDA or Smartphone or tablet. Please see all the details on the website at the audio Tab. Nine free stories are on the website, for listening and as a template for how to record and a comprehensive list of topics.

B) La Vina: La Vina is an interesting creature, a hybrid entity. It was started in 1995 as request from that years GSC. Read by 14% of the Spanish AA market (GV only by 5%), it is sold like a magazine (gets revenues) but will never turn a profit in the conventional business sense. It continues to run aa annual deficit .It has been deemed to be a service to the fellowship by the General Service Board and therefore supported thru the General fund of the GSB. Its continued existence is not in doubt. For this year's GSC : Review a new business plan for la Vina.

So you have a magazine with increasing subscriptions (2014 was 10,379) that runs a constant deficit? What can we do next to make it self-supporting? Short answer is that we are doing all that we can, and it is operating well.

I talked to District 16 DC Cesar last night about this and he tells that La vina is very popular in Toronto Area.

One thing we can do is buy a gift subscription for a group. Perhaps in another country. Because of that silly embargo thing from 1962, it was in all the papers, it prevents direct mailing from U.S. to Cuba. When I was in Cuba a few years ago I was given a business card with the groups address. I have a La Vina delivered to me in Canada, and then re-mail to that group.

And remember to recycle old La Vina's and GV when you go vacationing anywhere. Leave them in the cruise ship's library, or at a church, or if you actually find a mtg leave it there.

No translation is required when you see the smiles. Gratitude is a universal language.

C) Review the revised text of the pamphlet AA Grapevine and la Vina P52: The Advisory committee reviewed suggested changes from AAGV Board and made two more suggestions 1) re-edit for consistency and grammar (no issues there) and 2) that subtitle be changed to "Our meetings In Print and other media" on the cover.

So after a flurry of emails back and forth; the suggestion above was withdrawn. By including the additional words "and other media" limits rather than reflects the variety of media that AAGV uses, or will use. Issues here: None.

D) Encourage members and groups to purchase GV Gift Certificate subscriptions: Again, Raisin Awareness. Talk about it repeatedly and eventually our ears of stone will react. Go to the website and subscribe please.

E) GV Book topics for 2016 and later: The Conference committee on GV annually reviews a list of proposed new items at least one year in advance. This year's GSC will hear about proposed items for 2016 publication.

Items under consideration for 2016:

- 1) Armed Forces members AA stories. [Soft cover 10.99, eBook \$9.99]. Getting sober and staying sober while in the military, from previously published GV mags
- 2) Voices from Early AA Stories from the earliest days of AA and GV all previously published [soft cover 10.99, eBook \$9.99].

F) Review GV WORKBOOK: This is done annually, to keep up to date and relevant. This also includes the e version found on the website.

And the big one!

G) Increase organization wide support for GV and LV: A new and positive way of speaking about GVLV is needed.

During our workshop lots of input about how to increase awareness.

- focus on the mission to carry the message rather than all the financial aspects.
- refer to GVLV as the internationals Journal of AA. Rebranding or renaming, a change in the mind set.
- advocate that funds for AAGV subscriptions be included in local/committee budgets. District GVChairs need to lovingly promote this idea. You can buy a box of 50 back issues for an institution, or at least recycle past issue. Ask for old ones to bring to district table.
- support gift certificate subscriptions. For person, a committee a sponsee....
- participate in the 2015 subscription drive.
- have record your story workshops like is done at ICYPAA events.
- spread the word about Archives including the GV Story archive. Keep talking about GV Raisin Awareness.
- have a regular section of Box 459 set aside for GVLV.
- have regular time slot dedicated to GVLV at local events. Invite local chairs to attend and or speak.
- Include a GVLV link on local websites. We do this now.
- obtain permission to include GVLV content on local websites.

But he most important one is people! Please make sure that the group contact person has registered for AAGV and Your Group email and all other email from the website. If you build it they will come, not so much as Hello is there anybody out there. GV needs a wider network of contacts. This one major way to develop a larger base of potential users/readers/subscribers. This tasks that GSRs can fill or help complete. For those groups without a GSR, but a contact person, district registrars can lend a hand. Working with people leads to partnerships. With other committee's especially CF, TF, PI, and CPC.

Thank you to everyone who attended the Treasurer/Self-Support workshop yesterday. I hope you found the information useful. Thanks also to those who helped sell banquet tickets, total tickets sold was 189. The hotel charges us \$11 per person this weekend for coffee/tea/pop which is what the 7th we collect goes towards. Please keep this in mind when the 7th comes around. In the District Committee Members mail folders I placed 3 Area 83 contribution envelopes. Please share these with your District Treasurer for future contributions. Several of the envelopes are available on the side table, please help yourselves. When your group or district sends in contributions you will get back a thank-you letter and a receipt. Emailing these to you costs the area nothing. Mailing them however requires a stamp, envelope, receipt, paper and ink. Please encourage your treasurers to include an email address with your contributions. You will also get your receipts in a more timely fashion. Please make cheques payable to "Eastern Ontario International Area 83".

Also in the DCM mail folders, as well as the Area Committee Members folders I placed copies of the financial statements for the period ending March 11, 2015. Copies of these are available on the side table and I would like to go through the numbers now. Page 1 is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest maturing September 11, 2017. Total income for the period is \$9 204.22 and total expenses for the period are \$6 307.15 to date our expenses are \$2 897.07 lower than our income. Please note however that I have sent \$4000.98 less to the General Service Conference for the Assessment than last year at this time. As our finances allow, I will send more, as long as it doesn't affect our prudent reserve. The goal being, to send the full amount before the year end.

Thank you to the 49 groups and 4 districts that have made financial contributions to Area 83.

As of March 11 2015 all cheques received were deposited and receipts along with return contribution envelopes were sent out. The bank opening balance as of January 1, 2015 was \$ 18 927.31.

Total income of \$ 9 204.22 less expenses of \$ 6 307.15 leaves a balance in the operating account of \$ 21 824.38 as of March 11, 2015. The March bank reconciliation has been done and the balance in the operating account is accurate. The Page 2 shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member. There is one minor correction that I will make under CERAASA which is to put \$116 under Meals and change Misc amount to \$35. This does not affect the totals. The corrected report will appear in the minutes. Page 3 shows contributions by District. These amounts include contributions from the District, as well as Groups within the District.

This weekend's 7th Tradition was; Friday \$382.10 Saturday \$1086.50 and Sunday \$1227.60 for a total of \$2696.20 collected over the weekend. Thank for your generous contributions, and thanks to everyone who helped collect and count the 7th Tradition.

9. DELEGATE'S REPORT

JOYCE S.

Hello, everyone. I am an alcoholic, member of St. Clement's Group in Toronto, District 10. I also have the honour of serving the fellowship as Panel 65 Delegate for Area 83 Eastern Ontario International and my name is Joyce.

It is with tremendous gratitude that I have been elected as your Area 83 Delegate! What an honour! This is a journey which I hope many of you will be able to experience, one which I look forward to for the next 2 years.

Those of you who are here for your first assembly may not be familiar with how yesterday's Service Information Day will help me to take your viewpoints and opinions to the General Service Conference, which I will be attending in New York from April 19 to April 25th. The agenda and most of the background material for the conference has been emailed to all the District Committee Members, Officers, Sub-Chairs and Past Delegates. If you have not had a chance, to go over these documents, please do so. There is so much information which is very interesting and may have an effect on A.A. as a whole. I will be your voice at the conference and need to know how you would like me to vote on items which are on the agenda.

Since this is my first year to attend the conference as a Panel 65 Delegate, I will be reading the 2 minute highlights which I have prepared. I have been timed and I have .10 of a second left, so hopefully I won't get buzzed when I give the report. I would like to read you what I will be saying about our area:

Area 83 spans from the Quebec border, West to Toronto, North to Algonquin Park and South to New York State. Currently our area has 25 Districts. In 2014, 1 district folded and 2 dark districts which were in upper New York have since joined neighbouring areas. There are 641 groups with 15,000 members. We have 5 Intergroup Offices, one of them being in our linguistic district which serves an active Spanish population. We also have 7 standing area committees, active in carrying the message, as well as putting on workshops at assemblies and within the area.

We hold 2 assemblies each year supplemented by 7 Area Committee Meetings over the term. We have now designated our Spring Assembly as a pre-conference assembly. This gives our membership the opportunity to contribute their thoughts and views on agenda items.

Area 83 hosted the second bi-annual CERAASA in February. We had a full agenda with most of the other Delegates in Eastern Canada participating. We were also pleased to have our Eastern Regional Trustee, Richard B. in attendance. Also, in attendance were current and past Board Members and Trustees.

Our area has been so blessed to have our Panel 51 Delegate, Joe D., serving as a Class B Trustee of the General Service Board and Director of AA World Services. Our Panel 55 Delegate, Barb K. has served as the Trustee-At-Large/Canada for the last 4 years. We couldn't be prouder of them both.

I am truly humbled and honoured to represent Area 83 Eastern Ontario as their Panel 65 Delegate by giving back which has been so freely given to me.

My activities so far this year are as follows:

- My first task as Delegate was to send a reminder letter to a member in Toronto for breaking his anonymity at the public level. In following up on anonymity breaks, the General Service Conference recommended that the staff member on Public Information pass along the basic facts to the appropriate area delegate. In this way, I was asked to send a friendly reminder to the member whose anonymity has been broken, sharing with them the significance of our Eleventh Tradition of personal anonymity at the public level. A guide letter was supplied, which I sent to the member.
- Attended the Canadian Eastern Region Alcoholics Anonymous Service Assembly (CERAASA) at the Nova Hotel in Mississauga from February 20th to February 22nd. What a great weekend it was for those of you who attended. There were approximately 303 in attendance with all 10 Eastern Canada Area Delegates and the Alternate Delegates (except one), our Eastern Canada Regional Trustee, Richard B., our Trustee At Large for Canada, Barb K., Linda B. A.A. Grapevine Director and of course Joe D., Class B Trustee and Director of AA World Services. I am able to share with you, since I was the Treasurer for CERAASA that we are in a position to forward the original \$2,500.00 seed money to Area 81, plus any excess. Area 81 will be hosting the 2017 CERAASA in Moncton, which I am sure you will be hearing about for the next 2 years. Please plan on attending this great event.
- The following weekend, I attended the Ontario Delegate's Committee Meeting in Hamilton which was hosted by Area 86 Western Ontario. This is where the four Ontario Delegates and Alternates prepare for the upcoming Conference. Oddly enough and this does not happen very often, all 4 current Delegates have already been to last years' 64th General Service Conference. I went to the 64th Conference when I was Alternate Delegate in place of Mel C. our Panel 63 Delegate who could not attend. 12(a) Auditors Report

Tom L., DCM District 28

The Operating Procedures for Area 83 require that the Current Treasurer and auditors approved by the Area Committee shall audit the previous term's financial documents.

The audit that took place on February 1, 2015 where we reviewed the documents for the years 2013 and 2014. The purpose of the review is to satisfy ourselves and to be accountable to Area 83 members that the revenues and expenses reported have been recorded properly and that they balance, and that there were no major discrepancies in these practices.

Specifically the Audit committee reviews the financial documents from January 1, 2013 to December 31, 2014 in order to evaluate:

- 1) Completeness and accuracy of the recorded transactions,
- 2) Completeness and accuracy of the reporting,
- 3) that all recommendations from previous audit Review Committees were implemented.

Each of the committee members reviewed an entire month's transactions from each year, covering 6 of the 24 months in the term. The months chosen were selected to reflect various types of situations: a month with an Assembly, a month with an Area Committee meeting and the last month at random. During this process; large items like GSO Assessments, Ontario Delegate's conference expenses, Ambassador Hotel bills, and Grapevine seasonals were reviewed. We reviewed October June, July, and October of 2013 and March, April, July and November of 2014.

Bank reconciliations were review with income items traced back to bank deposits and to group and district contribution files. Expenses in a given month were reviewed and traced back to the Area 83 cheque register.

The expenses for the following trusted servants were reviewed for accuracy. in the year 2013 Delegate, Alternate Delegate, CPC, Archivist, Registrar and all submitted expenses for the Service Information Day committee.

For 2014 the expenses for the Secretary, PI, Corrections, Treasurer, Webmaster, Grapevine, and Immediate Past Delegate were reviewed.

To the best of the Audit Committee's ability, all available records were reviewed and found to be in order, with no major discrepancies noted.

The only recommendation that the committee has is to remind subcommittee chairs and officers to include all receipts for expenses claimed with their expense sheet. On a few occasions, receipts were not submitted with the expense claim. Double check the calculations prior to submitting claims to the treasurer, in a few instances the claims were off by as much as 2 dollars!

12(b) 2015 Financial Guidelines

Kimberly M., Area 83 Treasurer

The purpose of the proposed spending guidelines is simply to give us a rough idea of what the expenses for the year might be, and the income required to carry out the services provided by Area 83. Some actual amounts will turn out to be higher than the guideline, and some lower. Predicting expenses is difficult because of several factors.

Typically, the proposed guideline has been forecasted using the average expenses of the past 4 years. This was also what I used as a starting point. I made some adjustments based on last year's actual amounts.

The GSO full assessment is estimated to be \$7500 US which works out to be approximately \$9562.50 at a recent exchange rate. Assuming we are able to pay the full amount by the end of the year, the actual amount will depend on the exchange rate at the time of payment.

Grapevine Seasonals also appears at the top of the page under income. These values may vary slightly because the grapevine chair must determine costs for pocket planners and calendars months before the payment is made to Grapevine Inc. In that time the exchange rate can change drastically as happened last year.

Under Fall and Spring Assembly, looking across to Miscellaneous is the amounts for the projectors and AV equipment used this weekend, for the set up of this room and for the Archives Room.

Accommodation, meals and travel for the various positions is very difficult to predict accurately so these are just a guestimate. Some actuals will surely be higher and others lower. Some districts may absorb some of these costs by financially supporting Area Officer and Committee Chairs that they invite to service days etc.

Back to page 1 under income, beside Contributions is an amount that is NOT based on the 4 year average. The amount here is the Contributions from groups and districts that would be required to cover the proposed amounts to effectively carry the message to the still suffering alcoholic throughout Area 83.

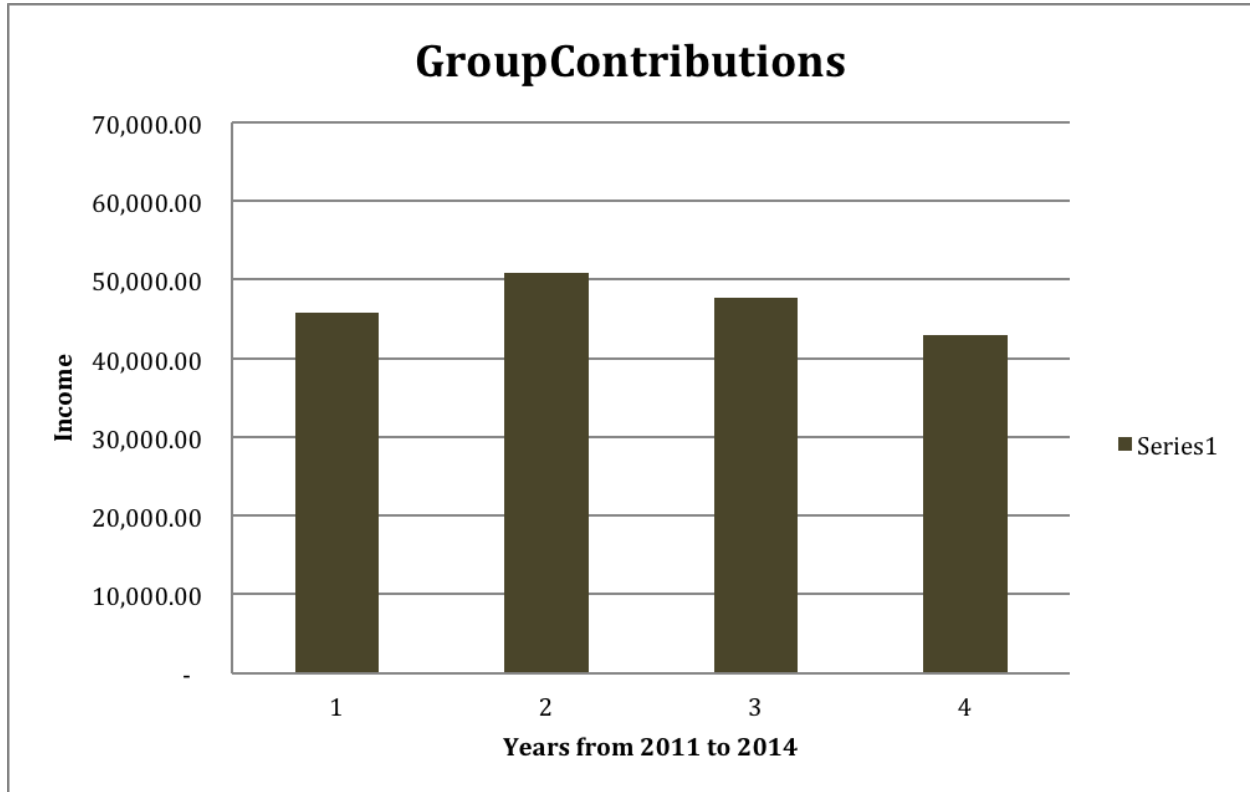
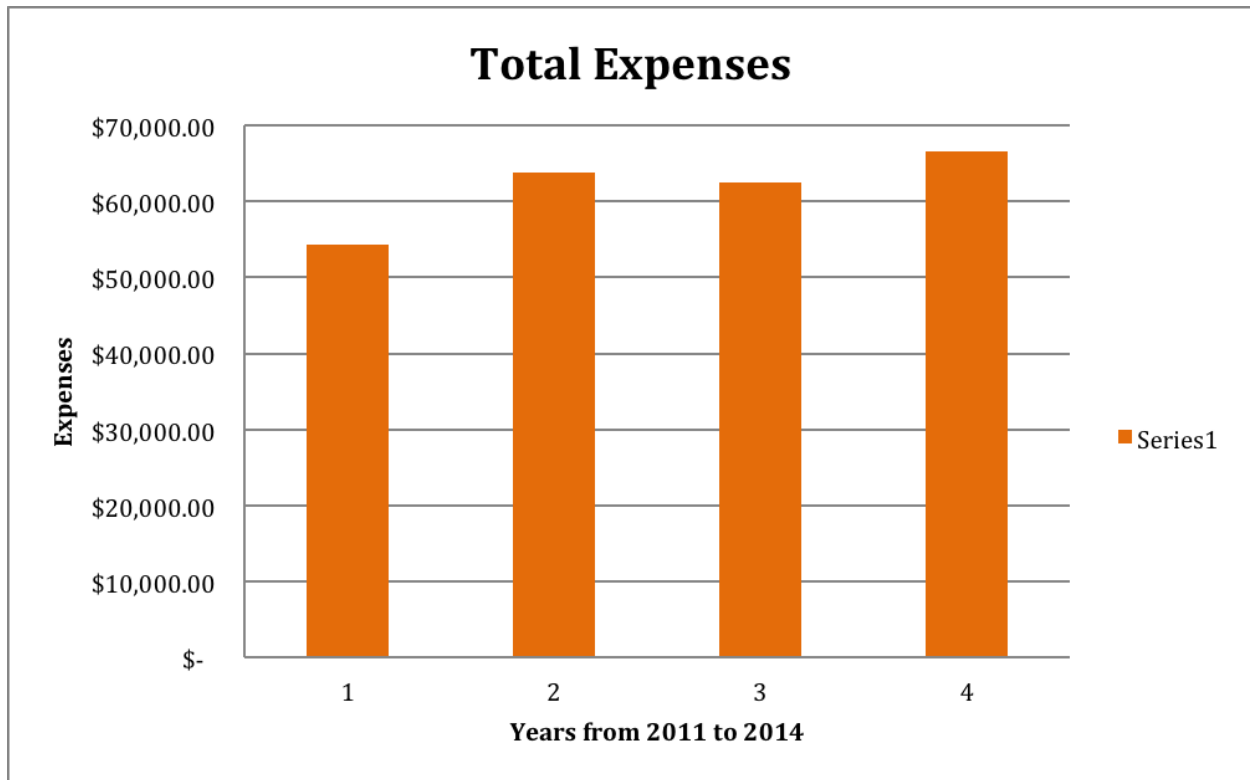

Appendix D- Ad Hoc Committee Report

Good afternoon, I am an alcoholic and my name is Robb W. I am a member of the Harmony group in Hamilton and I have had the honour of serving Area 83 as its panel 61 delegate.

On November 19th, 2013 the Area Chair, Kim S., struck an ad hoc committee to review the Area Service Information Day Guidelines. The committee consisted of Herb W., Area Public Information Chair; Rob M., Area Treasurer; and myself as chair. The scope of the committee, as outlined in the November 17th email from the Area Chair was: "To make an assessment of and recommendations around Area 83 Eastern Ontario International Service Information Day Guidelines as they apply to our Service Information Day at our Area Assemblies"

The term "Guideline" as defined by Merriam Webster is "a rule or instruction that shows or tells how something should be done". Concept X states that "Every service responsibility should be matched by an equal service authority". It is this concept that gives the Service Information Day Committee the authority to suggest and schedule the workshops and/or presentations for the Service Information Day. This authority is vested in the committee of 6 DCM's when elected in at the first January Area Committee Meeting of each term.

Your Ad Hoc Committee reviewed the current Guidelines for the Service Information Day Committee with these two ideas in mind. The Committee reviewed the current guidelines and felt that, on the whole, they provide excellent direction for a new Committee just beginning their term as well as continuing guidance over the four Service Days during their term.

While it is expected that DCM's who choose to let their name stand for election to the Service Information Day Committee will have a good understanding of the duties and responsibilities of the Service Information Day Committee, ***the ad hoc committee suggests to the Area Committee*** that the Area Secretary prepare printed copies of the Service Information Day Committee Guidelines for the first Area Committee Meeting of the term in order that the new Service Information Day Committee members receive a copy as soon as they are elected.

These guidelines have been in use in our Area since January 5, 2002. The recommendations in this report are not time sensitive and, if passed today, should be put on the agenda for the Spring Assembly.

Your Ad Hoc Committee, after meeting a number of times and discussing the Service Information Day Guidelines, respectfully makes the following three recommendations:

14. **The Ad Hoc Committee recommends to the Area Committee** that the following line be added to the section "Friday night open meeting" on page 3 of Appendix Two; *"When selecting a speaker for the Friday night open meeting, it is suggested that no sitting member of the Area Committee be chosen so as not to give any implied advantage to anyone with regards to upcoming elections at the end of the term."*
15. **The Ad Hoc Committee recommends to the Area Committee** that the following line be added to the first point in the section "Spending Guidelines" on page 6 of Appendix Two; *"As each committee member is also serving as a District Committee Member for his or her District, it is expected that the District will reimburse any other reasonable expenses for attending the Area Assembly."*
16. **The Ad Hoc Committee recommends to the Area Committee** that the following point be added to the section "Spending Guidelines" on page 6 of Appendix Two; *"The Chairperson of the Service Information Day Committee will be entitled to be reimbursed for their room Friday and Saturday night as well as meals for Friday night and Saturday. The Area Chairperson will manage the room reservation as part of their responsibility."*

Your Ad Hoc Committee would also like to put forth two additional considerations:

1. **Should the Area make the decision to officially designate each Spring Assembly as a "Pre-Conference Assembly"**, the following wording be added to the section "Workshops/Presentations" on page 4 of Appendix Two; *"As the Spring Assembly has been designated a pre-conference assembly, workshops that are presented by the different*

Area Sub-Committee Chairs shall focus on issues that Alcoholics Anonymous will be addressing at the upcoming General Service Conference. Any “alternate” workshops shall be informational workshops that deal with General Service and/or the General Service Conference specifically.” or words to that effect.

2. **In the interests of passing on shared experience**, the Area Committee should explore ways to pass on the shared experience of past Service Information Day Committee members to the incoming Service Information Day Committee. Some suggestions might be a Service Information Day workshop at the last assembly of the term or a portion of the DCM workshop be dedicated to the responsibilities of the Service Information Day Committee.

On behalf of Herb, Rob and myself, I would like to thank our Area Chairperson for the opportunity to serve the Area in this capacity.
