### Seating:

As much as possible – District Committee Member's and Sub-Committee chairs sit on the outside of the tables. Alternate District Committee Member's on the inside. Visitors and Past Delegates area asked to sit at the tables set up at the side of the room. This seating arrangement helps to facilitate the voting.

### Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All DCM's of Districts in Area 83; in their absence, the Alternate DCM may act on behalf of the District. There is one vote per person.

### How do we vote?

#### Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone can raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority, the items under new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get there. If for any reason you think that we should be under 2/3 before then, please make the motion.

### Voice of the Minority

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. **If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, he or she may make a motion to reconsider.** If this is seconded and passes by a two-thirds majority, we start discussion again on the *original* motion.

### Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to “call the question”. This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many good points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

### Who may address the committee meeting?

It has been the *practice* at the Area committee level to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons:

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly – members are representing their District's positions or Area's in the case of our Officers, rather than their own.
- It also maximizes the time available for those members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I just described, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcomed to participate and their opinions will be heard.

### **g) Archives Report**

Good morning friends. My name is Peter N. I am an alcoholic and a member of the Bayview Group in District 14, Toronto North Central. I have the honour and privilege of serving as your Archives Chair.

June 23 I presented an Archives workshop in Cornwall at the Districts 42, 48 and 50 Service/Information Day. It was an excellent day, well organized and attended.

July 6-8, I attended the Eastern Canada Regional Forum in St. Catharines. I posed the question to the GSO Board Chair Ward E as to when Archives would become a full Conference Committee as opposed to being a secondary Conference Committee. We are closer but do not have a firm date yet.

I attended the Archives Workshop in French on Saturday and it appears that the four Quebec Delegate Areas are just six months into setting up Archives. I spoke with our Delegate Robb W. and with Pierre C., Panel 62 Delegate for Area 87, Southwest Quebec about the idea of our presenting an Archives Workshop at CERAASA (Canadian Eastern Region Alcoholics Anonymous Service Assembly) to be held in Longueuil, QC February 22-24, 2013 so that we could share the experience of the Area 83 and GTA Archives Committees with the 10 Delegate Areas in Eastern Canada. Since Pierre's wife Louise D. was chairing the Archives Meeting, we may have some support. In addition, I was approached by Russ, a DCM from Area 82 Nova Scotia/Newfoundland/Labrador and they are just starting out as well. If we could coordinate the ten Areas in the Canadian Eastern Region, that would be fantastic.

Our Delegate Robb W. spoke with Pierre C., Delegate Area 87 it appears that we will have the workshop. I have been corresponding with Pierre V. who is the Archivist for Area 87 in Quebec, and copying all concerned so that we can build and coordinate a Power Point Presentation Workshop. Our Archivist David T, Eddy G and Jim W from GTA Intergroup, Katrina, who is doing the software programming so that we can create a uniform data input standard are all involved in this effort.

### **7. Registrar's Report**

***Tony A.***

Good day, I am a member of Alcoholics Anonymous, and belong to the Church Street Group in District 10 and currently serve as your Panel 61 Registrar for Area 83 and my name is Tony A.

The roll call for today is **15** Area Officers (including Webmaster, Chair & Area Archivist), **1** Immediate Past Delegate, **2** Past Delegates, **21** DCMs, **13** Alternate DCMs and **6** Visitors. For voting purposes there are **12** Area Officers eligible to vote (includes our Immediate Past Delegate) and **23** DCMs or Alternate DCMs for a total of **35** votes. Total delegation for this meeting today is **58** people.

## ALCOHOLICS ANONYMOUS AREA 83 EASTERN ONTARIO INTERNATIONAL

Since my last report given at the area assembly, I have been much slower but still steady with group changes and related registrar work. I attended the Eastern Regional Forum in St. Catharine's in early July.

The 2012 regional directory should be made available to the membership in the next few weeks as it has been delayed a bit in its release this year. I also received an email from the GSO Records Department reminding us that when a group is newly registered with GSO, the group sits on a "pending active" status for a period of 30 days. I can advise groups of their service number after the 30 day period has elapsed and the group status has been changed to "active."

Currently, our census in Area 83 is: 963 groups in total listed in the GSO database. The breakdown for these groups are 501 active groups, 329 inactive groups, 21 groups that have merged, 2 groups pending active (new) and 110 groups listed as incomplete or unknown. Inactive groups never get removed from the GSO database.

All group changes and forms submitted to me have been entered and are up to date. Any groups that you know that are listed as an unknown group but you know for certain are inactive, please send me an email so I can forward this information to the GSO records department.

A reminder about group status – active status means there is a contact associated with this group and the General Service Office is able to send information to this group. Unknown status means the group is **still active** but does not have a contact associated with the group record. Inactive means the General Service Office has received information that the group has disbanded or is not currently meeting – this might be due to returned mail.

I have started sending out to the DCMs of each district that still contain groups listed with an unknown or incomplete status. If you could get a contact for these groups, this will change the status to active and ensure the record is more current and up to date. Your prompt attention to this would be greatly appreciated in my attempt to pass over a more cleaned up database to my succeeding registrar.

When you send me your updated changes, please ensure that all fields are completed especially in the mailing addressing area. I cannot enter incomplete information into the GSO database as the system will not allow me to do so. You can submit changes by email (preferred) at [registrar@area83aa.org](mailto:registrar@area83aa.org) or by faxing them to 416-924-6149. If you have general registrar related inquiries, you are more than welcomed to call me and we can discuss them at 416-702-6280. Group change and new group forms are posted on our area website under district resources and can be downloaded for your convenience.

Finally, since our upcoming fall assembly is a voting assembly, I would like take particular attention in ensuring accuracy with the roll call given prior to our vote. Therefore I am requesting all DCMs to come and verify my tally prior. Thank you for the trust that you have placed in me. It has been my privileged honour to be of service to Alcoholics Anonymous Area 83 International.

### 8. Treasurer's Report

Good morning everyone, I am an alcoholic a member of the St Andrew's Group in Scarborough, my name is Jim A. I have the honour and privilege of serving as your Area 83 Treasurer.

I hope everyone had a great summer. It's almost fall now, so let the service marathon begin. The Forum in St. Catharine's was awesome. And very informative regarding all aspects of finance that GSO and Grapevine are going through right now. It was pleasures to meet other Area Treasurer's and learn of some of the situations they have encountered.

I also had the pleasure of visiting GSO in August. That is a trip I will not soon forget. Again meeting the people that are our trusted servants and those that do the day to day work of keeping our organization going was very rewarding.

## ALCOHOLICS ANONYMOUS AREA 83 EASTERN ONTARIO INTERNATIONAL

Thanks goes out to those districts sending their minutes to Area.

I would like to present you with our Area's financials as of August 31, 2012.

Our reserve account has a balance remains in a \$20,000.00 GIC maturing Sept 16, 2014, paying interest of 1.85% compounded annually.

Income for the year to date: 7<sup>th</sup> Tradition is \$2638.83 (\$2,519.06 in 2011), cost recoveries \$160.00 (\$118.76), Group & District Contributions \$31,108.93 from 16 districts and 112 groups (\$26,826.57 from 11 districts and 119 groups), GSO Flow Through \$76 (\$40.00) and Interest received of \$148.77. The total of these inflows to the operating account is \$34,132.83 as compared to \$29,653.16 as at August 31<sup>st</sup>, 2011.

The total expenses for the period ending August 31<sup>st</sup>, 2011 were \$37, (\$31,909.55 in 2011, and \$38,009.42 in 2010). To date our expenses are \$3,353.83 higher than our income.

The opening balance of the operating account as of January 1, 2012 was \$ 34,977.40. Total inflows of \$34,132.53, less expenses of \$37,486.15 leaves an Operating account balance of \$31,623.78 as at August 31, 2012. **The combined balance of all bank accounts is \$51,623.78.** This amount represents 87.5% of our proposed spending, or in terms of time, 10.5 months of spending. The suggested guideline for an Area is 12 months. Area 83 is doing very well.

All invoices are paid and bank reconciliation is up to date.

Our group and district contributions are ahead of the 2011 YTD total by \$4,282.36. To date 112 or 18.64% groups (119 groups (20.66%) and 16 of 28 Districts (2001: 119 or 20.66% of groups and 11 of 28 districts) have made contributions to Area 83. In comparison to 2010: 122 groups and 19 Districts made contributions. According to the 2012 General Service Conference report, 42.7% of the groups and districts in Area 83 made a contribution to GSO during 2011, a larger participation figure than those making a contribution to Area 83.

Observations: Your trusted servants were very busy accepting all of your invitations to participate in your service days. Someone far wiser than me, made a suggestion and it came true. I should watch the post marks of the mail I received. The outcome was unbelievable, and consistent. About three weeks to a month after a service day, wherever in the Area, I would get mail from the groups and districts near there.

That says that the fellowship really appreciates the efforts and dedication of the various chairs and officers. Special mention needs to be made of the thoughtfulness exhibited by service day organizers. The co-ordination of service days in Cornwall and Ottawa on the same weekend, billeting of speakers, these are some of the great ways our fellowship shows that it cares. And it means less wear and tear on your Area resources, both the bank account and the service road warriors of 83.

Projections: Upcoming expenses for Area 83 will be the travel costs of today's meeting, the Fall Assembly and the December Area committee meeting. I estimate these three items to be approximately \$19,000.00. Therefore over the remaining four months of there will be a considerable challenge to remain self supporting. The level of support during the past four months alone is an encouraging sign that Area 83 will continue to have sufficient financial resources for caring the message of recovery to the outside world, and the message of service to the fellowship.

You will also find some SAE contribution envelopes. As before please do not use envelopes with previous Treasurer's addresses, as cheque risk being staled dated before them their way to me...

Page two: Detailed expense report by activity and trusted servant/committee. [Question from Bonnie F. DCM 58 "What does the amount of \$3399.49 under meals and assembly represent? Answer: The coffee bill for the entire weekend]

Please note the two summary boxes that provide: 1) summary of income and 2) year over year comparisons of cash flows such as total inflow, total expenses, and total contributions. My comment here is that the financial support of Area is very strong hence the increased contributions (\$4382.36). The increased expenses of \$5,575.80 are mostly the Area contribution to GSO (\$4000) and increased costs for the General Service Conference (\$825) and ODC (\$775). Increased travel has been offset by lower literature costs.

Page three: Contributions by each District and its respective groups. Thank you all.

Page four: I have prepared a cash flow analysis of the term. You will see the significant expenditures listed in the period they occur. This is foreseen and has been accounted for in the Proposed Spending Guidelines as passed by the floor at the March Assembly.

Just like seeing a newcomer come to my home group for the first time, seeing someone at their first District meeting gives me a nice feeling of Remember When.

At a number of Service Days or District visits I sat with DCM's and Alternates and discussed issues in that location and together, using the Traditions and Concepts, came up with possible steps toward a solution. I feel now more than ever that Area 83 is vibrant and strong.

At our last meeting, there was some discussion around the registered name of our Area. To be honest, I was a little surprised at some of the reactions. It's only a name. We're not an International Area because our name says we are, we're international because we have districts in the United States. That being said, I have written to Karen H. in the records department at the General Service Office and asked what needs to be done to fix this. I haven't heard back yet but when I do, I'll be sure to report back to you.

I received a letter from the Treasurer at GSO, Terry B., who tells me that for 6 months ending June 2012, 28.8% of groups in our Area have contributed. This compares to 26.21% for the same period last year. This is a good trend but we still have a long ways to go. This is where I go when I talk about us not being self supporting. Certainly AA groups are self supporting as well as Districts and Areas. The General Service Office, however, is not. The message I try to get across is that we need to step up to the plate and encourage groups and individual members to contribute to the General Service Office. GSO is still relying on literature sales to cover their budget. Through the end of June, literature sales were lower than budgeted by a little less than \$30,000. Of the 900,000 print books sold, non-AA purchases accounted for 161,000 or almost 18%. Now, as a publishing company, we have to sell our literature to anyone who wants to buy it. That's the law. But that shouldn't stop us from trying to help our General Service Office become self-supporting through our own contributions. If we were truly self-supporting, our literature would not be free. I've always said that we would only have to pay what it costs to produce.

Now, on to a different type of support. I asked Kim, our Secretary, to send out some information recently to all DCM's with regards to an opening for a GSO staff member. I hope that you have all shared that information with your Districts. The office will be accepting applications until the end of next month. Anyone who has attended Information AA Day in Toronto and has heard the guest speaker from GSO will understand what a great job being a staff member is.

For those who would like to be involved in some small way with the General Service Conference, I have received a request for suggestions for the theme of the 2014 General Service Conference. If you are interested, just see me sometime today and I'll give you the information you need.

As this term comes to an end, I find myself reflecting on my time around this Area. It's been a blast! That's not to say that there haven't been opportunities for learning. I'll tell you that I'm really looking forward to the Assembly next month. For some reason, I seem to be more relaxed than I usually am for an election Assembly. That being said, I would just like to remind everyone here in this room that the only thing you have to do at this election is to say "Stand" and let God and the Assembly decide what you will or won't do.

Thank you for the opportunity to serve Alcoholics Anonymous. This experience certainly is one of the highlights of this poor drunk's life.

Dear Friends,

Greetings from all of us here in AA India

I am still recovering from the overwhelming experience I had during my visit, I am grateful to all of you for allowing us to be with you and witness the magic of group conscious and prevalence of collective wisdom in action. In our forth coming conference (November 2012 end) I will present a full report to the fellowship in India.

#### **There is news from INDIA.**

Aamir Khan a very big film star from India had made a TV show named "**SATYAMEV JAYATE**" (only truth shall prevail), in which he highlighted various social problems & their possible solutions. He chose alcoholism as a topic in one of the episodes; we worked very closely with the production team since the last one year explaining them our traditions and providing them with all the information they needed.

They shot the entire show revolving around alcoholism & its effects on people, society, economy etc. during the show they had one AA member as a speaker (his anonymity was protected by blurring his face) we also had our class "A" trustee Dr. Ashish Deshpande who is well renowned psychiatrist in India on the show speaking about alcoholism as a disease. Overall the episode was hugely successful in portraying the problem of alcoholism & the possible solution in AA programme.

#### **Our preparation**

We were anticipating a lot of calls as the episode was to be telecast on national television in eight languages simultaneously. In fact the popularity & languages were our challenges; we needed to answer people in their own language! We understood that simple phone numbers will not help & we could not hire help of call centers due to issues of money, traditions & languages involved, eventually we found out the solution in cloud telephony wherein a single number can divert calls to hundreds of volunteers in nine Indian languages simultaneously!

Our regions responded with about more than 200 volunteers making themselves available to receive calls! We had also displayed a five digit SMS no. our email & web address. While we were waiting for the telecast; I had written a letter to fellowship titled "Jack Alexander comes to India" I had mentioned the game changing article & contemplated whether history would repeat itself after so many years?

We have decided to record & make a pamphlet on the lines of "Jack Alexander article", yes now we can say that we have an Indian jack Alexander & his name is **Aamir Khan**.
