Lunch will be extended to 90 minutes to give everyone time to go out to eat.

Seating:

As much as possible District Committee Members and Sub-Committee chairs sit on the outside of the tables. Alternate District Committee Members on the inside. Visitors and Past Delegates are asked to sit at the tables set up at the side of the room. This seating arrangement helps to facilitate the voting.

Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

How do we vote?

Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone may raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority. The items under new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

Minority Opinion:

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that

person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the *original* motion.

Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many good points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who may address the committee meeting?

It has been the *practice* at the Area committee level to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly –
 members are representing their District's positions or Area's in the case of our Officers, rather than
 their own.
- It also maximizes the time available for members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I mentioned, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcome to participate and their opinions will be heard.

District 02 Malton Ray R

I'm an alcoholic, a member of the Last Chance Grp, and the District Committee Member for Malton District 2, my name is Ray R.

Our District table will be reconvening, tomorrow after taking the summer off. But the business of AA in district 2 did continue. The jails and treatment were attended to, and we've started up a trial meeting at a privately run health care facility in our district.

We will be participating with district 6 on Bring a Professional day in November, and are actively working with district 12 to facilitate the Gift of Life service meeting. Theres also a new big book service meeting that meets 10 a.m. Wednesday mornings at the Grace United Church, in Brampton, and it seem to be doing quite well, attracting about 15 members weekly. Our annual District 2 Service Day will be held on November 12th at the Church of Christ, in Brampton. More news on that will be posted on the Toronto Intergroup website.

We began our election process before the summer break, and managed to fill the DCM position, but that was it. We will continue elections until all head table positions are filled. Shane H is our incoming DCM.

Issues we're discussing at our table include ways of reducing the amount of money we spend on literature, it seems literature cost is

cutting into a large part of our operating budget, limiting our ability to contribute elsewhere. Some of the things we're looking at include, handing out beginner packages, instead of big books and other literature at the treatment centres, it was noticed that literature was often misused or discarded after they were given to the patients.

We're also asking groups to donate big book to the correctional facilities to aide in the b/b studies, and the groups seem to be responding to that idea. As always, we're open to ideas from other districts on what worked for them.

We're also looking at ways of strengthening our bridging the gap program, especially on our women side, as we've had to re-direct some calls lately as there was no one in our district to fill them.

All in all, we continue to serve our community well, and as usual, we're looking forward to greater things to come...

Who will be your District Bridging the Gap (BTG) corrections contact person for 1 Jan 2017?

Corrections Canada connected with David T. and they have accepted that this is only a Correspondence Service and therefore have offered to simplify the whole process by volunteering to send a letter to all regions across Canada to advise the Client Welfare organizations in the Federal Institutions for the availability of our service.

The only question remaining is where should the internal clients be sending their requests i.e. should they write GSO or do we wish to set up an equivalent service here in Canada.

Please be advised that GSO has a list of Canadian AA members who wish to be correctional correspondents. At first they may write US clients (inmates) until more Canadian client become aware of the opportunity, or wait to be linked. The KEY right now is to have Canadian AA members aware, ready, willing & on the list at GSO. So if you will please announce that Canadian Correctional Correspondence are being ask to sign up on GSOs list.

Most correctional facilities in our area are doing very well with some exceptions like Toronto South Detention Center which was doing great this spring and is now about half the time lockdown. The correction center still with the most problems is the Central East Correctional Centre (Lindsay) which still having difficulty in getting in over the summer.

Most of the other correctional facilities common problem seems to be not enough AA volunteers and need more literature.

Bridging The Gap (BTG) at this time is going Okay. Still updating CF Chair list with the corrections BTG contact for each District. Please let me know any updated info about BTG contacts for your Districts.

For some years one of Toronto jails was run by a group of AA volunteers who had no interest or involvement with Toronto Intergroup or any District. Once their jail was closed they made an attempt to establish contact with the new Toronto South Detention center. Jim D. District 18 Correctional Chair for district18 stepped in and made it clear that an elected representative of Alcoholics Anonymous should be their contact person, who will report back to Toronto Intergroup district and Area 83 and be accountable to the AA fellowship. The roll call for today is 15 Area Officers (including Webmaster & Area Archivist), 0 Immediate past Delegate, 2 Past Delegates, 19 District Committee Members, 12 Alternate District Committee Members and 7 Visitors.

For voting purposes there are: 13 Area Officers eligible to vote (including 0 Immediate Past Delegate) and 23 District Committee Members for a total of 35 votes. Total delegation for this meeting is 54.

One of our Delegate's goals this term was to clean up the active groups still listed in Districts 38 and 46 which had both disbanded a few years ago. Between Joyce, Bill - the Delegate of Area 48, Milner - DCM of District 42 and I, this goal has now been accomplished.

When I started my term as Area Registrar, we had approximately 90 Unknown Groups. As of today, we have 34. Treasurer's Report Kimberley M

Hi friends, I'm an alcoholic, a member of the Ajax Area Group in District 26, and my name is Kimberley. It is my privilege to serve Area 83 as your Treasurer. Hopefully you enjoyed your summer and the warm weather!

Our next big event is the Fall Assembly next month! While you are encouraging your GSR's and their alternates to attend, please gently remind them that Area 83 pays the Ambassador \$13 per person to provide coffee/tea throughout the weekend. The contributions put in the 7th tradition and coffee cans over the weekend, will go towards this expense.

In the District Committee Members mail folders you will find 2 Area 83 contribution envelopes. Please share these with your District and Group Treasurers for future contributions. More envelopes are available on the side table, please help yourselves. Please thank the groups that are including their service number either on the envelope or right on the cheque. It is helpful and appreciated.

Also in the DCM mail folders, as well as the Area Committee Members folders you will find copies of the financial statement for the period ending August 28, 2016. Copies of these are available on the side table and let's go through the numbers now.

<u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest maturing September 11, 2017.

<u>Income for the period:</u> 7th tradition collected at the Assembly and Area Committee Meetings (\$3 667.13), Cost recoveries from the sale of grapevine and service manuals (\$371.00), Group and District contributions (\$33 287.22)

Total income for the period is \$37 325.35. Expenses for the period: Committee expenses are \$22 176.05, Area committee meeting – rent and refreshments (\$802.85), General Service Conference \$10 412.40, Bank service charges \$6.82, Paypal Fees \$10.64, Forum in Thunder Bay \$744.34, Ontario Delegates Conference \$1 514.37. Total expenses for the period are \$35 667.47. To date expenses are \$1 657.88 lower than income. The bank opening balance on January 1, 2016 was \$26 640.83. Total income less expenses leaves a balance in the operating account of \$25 298.71 as of August 28, 2016. The bank reconciliation has been done and the balance in the operating account is accurate.

<u>Page 2</u> shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date.

Just to clarify some of the numbers that you see here: The amount shown on the Webmaster line under miscellaneous, \$39.98, is the amount of website renewal for 2 years. The amount shown on the Archives line under miscellaneous, \$499.93, is for the Archives workshop in Ottawa. Beside the Spring Assembly, under meals you see \$4000 which covers the coffee. In that same line under miscellaneous, the amount of \$1255.74 includes Archives room and DVD rental (\$322.05), data projectors (\$214.70)and the set up of the ballroom (\$678). Beside Area Committee Meetings, travel expenses were for a previous delegate to facilitate the election for the new self-support chair at the January ACM.

Miscellaneous in that same line is for the rent and refreshments for the January and June ACM meetings.

At the bottom of the page is a summary comparing year to date for 2016 and 2015. Here you can see that our income to date is up \$1 856.08 compared to last year at this time. Our expenses are up \$9 446.23. The resulting net change to our operating account is \$7 590.15. Contributions are up \$1 607.15 compared to last year at this time. 7 less groups have contributed and 2 more districts have contributed so far this year compared to last year.

You may ask why expenses are up \$9446 compared to last year. Many expenses are actually down. Three items that contribute to this increase are: General Service Conference – we have paid the full amount which is approx. \$7800 more than we had paid at this point last year. Forums – approx. \$580 more due to being in Thunder Bay. There was no forum last year. The Ontario Delegates Conference – was held in Sudbury vs Hamilton accounting for an additional approx. \$780.

<u>Page 3</u> shows contributions by District. These amounts include contributions from the District, as well as Groups within the District. Thank you to the 133 Groups and 14 Districts that have made financial contributions to Area 83 this year. As of August 28, 2016 all cheques received were processed and receipts along with return contribution envelopes were sent out.

Please continue to remind groups who would like to contribute using Paypal to include their 6 digit Group Service Number with any contributions using Paypal so that the group can get credit for the contribution. The place to enter the group number is the screen after entering credit card information. Paypay charges a fee of 2.9% plus 30 cents per transaction. There have been 4 contributions using Paypal this year so far.

For the six months ending June 30, 2016, 26.88% of groups in Area 83 have sent contributions to the General Service Office compared to 25.68% last year. This morning Joyce gave me a hard copy of contributions to GSO listed by group per district. I put

The 7th Tradition today was \$302.20. Thank for your generous contributions.

b) Report from Ad-Hoc Committee on Area Assembly Location - Kim S Area 83 Alternate Delegate

c) Discuss Ontario Delegate's Committee Meeting at CERAASA 2017 - Joyce S Area 83 Delegate

At the Ontario Delegate's Committee Meeting, which was held in Sudbury from March 4-6, 2016, the current 4 Ontario Delegate's and Alternate's voted to forgo the 2017 Ontario Delegate's Committee Meeting which was scheduled to take place in Thunder Bay. This was due to CERASSA 2017 which will be taking place in Moncton, NB from February 24-45, 2017. It was felt the cost for the Delegate and the Alternate to attend both events on back to back weekends would be a tremendous cost to the individual areas. This

happened when Area 83 hosted CERASSA in Toronto in 2015, then the following weekend the Delegate and Alternate attended the Ontario Delegate's Committee Meeting in Hamilton.

At the June 1, 2013 Area Committee Meeting, when I was Alternate Delegate, I put forward the following motion:

The Immediate Past Delegate is a voting member of the Assembly, but is not eligible for any Area office and is to be reimbursed for attending the Area Assemblies, Area Committee Meetings and the first Ontario Delegates' Committee Meeting of their term.

The reasoning behind saying the first Ontario Delegates' Committee Meeting of their term was that in the second year of the Delegate's term, the Delegates would have already attended a General Service Conference, therefore would already know what to expect.

This motion passed and was inserted into the Operating Procedures.

I am requesting a sense of the room as to whether the Immediate Past Delegate for the term 2017-2018, which would be me, should attend CERASSA 2017 since there will not be an Ontario Delegate's Committee Meeting in 2017. Past Delegates are encouraged to attend the Ontario Delegate's Committee Meeting and CERASSA for their shared experiences in attending the General Service Conference. Requests for the Immediate Past Delegate to participate in either are quite common. The host committee is making every effort to incorporate the Ontario Delegate's Committee Meeting into the agenda of CERASSA.

I have done some cost comparisons and they are as follows:

- 1. Thunder Bay costs could have been approximately \$750. This total was taken from the costs which were incurred to attend the 2016 Regional Forum in Thunder Bay this past July. This includes all expenses.
- 2. I checked flights from Toronto to Moncton and the cheapest I could find was Air Canada for approximately \$500.00. With registration, 2 nights hotel and meals, I arrived at a cost of approximately \$988.00

This is a difference of about \$244.00.

d) Discuss 2020 Regional Forum - Joyce S Area 83 Delegate
