#### Seating:

As much as possible – District Committee Member's and Sub-Committee chairs sit on the outside of the tables. Alternate District Committee Member's on the inside. Visitors and Past Delegates area asked to sit at the tables set up at the sides of the room. This seating arrangement helps to facilitate the voting.

#### Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

How do we vote?

#### Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone may raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority. The items under new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

#### Minority Opinion:

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the original motion.

#### Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them

#### Who may address the committee meeting?

It has been the practice at the Area committee level to use the same principle as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly members are representing their District's positions or Area's in the case of our Officers, rather than their own.
- It also maximizes the time available for members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I mentioned, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcomed to participate and their opinions will be heard.

#### AREA 83 EASTERN ONTARIO INTERNATIONAL

Good day friends. I am an alcoholic, a grateful member of the Get Well Group in Kingston, and it is my honour and privilege to serve as the Correctional Facilities Chair for Area 83 and my name is Mac.

Since the September Area Committee Meeting I have received a number of Bridging the Gap Requests and was able to pass them on to the appropriate Areas and Districts. Two were particularly challenging. There were two inmates being released from a Correctional Facility in upper New York State and going to Islip N.Y. and Rochester N.Y. It took me awhile to find the correct Areas. But I finally got the right ones.

I received a Corrections Activity Update from Diana L, the Corrections Coordinator at the General Service Office in New York. 2017 General Service Conference

Here is an update on the additional considerations from the Conference Corrections Committee:

- A letter was created to be sent to corrections professionals in Canada raising awareness about the Corrections Correspondence Service (CCS) in Canada and summarizing its benefits. The letter was targeted to those roles who have daily contact with inmates: activity coordinators, counsellors and social workers.
- A postage-paid envelope was implemented to reduce the initial postage cost for "inside" Canadian members to sign up for the CCS. We are mailing samples out to incoming Corrections, Bridging the Gap, and H & I Area Chairs and Delegates in Canada.
- A memo was sent out to Canadian Delegates and District Committee Members sharing a brief history of how CCS started at the ground level, to be shared with Canadian members at the local level.
- The CCS request form for "inside" members was added to the Corrections Committee page on G.S.O.'s A.A. website, in order to make it more accessible to local corrections committee members.
- Ways to offer CCS via email were explored. The CCS matches will continue to be randomly based on a physical address that is two regions away. Once an insider and outsider have made contact, they can switch to email if mutually agreed. Various email services are offered at some correctional facilities.
- The pamphlet "Many Paths to Spirituality" was added to the Corrections Kit to aid local committee work to carry the message to incarcerated Native America/First Nations/Inuit People.
- A.A.W.S. received and approved a request to produce versions of the video "A New Freedom" that are dubbed in French and Spanish to make the A.A. message more accessible. This project is in progress.

**National Corrections Conference** 

The first National Corrections Conference was held in St. Louis, MO on November 10-12. There were 35 states, including the territory of Puerto Rico, and 4 Canadian provinces represented. It was a huge success. Over 389 AA members involved in corrections service attended. The 2018 conference will be held next November in Maine. I hope to be able to attend and represent Area 83.

I am an Alcoholic, a member of the Liverpool Group in District 26, Pickering and my name is Amy. I am grateful to be of service as Area Registrar for Area 83.

The roll call for the Area Committee of January 6, 2018 is:

15 Area Officers (including, and Area Webmaster), 1 Immediate Past Delegate, 0 Past Delegate(s), 15 District Committee Members, 13 Alternate District Committee Members and 9 Visitors.

For voting purposes, we have: 12 Area Officers eligible to vote (including 1 Immediate Past Delegate) and 16 District Committee Members plus 1 Alt DCM for a total of 28 votes. Total delegation for this meeting is 51.

#### AREA 83 EASTERN ONTARIO INTERNATIONAL

I continue to enjoy serving Alcoholics Anonymous as Registrar for Area 83. I have been so impressed with the effort and cooperation that the districts have shared with me over the last 12 months to do our part to keep each of the 560+ groups in Area 83 connected to AA as a whole.

I anticipate that I will be receiving a number of new Group Service Representatives and their Alternates in the upcoming weeks. Feel free to let your registrar know that they can submit these one at a time, or all at once.

I will be sending out Group Information sheets in the next week or so. Please tell your registrars to feel free to use these forms to submit your changes for Group information changes (including meeting details and GSR contact information and number members in the group). I want to remind you that an individual cannot be entered into the GSO database without an up-to-date mailing address. I have received a few forms that included just a name and maybe a phone number. In these cases I had to send it back to the district registrar to track out the complete details.

I took a chance and sent a note to a few DCMs to see if Santa brought anyone a GSR for their unknown groups. Low-and-behold, I was promised details for 4 unknown groups. If all come through, we should be down to 11 unknown Groups.

GSO has advised me that the Publishing department of GSO is reviewing and updating the components for the GSR and New Group Handbooks, therefore there is a delay in the delivery of these kits. Furthermore, there is a flush of changes in the new year that will be going through GSO (e.g., 40 some of the Areas are going through whole scale rotations) so this will add additional delays. I mention this, because if you have new GSRs that are keen to review their GSR kit, remember we have a link posted on the Area Website under Registrar Resources to the online documents that are included in the GSR kits. Please encourage these enthusiastic GSRs and their Alternates to start reviewing the contents online while they wait for their hard copy kits arrive.

Thank you to the Districts that send me your minutes; I enjoy reading them. If I am not on your District's distribution list, I would appreciate if I could be added. Send your minutes and any group updates to me at registrar@area83aa.org.

#### 8. Treasurer's Report

Sue B

Hello friends. I am an alcoholic, a member of the Parkwood Hills Group in District 62, and my name is Sue. It remains both my honour and a privilege to serve as your Area 83 Treasurer.

I have provided two envelopes with my address in each of the District Committee Members (DCM) folders. There are several envelopes also available on the side table, please help yourselves to them. Please thank the groups in your District who are including their Service Number either on the envelope or right on the cheque. It is very helpful, and appreciated.

Please continue to remind Groups who would like to contribute using PayPal to include their six-digit Group Service Number with any contributions using PayPal so that the Group may get credit for the contribution. The place to enter the Group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. There were eight contributions received in 2017 through PayPal.

The Financials were updated as of December 31, 2017 and will be part of the four-year average calculation used to determine the Proposed Spending Guidelines for 2018. I will be presenting these Guidelines at our Spring Assembly.

#### AREA 83 EASTERN ONTARIO INTERNATIONAL

The General Service Office (GSO) sends out a record of the Group contributions from Groups in our Area to the GSO several times a year. The latest ones received, dated September 30, 2017, have been put into the DCM folders for information purposes. The percentage of the 559 Groups in our Area that have contributed to the GSO as of September 30, 2017, was 34.35%. At December 31, 2016, it was 44.56%.

Also in the DCM mail folders, as well as the Area Committee Members folders, you will find copies of the Financial Statement for the period ending December 31, 2017. Copies of these are also available on the side table. Let's go through the numbers now.

<u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000, and is in the form of a GIC maturing September 11, 2020. The previous GIC matured on September 11, 2017 and \$1,800.00 in interest was transferred to the operating account.

#### Income for the period:

- 7th tradition collected at the January, June, and September Area Committee Meetings totaled \$799.29. At the Spring Assembly, \$3,541.62 was collected, and \$4,123.40 was collected at the Fall Assembly. Total of all = \$8,464.31.
- Cost Recovery is \$775.25. This is from the sale of Public Information Kits Les sold at the Spring Assembly, and for Service Manuals sold by the Service Information Day Committee at both the Spring and Fall Assemblies.
- GSO Flow Through = \$120.00. (A Flow Through is when a Group sends a cheque for ie \$120.00. They request a certain amount of the monies be allocated to Area 83, ie \$60.00, and the remainder be sent to the General Service Office. This is shown as Income as the total cheque of \$120.00 is deposited.)
- Grapevine Seasonals = \$4,244.39 collected for Pocket Planners and Calendars.
- Group and District contributions = \$57,508.19.

Total income for the period is \$72,672.14.

#### Expenses for the period:

- Committee expenses were \$41,022.84.
- Area Contribution to the General Service Office = \$750.00.
- January, June and September Area Committee Meetings Rent and Refreshments = \$919.23.
- General Service Conference Assessment \$8,688.10 CDN. (Total cost was \$6,500.00 US, and has been paid in full.)
- Bank service charges \$186.67.
- PayPal Fees \$37.61.
- Grapevine Seasonals \$3,970.89 CDN (\$3,113.54 US). This includes a courier fee of \$26.70, and \$15.00 for money orders.
- GSO Flow Through \$120.00. (A cheque from the Area in the amount requested, ie \$60.00, from the example given above, is now
  written and sent off to the General Service Office. This is now shown as an expense, as the monies will be deducted from the
  Area's Operating Account.)
- CERAASA, held in New Brunswick in February 2017 \$2,437.53

Total expenses for the period are \$57,892.87.

To date income is \$14,779.27 higher than expenses.

The bank balance on December 31, 2017 was \$44,557.43. As of that date, all cheques received have been processed, and letters of receipt, along with return contribution envelopes have been sent out.

The bank reconciliation has been done and the balance in the operating account is accurate.

#### AREA 83 EASTERN ONTARIO INTERNATIONAL

<u>Page 2</u> shows the details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses for 2017.

Just to clarify some of the numbers that you see here:

- The amount shown on the Alt/Delegate line under postage, \$29.52, is for mailings of Grapevines to Remote Communities. Under miscellaneous, \$1,013.29, is for the purchase of 1,000 Area 83 pins which was approved under New Business at the 2017 Spring Assembly, and for Remote Communities phone calls.
- Beside both the Spring Assembly, and Fall Assembly, under meals, you see \$5,600.00 which covers the cost for coffee. For the Spring Assembly, in that same line under miscellaneous, the amount of \$1,241.86 includes the Archives room, DVD rental, data projectors and the set up of the ballroom. Under miscellaneous for the Fall Assembly, the cost is \$1,098.08 as less equipment etc was required.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that "provided it doesn't affect our prudent reserve, Area 83 will pay to the GSO the full annual expense for our Delegate to attend the General Service Conference." The total cost this year was \$6,500.00 US, or \$8,688.10 CDN for our Delegate to attend and has been paid in full.

At the bottom of the page is a summary comparing year to date for this year and last year at the same time period. If you look under "Change" in the summary, Income is \$5,666.50 higher compared to this time last year, and contributions are up \$3,107.28 compared to this time last year with one more Group, and one more District contributing in comparison. Expenses are down \$3,256.71. The resulting net change to our operating account is \$8,923.21.

<u>Page 3</u> shows contributions by District. These amounts include contributions from Districts, as well as Groups within the District. You can see that 178 Groups and 17 Districts made financial contributions to Area 83 in 2017.

The rates for the 2018 Spring Assembly, being held March 23 – 25, will be as follows:

#### Room Rates:

- Traditional, 2 Queen Beds \$105.00 + applicable taxes
- Business Class King \$115.00 + applicable taxes

Our block of Hotel rooms will be held until Wednesday, February 21, 2018. After this date, you will not be guaranteed a room. Remember to quote the Group Name: "Spring Assembly" when you call.

#### Food and Beverage Prices:

- Saturday Dinner Buffet \$35.00 per person includes gratuity and tax
- Coffee Service \$15.00 per person includes gratuity and tax

Last year the Ambassador charged \$14.00 per person for coffee over the weekend. This year the Spring Assembly cost per person for coffee over the weekend will be \$15.00. Please share this with your Districts and Groups, and remind them that all the 7<sup>th</sup> Traditions and Coffee Can contributions collected over the weekend are entirely used to cover this coffee cost.

The 2018 General Service Conference (GSC) will be held in Manhattan, NY in April of this year. The cost of this event will be sent out to Delegates later this month, however the minimum required payment is \$1,600.00 US which is due by March 1, 2018. The GSC was last held in Manhattan in 2016 at a cost of \$7,400.00 US or \$10,412.40 CDN and was paid in full by Area 83.

As per the motion passed in 2007, that "provided it doesn't affect our prudent reserve, Area 83 pay to GSO the full annual expense for our Delegate to attend the General Service Conference", once our Delegate informs me of the GSC cost, I shall pay it in full by March 1st, and will report this amount to the Assembly in the Spring.

#### AREA 83 EASTERN ONTARIO INTERNATIONAL

The 7th Tradition collected today was \$231.80. Thank for your generous contributions.

I would like to thank those Districts who send me their Minutes; I love to read them. For those that do not, it would be great if you could please add me to your distribution list.

In closing, thank you to the 178 Groups and 17 Districts that made financial contributions to Area 83 in 2017; you are greatly appreciated!



## About this Project

Wouldn't it be great to have an app to help find AA meetings nearby, wherever you are? We think so! This project is a first step in that direction.

## The Problem

It can be a hassle to find AA meetings. First, you have to find the website for your area. If you're near a border, it might not be clear which website has the closest meetings. Sometimes the site, app or printed guide you're looking at is out of date. Or perhaps it's not even the 'official' list.

It's worse if you're traveling, because you probably have limited time, local knowledge, and transportation options. Once you find the right list, you might find it's in an unfamiliar format, and grouped by unfamiliar neighbourhoods.

For newcomers, finding a meeting can be daunting when they encounter unclear terminology, such as meeting codes, that require prior knowledge of the program.

Sometimes these sites are not formatted properly for mobile devices. Most AA websites get more than twice as many visitors from handheld devices as from traditional PCs.

This project is an attempt to standardize meeting information so that it's always readily available on your device, up to date, and clearly and consistently formatted. Additionally, the apps provide tools such as easy links to driving directions and tools to share meetings by email or text message.

## How It Works

Meeting information changes constantly. This system updates its database by scanning the latest information from compatible official area websites twice daily. To read more about the process, see <u>Get Connected</u>.

## Who Is Responsible?

This project is developed and operated as an AA service project by AA members. Our hope is to give this app to GSO / AAWS. Until that happens, we have formed a nonprofit corporation to operate the app.

## Concerns

We sometimes get questions from AA members about certain aspects of our project. Here is our best effort to answer them.

## The Organization

We understand this is one person's creation. What if something happens to them?

It was originally, but not anymore. We have formed a nonprofit corporation to operate the app. All accounts and passwords are now managed by the nonprofit. If anything happens to the founder, the app will continue to operate independently.

We'd be a lot more comfortable if this were an official AA project

We want to give it to them. We've submitted a proposal to AAWS (on June 5, 2017) to give them the app and help them continue to develop it. We have had subsequent conversations with staff and board members there, and have heard they are considering the offer. We don't expect it to be accepted immediately, but it will remain open indefinitely.

Will you ever charge people to download or use the app?

No. Our mission is to help people find AA meetings, and charging would limit their access.

Will you ever put ads in the app? No.

Will you ever list another program's meetings or resources in the app?

No, but we do help other programs to make use of our <u>12 Step Meeting List</u> WordPress plugin. Including other meetings in Meeting Guide could be confusing and counteract our singleness of purpose.

## The Traditions

#4: Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

How can groups remain independent while federating their data into a single app? We believe that we have found an elegant solution to this problem. This system of a distributed worldwide database allows individual sites to remain fully autonomous, while still contributing to the whole. And this is not 'our' system, this is AA's system. We have simply developed a protocol that other apps in the future might make use of as well.

#5: Each group has but one primary purpose — to carry its message to the alcoholic who still suffers. We believe this is the best reason to participate in the app. We help intergroups connect alcoholics with their AA meeting listings.

#6: An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose.

We don't believe that we are an "outside enterprise," we are an AA service organization in the same sense that a YPAA is. Furthermore, we don't believe that organizations that participate are endorsing us. They are free to link to us from their websites, and many do, but this is not a requirement. Finally, AA service entities make use of outside services all the time. They list their information in telephone directories, some take ads in public places. Most today worry about their website's search engine optimization. We are like an AA search engine.

Meanwhile there are many other apps and websites that copy meeting information from AA websites and list it without permission or attribution, some for a fee or with ads, and many inaccurately. We are the opposite. We get permission first, we attribute our information, we don't charge or run ads, and we maintain our listings assiduously.

#11: Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.

Our App Store listings are fully anonymous as of August 2017.
