We will have our election of the Area Officers at the upcoming Assembly which will be facilitated by our Panel 59 Past Delegate Sandy S. We will also be having an election for our candidate for Canadian Trustee at Large.

The agenda for the Assembly is sent out at least 6 weeks in advance. It is sent to DCM's to distribute to the GSR's. This is so that groups will have time to discuss the items and vote at the group level and at the district level prior to the assembly.

Food:

Lunch has been arranged by our District 34 DCM Gord, at a cost of \$5.00, per serving. Tickets will be sold at the break prior to lunch. You must have a ticket to be served.

Thank-you Gord for organizing the lunch, refreshments, and snacks.

Seating:

As much as possible – District Committee Member's and Sub-Committee chairs sit on the outside of the tables. Alternate District Committee Member's on the inside. Visitors and Past Delegates are asked to sit at the tables set up at the sides of the room. This seating arrangement helps to facilitate the voting.

Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

How do we vote?

Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone may raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority. The items under new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

Minority Opinion:

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the original motion.

Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who may address the committee meeting?

It has been the practice at the Area committee level to use the same principle as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons

It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly – members are representing their District's positions or Area's in the case of our Officers, rather than their own.

7. Registrar's Report

Amy L

I am an Alcoholic, a member of the Liverpool Group of District 26 in Pickering and my name is Amy. I am grateful to be of service as Area Registrar for Area 83.

The roll call for the Area Committee of September 8, 2018 is.

14 Area Officers (including Area Archivist and Area Webmaster), 1 Immediate Past Delegate, 1 Past Delegate, 19 District Committee Members, 17 Alternate District Committee Members and 11 Visitors.

For voting purposes, we have: 11 Area Officers eligible to vote (including 1 Immediate Past Delegate) and 19 District Committee Members plus 4 Alt DCM and 2 visitors representing the Districts for a total of 36 votes. Total delegation for this meeting is 62.

Well, I hope that you have had a nice summer. I am sending out my thanks to those districts who scrambled to get contacts for the Unknown Groups since we last met. We have gone from 19 unknown groups in June to today having only 11 with the promise of one more contact immediately following the ACM.

I have heard from the Records Manager in GSO that the FNV database will be undergoing some modification. They will be moving to a CRM (Customer Relationship Management) database, that they are referring to ERP (Enterprise Resource Planning system). ERP is a business software that will allow us to integrate all facets of the GSOs operations into one repository. Instead of having three individual databases the new system will hold information for Group and service records(FNV), publications, order entry records, contribution records as well as GSOs accounting, procurement and production information.

The Records Manager said that each department is actively working with our I.T. department and the developer to ensure all needs are met. We are at the stage in the process, where we will get to see what each departments interface will look like and if it meets the GSOs needs. All things going as planned they expect to go live with the system February 1st, 2019.

I have been told that the interface for Area Registrar's will look completely different, but I am sure that it is nothing more than we can handle. I asked the manager if there was anything that the Area Registrar's could do to make the transition to the new system run more smoothly.... And she said that – "In the case of area 83 there are only 11 unknown groups listed. It may be helpful to pass those unknown groups off to the DCMs for the districts to see if they are able to get primary mail contacts, GSRs for those particular groups."

For what it is worth, I think the information in FNV is very clean and up to date.

If there are any Groups that are electing and installing their new GSRs before the end of 2018, please get that information to me as soon as possible. It would be nice to have all service positions entered before FNV becomes ERB. Having some experience with shifting databases to new systems, (and how a lot of unexpected things can happen) I suspect there will be some hiccups in the beginning. So the earlier you get your changes in, the better chance new GSRs won't have to wait too long to get their kits.

I do have hard copies of New Group and Group Change forms. Otherwise these can be found on the Area's website (http://www.area83aa.org/resources/area-registrar).

8. Treasurer's Report

Sue B

Hello friends. I am an alcoholic, a member of the Parkwood Hills Group in District 62, and my name is Sue. It continues to be both an honour and a privilege to serve as your Area 83 Treasurer.

In each of the District Committee Members mail folders, I have provided the General Service Office (GSO) District Quarterly Report as of June 30, 2018, regarding contributions from each group received by the General Service Office. There are also two Area 83 contribution envelopes. Please share these with your District Treasurer for future contributions. Please find several more envelopes available on the side table. I would like to thank all the Groups that provide your Group Service Number and a return address either on the envelope or the cheque. This is really helpful, and greatly appreciated, as sometimes our writing can be hard to decipher. It also lets me know where the letter of receipt is to be sent back to.

Contributions can also be made using PayPal. Please remind Groups to include their six-digit Group Service Number with any contributions using PayPal to ensure the group will receive credit for the contribution. The place to enter the group number is the screen after entering the credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. So far this year, there has been two contributions using PayPal, both by the same Group.

Also, in the District Committee Members mail folders, as well as the Area Committee Members folders, you will find copies of the Financial Statement as at August 31, 2018. Copies of these are also available on the side table; let's go through these numbers now, please.

<u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest maturing September 11, 2020.

Income for the period:

- 7th tradition collected at the January and June Area Committee Meetings and the Spring Assembly = \$3,685.70
- Cost Recovery is \$123.50; this is from the sale of Service Manuals at the Spring Assembly in Kingston, and two more since then
- Group and District contributions \$37,270.77

Total income for the period is \$41,019.97.

Expenses for the period:

- Committee expenses are \$23,665.44
- January and June Area Committee Meeting Rent and Refreshments \$748.23
- General Service Conference Assessment \$10,386.94 CDN; total cost was \$8,200.00 US and has been paid in full to the General Service Office
- Bank service charges \$174.48
- PayPal Fees \$3.50
- Forum, held in Victoriaville, Quebec \$1,757.87
- GSO Flow Through \$60.00
- Ontario Delegate's Conference (ODC), held in Thunder Bay \$1,603.80

Total expenses for the period are \$38,280.26.

To date income is \$2,739.71 higher than expenses.

AREA 83 EASTERN ONTARIO INTERNATIONAL

The bank balance on August 31, 2018 was \$47,297.14. As of that date, all cheques received have been processed, and letters of receipt, along with return contribution envelopes were mailed out.

The opening bank balance as of January 1, 2018 was \$44,557.43. Total income of \$41,019.97 less expenses of \$38,280.26 leaves a balance of \$47,297.14 in the operating account as of August 31, 2018. We have \$2,826.36 less in our operating account this year compared to this time last year.

The bank reconciliation has been done and the balance in the operating account is accurate.

<u>Page 2</u> shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date.

Just to clarify some of the numbers that you see here:

Under Committee Expenses:

- The amount shown for Treatment/Accessibility under Literature, \$341.94, is for an order purchased from the GSO. Both displays required replenishing as this has not been done in a few years.
- The amount shown for the Spring Assembly under Literature, \$526.55, is for the order of Service Manuals purchased from the GSO. Monies from the sales is then placed under Income in cost recoveries. There is no mark up in price.
- Beside the Spring Assembly, under meals you see \$5,997.65. This is an Assembly expense which covers
 coffee/tea/pop, cleaning of the atrium, meeting rooms, and staff etc. We are also not charged for the majority of room
 rentals during our Assembly weekends. The above cost works out to be \$15.00 per person. In the same line under
 Miscellaneous, the amount of \$1,113.00 includes the rental of the Archives room, DVD rental, data projectors and
 the set up of the ballroom.

Under Other Expenses:

- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that
 "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to
 attend the General Service Conference." The cost for Delegates to attend this year was \$8,200.00 US, or \$10,386.94
 CDN and has been paid in full.
- Forums \$1,757.87. The Forum was held in Victoriaville, Quebec from July 20-22nd. The cost for our Delegate's meals and hotel have yet to be included. As per the Area's Operating Procedure's the reimbursement is for both our Delegate, and Alternate Delegate to attend.
- Ontario Delegates Conference (ODC) \$1,603.80. Was held in Thunder Bay this year from March 2-4th. The costs reflect the reimbursement for the Delegate and Alt/Delegate to attend as per the Area's Operating Procedure.

At the bottom of the page is a summary comparing year to date for this year and last year at the same time period. Income is \$48.32 less than last year at this time and expenses are up \$2,782.54 (no Forum last year, General Service Conference (GSC) held in New York, NY etc). Contributions are up by \$702.89 compared to this time last year. There have been five less Groups and two less Districts contributing in comparison. The resulting net change to our operating account is \$2,826.36.

<u>Page 3</u> shows contributions by District. These amounts include contributions from Districts, as well as Groups within the District. You can see that 134 Groups and 13 Districts have made financial contributions to Area 83 so far, this year.

Delegates and Alternates from Eastern Canada met for breakfast. Jan got to know us a little bit better and we got to know her as well. She was elected at the conference in April. Also, Luke the CERAASA Chair, gave us an update on which Rob has already reported on.

A couple of updates since the conference. There is a new Punjabi Big Book available at the Toronto Intergroup office. From the International Desk, Mary Cummings passed on several items about AA in other countries. She said that in Russia they have two GSOs but they don't get along. We have one GSO office that serves Canada and the USA. Mary also mentioned that she loves to hear about meetings "off the beaten path". If you happen to know of any, GSO would be happy to send out literature free of charge. Mary won't be on that desk anymore as they are rotating right now. Clay may be coming in to replace her.

One of the presentations I found most interesting was from the trustee Newton Prichard showing us a prototype of a world map. Clicking on a certain country there would be a drop down tab that would list meetings, etc. I almost didn't go to this meeting but was so glad I did. It was so interesting. His question was "Is this something we want? Does the cost outweigh the benefit?" So it is something to think about. Actually, in the board minutes, the committee will be bringing this up again. They will be deciding how to proceed the same weekend as our Assembly.

As I mentioned in June, in 2019 the GSB will be looking for two Class A Trustees. If you know someone in the professional field please pass on this information. Keep in mind that this is for "Amateurs" – not alcoholics.

From July 9th to the 22nd a poll was taken at the 68th GSC to resolve a discrepancy with the scheduled dates of the 69th GSC. There was 100% participation. Confirmed through the polling, the conference dates are now May 19-25th. There was a conflict with Easter weekend. They decided to put it out to the conference members to vote. There was a minority opinion. Many emails went around. Interesting to part of this kind of poll situation. The dates are now set. Things like INFO AA Day may need to be changed as it can't be in May next year. Some Areas have been burdened financially by the change. Jan asked if anyone could tell her how much the inconvenience may cost. While we are not effected some Areas are.

On July 30th the GSB held their third quarterly meeting, Jan sent us her diary of her trip to the meeting. It was interesting to hear as she shared each day of her experience. Jan has been assigned to the following committees: Corrections, Literature, CPC, Treatment/Accessibility. All trustee committees reviewed their composition, scope and procedures as well as their 2018 conference advisory actions and additional actions. First up for her was Corrections and she was named Vice Chair of this committee. That was her first board meeting! For CPC, Treatment/accessibility she was appointed to a sub committee regarding the deaf and hard of hearing. This is done predominantly by conference calls so she looks forward to seeing how this goes.

Some of the information, as I also receive some of the board minutes, are unofficial as they haven't been accepted yet. But just a couple of items I wanted to share with you. PI – Video PSA "Changes" is in post production. This item was approved at the 68th conference and is being added to aa.org.

The AAWS YouTube copyright notices and custom URL page have all been implemented on the YouTube channel. Subscriptions have increased to 1300 with new subscriptions daily.

The Anonymity in the Digital Age placard in the medium size, 11X17, is now being priced at \$11 each. The smaller one, $8 \frac{1}{2} X 11$, is priced at \$8.50. Not sure how much the posters will be but they are in production.

They also set up an ad hoc committee to look at the Safety Card because of feedback from the fellowship. They want to make sure that this is really what we want and/or need.

Carrying the message of the program through AA Grapevine and La Viña remains the focus. Subscriptions and product sales are essential to self support which Ray mentioned – they are self supporting. Please remember that Grapevine is completely self supporting with no contributions. Digital and print will continue to gradually decline without more effective outreach to the fellowship. The Grapevine app continues to gradually find its audience.

In CPC the secretary reported the progress of the LinkedIn page. The committee agreed to move forward being realistically mindful of what the company page can really accomplish.

These are just a few items from a 63 page report. Something I wanted to bring to your attention is the time that the Trustees are putting in. When we give our report about where we have been I am amazed at how much time they put into serving the fellowship. Next time you see a Trustee, shake their hand and say thank you because they are putting in a lot of time.

Tomorrow I am participating in the District 2 inventory. September the 11th I was scheduled to do a District 18 safety and inventory audit but the DCM could not attend and I felt that it was very important for the DCM to be present. That's going to be rescheduled. Will also be attending District 14 Service Day next weekend. I am also taking part in the Toronto Gratitude Conference from October 5 to 7th – talking on service. The Scarborough Roundup is on October 13th and on November 14th the District 12 inventory. District 2 Service Day is on November 24th.

The GSO is going through their rotation at the moment. People are moving desks and being trained. So if you email someone and it takes a bit more time than usual for them to get back to you, that's why.

Note: At this point in the agenda, I would like to recommend that we move to 2/3 majority. May I have a motion to move to 2/3 majority?

12. OLD BUSINESS

a) Discussion to revisit the motion put forward at the June Area Committee Meeting regarding the closing of meetings at the Assemblies and the Service Information Day.

(Mike B, DCM District 62) - Rob M, Alternate Delegate

[MIKE B WITHDREW HIS NAME FROM THIS MOTION AND ROB M TOOK UP THE MOTION]

The motion was: "We close the Friday and Saturday night speaker meetings with the Responsibility Declaration AND the Lord's prayer. All the workshops close with the Responsibility Declaration only"

Rob M (Alternate Delegate) made the following statement about his motion:

"Some Groups and Districts have a policy that motions can't be revisited for a period of time. This is in place to prevent the unsuccessful side from trying to reverse a motion they don't agree with at the next meeting. That's not what I'm trying to do. Although I voted against the motion in June, I'm a firm believer that an informed Group conscience will make the right decisions, even if I don't agree with them. Concept 5 says throughout our world service structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered. It goes on to say the traditional "Right of Appeal" should permit any person in our service structure, to petition for the redress of a personal grievance. The "Right of Petition" makes certain that grievances can be heard, and properly acted upon. These general principles can of course be used to good effect throughout our entire structure.

I don't really have a personal grievance, but I think the spirit of concept 5 allows us to revisit a motion if we believe it's necessary.

It's not so much the motion that I want to discuss, but how we got there, how it would be implemented, and possible repercussions.

At our meeting in June, I was of the belief that any motion changing the operating procedures would have to go to the Assembly, and I think many of you probably thought the same. In section 5 of our operating procedures it says "Appendices are deemed as guidelines

and NOT operating procedures and as such are written, amended, and approved by the Area Committee not the Assembly". The Service Information Day guidelines are appendices, so basically the motion that passed in June is a done deal, it doesn't have to go to the Assembly.

We talk about the Groups being at the top of our Service structure, Concept 1 and Tradition 2 reinforce this. We made a very important decision in June without any consultation of the Groups, and again many of us may have thought the groups would have their say at the Assembly.

Our operating procedures were written in the early 90s, and were purposely left fairly non directive. Some might think they are vague, but this was done to not box future committees in. They didn't want too many rules saying you will do this and that. Over the years we've added bits and pieces of rules, this would be another one. The Saturday banquet isn't mentioned in the SID guidelines. The only mention of the banquet is in the operating procedures under section 3, responsibilities, # 17, SID Committee and says The Delegate shall select the Saturday night dinner speaker. If we're going to add something about closing the meeting, we should probably more about the meeting itself.

When the motion passed in June Kimberley wasn't sure where it would go in the operating procedures, does the Saturday banquet belong to the SID even though it's not mention in the SID guidelines, does the motion go to the Assembly? She spoke with some past Chairpersons, past Delegates, some of us at the front of this room, and it was felt this should be further discussed.

I was talking with a member last Monday who shared with me a situation at a seniors club. It's a private club that has been around for many years, and has around 2000 members. They open their meetings (he didn't say what kind of meetings) with the Lord's Prayer. Recently a Jewish member expressed opposition to this. The club sought legal advice and were told the Jewish member could take it to the human rights tribunal, and would be successful. The club would have to stop the Lord's Prayer, or say prayer for every denomination belonging to the club. They were also told that they'd be on the hook for any legal costs. Something we should think about.

The last 2 times Adhoc committees were formed regarding the SID guidelines, they reported, and made recommendations to the Assembly, and the recommendations were voted on by the Assembly. Although our operating procedures say amendments to the SID guidelines are done by the Area Committee, there is precedent for the Assembly to make amendments.

My biggest concern is that we, the Area Committee, may be making important decisions that will affect the Assembly, without first consulting the Assembly.

So, we can decide that the motion passed in June, now it goes into the SID guidelines as our operating procedures state, or we can decide to take it to the Assembly, and let the Groups have some input on this very important decision.

I hope some of you will share your thoughts on this, and we can come to an informed decision.

From Concept 3

This "Right of Decision" should never be made an excuse for failure to render proper reports of all significant actions taken; it ought never be used as a reason for constantly exceeding a clearly defined authority, nor as an excuse for persistently failing to consult those who are entitled to be consulted before an important decision or action is taken."

Discussion then moved to the floor.

Seems there was little consultation with groups and those it would effect. How will this effect the upcoming Assembly?

This is too important to be rushed through. Suggested to revisit in January with new DCMs and then brought to the Spring Assembly. Timing is challenging for some Districts due to elections, etc.

The concern is more about some 40 people making decisions that effect over 600 groups.

The following excerpt from Bill W was read aloud:

"A Letter From Bill Wilson About The Use Of The Lord's Prayer At A.A. Meetings

April 14, 1959

Dear Russ.

Am right sorry for my delay in answering. Lois and I were a long time out of the country and this was followed by an attack of the marathon type of flu that has been around here in New York. We are okay now, however, but I did want to explain my delay.

Now about the business of adding the Lord's Prayer to each A.A. meeting.

This practice probably came from the Oxford Groups who were influential in the early days of A.A. You have probably noted in AA. Comes of Age what the connection of these people in A.A. really was. I think saying the Lord's Prayer was a custom of theirs following the close of each meeting. Therefore it quite easily got shifted into a general custom among us.

Of course there will always be those who seem to be offended by the introduction of any prayer whatever into an ordinary A.A. gathering. Also, it is sometimes complained that the Lord's Prayer is a Christian document. Nevertheless this Prayer is of such widespread use and recognition that the arguments of its Christian origin seems to be a little farfetched. It is also true that most A.A.s believe in some kind of God and that communication and strength is obtainable through His grace. Since this is the general consensus it seems only right that at least the Serenity Prayer and the Lord's Prayer be used in connection with our meetings. It does not seem necessary to defer to the feelings of our agnostic and atheist newcomers to the extent of completely hiding our light under a bushel.

However, around here, the leader of the meeting usually asks those to join him in the Lord's Prayer who feel that they would care to do so. The worst that happens to the objectors is that they have to listen to it. This is doubtless a salutary exercise in tolerance at their stage of progress.

So that's the sum of the Lord's Prayer business as I recall it. Your letter made me wonder in just what connection you raise the question. Meanwhile, please know just how much Lois and I treasure the friendship of you both. May Providence let our paths presently cross one of these days.

It is already in the Procedures & Guidelines "in spirit" but not worded exactly like that.

SENSE OF THE ROOM was taken. It was unanimous to send the Immediate Past Delegate to CERAASA (ODC is included).

b) Discuss DCM reports at election Assembly Kimberley M - Chairperson

For the last four election assemblies, the Area Committees have chosen to dispense with the verbal DCM reports and instead, submit written reports to the Area Secretary by email to be included in the Assembly minutes. Would you like to continue this practice?

Before taking a sense of the room, is there any discussion? No.

Can I take a sense of the room? This is not a vote and anyone in the room can raise his or her hand.

UNANIMOUS to dispense with the verbal DCM reports for this election Assembly.

There was an Ad Hoc Committee reviewing Area Assembly Election Procedures a few years back. With regards to posting her sobriety time, she is very very careful. An anonymity workshop was presented at the beginning of the term. And seeing as she was on the PI committee at the GSC this was discussed a lot. The anonymity card and subsequent posters is something that they really really wanted. At the last International Conference — anonymity can be broken with just one touch. All you

have to do is press a button and you have broken someone's anonymity – either your own or someone else's. And she found this important enough to bring up as a separate agenda item and not bury it in her report. She wanted to open it up a little bit and get a conversation going. Of course, it is not just what she thinks about the topic of anonymity but to hear from the Area Committee and see what their thoughts and ideas are on the subject. This is not just about Facebook but Instagram and all other social media platforms.
