Assembly rooms cannot be booked online. Call the Ambassador hotel and quote the group name AA March 2019 or AA October 2019. Our discounted block of rooms is held until 30 days before the Assembly.

NOTE: Westminster United Church now requires (as of January 1, 2019) insurance for groups meeting in this building. We acquired the necessary insurance at the cost of \$187.92 for the full year – that would be 3 ACMs.

The agenda for the Assembly is sent out at least 6 weeks in advance. It is sent to DCM's to distribute to the GSR's. This is so that groups will have time to discuss the items and vote at the **group level** and at the **district level** prior to the assembly.

<u>A REMINDER</u> there is a motion that has been deferred to our upcoming Assembly regarding how we end the Friday and Saturday open meetings over the Assembly Weekend. In advance of the Spring Assembly, this motion should be discussed and voted on at the group level and brought back to the District. This will help all the DCMs and GSRs to have an informed group conscience that they bring to the Assembly.

Recycling and garbage disposal. Please adhere to the signage, and if in question, ask someone for help. Washrooms, keep them tidy please.

Food: Lunch has been arranged by Maria M. alt DCM of District 30 at a cost of \$5.00, per serving. Tickets will be sold at the break prior to lunch. You must have a ticket to be served.

Thank-you Maria M., Alt. DCM for District 30 for organizing the lunch, refreshments, and snacks.

Seating: As much as possible – District Committee Member's and Sub-Committee chairs sit on the outside of the tables. Alternate District Committee Member's on the inside. Visitors and Past Delegates are asked to sit at the tables set up at the sides of the room. This seating arrangement helps to facilitate the voting.

Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All District Committee Member's of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

How do we vote?

Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone may raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority. The items under new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

Minority Opinion:

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the *original* motion.

Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who may address the committee meeting?

It has been the *practice* at the Area committee level to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons

It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly – members are representing their District's positions or Area's in the case of our Officers, rather than their own.

It also maximizes the time available for members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I mentioned, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcomed to participate and their opinions will be heard.

District 02 is alive and well! At our last meeting, we had 73% attendance of General Service Reps. We only have four of our twenty-three groups in Toronto, the rest being in Brampton and Malton. Currently, our business meetings are in the West Toronto area. We are in the process of looking for a venue in Brampton in the hopes of improving attendance. As well, I and Bob D., our Archives Chair will be visiting all groups to encourage General Service Reps, and to do an Accessibility Checklist to forward to the Intergroup Committee to update our Meeting Guide. Just to note, we want to discover Groups who are or are not accessible – there is no "partial" accessibility.

To date, we have only five Committee Chairs: Accessibility, Archives, Intergroup Liaison, Grapevine and CPC/PI. With incoming General Service Reps, we hope to fill the remaining Committees.

Financially, we are struggling, but hope to turn this around in the next few months.

Our first business meeting of the Term is Sunday, January 13, 2013 and we will begin discussion about our Service Day.

In other matters, as Chair of the Information AA Day, I have contacted the General Service Office via email and expect to hear back from them by month's end with a Speaker. We do have a venue, Bar-Parkdale Presbyterian Church, 250 Dunn Ave., Toronto, which is the current location of the Sunnyside Group. We meet again Monday, January 28, 2019 and encourage anyone who is interested to come on out and support us in any way. There are many tasks and positions to fill.

The Concepts Committee, which brought a very successful Workshop to Toronto in November, has asked me to help with a venue West of the city, and I have provided them two locations: St. Paul's Apostle Church in Rexdale, and Bloordale United on Bloor St. at highway 427. Their next meeting will be Monday, January 7, 2019. The hope is to have another Concepts Workshop late April, early May. This concludes my report.

It is rumoured that he didn't just make one phone call but that he made 11 calls until he was directed to an alcoholic. This might have been the first indication of self support. Time & Money! Bill used his own money to travel and also used his own time to carry THE message. Think about it, that was 11 phone calls at a nickel a call, considering the average wase was 25 cents an hour back then.

Please pass along to your District Registrars that it is much easier to identify the changes to a form if they are highlighted or bolded. Updates or new group forms should be sent to me by email and in a Word format. It makes it so much easier to cut and paste information and avoid human errors.

It is important for your groups to update their information as soon as possible. While each district is autonomous, the general practice is to have your District's Secretary or Registrar collect the Change forms and submit them to me. I will enter the new information in the General Service Office's database, called Fellowship New Vision (FNV) and if there are any new GSRs, I flag these people for GSO to send out GSR kits. The place to enter the group number is the screen after entering the credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. So far this year, there has been two contributions using PayPal, both by the same Group.

This initial report was incorrect as the bank charges and the PayPal charges were shown as a credit (income) instead of an expense. The Financial Statement has been corrected, distributed (sent as an attachment on Jan 3, 2019 at 9:23 pm (FILE: Area 83 Financials Jan 5 2019 Revised 2.pdf) and available to the Area Committee for approval at the ACM on January 5, 2019.

In the District Committee Members' mail folders, as well as the Area Committee Members' folders, you will find copies of these revised Financial Statement for the account as at December 31, 2018. Copies of these are also available on the side table; let's go through these numbers now, please.

<u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest maturing September 11, 2020.

Income for the period:

- 7th tradition collected from all four Area Committee Meetings and both Assemblies = \$7,768.10
- Cost Recovery is \$403.00; this is from the sale of Service Manuals, PI Workbooks and Grapevine books
- GSO Flow Through = \$60.00 (A Flow Through is when a Group sends a cheque for ie \$120.00. They request a certain amount of the monies be allocated to Area 83, ie \$60.00, and the remainder be sent to the General Service Office. This is shown as Income as the total cheque is deposited.)
- Grapevine Seasonal = \$3,890.00 was collected for Pocket Planners and Calendars.
- Group and District contributions \$56,082.04

Total income for the period is \$68,083.14.

Expenses for the period:

- Committee expenses are \$46,296.41
- Area Contribution to the GSO \$5,000.00
- Area Committee Meeting Rent, Refreshments and Insurance for three meetings in 2018 \$1,823.21
- General Service Conference Assessment \$10,386.94 CDN; total cost was \$8,200.00 US and has been paid in full to the General Service Office
- Bank service charges \$169.83
- PayPal Fees \$28.75
- Forum, held in Victoriaville, Quebec \$2,319.34
- Grapevine Seasonal \$3,920.51
- GSO Flow Through \$60.00
- Ontario Delegate's Conference (ODC), held in Thunder Bay \$1,603.80

Total expenses for the period are \$71,488.79.

To date income is \$3,405.65 less than expenses.

The bank balance on December 31, 2018 was \$41,151.78. As of that date, all cheques received have been processed and Letters of Receipt have been mailed out.

The opening bank balance as of January 1, 2018 was \$44,557.43. In 2018, total income = \$68,083.14 and total expenses = \$71,488.79.

The bank reconciliation has been done and the balance in the operating account is accurate.

<u>Page 2</u> shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date.

Just to clarify some of the numbers that you see here:

Under Committee Expenses:

- The amount shown on the Area Web Site/Webmaster line under miscellaneous, \$334.80, is the amount of the website hosting services renewal for 2 years provided by PowWeb.
- The amount shown for Treatment/Accessibility under Literature, \$341.94, is for an order purchased from the GSO. Both displays required replenishing as this has not been done in a few years.
- Beside both the Spring and Fall Assemblies, under meals, is an Assembly expense which covers coffee/tea/pop, cleaning of the atrium, meeting rooms, and staff etc. We are also not charged for the majority of room rentals during our Assembly weekends. Under Miscellaneous for the Assemblies are costs for the rental of the Archives room, DVD rental, data projectors and the set up of the ballroom.

Under Other Expenses:

- Area Committee line, under miscellaneous, includes \$187.92 for Insurance covering the three Area meetings in 2018.
- Area GSO Contributions = \$5,000.00 which had been approved at the 2018 Spring Assembly.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating
 that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our
 Delegate to attend the General Service Conference." The cost for Delegates to attend this year was \$8,200.00
 US, or \$10,386.94 CDN and has been paid in full.
- Forums \$2,319.34. The Forum was held in Victoriaville, Quebec from July 20-22nd.
- Ontario Delegates Conference (ODC) \$1,603.80. Was held in Thunder Bay this year from March 2-4th.

At the bottom of the page is a summary comparing year to date for this year and last year at the same time period. Income is \$4,589.00 less than last year at this time and expenses are up \$13,595.92 (no Forum last year, General Service Conference (GSC) held in New York, NY, \$5,000.00 contributed to the GSO, etc). Contributions are down by \$1,426.15 compared to this time last year. There have been sixteen less Groups and one more District contributing in comparison. The resulting net change to our operating account is \$18,184.92.

<u>Page 3</u> shows contributions by District. These amounts include contributions from Districts, as well as Groups within the District. There were 162 Groups and 18 Districts who made financial contributions to Area 83 in 2018.

The rates for the 2019 Spring Assembly, being held March 29 – 31, will be as follows:

• Traditional, 2 Queen Beds - \$107.00 + applicable taxes. A valid credit card is required to guarantee all reservations. When making reservations, contact the Hotel at 1-800-267-7880 and quote the Group Name "Spring Assembly Area 83". (You cannot email your reservation)

Our block of Hotel rooms will be held until February 25, 2019. After this date, you will not be guaranteed a room.

Food and Beverage Prices:

Saturday Dinner Buffet – \$39.50 per person including gratuity and tax

Assembly Fee – \$17.25 per person including gratuity and tax

Please note - before anyone in their new Area 83 positions can order literature, you will require a GSO Service number to do so. I have sent an email off to the GSO requesting this information. I will be sending out an email to all those involved as soon as I am in receipt of this information.

Questions following the Treasurer's report

QUESTION 1: Why is there an increase in the Area Expenses for the Year 2018?

Answer: I have looked at the financials for 2018 and have found the following which may help to explain the \$13,000 increase in expenses.

- \$5000.00 contribution to the General Service Office
- Assembly Cost increase \$917.49
- 2018 Fall Election Assembly \$430.47 for travel reimbursement for Election Chair
- Website hosting service \$334.80 (2 year renewal)
- Insurance for Area Committee Meetings \$187.92 (new expense coverage required by Church)
- General Service Conference held in Manhattan as opposed to Rye, NY for an increase of approximately \$3000.00
- An additional Area Committee Meeting in the last year of Panel 67 approximately \$450.00
- Eastern Canada Regional Forum held in Victoriaville, PQ \$2319.34 (forum held every 2 years)

QUESTION 2: Why was the Fall Assembly \$1196.01 over the spending guidelines?

ANSWER: There are a few items that may contribute to the increase in costs - they are:

- An extra projector was required approximately \$110.00
- Costs for coffee / facility fee per person increase from the Spring Assembly to the Fall Assembly \$602.97
- Ballroom Cost increased \$113.00 (\$100.00 plus HST)
- Travel costs for imported speakers may be an increase as well.

9. SECRETARY'S REPORT

Amy L.

Good morning friends, I am a member of the Liverpool Group in Pickering, and my name is Amy. I have the privilege of serving Area 83 as your Secretary. I met with James on December 9 where he shared his experience, strength and hope as the outgoing Area Secretary. Aside from a number of laughs, I felt like I left with a better understanding of what was expected from this position and comforted by the fact that if I had any question- James and so many of those before me will be happy to clear up any of my issues.

My report will be fairly short with just a few points to make at this early stage of our term.

First, I want to make sure that I am communicating with everyone in the best possible way. When I am sending out communications to the Districts, I am sending it the DCM. We are relying on the DCMs to share this information with all groups and committee chairs in your district. I assure you, if I send something out that is not to be shared (such as Area 83 Rosters, since these have last names included), I will indicate that it should not be shared. Everything else is for the General consumption of members of Area 83, especially at your district. You are the conduits to the groups.

Also, in an effort to save money I want to determine the number of hard copies of the minutes that are required. The Operating Procedures say that I must print at least 3 copies per district. This is the upper threshold, so if your district chooses to not have any minutes printed, I can honour that. I am sending around a sheet for all of the

districts and I open that up to our delegates and appointed positions to let me know if you need a hard copy printed. While you are checking off your needs, you can double check your email and make sure that it is correct and that is the email to which you want to be reached when I am circulating communications.

I have placed a copy of the roster just for your District in your mail folder. Please review this quickly, because, these details are what have been entered into the FNV- this is what GSO will use to mail out service Kits. If there are any address updates required, I would like these ASAP, so that I can enter them before GSO sends out the Service kits. (Note: DCM, CPC, PI, Archives, Corrections, Treatment, Accessibility) all receive kits and it would be wasteful if GSO sent these out to the wrong address- simply because we didn't check the details. Further to that, if you are waiting for your kit, you will find electronic links to all of the contents under the Secretary's tab on Area 83's website.

Lastly, I found that when I was DCM it would have been most helpful to have the ACM minutes available to me at my district meetings when I was giving my report. According to the Operating procedures I am required to send out the minutes within 6 weeks of said meeting. My preference, would be to send the minutes out sooner rather than later. That means, I would need your reports, if not before the ACM, shortly right after. With your cooperation I will do my best to turn these around very quickly.

We're only 5 days into panel 69 and already I have much to share with you.

The 69th General Service Conference will take place in New York City May 19th – 25th. The theme for this year's Conference is "Our Big Book – 80 Years, 71 Languages" and the Presentation/Discussion topics will include:

- 1. Yesterday's World-Our Legacies Begin
- 2. Today's World–Demonstrating Integrity, Anonymity and Service
- 3. Tomorrow's World-Courage to be Vigilant

The General Service Conference runs on the committee system – there are 13 standing committees of the Conference which are mirrored with Trustee's committees. Conference committees do most of their work during the Conference week; the Trustee's committees work throughout the year, getting together during board weekends. Discussion: Rationale for the motion amending the Operating Procedures (Kimberley M.)

At the elections at our last ACM in December, Mel pointed out an anomaly in the Operating Procedures. With respect to the election of the Sub-committee chairs, the Operating procedures state that the members of the Area Committee, except the Area Chair, are eligible to vote. Some felt it referred to the chair of the elections, but it says Area chair. However, with respect to the election of the Area Officers in October, the Operating procedures state that all members of the Area Assembly are eligible to vote. For the election of the Area Officers, this of course makes sense because the Area chair is eligible to stand for a position, so therefore they are eligible to vote. Let's suppose that the area chair stood for a position in October and did not get elected. Then they would be eligible to stand for a sub-committee chair position at the election in December. However according to our operating procedures, they would not be eligible vote. I inquired with past Delegates and past minutes to see why this might be the case. So far, the best rationale I've found is that if the chair is not eligible to vote, then they can facilitate the elections of the Sub-committee chairs. These elections typically take place once every 2 years.

This could save the Area travel reimbursement costs for the facilitator. Of the past 7 elections held for the Sub-committee chairs, only twice did area chairs choose to facilitate the elections themselves. For the other 5 elections, the Area chairs had a past Delegate facilitate the elections. Some of these Delegates were reimbursed and some shared rides and did not need reimbursement.

After talking with some of the past Area Chairs, it is possible they voted in the December elections at the end of their term.

To summarize, here are four reasons why we might permit the Area chair to vote at the election of the sub-committee chairs:

- a. As the operating procedures are now, there is a loop hole where it is conceivable that an Area chair could decide to facilitate the sub-committee election and also stand for a position in that election. Although we hope this would not happen, it is possible.
- b. To create consistency between the elections of the Area Officers and the elections of the Subcommittee chairs so that all members of the Assembly vote for the Officers, and all members of the Area committee vote for Sub-committee chairs.
- c. The Area Chair is a member of the Area committee. Over the term, they have been working closely with those who may be standing for positions. Their vote could be considered just as valuable as every other member of the Area committee.
- d. The Area Chair is eligible to stand for a position, and therefore should be eligible to vote.

One reason against this motion is to permit the Area chair to facilitate the December elections if they choose. This may or may not save the area a small amount of money. If this motion were to pass, the Area chair would not be able to facilitate the elections of the sub-committee chairs. With the elections still fresh in our minds, it seemed like a good time to bring this inconsistency to you as a committee to see if you want to modify the operating procedures as stated in the motion.

In the motion there are 2 locations referenced in the Operating Procedures where this might be changed. The first location refers to the section for the Bi-annual elections, which we just held. And the second location refers to the section for interim elections. These would take place should a sub-committee chair step down and another be elected at some point during the term.

QUESTION: Would an Area chair ever be eligible to facilitate elections if we amend these operating procedures as described above?

ANSWER: No.
