Assembly rooms cannot be booked online. Call the Ambassador Hotel directly. Our discounted block of rooms is held until 30 days before the Assembly.

Food: Lunch has been arranged by Maria M. alternate DCM of District 30 at a cost of \$5.00, per serving. Ron and Hanna are working away in the kitchen. Tickets will be sold at the break prior to lunch. You must have a ticket to be served.

Seating: As much as possible – District Committee Member's and Sub-Committee chairs sit on the outside of the tables. Alternate District Committee Member's on the inside. Visitors and Past Delegates are asked to sit at the tables set up at the sides of the room. This seating arrangement helps to facilitate the voting.

Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

How do we vote?

Procedure: Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone may raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority. The items under new business and old business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

Minority Opinion: A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the *original* motion.

Calling the Question: During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who may address the committee meeting?

It has been the *practice* at the Area committee level to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons:

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly members are representing their District's positions or Area's in the case of our Officers, rather than their own.
- It also maximizes the time available for members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I mentioned, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcomed to participate and their opinions will be heard.

Doreena, our Grapevine chair delivered Grapevine-sized boxes with purple wrapping to our meetings for our groups to place on their literature table in hopes that they will be filled with used Grapevines. These will be passed on to Treatment and Corrections for distribution. Our Registrar/Webmaster position became open in June and we had an election for the

Our finances are in good shape, marginally higher than last year at this time; 16 groups had contributed. We passed a motion to disburse \$1500 to Area and GSO. (Past delegate) will be celebrating 35 years on Thursday Sept 26, 7.30 pm at the Kipling Group. Thank you for my sobriety.

<u>Attendance/Participation</u>: To quickly recap, D10 currently has 26 registered groups. Of which, about 17 regularly attend our District meetings, representing a healthy 65% participation rate.

<u>Finances</u>: Overall, we're in solid shape financially, meeting all obligations, with multiple groups contributing. We contribute to Area and GSO when the budget allows and try to assist groups to attend the Assembly when needed.

<u>Positions</u>: At present, all 5 District Positions and 6 of 9 sub-committee chairs are filled, but it's been a busy period. We recently transitioned Corrections and Archives and activated an Alternate Archives position. Grapevine remains open since April, and more recently, our PI and Accessibility chairs had to step down for personal reasons.

The table has conceptually approved activating **Alternate** Sub-Committee Chairs for Treatment and Accessibility as well.

<u>Service Commitments</u>: We currently put on ~30 service commitments each month which are mostly well attended, and Group participation is high. We continue to monitor facility attendance as well as our own capacity limits.

You have to apply to each Institution for clearance.

D. Treatment Facilities/ Accessibility Shane H.

Good morning friends, I'm an alcoholic and my name is Shane. Grateful member of the reaching out group in District 02. Currently serving as your Treatment/Accessibilities Chair Panel 69.

TREATMENT: Summer for Treatment was steady. A decrease in bridging the gap requests from 10-12 a week to 3-4 on average, but still coming in. During that slowdown, Treatment had an influx of questions coming in from 4 different district chairs. Asking for my experience strength and hope. I was glad I could go back to the traditions and do what I was taught to do and keep referring them back to the traditions. They said that was a great help. It was great to be asked for my experience strength and hope, and to be a part of the districts. Next week I will be presenting on Treatment at District 22's Service day. Things are going well in Treatment. The Treatment chairs are very strong and my main job is that of manger/custodian. Manager, keep the chain emails as low as possible so that not too much time lapses between bridging the gap. Makes it easier for the District chairs and volunteers to mobilize quicker, to at least have 3 days. I did make contact with Area 86 bridging the gap chair. Since then, we have gone from 30% from having no discharge date, no name etc... has decreased to 15%. That makes the custodial job a lot easier. I really love this job, and I am so grateful. I was very worried about doing treatment because of the email and computer work, but you all believed in me and I think I am doing not too bad.

ACCESSIBILITY: This type of service is on the rise in North America with no signs of slowing down. I would like to give special thanks to Amy for sending an email to the DCMs for asking for information if Districts have stand alone accessibility committees. The tally so far, is 11 stand alone committees and 5 that have been added to treatment. That is 16 out of 24- which is not too bad. Over the summer , Bill C. our CPC chair and myself have been working on a webpage for Accessibility for Area 83 and we are hoping to have it finalized for the beginning of October. Bill has done most of the work, with a little bit of input from this drunk. Again, thank you for being a part of it and helping me to get this done. CPC has always been a friend of Accessibility, historically. Accessibility Display needs DVDs of American Sign language; preferring the DVDs in Big Book and 12 and 12, as well as other miscellaneous items. After pricing out these items it will come to approximately \$150. I will have to ask permission for that, as per our Ops.

Three weeks ago, I was given the privilege to give a presentation on Accessibility at District 06 business meeting. It went really well and I would like to thank Susan and Nat for accommodating my schedule. June information AA day I presented on Accessibility, I was given the choice to present on one or both...I considered doing both, but I remembered right of participating and I chose Accessibility and they had the intergroup Treatment chair as well as Christy from District 06 to put on the Treatment presentation and it was wonderful.

The GTA accessibility committee is up and running. District 02, 12 and 18 have chairs, and district 06 14 are sending reps that have a strong presence. Still need active participation from District 22 and then we will have all 7 on board. We have come a long way since May 1995, Ontario was the first one to have an accessibility sub committee, and it started in Toronto. In 1999 there was an effort to have the committee recognized at the Area, that didn't work out, and here we are trying again. We will see what happens.

F. Self-Support

Good morning, I am an alcoholic and a member of the Parkwood Hills Group in Ottawa and have the honour and privilege of serving as your Panel 69 Self Support Chair for Area 83 Eastern Ontario International. My Name is Mike.

It's been a summer with quite a bit of activity. I was blessed to have been invited to 3 separate service days in June and I thank the 10 Districts that were involved for inviting me. I was also invited to do a Self-Support presentation to District 6 (Mississauga) on August 21. Considering I live in Ottawa and Mississauga is a little under 500KM away, we used the ZOOM App. to conduct my presentation to the District. The technology is here, let's use it wisely. History was made, this was the first-ever Subcommittee presentation done over the internet to a District. Technology is our friend.

When I gave my report in January of this year at our Area Committee Meeting, I expressed a desire to create a new Self Support display since the one we have was looking old and tired and has been well-travelled just like a well used Big Book. After confirming with our Area Chairperson and others and receiving his blessing to go ahead with it, I went to work and started doing some research on prices, sizes etc.. The new display arrived at my home last week and I have already started working on the content of it keeping the integrity of our old display. I am excited to present it to the Area at our Fall Assembly. The display has what is called a 'hook & loop' feature, which in layman terms is simply a fabric backing that uses Velcro® to attach display material to it so it can be changed around when new material is needed.

Our Alternate Delegate sent me the Area 83 Area Committee Meeting minutes from June 3-1989, when the Area meeting was held at the Ramada Inn in Belleville. It was an interesting read, to say the least. They spoke about ordering Grapevine calendars at a cost of \$3.00 and pocket planners costing \$3.50 ea. The 7th Tradition for the day was \$117.00. They also discussed reimbursements for all Area Committee members. The hot topic was mileage. It was proposed that the reimbursement ought to be raised from 15 cents a KM to 20 cents KM. This was the first increase since 1982. Does all this sound familiar in regard to our recent discussions? Does all this show us that the cost of everything has increased over the years? Does all this show us that "A buck in the basket' might be just an outdated term today?

Katie G. was our Delegate in 1989 and in her Delegates report she spoke on "The Self-Support system" and the need to help groups understand the importance of finances. Katie spoke about a few different ideas that were bounced around at the General Service Conference and one of those ideas was to set aside a month a year as "Self-Support month". That was the reasoning behind the \$8.06 challenge we had over the summer this year. And thank you to all the groups that participated in it.

Years before, Area 83 had what was called a Financial Chairperson and that position was abolished since the position was sort of duplicating what the Treasurer did. Through further conversation at that meeting, a motion came forward to create a position called the Self-Support Chairperson and his/her duties were to promote Self-Support throughout Area 83. The Self-Support position in Area 83 turned 30 years old this year. Denis D. (Past Delegate) was Area 83's first Self-Support Chair.

In July I sent all District Committee Members of Area 83 information on Individual recurring contributions and The Birthday Plan. I hope this information was passed along to your General Service Representatives and then to their Home-Groups.

At the upcoming Fall Assembly, my focus for the Self-Support workshop will be on, 'The 7th Tradition and what does it do and where does it go and how does it help further 12 Step work?' 'YOUR SEVENTH TRADITION CONTRIBUTIONS-Carrying Our Message Beyond Your Home Group'. I have attended multiple ZOOM meetings thus far and am planning on holding a sharing session with all the District Self-Support Chairs and all interested parties in the near future. A.A.W.S. Highlights

For the five months ended May 31, 2019 revenues were 3.67% higher than budgeted and 3.42% higher than the five months ended May 31, 2018. Operating expenses were 4.68% greater than budgeted and 9.83% more than last year. Actual contributions for the five months ended May 31, 2019 were \$3,435,535, 4.76% higher than budget and 4.76% higher than the five months ended May 31, 2018. Online contributions for the first five months of 2019 amounted to \$373,706. This compared with \$369,067 in 2018, \$333,480 in 2017, 212,908 in 2016, and \$179,449 in 2015. The first five months of 2019 online contributions accounts for 10.94% of our total contributions.

Unknown Groups are currently at 0 thanks to great follow-up by dedicated District Registrars and DCMs. I am sending out my thanks to those districts who scrambled to get contacts for the Unknown Groups when they arise.

I attended the Service Day in Oshawa on June 23 and the Lakeshore Districts Conference in Oshawa August 9 - 11. The event was well organized with excellent speakers.

The General Service Office database conversion from the Fellowship New Vision (FNV) to the new NetSuite system took place over the 2 weeks ending August 5. FNV continues to run in parallel to the

new system and is used by Registrars, with the data transferred to the new system behind the scenes. Conversion to the new system is proving challenging. FNV currently has limited access, with some functions not available. This limits the information that Registrars can enter and extracted information is only as of July 19, 2019. Down the road, Registrars will be trained and start inputting directly to NetSuite.

8. TREASURER'S REPORT

Hello friends, I am an alcoholic, a member of Courtice 12 & 12 Group in District 28, and my name is JoAnn. I am grateful for the opportunity to serve Area 83 as your Panel 69 Treasurer.

Today, under Old Business, we will be voting on a motion to allow e-transfers of contributions only for Area 83 as outlined by the Treasurer of Area 83.

Also, I am asking for volunteers to assist selling banquet tickets at the Fall Assembly. If you can volunteer for one shift, please see me today. I happen to have a tentative schedule today and I would be thrilled to fill in spaces with familiar faces.

In each of the District Committee Member mail folders, I have provided the General Service Office (GSO) District Quarterly Report as of June 30, 2019 regarding contributions from each group received by the General Service Office. There are also two Area 83 contribution envelopes. Please share these with your District Treasurer for future contributions. You can find several more envelopes on the side table; please help yourself. I would like to thank all Groups that provide your 6-digit Group Service Number and a return address either on the envelope, on the cheque or in an attached note. This information indicates where I will send the letter of receipt. An e-mail address is appreciated – letter of receipt can be e-mailed to your Group or District. Also, please remind groups that the address to remit contributions can be found on the Area 83 website under the About Area 83 Tab – Area Contributions. I have received contributions that have been mailed to previous Area Treasurers as far back as 3 panel terms.

Please continue to remind groups who would like to contribute using PayPal to include their 6-digit Group Service Number with any contributions using PayPal so that the group will get credit for the contribution. So far this year, there have been 4 contributions via PayPal.

Also, in the District Committee Members mail folders, as well as the Area Committee Members folders, you will find copies of the Financial Statement as at August 30, 2019. Copies of these are also available on the side table; let's go through these numbers now.

<u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 and is in the form of a GIC paying 1.4% interest maturing September 11, 2020.

Income for the period:

- 7th Tradition collected at the January and June Area Committee Meeting and the Spring Assembly = \$4358.90.
- Cost Recovery is \$760.00 no change from June ACM.
- Flow Through to General Service Office is \$200.00.
- Group and District Contributions are \$36,096.87.

Total Income for the period is \$41,415.77.

Expenses for the period:

- Ad-Hoc Committee (review operating procedures) \$125.00.
- Committee expenses are \$27,040.91.
- January and June Area Committee Meeting Rent and Refreshments \$835.36.
- General Service Conference Assessment \$11,170.14 CDN; total cost was \$8,300.00 USD.
- Bank Service Charges \$28.10.
- PayPal fees \$9.93.
- GSO Flow Through \$200.00.
- Ontario Delegates Committee (ODC) deposit for 2020 in Mississauga \$1,200.00.
- CERAASA (Canadian Eastern Region AA Service Assembly) \$2,801.79 held in Laval PQ.

Total expenses for the period are \$43,411.23.

To date, income is \$1,995.46 lower than expenses.

The bank balance on August 30, 2019 was \$39,825.37. As of that date, all cheques received have been processed, and letters of receipt, along with return contribution envelopes were mailed out.

The opening bank balance as of January 1, 2019 was \$41,820.83. Total income of \$41,415.77 less expenses of \$43,411.23 leave a balance of \$39,825.37 in the operating account as of August 30, 2019. We have \$4,735.17 less in our operating account this year compared to this time last year.

The bank reconciliation has been done and the balance in the operating account is accurate.

<u>Page 2</u> shows detail of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member, as well as all other expenses to date.

To clarify some of the numbers you see here:

Under Committee Expenses:

- The amount shown for Treatment/Accessibility under Literature, \$261.38, is for an order purchased from GSO. Also, under Literature, Corrections amount is \$428.57 for various items (pamphlets, workbooks, etc.) purchased from GSO.
- The amount shown for Service Information Day Committee under literature is mostly Service Manuals purchased from GSO for sale at the Spring Assembly. More manuals will be purchased for the Fall Assembly.
- Beside the Spring Assembly, under meals, you see \$6,900.77. This worked out to \$17.25 per person which covers much more than the cost of coffee/tea/pop. We are not charged for most room rentals, cleaning of the Atrium, meeting rooms, staff, etc. In that same line under Miscellaneous, the amount of \$1,582.00 includes data projectors and the set up of the Ballroom.

Under Other Expenses:

- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion was passed stating that "provided it does not affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to attend the General Service Conference." The cost this year for our Delegate was \$8,300.00 USD or \$11,170.14 CDN. This amount has been paid in full. Also, a note of interest regarding the GSC Assessment the full assessment covers much more than travel and accommodation costs to attend the GSC. Oher costs factored into the assessment (total costs divided by the 93 Delegate Areas) are expenses for Trustees and GSO staff to attend, meeting rooms, A/V equipment, the Conference Final Report and miscellaneous expenses.
- Ontario Delegates Committee (ODC) a deposit of \$1,200.00 was required to secure a venue for 2020. Area 83 will be the host.
- Canadian Eastern Regional AA Service Assembly (CERAASA) total costs to attend for our Delegate, Alternate Delegate and Immediate Past Delegate was \$2801.79.

At the bottom of the page is a summary comparing year to date for this year and last year for the same time period. Income is \$395.80 more than last year currently and expenses are up \$5,130.97. Contributions are down \$1,173.90 compared to this time last year. There have been 9 less Groups contributing in comparison. The resulting net change to our operating account is \$4,735.17.

<u>Page 3</u> shows contributions by District. These amounts include contributions from Districts, as well as Groups within the District. You can see that 125 Groups and 15 Districts have made financial contributions to Area 83, so far, this year.

The rates for the Fall Assembly (October 25 – 27, 2019) will be as follows:

Room Rates:

10. ALTERNATE DELEGATE'S REPORT

Good afternoon, I'm an alcoholic and a member of the Ajax Area Group. I have the privilege of serving you as the Panel 69 alternate Delegate for Area 83 Eastern Ontario International, and my name is Kimberley.

I had the pleasure of accompanying our Delegate on three occasions as he delivered his report of the 69th GSC. His report was packed with both interesting and valuable information. It was a great learning experience to be with your Delegate as he presented his report on the 69th Conference.

As you know, in response to the Communication Audit, Area 83 is striving to improve Communication throughout the Area. There are many great activities and events already going on, as you have heard in

reports given earlier today. With the availability of video conferencing, we are hoping to **add to** what we are already doing to create even more opportunities for members to become involved and informed.

Here are some of the ways we have already been making use of this technology to benefit communication:

- Robb W., our Panel 61 Delegate, presented an informative GSR Workshop using video conferencing in June.
- ➤ The Area Committee met, informally, since our last ACM, using video conferencing to discuss ideas to further improve communication with group members within our Area we meet again later this month on Sept 22.
- Intergroup chairs from Toronto, Peterborough, and Lakeshore Districts met by video conference for the first time.
- The ad hoc committee looking at the Operating Procedures and the ad hoc committee planning Pre Conference agenda sharing, have met multiple times using video conferencing.
- A CERAASA steering committee has begun to look at the Guidelines for CERAASA. This committee is made up of the ten delegates of the eastern Canada region along with their alternates and our Eastern Canada Regional Trustee Jan L. We are meeting bi-monthly using video conferencing which is much more efficient than sending emails back and forth.
- > Two weeks ago there was a Zoom training session to help members of the Area Committee host meetings with District sub-committee chairs or GSRs. Another training session is scheduled for September 30th.
- ➤ I have been reaching out to DCMs to ask if our Delegate and I can visit their District meetings. So far we have used video conferencing to visit Districts 34, 54 and 50 and are scheduled to visit District 70 next week. We are scheduled to physically visit District 86 next month. I will contact the rest of the DCMs and request a date for Rob and I to visit their district meeting.
- Area Sub Committee chairs have met with District chairs which otherwise only occurs at the Assembly.

Upcoming communication opportunities:

- Pre Conference Agenda Sharing will be taking place next Spring more about this later today
- Pone topic that we know is of interest to our members, based on the response at the last Assembly, is "Safety in AA". Our immediate past Delegate, Kim S, has agreed to give a presentation and discussion opportunity sometime in November for our members. An email with details will be sent out once we have a date selected.
- We are able to offer presentations on any number of topics to members in Area 83. Please ask them...what would be of interest to them?

"Did You Know" that items found by clicking the Did You Know button on the area 83 website, area83aa.org, can each be read in one minute or less? Each item is a brief snapshot of information that many group members may not otherwise hear about. New items are being added regularly. Please let GSRs know that this resource is available and can be added to their weekly readings. By sharing one item at a time, our members can become better informed without being overwhelmed.

As Area 83 Liaison I took part in the Inter-Area Remote Communities Workshop meeting on July 15th. The next meeting takes place on September 16th.

As a member of the Ad Hoc Committee looking at the Operating Procedures, I am continuing to compile motions and other notable items in a searchable document. This should make locating items in past minutes easier. I still have 18 sets of minutes to review. James has graciously given us an extension on this task until the January 2020 ACM. We do not have copies of the following minutes: March 1993, June 1991 (missing pages 9 and 10), September 1990, September 1988, October 1976, October 1975. 12. OLD BUSINESS

A. Final report from the Accessibility Chair Ad Hoc Committee. Kim S. –Immediate Past Delegate I am an alcoholic, a member of the St. Clements Group; the Immediate Past Delegate for Area 83, my name is Kim. I am also the Chair for the Accessibilities ADHOC Committee. On the committee we have Bill C., Ruth F. and Marty M.

Just to recap...

The last time such a committee was formed was in 1995. It was a "simply a fact-finding exercise, to determine if and how we are meeting the needs of those with mobility and sensory disabilities both inside and outside the Fellowship." There was a report to the Assemblies in March 1996 and October 1997. There was further discussion and recommendations made but not accepted. Then there was a motion in March 1998 to discontinue pursuing this idea. More recently, there was a motion in March 2014 for Area 83 to recognize Accessibility as a stand-alone committee at the Area level. This was tabled until the June 2014 meeting. Ruth F. researched and prepared a report to present at the June meeting to provide further information. This report is included in the June minutes. The motion was again tabled to the September 2014 meeting. At the September meeting the motion was defeated. A new motion passed which was "That Area 83 add Accessibility role/functions to the Area Treatment Chair". This motion was passed by the Assembly in October 2014.

Committee Scope: To make an assessment of and recommendations around

- the value of an Area Accessibility chair to Districts and Groups in Area 83
- the pros and cons of creating a stand-alone committee verses continuing to have the responsibilities fall under the role of the Treatment chair
- the potential responsibilities of an Accessibility chair

the costs to carry out the responsibilities of an Accessibility chair

As a committee we looked at what other Areas had in place for Accessibilities¹. We found 42% had a standalone accessibilities committee. 47% did not have accessibilities at all and 9% were combined with Treatment and 1 Committee was combined with Remote Communities. During that search we were able to get a general idea of their Accessibilities committees. We also found some different ideas from other Area websites for ways accessibility could be even more effective.

We voted unanimously to have a stand-alone Accessibilities Chair. We truly feel that Area 83 would not only benefit from a stand-alone Accessibility Committee Chair but that Area 83 needs one. Accessibility is more than a wheelchair bound person or a deaf individual. Accessibility is about no barriers to attend and participate in Alcoholics Anonymous meetings. How many people do you know that may have an issue? Single mothers, people with DUIs, health issues, people in nursing homes is a big issue. When was the last time you heard of a meeting in a nursing home? I never hear that announced at my home group. There are alcoholics in nursing homes. Area 83 would greatly benefit from a dedicated person to address and solve all our accessibility issues.

A.A. members in regions around the country have formed committees addressing how best to pave the way for A.A. members with special needs to reach and participate in A.A. meetings, or to arrange to have A.A. meetings brought to them. These committees work with local A.A. groups to find ways to make their meetings available to all who want to attend.

Carrying the message to special needs populations can be a challenge — one A.A. members have always been willing to accept — with the goal of including all alcoholics in the wonderful experience of belonging to a group and partaking in the full range of benefits of membership in A.A.

Please see your handout (<u>Appendix B Recommended Accessibility Committee Outline</u>): and we can go through it together.

We also included a Draft Accessibilities Committee Toolkit (<u>Appendix C</u>²). This would be a helpful resource for an Accessibility Committee. It is also a way of showing Area 83 what our Area can do with a standalone Accessibility Chair. An example from the toolkit of an accessibility issue that never occurred to me is...

Try to set up the meeting the same way each week (e.g., arrange seating, speaker podium, coffee pots, in the same place each meeting). If you move and reorganize things, it's only hiding whatever has been moved to a blind or vision impaired individual.

Place coffee pots back from the end of tables in a position where a cup will slide under the spout and rest on the table.

This is just a couple of examples but there is much more involved with Accessibility. There is a great need for Accessibility within Area 83 to ensure that every alcoholic may attend and participate in Alcoholics Anonymous.

We recommend a stand-alone Accessibility Chair and Committee.

Questions and additional discussion following Ad Hoc committee report on Accessibility:

Notes about the Tool Kit: in the report, Kim stated that the Toolkit, following a few tweaks, it will be made available under the Accessibilities Tab on the Area 83 website.

Reference to Single Parents requiring child care in the Tool kit. This could cause some legal issues- people looking after kids. That likely will be removed.

Shane also mentioned that there are online meetings for those who are needing child care and cannot get to a meeting.

Kim Noted: If we do vote to have this happen today and we want to have a stand-alone accessibility committee, someone is going to have to make a motion.

QUESTION: do we have any testimonials from people who fit into these into these categories? There is no way we can understand what it is like for people with accessibility needs. Adding to the report that these special needs issues are just the tip of the iceberg.

ANSWER: I can get those for you, or Shane I am sure has many examples.

There was a lot of personal sharing about disabilities, many of them invisible, and some among those at the ACM and pointing out we just never know -we need to appreciate that.

In the Recommended Accessibility Committee document, it talks about specific needs, and we know that this list is not exhaustive, perhaps add "etcetera" to reflect that.

QUESTION: is the financial demand something that we can sustain?

Answer: If this is what the Area wants, it will then become part of the Spending guidelines. From that we should hope that the contributions would come into to match what our expenditures will be. If it is what the Area wants, then I am sure the Area will support it.

Kim added that in the 20 years that she has been coming to the Area I have never seen us not be able to do the work that we've needed to do. So, there will always be room in the spending guidelines for it, because we always come forth and do what we need to do.

QUESTION: Will it be a two-year term?

Answer: Yes, and it will be in sync with the other Area positions. Starting 2021.

Question: you eluded in your presentation that we could put on the floor to day to create the position, or is it also to elect a position?

Answer: No, this would have to go to the Assembly. That is why, at the beginning of the Accessibility Tool kit it says "At the Area 83 Assembly held in (date to be added), it was voted to form an 'Accessibilities Standing Committee' starting the two year rotation on January 1, 2021."

Technically this doesn't have to go to the Fall Assembly, it could go to another Assembly. The hope is that it will start in 2021, so there is no hurry.

Question: Mike asked if we put a motion on the floor here, it would go to the Fall Assembly.

Answer: It would be voted on here, and if it PASSES here it goes to the Assembly.

Mike B put a motion on the floor to create a position of Accessibility Chair for Area 83 Eastern Ontario International elected on the December 2020 ACM.

The Pre-Conference Agenda Sharing idea started as discussion among some of the Area Committee. It became a planning group, and then our Area Chairperson, James, decided to form an Ad hoc Committee. The committee is comprised of the following members:

Bill C (Area CPC), Amy L (Area Secretary), Eileen S (DCM – D28), Jo D (DCM – D54), Kim S (Immediate Past

Delegate), Ray R (Area PI), Kimberley M (Alternate Delegate) and I was asked to chair this committee.

The scope of the Committee is:

To plan pre conference sharing sessions on Zoom for Members of Area 83, ultimately enabling our Delegate to hear, understand and communicate the Area's group conscience to the GSC

The mandate is:

- 1) To plan and action these sharing sessions before the 2020 Spring Assembly.
- 2) Gather, distill and direct the findings from these sessions to the Area Delegate in a timely manner so that the Area's collective voice can be brought to the General Service Conference.

The timing is:

The Chair will need to make an interim report at our 2019 September ACM, 2019 Fall Assembly, January 2020 ACM and a final report at the 2020 Spring Assembly.

The Committee has met 3 times and has made much progress.

We have developed a plan for Pre-Conference Agenda Sharing using the Zoom video conferencing app. Sessions will take place March 8-21, 2020 from 7pm to 9pm.

Zoom is a free video conferencing app that can be downloaded to a desktop, laptop, smartphone, tablet or iPad. Members can also join Zoom meetings by calling in from their landline or cell phone.

The GSC consists of 13 Standing Committees: Agenda, CPC, Corrections, Finance, Grapevine, Literature, Policy/Admissions, Public Information, Report and Charter, Treatment and Accessibilities, Trustees, Archives, International Conventions/Regional forums. Area 83 has corresponding Sub-Committees for six of these Conference Committees. Each Sub-Committee Chair has been asked to chair their corresponding Conference Committee. Finance will be co-chaired by our Self-Support Chair and Treasurer. Literature is usually a very extensive agenda and will be divided in two with our Area Secretary chairing one committee, and our Area Registrar chairing the second. The remaining five Conference Committees typically don't have much on the agenda that requires feedback. They will be grouped together as one committee chaired by our Area Archives Chair, and one of our Past Delegates. This will total nine committees. Each Committee Chair will be provided with agenda items and background material for their Committee and asked to compose background summaries.

In late February, agenda topics with background summaries will become available and emailed to members via DCMs and GSRs. This information will also be available on the Area 83 website. All members of the assigned Districts are encouraged to join the Zoom video conference session for their Committee. The background information that will be provided in advance of the Zoom session should provide enough detail to all members to make informed decisions. Prior experience on a particular committee is not required. All members of Area 83 are invited to participate in any or all sharing sessions.

We have assigned two or three Districts to each Committee. Districts will receive agenda items and background summaries before the session for their assigned committee and have a chance to prepare for discussion of their agenda items. It is hoped that giving Districts the "responsibility" of a certain committee this will encourage more members to get involved.

The Chair of the Committee will go through each agenda item, giving a recap of the background summary, and then open it for discussion. At the conclusion of discussion on each agenda item, a vote will be taken. A Secretary will capture the essence of the discussion, and the voting results. A report of each session will be submitted to the Delegate.

Area 83 is trying to *improve communication* between the Fellowship and the General Service Conference. We hope to hear from all group members including those who may not be involved in service outside the

home group, as well as those who are.

District Committee Members *should forward all information to the GSRs* and as GSRs to share with all members of their groups. DCMs can continue to be actively engaged in encouraging members to get involved (Please talk about this at our district meetings, home group meetings, with our sponsees and sponsors and try to get all members of Area 83 involved.)

A flyer with session dates and District assignments has been distributed today. An electronic flyer will be posted on the Area 83 website. The flyer, along with a letter with more details, will be emailed to all DCMs with a request to forward it to their GSRs, who in turn are requested to forward it to their group members.

I will go through the schedule now. If you notice any dates that conflict with your District meetings, please let me know.

Question: Will there be an invitation sent for people to attend? With a link to get on to those sessions? Answer: Yes, there is a letter that we will be sending out to the Area will explain those details. The link for video conferencing will be available from our Area 83 website.

Question: Will the subcommittee chairs be getting an invitation for their certain agenda committee?

Answer: The Area subcommittee chairs have received their invitation to participate, but at the time we didn't have the dates picked. Subcommittee chairs were asked to facilitate the sharing session on agenda committees most aligned with their current position. District Subcommittee chairs will also be invited to participate- as well as anyone interested in the topics covered during the session.

NOTE: All sessions will have the same link and dial-in number. This will be posted on the Area Website. Because we have posted this link online, we have made the sharing sessions password protected-to make sure that people who are joining are members of Area 83. The Password is available on the hard copy flyers, and each DCM should know what the Password is. The flyer on the web will not have the password published but indicate that "the password is available from your DCM". Same for the Call-in number, there will be a password that will have to be entered to join the sharing session via telephone.

Question: How did you pick the grouping of districts?

Answer: We took into account when district met, and the size of the districts. We paired small districts with larger districts. Other than that, it was random.

Questions: are these sharing sessions only for GSRs? or can any member of Area 83 participate?

Answer: Any member of Area 83 can participate. That could be a lot of people, but we have the ability to do break-out rooms with this software- we have found that if we have more than 20 people, it is good to break them into two rooms. Let's hope this happens!!

Question: because of the details of the content of the Agenda topics (i.e., treatment and accessibility) it might be tough for one person to chair those meetings, and can chairs request assistance from Past Delegate with the content?

Answer: we are going to invite all past delegates to help with this, by assisting the chairs with these sessions that request help. An invitation will be going out after this ACM.

B. Motion that Area 83 contributes \$400 to the Eastern Canada Region hospitality suite at the 2020 International Convention in Detroit, Michigan. Rob M.-Delegate.

The international convention assigns each region a hospitality suite free of charge. The Eastern Canada hospitality suite for 2020 International convention in Detroit, MI is being facilitated by Tim M, Panel 67 delegate for Area 82 Nova Scotia, Newfoundland, Labrador. Tim is asking each Area in Eastern Canada to contribute \$400 to purchase 3000 Eastern Canada Region pens, AV equipment, table and chair rentals, maps, flags and other items. Any surplus funds will be given to GSO as a regional contribution. A full financial account will be given after all of the bills are paid.

C. Discussion CERAASA Startup Fund

Rob M. – Area 83 Delegate

In 2011 the following motion passed at our Fall Assembly. As Recommended by the Area Committee that Area 83 participate and support CERAASA. To get CERAASA started each of the 10 Areas in Eastern Canada contributed \$250 to establish a \$2500 start-up fund. At the 2015 CERAASA business meeting, the following motion passed: that CERAASA establish a prudent reserve from surplus funds at each CERAASA, such prudent reserve not to exceed \$2500. After CERAASA 2017 an amount of \$5482 was forwarded to the CERAASA 2019 host committee, which was Area 90, Northwest Quebec. \$2500 was for the start-up fund, \$2500 for prudent reserve and \$482 to maintain the CERAASA website. At the end of CERAASA 2019 the bank balance was -917.32. Area 90 advanced CERAASA the \$917.32 so that all of the bills could be paid. A steering committee was formed to review the guidelines take any suggested revisions to the business meeting at CERAASA. The steering committee is comprised of the 10 Delegates, and 10 Alternate Delegates of each Area in Eastern Canada along with the Eastern Canada Regional Trustee. The steering committee is asking each of the 10 Areas to contribute \$250 to create a start-up fund and \$91.74 to reimburse Area 90.

I don't believe that this requires a motion from our Area. As Area 83 agreed to participate and support CERAASA, and the CERAASA guidelines state that there must always be an amount of \$2500 to be forwarded to the incoming host Area, to be used for start-up expenses for the next CERAASA. When the surplus available to forward to the next host Area is less than \$2500 each of the 10 Areas that comprise the Eastern Canada Region will contribute an equal amount that will restore the start-up to \$2500. Again, I don't think this requires a motion because we have agreed to the guidelines of CERAASA, which clearly outlines our financial commitment to CERAASA. I brought it up at this meeting for transparency so that you know what happened, and as long as everyone is okay with it, I will ask our treasurer to write the cheque.

So, todays discussion is really to inform Area 83 and try to answer any questions you may have.

Questions following the report on CERAASA fund.

Question: Do you know how the short fall happened?

Answer: There are several reasons, but the main reason is that the cost for registration went from \$40 to \$30. When CERAASA was held in Montreal, which is just outside of Laval, there was 500 people there. A couple years ago, at the Eastern Canada Regional Forum was held in Laval, at the same facility where this year's CERAASA was held, and there was 700 people there! It appeared that the members of Quebec tend to come out for these regional events, so Area 90 was anticipating a much larger turnout. To make this more affordable for members to attend, they would drop the registration by \$10. Only 350 people showed up.

With the extra \$10x350= \$3500....and then we wouldn't be asking for the top up of the Startup funds. I think a lesson was learned.

In summary: Area 83 will contribute \$250 for start-up fund, and \$91.74 to reimburse Area 90.

There were no more questions.

D. Operating Procedures Ad Hoc committee's recommendations. James O'D – Area Chairperson After the January ACM, Kimberley, Sandy and Amy were asked to participate on an ad hoc committee to take on the task of a "fact finding and fact facing" approach to updating our Area 83 Operating Procedures. The last time the Operating Procedures were overhauled in depth was in 1991. They were reviewed again in 2004 but not much was corrected. Modifications to the Operating Procedures have been made over the years as reflected by the 24 dated entries listed on the front of the current Operating Procedures.

The scope of our task was to assess and offer recommendations around:

- Inclusion of motions passed over the years (to make sure they were incorporated correctly)
- Determine how the OPs reflect our current practice
- Improvement flow of format
- Inconsistencies and/or eliminate repetition
- Creation of a historical Motions database for future Area Committees

They compiled an historical database of motions and other interesting items by reviewing the reports from the Delegate and Alternate Delegate, Old Business, New Business and reports by Ad hoc Committees from the Assembly and ACM minutes. They have reviewed minutes from 1973-1987 and 1999 to present. A final report reviewing 1987-1999 will be presented at our January 2020 ACM. We have more than enough to get a good start on.

The recommendations have been organized into four categories:

- **Category I)** It has always been the secretary's responsibility to correct language and punctuation, and any other modifications that do not alter the meaning or intent. The items listed in this category have already been approved by the ACM and/or the Assembly and are the responsibility of the Secretary to incorporate into the Operating Procedures. These would not need approval.
- **Category II)** Requires the approval of the Area Committee. These may be modifications to the Appendices, which in the Operating procedures under Section V: Appendices (in updated Operating Procedures that would be Section 9) says "Note: Appendices are deemed as *guidelines* and NOT *operating procedures* and as such are written, amended, and approved by the Area Committee not the Assembly."
- **Category III)** Requires the approval of the Area Committee and then the Assembly. These are items that modify the Operating Procedures and would require approval from both ACM and anything that the Area Committee agrees to would have to be approved by the Assembly.
- **Category IV)** No action required. These are items that were noticed, were discussed, but felt that nothing further needs to be done with them.

The Chair suggested that we proceed in the following manner:

Category I items, as they have already been approved by the ACM and/or the Assembly, I would suggest we leave these with the Area Secretary to be actioned. These do not require approval as they have already been approved. There is no need for a motion.

I would like to take a sense of the room at this time to see if there are any objections to the suggestion to leave **Category I** items with the Area Secretary to be actioned. (See <u>Appendix D</u>: for Category I items being considered).

- Sense of the Room: there was no one in opposition, so Items 1-7 will be actioned by the secretary.
 - As **Category II** items only require the approval of the Area Committee, I would suggest that we skip over this section for the time being as we can address these later in this meeting (time permitting) or at our January ACM. Items in **Category III** however, require the approval of the AC and then need to go to the Assembly for approval and are therefore more time sensitive. If we can approve some or all of these items today, then they can go to the Area Assembly in October. **Category IV** have been deemed "no action required". These can be discussion items at later ACMs and therefore do not need to be discussed or actioned today.

At this time, I would like to take a sense of the room to see how the committee feels about proceeding in this manner.

• Sense of the Room: Everyone is okay to defer Category II items until later.

The Chair recommends that **Category IV** items also be deferred for a later discussion. These were not recommendations, but there may be great information that may or may not lead to a motion down the road.

• <u>Sense of the Room</u>: With your permission, can we put those off **Category IV** items as well. No one objected to this.

Proceeding with **Category III items.** We are starting with item number 33, and the last item is 53. We can proceed by taking each item one at time- taking motion to accept or modify, or we can go through all of them and pull those that need further discussion. (See <u>Appendix D</u>: for Category I items being considered).

The committee agreed to read each one, and request that the chair pulls any items that require further discussion.

The Chair went through all Category III items and 5 items were pulled for further discussion: 44, 45, 49, 51, 53.

<u>Sense of the Room:</u> How does everyone feel about creating a bulk motion to approve 16 of the 21 items in Category III? no one opposed this suggestion. 44, 45, 49, 51, 53 were pulled for further discussion.

 - My district gave a survey for all of us to fill out with our homegroup. To which a member in my group said I don't know why we would do this, we don't get anyone here with that type of disability.
 Unfortunately, that is a normal attitude, and we need to check ourselves about how we think of people with disabilities and what it means to be barrier free-
 - o In this meeting space I experienced the following that is presenting problems- White noise, all of the fans set up are creating a background level noise that really is drowning out what is happening in this room. Furthermore, that type of noise for people with sensory issues may find it incredibly uncomfortable, and I find it difficult to sit in here for extending periods of time.
 - Lighting: when we turn the lights on/off, that again is difficult for those with sensory issues.
 - o Remember it isn't just what you can visually see or hear that is a barrier to some.
- Franklin- visitor from New York, thank you for your hospitality, it has been awesome. I know in my area they have treatment and accessibility chairs. I am going to sit in on the accessibility committee because of what I heard today. One thing I noticed is that my homegroup when I first started going there-we had only 5 people. Now we are about 15, and I have found that a gentleman who used to always be there is no longer coming. He told me he was claustrophobic, and when the meetings are that big he cannot feel comfortable. You have showed me here that maybe we should be making a switch to a larger space. My homegroup has been dark, and technically we are still part of Area 83, because we need some paperwork signed to complete the switch, I came here to get the delegate to sign some forms.

Accessibility Committee

Mission

The purpose of this Committee is to diminish or eliminate barriers that prevent anyone from participating in any aspect of AA in Area 83. The Committee provides information and coordinates services for alcoholics who otherwise would be unable to participate in meetings, groups, or service work because of a disability, difficulty accessing AA meeting places, or because of a need for special assistance with communication.

Accessibility needs: who has them?

- A.A's from minority groups: For example, ethnic groups, LGBTQ communities
- A.A's from a variety of cultures that are ESL (English as a second language)
- A.A's who are deafened or hard of hearing (do not use American Sign Language)
- A.A's who are hospitalized or housebound
- A.A's who are parents that are unable to find suitable childcare to attend meetings
- A.A's who do not have transportation
- A.A's who are not able to drive themselves due to health conditions
- A.A's who are house/hospital bound due to heath conditions
- A.A's that are unable to drive as a result of receiving a DUI
- A.A's who live in nursing homes/foster care homes
- A.A's who are blind or have low vision
- A.A's who have mobility issues
- A.A's who are with concurrent disorders (i.e., mental illness and alcoholism)
- A.A's who have head injuries
- A.A's whose speech is difficult to understand
- A.A's who live in rural or remote communities
- A.A's who have learning, reading or writing challenges
- Etc....



 - Forms a working committee of AA members to assist in carrying out the performance of these responsibilities



Introduction

At the Area 83 Assembly held in (date to be added), it was voted to form an "Accessibilities Standing Committee" starting the two year rotation on January 1, 2021.

The purpose of the Accessibilities Committee is to help make A.A. accessible to every member who desires it—to help alcoholics with special needs to either get them to meetings, or having meetings brought to them. This includes, but is not limited to, those who are blind/visually impaired, hearing impaired, confined to their homes for health reasons, and/or

The guiding principle of this committee is that there are no special A.A. members, only members with special needs. They are A.A. members who wish to have the same privileges and responsibilities as all A.A. members with regard to the activities we all consider necessary for our continuous sobriety. These include regularly attending meetings and special AA functions; speaking at meetings; and participating in 12 Step work, sponsorship, and service on both the local and area levels.

physically incapable of getting to meetings on their own

Meeting the Challenge

A.A. members in regions around the country have formed committees addressing how best to pave the way for A.A. members with special needs to reach and participate in A.A. meetings, or to arrange to have A.A. meetings brought to them. These committees work with local A.A. groups to find ways to make their meetings available to all who want to attend.

Carrying the message to special needs populations can be a challenge — one A.A. members have always been willing to accept — with the goal of including all alcoholics in the wondeful experience of belonging to a group and partaking in the full range of benefits of membership in A.A. Some A.A. entities are attempting to meet this goal by forming Accessibility Committees and there are currently some 200 such committees. throughout the U.S. and Canada A.A. service structure.

This Accessibility Toolkit was created in efforts for all Districts and groups to discuss and inventory special needs in their community. A preliminary scan of Districts in Eastern Ontario are showing many districts require the need to raise awareness and build capacity for Special Need/Accessibilities, therefore, we hope this toolkit would help assess where your District/Group is and what steps need to be taken to help better carry the message to the special needs population.

GSO special needs and accessibility materials is a collection of experience from several General Service Conference areas, central offices, intergroup offices, and districts where Special Needs Committee or Accessibility Committees have been formed in the United States. This service material is available to the Fellowship for those who wish this shared

While there are no "special" AA members, there are many members who have special needs. This would include alcoholics who may be:

- Deaf or hard of hearing
- Use a wheelchair, walker, or cane

- Limited in reading and writing skills
- Live in rural areas/isolated, home or hospital
- Single parents that are unable to find suitable childcare to attend meetings
- Physical disabilities or chronic illnesses

Whatever their disability or particular challenge to receiving the AA message may hope that they would never be excluded from AA meetings. Twelve Step work, y be, we

Respect for the dignity of others is the foundation for all our efforts to carry the message to alcoholics with special needs, with emphasis on identification rather than on how we are different. As one deaf AA put it, "I'm just an alcoholic, like everyone else here. I have the same need to be a 'worker among workers' and not be singled out for special treatment. If you can just make the program available to me, I'll do what I have to do to The goal is to include all alcoholics in the wonderful experience of belonging to a group and partaking in a full range of benefits of membership. How we serve these people is to provide interpreters for meetings and events, as well as Braille AA literature, audio material, programs for special needs, and rides in special cases. We encourage wheelchair accessible meetings/events and big book tape study meetings in each district. The list goes on: assist the physically disabled at events; directories (and on-line); bring meetings into homes, hospital or long-term care facilities; encourage districts and groups to support meetings in special needs facilities; provide literature and workshops on special needs; explore other special needs; and work with GSO and other districts and areas. encourage groups to provide childcare; update special needs information in meeting

As you can see Accessibilities has a very broad range of responsibilities. The Area Special Needs Committee suggested each districts help in the form of a designated individual who carries the message to the groups within each district. This is a big job but together we are confident that everyone who needs and wants the message of hope that Alcoholics Anonymous offers, will have the chance to hear it.

Accessibility Committees at the District Level

committees refer to themselves as Special Needs or Accessibilities Committees. When one or more members of a group have special needs (such as the need for an American Sign Language interpreter or wheelchair accessibility, or have an illness which prevents them from getting to the meeting room), AA members from that group will attempt to see that those needs are met. Some AA Districts are attempting to meet such needs by forming Accessibility Committees. Since the goal is to make AA accessible, research shows that some

Tips for Making Meetings Disability Friendly (Accessible)

Always unlock wheelchair entrance door(s) when

Keep wheelchair ramps and/or entrances clear of individuals with mobility devices to maneuver around the room for

Have microphone/amplifier available for chairpersons, speakers & readers (seldom Place coffee pots back from the end of tables in a position where a cup will slide under the spout and rest on the table is a non-amplified voice loud enough for an individual who has a hearing problem). Be open to the possibility of having certified sign interpreter for an individual who is

Try to set up the meeting the same way each week (e.g., arrange seating, speaker podium, coffee pots, in the same place each meeting). If you move and reorganize things, it's only hiding whatever has been moved to a blind or vision impaired

Don't interfere if an individual with disability is doing a task for his or herself (even if it may look awkward to you. It is okay to ask if he or she needs help, rather than just jump in and take over. Freely offer rides to and from meetings when possible (reasons are obvious)

One AA member reminded us that, in carrying the message to the deaf alcoholic, "Try not to treat them as different or special but allow them freedom to participate in a typical AA meeting.

"The main thing to remember is that deaf alcoholics have the same problem as anyone else. While we and they may come up with a thousand reasons why they are different let's emphasize over and over "Don't drink; Keep coming back."

For the purpose of these guidelines we will use the term "deaf." There are other people who are hard of hearing, either permanently or temporarily. People who are deaf or hard of hearing are all unique, and there is a variety of ways to communicate with them: sign language, speechreading, writing, typing, and TTY, for example.

Often, sign language is the most effective way to communicate, and many groups use sign language interpreters to help carry the message to deaf members. In a pinch, you can try writing back and forth. But keep in mind that English is not the first language of many deaf people—sign language is! So, whenever possible, use sign language—either directly or through an interpreter. If you do have to write, keep it simple and brief. Encourage the newcomer to take AA literature and invite them to come to another meeting. A smile, a handshake and a cup of coffee speak "the language of the heart,"

Sign Language Interpreters

If there is a need for an interpreter try to arrange to have a sign language interpreter at the meetings that deaf alcoholics attend. The deaf member may be able to bring an interpreter, if not, try to make arrangements through a local agency or check with your local special needs committee, intergroup or central office, general service district or area committee to see if they have any experience with the situation.

Qualified interpreters are professional people who charge fees for their services. Experience suggests that most groups will agree to have a non-AA attend its closed meetings to act as interpreter for the deaf alcoholic. Professional ASL (American Sign Language) interpreters adhere to a strict code of ethics, which assures the Language) interpreters adhere confidentiality of the AA meeting.

Some AA groups cover this expense. Sometimes an agency will take care of the expense. On occasion, local area committees, districts, and central/intergroup offices have authorized payment for interpreters. Professional interpreters who are also AA

members sometimes are willing to volunteer their services. Occasionally advanced students of interpreting will do the job at no fee for the experience gained. Be careful of placing too much reliance on volunteers, as deaf members rely on these services and there should be stability in whether the meeting is interpreted or not.

In order to welcome the deaf person and the interpreter and make the newcomer feel that he or she is an important

Initially it may be difficult to convey feelings through another person, so try to communicate as directly as possible. It is important to have the deaf person's attention before speaking. He or she may need a wave of the hand, a tap on the shoulder or some Look directly at the person while speaking. If you are called on to read something while an interpreter is signing, read slowly and clearly. Try to furnish the interpreter with the text there should be no back lighting. If a deaf person indicates that he or she can speechindividuals. Effective speechreading also requires very specific conditions: the speaker should not be chewing gum or eating, should not have an accent or a mustache, and sort of signal that you wish to communicate. Many deaf people have some training or experience in speechreading (also known as lip-reading). However, this varies widely with beforehand, as formal writing is more difficult to interpret quickly. read, try to follow these guidelines. Also, speak slowly and clearly, but don't exaggerate

Deaf AA members may need a few special considerations when attending an AA event. For those who have a fair amount of hearing and/or who read lips, seating near the speaker may be all that is required. Others who are deaf may require the use of a sign meeting that will be attended by deaf AAs. language interpreter. Here are some points to consider when planning a conference or

Find out early what the estimated cost will be, whether

Stick with your plans once you have announced that an event is to be interpreted. Deaf people are very likely to travel far for the few events that are interpreted. If you are listing the event with the General Service Office, your local intergroup/central office or in any AA publication, specify that it is sign language interpreted. If possible, have a TTY number that deaf people can call for more information.

Banging into a chair or a table in what was empty space at the prior meeting can be both dangerous and embarrassing. be recruited to guide the blind or visually impaired newcomer to chairs, the hospitality table and rest rooms, until that member is acquainted with the surroundings. Meeting For AA members who are blind or visually impaired, simply getting to the meeting room can be the biggest problem. The Special Needs Committee can compile and maintain a list of sighted meeting where are willing to provide transportation to and from meetings and other AA functions.
