The agenda for the Assembly is sent out approximately 6 weeks in advance. It is sent to DCM's to distribute to the GSR's. This is so that groups will have time to discuss the items and vote at the **group level** and at the **district level** prior to the assembly.

#### Who votes?

All Area Officers, including the immediate past Delegate, but not the Chair. All Area sub-committee Chairs. All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

#### How do we vote?

#### **SENSE OF THE ROOM**

At the bottom of the participant window you will see a green YES button and a red NO button. We will use these buttons to gauge the feeling of the room – this is not a vote. We will also use this function to second a motion. IF YOU WISH TO SECOND A MOTION USE THE "YES" BUTTON.

I would like take moment to ask everyone to click on the YES button. If anyone is having a problem, please raise your virtual hand.

**VOTING**: For anything requiring a vote we will be using the polling feature. There will be two options: For/Against. Agenda item "D" in new business – discussion regarding date of December ACM - there will be four (4) options. We are not recording abstentions.

#### **DISCUSSION/RAISING HAND:**

If you would like to approach the virtual mic and stand in virtual line to share a new perspective or ask a question, please raise your virtual hand using the RAISE HAND FUNCTION located at the bottom left of the participants window. Zoom will keep people in line in the order in which hands have been raised.

Reminder: IF YOUR IDEA OR COMMENT HAS ALREADY BEEN PRESENTED PLEASE LOWER YOUR HAND. Your humility and cooperation in this regard is appreciated.

**Procedure:** Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote, and anyone may raise his or her hand. I believe that the first part of the agenda today can be handled under simple majority. The items under new business and old business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

**Minority Opinion:** A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the *original* motion.

Calling the Question: During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in discussions, and if discussion is prematurely cut off, we will not get to hear them.

#### Who may address the committee meeting?

It has been the *practice* at the Area committee level to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons:

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly –
  members are representing their District's positions or Area's in the case of our Officers, rather than their
  own.
- It also maximizes the time available for members to voice the opinions and needs of their District. All who
  are attending may say their piece during sharing time.

I respectfully ask for your cooperation in this. If you don't have a vote, as I mentioned, please keep your input for sharing time which is scheduled for later this afternoon. At that time all in attendance are welcomed to participate and their opinions will be heard.

#### District 02 Malton

Good morning all, my name is De, I'm an alcoholic, grateful member of the KF Group and have the honour and privilege of serving as District Committee Member for District 02 – Malton. I hope everyone had a great summer, even if plans may have had to be altered.

Attendance at our business meeting since June has declined with an average of 26%. We continue to keep our General Service Reps informed by forwarding information from the Area and General Service Office, and various workshops made available to us.

We continue to meet virtually and there is no indication at this time when we will be allowed by the Church to meet in person.

Financially, we are stable and have some contributions from our groups and 7<sup>th</sup> at our District business meeting through e-transfers set up by our Treasurer. At our upcoming September business meeting, we will discuss financial support to Area and GSO.

At our June meeting we held our Table Officer elections and I am pleased to announce that Patrick B., of the Rexdale United Group was voted in as District Committee Member. Also, we filled the position of Treasurer and I am once again pleased to announce that Vince R., of the Sunday Serenity Group was voted in. We continue to find someone to stand for our Secretary/Registrar as well as Alternate District Committee Member.

We have heard from our General Service Reps that many in our District are attending online meetings, and in some cases, attendance has increased in lieu of in person meetings. Two of our Groups, the Rexdale United and the KF Group will begin in person meetings September 16<sup>th</sup> and September 19<sup>th</sup> respectively. All precautions will be in place

to safely re-open these groups – distancing of chairs, people, having sanitizer and face masks available. Both venues are churches which have resumed their services.

We continue to encourage our members to attend online meetings. Several of our Subcommittee Chairs have been meeting with Intergroup's Chairs for hybrid meetings, so the business of AA continues, as well as information sharing. At our last Area Committee Meeting I announced the shut down of all our in-person meetings. Online meetings have supported many in the fellowship and many new members are getting sober virtually. Currently we have three groups and one service group that have opened in person meetings. Many more are having discussions on how to best move forward. Our Webmaster Ivy has been diligent in keeping the aamississauga.org website up to date.

Our finances remain in good shape, although contributions from the groups are low given the current climate. Our Treasurer, Jill, put forth a motion to disburse funds beyond our prudent reserve with \$1000 to GSO and \$500 to Area.

I'm happy to report that one of the Treatment facilities we support have opened their doors to us. We're looking forward to the others following suit along with our Corrections commitment at Toronto South.

In June we held elections for our 2021/22 DCM and ADCM positions: Nat S from Bloordale is our incoming DCM and Jill B from Erin Mills is our incoming ADCM. District 6 has enthusiastic leadership coming into the new term.

I look forward to our continuing Service Information workshop Session and our Area Assembly. Thank you for my sobriety.

#### District 10 Toronto South Central

Hi everyone. I'm an Alcoholic and my name is Ann. I'm a member of Eglinton Park Group in Toronto and I am honoured to currently be serving as your DCM for District 10.

<u>Overview of Groups and Participation</u>: District 10 still has 26 registered groups. All but two have a contact registered and 21 have GSR's. Since going to online in April we have had between 18-20 attendees at our monthly District meetings. There continues to be valuable exchange of group experiences, ideas, and information at our District meetings, which is helpful for everyone. We did experience a slight downturn at our Sept. meeting this past week, but are hoping it's due to the long weekend, school starting etc.

<u>Finances</u>: Overall, D10 is currently financially stable. We have had 3 contributions since going online in April, totaling \$525, down significantly from the same time last year. Most groups who are able, are contributing to GSO and Intergroup, as they deem them as the most in need at the moment.

The District voted to pay our 2H2020 rent, although we may not be able to get back into the space in 2020. Once we assess our required reserves and projected 2020 year-end balance, we will have a fuller picture.

<u>Group Activities</u>: Currently 24 of our 26 groups hold online meetings, with over 45 meetings a week. The groups are well settled into the new normal and have adapted well to the new environment. The GSR's now report

consistent and good attendance and are doing their best to reach out and connect with newcomers, as well as those struggling!

At least 50% of the groups have adopted an electronic 7<sup>th</sup>, and are still experimenting with processes that work for their membership.

Currently only three groups are moving back to in-person "hybrid" meetings. We're excited to see how these go. Most groups cannot get back into their venues because they are not opening to them yet, or the members are hesitant to move back to in-person meetings because of concerns of health safety. A couple of venues have told a few groups that they will not be asked back at all.

<u>Service Commitments and Service Committees</u>: Our District Treatment commitments are slowly beginning to resume, on Zoom only. CAMH and Women's Own are starting back up, but there is little to no attendance yet. It's still early and we're working with the Centres to encourage and establish attendance. We hope to be back to our 24-26 Treatment commitments in the next two or three months.

Most of the other Committee Chairs are still meeting with their counterparts at the GTA level, and they report that things are becoming more active in these service areas as well!

#### **Positions:**

These are uncertain times and we're so grateful to have so many people able to continue to participate in District service. Since our last ACM we filled our open CPC position but lost our Grapevine, Self-support, and Treatment chairs due to other life commitments. Treatment has been filled already and we hope to fill the other two soon!

#### **Summary**

As we move toward the conclusion of this term, we've established an ad hoc committee to review and update our District 10 Operating guidelines. We have a team of 5 working together, with a target to present a revised version to the table in November/December 2020. It's a tight deadline, so we'll be focussing on major items along with recommendations for further changes at a later date.

On a final note, we will be holding District elections for the 2021-2022 term at our October meeting. As well as new faces, we hope some of our members will consider new positions next year! 2020 in particular has been a challenging journey and I am so grateful to be part of such a dedicated and enthusiastic team.

#### B. Cooperation with the Professional Community Bill C

I am an Alcoholic, a member of The West End Group in District 74 Pembroke, and my name is Bill. It is my privilege to serve you as your Area Cooperation with the Professional Community Chair for this term of Panel 69.

Since our Area Committee meeting in June, CPC has been keeping active over the summer. We had our fifth CPC District Chairs meeting which was held on 12 August 2020. We had 9 District CPC Chairpersons join and had a chance to discuss many topics. Our "Pay it Forward" project has moved along considerably. We have developed a set of materials which, as CPC Chairs, we can pass along to the next incoming Chair. Jeff A from District 18 is currently editing this document to put it into a more professional format. Two of the easy to implement actions, but with big impact, that emerged from this project are having a District-level email address that stays with the position rather than a personal email address and a simple spreadsheet (suggested template developed) that can be used to track contacts and follow-up over the service of an individual. Both of these actions make it much easier to have a more continuous level of service over different Chairs.

David T. has continued his work with Senior Military commanders in Canada to determine if and how AA can provide support to military members with alcohol problems. He has made great progress and has identified Military Family Resource Centre (MFRC) as the point for contact within the Military Command Structure.

#### D. Treatment Facilities/ Accessibility Shane H.

Hello Friends, I'm an alcoholic and my name is Shane. I am very grateful to serve as your Treatment-Accessibility Panel 69 Chair.

**Treatment:** Great News! Area 83 received a first bridging the gap request from Homewood in Guelph three weeks ago. I have received 10 since then. Currently 2 of 5 treatment centres are open for bridging the gap from Area 86. Two out of four treatment centres are open in Area 83 as well. Before Covid happened in March I received 260 Bridging the Gap requests. It was pretty quiet until Toronto went into Stage 3 of the reopening protocol; that is when I received the Homewood request.

I am really looking forward to face to face meetings and I hope I can see you all in person again.

Accessibility: When Covid-19 hit, the GTA Accessibility committee was already meeting on Zoom. Under the strong leadership of De R., and her unofficial co-chair, Bert J., the committee did not miss a beat. They have put together a handbook and a flyer for the upcoming mobile meeting service that will be introduced to Toronto. Not the first of its kind, but a much-needed service in that area. They have a detailed handbook and offer a Zoom option as part of that service. This alcoholic is grateful to have been there and was allowed to participate.

It is so amazing to see a committee I love become mainstream—almost overnight. Online meetings started in 1986. They used computer bulletin boards. In 1990, members of special needs committees got together and started the Lamplighters. Wow! What a name. They called themselves that because they wanted to light the way for those who were lost in the dark; those who could not get to meetings such as loners, internationalists, persons with disabilities, shift workers. In 1992 the Online AA group was founded. By the year 2000 there were 6,000 members and 150 groups. Look at us now! 11 of the 15 districts I serve are very active and have been since before the Covid outbreak. A lot of members feel that \$1,200/year for a stand-alone Accessibility committee is not a lot, especially from what we have heard here today. From the various requirements for Hybrid meetings (hybrid meetings do overcome barriers). Looking forward to next Sunday for the presentation on Accessibility.

Special thanks to James and Rob for getting me in touch with various area chairs and six workshops from different areas. Wow! I really enjoyed all of them. It is my hope that a stand-alone accessibility chair might consider an annual Zoom Accessibility workshop. I attended Area 66 Accessibility workshop. There were 450 people in attendance. I really think this Zoom platform is important. While I really look forward to face to face meetings, I do think we need to continue hybrid meetings and Zoom will help make us more efficient. I am sorry that I voted against Zoom way back; I let my fear of the technology get in the way. I know that we are smart enough not to let it replace the old ways of AA. We need to incorporate and find a balance.

I have been put in touch with an Accessibility work group that has 18 area chairs as members and is growing fast. They started up on March 18, 2020. Every second and fourth Monday of the month 7 pm EST. Accessibility is mainstream now! Thank you for allowing me to serve.

Good morning, I am an alcoholic and a member of the Parkwood Hills Group in Ottawa and have the honour and privilege of serving as your Panel 69 Self Support Chair for Area 83 Eastern Ontario International. My Name is Mike.

Firstly, I Would like to take the opportunity to thank the Districts that invited me to both Service Days back in June to put on a virtual Self-Support presentation that was facilitated by Area 83.

On August 17th our Delegate sent everyone the General Service Office financial report with a power point presentation from Leslie Backus, Class A (nonalcoholic) Trustee General Service Board Treasurer. A summarized and condensed finance report can be found in the final General Service Conference report on page 48. A more detailed report on A.A. finances will be made available separately in a supplemental report shortly. <a href="Update">Update</a>: The final financial report as presented to the General Service Conference on August 15th was emailed to all Districts late last night.

It has been interesting watching the financials coming out of our General Service office and seeing the fellowship rally when needed. I believe we are truly blessed to have the trusted servants as we do looking after our finances. During these challenging times and with the shut down, I am sure a lot of Prayer and meditation is taking place on their part. One phrase from our Big Book keeps coming to mind and that is, "Fear of people and economic insecurity will leave us,"

I have been asked by several members since the Conference, "What does it cost the General Service Office to service the Groups in AA?"

The total cost was \$11,804,000 in 2019. There are an estimated 1,446,603 members in Canada and the United States. If you divide the cost by the number of members it comes to, \$8.16 per member. So, if each and every member of AA contributed an additional \$8.16 one time this year there would be no shortfall.

There has been a grassroots challenge over the past few years and this year is no different. Some members have taken up the challenge once again. I have changed my view on such challenges over this term and although the \$8.16 figure is valid and accurate, I see it as more of a fundraising scheme than A.A.'s tradition of self-support "Where Money and Spirituality Mix". Each member ought to make his/her own decision whether to participate or not. Keeping in mind that this is not and has never been a challenge initiated by the General Service Office but from individual members.

Fundraising conflicts with the AA General Service Board's expressed and adopted definition of the phrase "fully self-supporting" from Tradition Seven, which states, all expenses are to be liquidated by individual contributions. Our founders wished to be very clear. Fundraising activity interferes with our faith that a God of our understanding will direct and provide for our fellowship if we follow traditions. Practicing our Traditions is our path to a higher power and true unity.

Fundraising encourages our membership to miss the underlying spiritual experiences inherent in the phrase "fully self-supporting". Simplicity, faith, generosity, sacrifice and responsibility are for many, necessary experiences required to have changed lives, becoming fully contributing members to our fellowship and to society as a whole.

In my very first report and workshop as Self Support Chair I discussed wording. Donation vs Contribution

regarding Self Support. In AA we use the word contribution because Self Support means so much more than just money. It also means time. Twelfth Step work is the lifeblood of Alcoholics Anonymous, carrying the message to the next suffering alcoholic. Without it, the Fellowship would wither and die.

Some face to face meetings are starting or will be discussing meeting re-opening. This will put us all to the test and hopefully the true meaning of Self-Support will be predominant. It will take a lot more than one person to open meetings during this pandemic. This is the time we as members need to pitch in and raise our hands to be part of. And please don't forget about the members who will not be able to attend face to face meetings at this time. AA was always meant to be inclusive not exclusive. Let our 12 Traditions be our guide when making decisions.

A special thanks to the Service Information Day Committee for mobilizing quickly and efficiently in going forward with the traditional workshops that usually proceed the Fall Assembly. I am looking forward to attending as many of the upcoming virtual Service information Day workshops as possible which will be held in September and October. The Self Support workshop is being held on September 27th at 7 pm. The theme of this workshop will be, 'Getting Back to the Basics of Self-Support'

In closing, thank you to all the Districts that continue to send us your District minutes. Rest assured, I read them all. #### H. Service Information Day Committee Chair De R.

Hello everyone, I'm an alcoholic, member of the KF Group, District Committee Member for District 02 – Malton and have the honour and privilege of serving as your Panel 69 Service Information Day Chair and my name is De.

The Committee met via zoom July 5<sup>th</sup>, July 29<sup>th</sup> and August 2<sup>nd</sup> respectively to discuss our role in the upcoming Fall Assembly in October. Knowing there would be a two-day Assembly, we discussed various ways to present the workshops historically available on the Saturday.

Having workshops of fifteen minutes was discussed, as well as not having wildcard workshops. Thus, leaving a block of time on the Saturday for part of the Sunday's business agenda. We discussed having the District and Subcommittee reports Saturday morning freeing up valuable time for Sunday's agenda items as well as Elections.

Zoom-fatigue was also discussed. We wanted to be able to present Service Day workshops while also not taxing those in attendance. It was discussed hosting the Subcommittee and Table Officer workshops stretched over the summer. This seemed to be a great solution – having all the workshops prior to Assembly. An agenda for five workshops was put together, with each member of the Service Day chairing one of the sessions to be offered Sunday evenings between 7:00 and 8:30 pm. Each member of the Service Day chose a date that would work for them and they were responsible to asking presenters. As this Assembly is unlike any before we wanted to provide presentations to all in Area 83 in an informative and relevant way.

Our first session Sunday, August 30 at 7:00 pm was well attended with approximately forty people in attendance. Lynn E., District Committee Member for District 22 chaired the Secretary presentation by Amy L., the Registrar presentation by Dave L. and "Change – Essential to AA" presented by Joyce S. Panel 65 Delegate. Terry N. District Committee Member for District 26 and Jack R. District Committee Member for District 36 were on hand to offer zoom tech support. Each of the presentations were informative and each presenter added in his or her personal experience. Thank you to all who presented, Lynn for her great chairing and the tech support from Terry and Jack.

The agenda for the five sessions is on the Area 83 website, as well as the Toronto Intergroup website. A flyer will be posted on both websites approximately ten days prior to each session. The flyer will also be available on Facebook's private page, The Fellowship of the GTA. The next session will be on September 20, 2020 from 7:00 to 8:30 with Jack R. District Committee Member District 36 Chairing. We appreciate all the presenters for taking the time to virtually share with all members of Area 83.

One other item discussed was the technical support for the Assembly. Some expressed that perhaps there was someone in our Area that could provide this service. James was invited to our July 29<sup>th</sup> Service Day virtual meeting and shared with us the rationale of a contract with Check 2 AV.

This is the same company used to provide tech support to the General Service Conference and they would be signing non-disclosure agreements keeping anonymity for all in attendance The company has the technical equipment needed, the technical expertise, and the staff. James shared the quotes for a one-day and two-day assembly. In Canadian dollars the cost would be \$5,200 approximately. The average cost of Assembly is approximately \$15,000. As we had cancelled our Spring Assembly, we saved \$5,000 and with the tech company for the Fall Assembly we would save the same.

As a Committee we continue to stay in touch and hope you will join our Service Day Sessions between September 20 and October 4, 2020.

#### 7. REGISTRAR'S REPORT

I delivered a Registrar Workshop as part of the Service Information Workshop Session on August 30.

The General Service Office transition to the NetSuite database continues to have some challenges with the quality of some of the data. Work continues on the "clean up" of the data. The backlog of data changes sent to GSO for

inputting has reduced to 3-weeks, down from 17-weeks. No timelines have been communicated about the further phased rollout of My Portal to Area Registrars.

Since the NetSuite data is still not totally reliable, I continue to maintain a separate database with up to date Area 83 Group information data. For now, all changes to Group, GSR and Alternate GSR information, should be sent to me by way of GROUP INFORMATION CHANGE FORMS.

There has been a lot of work to prepare for the Virtual Assembly in October. We had to rethink how the registration and roll call preparation could work in a virtual setting. We will recruit 20/30 AA Members to be Virtual Registration Desk Staff who will register attendees and enter their District, Group & Position information into the Roll Call spreadsheet. This needs to all happen Sunday morning largely between 8 - 9:30 am. As attendees pass through the Waiting Room, they will be sent to Breakout Rooms, manned by the Virtual Registration Desk Staff. We have also tested Google Sheets as a tool to allow multiple Virtual Registration Desk Staff to be able to make entries at the same time to our spreadsheet. I will be reaching out shortly to the District Registrars and Alternate DCMs for volunteers to man the Virtual Registration Desk After the recruitment process is completed, training sessions will be held for the Virtual Registration Desk Staff.

It is also critically important for you, as DCMs, to ask your District attendees to log onto ZOOM as early as possible (starting at 8 am) on the Sunday (October 25) to be registered.

#### 8. TREASURER'S REPORT

Hello friends, I am an alcoholic, a member of Courtice 12 and 12 Group in District 28, and my name is JoAnn. It is both an honour and a privilege to serve as your Panel 69 Eastern Ontario International Area 83 Treasurer. I took

part in the virtual Area Service Days held in June. My presentation was an overview of the General Service Structure. The June / July Area Roundtable discussions were interesting as well.

I have re-forecasted the 2020 Proposed Spending Guidelines to mirror our financial position as it will stand for the remainder of the year. This item will be on the agenda for our Fall Assembly for approval. Our Panel 69 Delegate, Rob M, has received information as follows: Our Regional Trustee Jan reported to the Eastern Canada Delegates that we will not be reimbursed for the GSC. Each Area contributed the required \$1800 and some contributed more. The total amount received was \$14,000 less than the cost of the virtual GSC. With this information in mind, I would like to let the Area Committee know that I have added a \$5000.00 contribution to the General Service Office in the proposed spending guidelines to be presented to the Assembly in October. If any of the Area Committee and Sub-Committee have upcoming expenses that they would like to see in the Proposed Spending Guidelines, please let me know by October 15<sup>th</sup>.

My duties as Treasurer have certainly pivoted from extremely busy to exceptionally light. I am continuing to receive Group and District contributions in the mail as well as by e-Transfer.

As we start to re-open face to face meetings, I am hopeful that 7<sup>th</sup> Tradition contributions will increase to some degree. I have done a month by month comparison of the number of contributions and transactions to the end of August (**Table 2**); we are down 87 contributions versus 2019 year to date.

Please continue to remind groups who would like to contribute using PayPal to include their six-digit Group Service Number with any contributions so that the group may get credit for their contribution. The place to enter the group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. There has been one contribution, so far, this year using PayPal.

There have been 18 contributions via e-Transfer so far in 2020. This method of contributing to Area 83 is easy for the Groups and Districts and straightforward to process letters of receipt. Please consider this payment method when your Group or District discusses contributing to Area 83. As with all contributions, please reference your Group and service umber or District name and number in the memo field.

When a Group or District sends in a contribution, they will receive, in return, a thank-you letter of receipt. Emailing these to you costs the Area nothing, whereas mailing them requires a stamp, envelope, paper, and ink. Please encourage your Treasurers to include an email address with your contributions, and I can email your letter of receipt. <u>Page 1</u> is a financial summary. It shows our reserve account, which is set aside for unforeseen circumstances, has a balance of \$20,000 in the form of a GIC which matured September 11th. Interest income will be reported on the financial statements for the Virtual Fall Assembly. The reserve account starting balance has been re-invested for 3 years with the rate being

a minimum of .33 % to a maximum of 12% (Canadian Utilities and Banks). This is tied to investment performance of the fund.

Income for the period as at September 5, 2020:

- 7<sup>th</sup> Tradition collected at the January 4<sup>th</sup> and June 6<sup>th</sup> Area Committee Meetings \$642.05
- Group and District Contribtuions\$19,315.35
- GSO Flow Through \$1010.00.
- Cost Recoveries \$56.00

Total Income for the period is \$21,023.40.

Expenses for the period as at September 5, 2020:

- Committee expenses are \$4,969.82.
- Area Committee Meeting, January 4<sup>th</sup> rent and refreshments \$477.19
- General Service Conference Assessment \$8,821.80 (US\$ 6,500.00)
- PayPal Fee \$1.32
- Bank Service Charges \$27.40
- Ontario Delegates Committee \$5,663.02
- Flow Through Payment to GSO \$1010.00
- Refund of \$150.00 from Eastern Canada Region Hospitality Room at the International Convention event cancelled

Total Expenses for the period are \$20,820.55.

The opening bank balance at January 1, 2020 was \$40,490.20. Total income of \$21,023.40 less expenses of \$20,820.55 leaves a balance in the operating account of \$40,693.05. As of September 5, 2020, our expenses were \$202.85 less than our income. Thank you to the 83 Groups and 10 Districts for your generous contributions to Area 83.

<u>Page 2</u> shows details of expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member as well as all other expenses to date.

Some of the numbers you see here:

- The amount shown under Printing (\$285.00) for Secretary is for September 2019 ACM minutes and January ACM Agenda.
- The amount shown under the Treasurer for Stationery is for a \$173.20 cheque reorder.
- The amount shown under Registrar (\$192.21) is for an order for name badges.
- The amount shown under Alternate Delegate for Miscellaneous Expenses (\$326.69) is for Zoom annual renewal \$235.70 and 2 large group add-ons \$90.99.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to attend the General Service Conference". The estimated assessment for our Delegate to attend this year is \$8,400.00 USD (based on 2019 GSC). Since the location was in Rye Brook NY, our Delegate was in discussion as to what amount we should remit to GSO. Area 83 suggested \$6,500.00 US\$ (Canadian \$8,821.80). This amount was remitted to GSO in January of 2020. The GSC Assessment covers the total cost of the General Service Conference divided by the 93 Delegate Areas. These costs include expenses for Delegates, Trustees, and GSO staff to attend, as well as meeting rooms, A/V equipment, printing (includes the final conference report sent to each group) and miscellaneous expenses.
- Ontario Delegates Committee is \$5,663.02 for event hosted by Eastern Ontario International Area 83 in Toronto
  February 28-March 1. This event is to prepare the 4 Ontario Delegates and Alternate Delegates for the 70<sup>th</sup>
  General Service Conference. These costs were for hotel meeting rooms and refreshments, organizing

committee hotel rooms, meals and transportation, and guest presenter's hotel rooms, and transportation as well as the organizing committee's printing and stationery.

• Flow through amount forwarded to GSO on behalf of 2 Groups and 1 District in Area 83 (\$1010.00).

To summarize, our financial position for year to date 2020 compared to year to date 2019 is as follows: Income for 2020 is \$20,392.37 less than the same period in 2019. Expenses to date for 2020 are \$22,590.68 less than the same period in 2019. The net change to the Operating Account is \$2,198.31. The reduction of contributions in 2020 versus 2019 is \$16,781.52.

\*An item of special note is the cost to cancel the 2020 Spring Assembly. We have a credit at the Ambassador Hotel of \$1,288.25 toward payment of a future Assembly.

<u>Page 3</u> shows contributions by District. These amounts include contributions from Districts, as well as Groups. 83 Groups and 10 Districts have contributed to Area 83 in 2020. There are 42 less Groups and 5 less Districts contributing in 2020 versus 2019.

The virtual Fall Assembly (October 24 - 25) will be technically facilitated by the firm Check 2 AV who worked with GSO to deliver all technical needs of the  $70^{th}$  virtual General Service Conference. Our cost for this service will be approximately \$3,388.50 USD. We will be collecting a  $7^{th}$  Tradition during the Assembly. Instructions will be shared during the Assembly.

We will be collecting a 7<sup>th</sup> Tradition today. Please e-transfer your contribution and reference ACM in the memo field. Email address is <a href="mailto:treasurer@area83aa.org">treasurer@area83aa.org</a>. I will group the contributions and report the total at the Virtual Fall Assembly.

Under new business, I have asked for a discussion regarding "Should Eastern Ontario International accept contributions from individual members of A.A.?" I have some interesting facts which I look forward to presenting.

I will be taking part in the Fall Virtual Workshop Sessions on Sunday October 4<sup>th</sup>. I hope to see many of you online that evening at 7pm. Thank you for the opportunity to be useful and serve. I am confident we can prudently navigate the remainder of 2020.

#### QUESTIONS FOLLOWING TREASURER'S REPORT:

QUESTION: Glenn G., DCM, d18: When will the proposed spending guidelines will be available?

Answer: They will be issued one week in advance of the Fall Assembly; so you can all review them. They are going to look a lot like what our actual spending has been, with the addition of the \$5,000 contribution to GSO.

QUESTION: Should we adjust our Reserve account?

Answer: I do not have an opinion regarding the reserve account. If the membership is concerned that \$20,000 was not enough that would be something that would come from the floor. I can just point out the history. These are unusual times for sure.

QUESTION: Bev H., DCM d34: Why did we not receive a refund from the GSC?

Answer: The cost of the GSC was \$14,000 more than what the Areas remitted to the GSC. That being said, there were no real cost savings (note: if it was a physical conference, the deficit would have been a lot larger than \$14,000). This was the case for all Areas. The net that was collected, which was \$1,800 USD conference assessment that is suggested each area contribute. Some areas, like us) contribute more than the suggested amount.

QUESTION: Ray, PI chair: the \$5,000 contribution that you are going to put on the spending guidelines is separate from the refund from the GSC that we did not receive?

Answer: Yes, that is correct. If you remember the conversation that we had at the June ACM about whether we should contribute to GSO, we agreed to wait and see what and if we receive a refund from the GSC. There was no refund, and I think that we can be happy that we contributed to the totality of the GSC, more than the prescribed about per area.

QUESTION: Ray, PI chair: How does a conference that ran virtually run into such a deficit? You may not be able to answer that questions, but if you have any thoughts, I would like to hear them.

Answer: Traditionally the GSC, 9 times out of 10 goes into a deficit position when you take the Assessment and the contribution compared to the cost of the event. Perhaps Rob might be able to sign off on that thought. The cost for the virtual conference, they had to factor in the cost for technology, support staff. That is why it wasn't markedly less. Organizing, cost, electronic cost, employee, and tech firm to facilitate the GSC.

ROB M ADDED: two of the bigger costs of the virtual GSC were the final conference report was made available in hard copy. Area 83 chose to receive only a limited number of hard copies, but some area chose to receive a copy for each group. Those were still printed and shipped out and are part of the General Service Conference expenses.

Also, Conference members book their own travel before they go to GSC and get reimbursed for that travel. A lot of members had already booked their flights and were reimbursed BEFORE the conference was cancelled. Some of them, did not have travel insurance (did not receive a refund), so there was quite a bit of travel expense involved with the conference even though it was virtual.

#### 9. SECRETARY'S REPORT

#### Amy L.

Good morning friends, I am a member of the Liverpool Group in Pickering found in District 26 and my name is Amy. I have the privilege of serving Area 83 Eastern Ontario International as your Secretary and it has been a pleasure.

It is so nice to see you again, it doesn't seem that long ago and that is probably because of all the virtual activities the Area has been doing, I am bumping into many of you every couple of weeks. How cool is that? I am so grateful for the virtual platforms we are using, as it has given me so much more freedom to move around in my AA world.

Some of the activities I have been doing on behalf of the Area since we last met have been:

#### 11. DELEGATE'S REPORT

#### Rob M.

Hi everyone. I'm an alcoholic, a member of the Motorcity Group in District 28, and my name is Rob. It's an honour to serve as Panel 69 Delegate for Area 83 Eastern Ontario International. I really wish we were gathered together in the basement of the church in Quinte West. I miss seeing all of you guys. However, I am grateful that we are still able to meet online and it is really nice to be with you here today.

Here's what I've been doing since we last met.

I reported on the General Service Conference at Area 83 Service Days on June 13<sup>th</sup> and 20<sup>th</sup>. June 27<sup>th</sup> was info AA day, a service day hosted by the GTA Intergroup and the eight Districts in Toronto. All three were well organised with informative presentations. Thanks to everyone involved and all those who attended.

June 16<sup>th</sup> and 30<sup>th</sup>, and July 21<sup>st</sup> I zoomed into the Area 83 round table discussions on who is missing from our Zoom meetings, and safely re-opening our in-person meetings. These discussions were captured, and some really helpful summaries can be found on our Area 83 website.

On June  $22^{nd}$  the CERAASA steering committee met. CERAASA 2021, hosted by Area 86, is scheduled for February  $26^{th} - 28^{th}$  in St. Catherines. The hotel has not cancelled any events past September of this year. There is a chance of re-scheduling in 2023 and deferring cancellation costs. The committee chair will report more on this at our next meeting on September  $28^{th}$ .

On August 5<sup>th</sup> the Delegates of Eastern Canada met with our Regional Trustee Jan to hear Jan's report on the August General Service Board meetings. The big news here is that the board has been advised to cancel all in person events next year. Here is a recommendation that was approved by the General Service Board: "That the General Service Board begin planning for the likelihood of a virtual General Service Conference from April 18-24, 2021, and that the planning involve the 71st General Service Conference delegate members, while acknowledging that if and when circumstances allow, an in person Conference is always preferred".

On August 15<sup>th</sup> the GSC members reconvened to hear an updated financial report from Leslie B. Class A Trustee and Treasurer for the General Service board. A digital copy of the final financial report was sent to District Committee Members and posted under the Delegates tab on our website.

On August 30<sup>th</sup> I was on our Service information day's first virtual workshop. Amy, Dave, and Joyce all gave wonderful presentations and the committee did a great job of facilitating the workshop. I plan to attend upcoming Service Information Day workshops scheduled in September and October.

I participated in our 3<sup>rd</sup> Legacy workshop on September 9<sup>th</sup>. Documents used in the workshop with suggestions for conducting virtual elections were sent to DCMs.

September 26<sup>th</sup> is the National Archives Workshop and the District 22 Service Day. With one scheduled in the morning and one in the afternoon I hope to attend both.

Area 82 Nova Scotia Newfoundland and Labrador will elect their Panel 71 Committee at their Assembly on October 11<sup>th</sup>. Kimberley and I have been invited to be part of the Zoom team facilitating the elections. It will be a chance for us to witness virtual Area elections before we get to ours later in October.

As you know the Eastern Canada Regional Forum scheduled for November 13<sup>th</sup> – 15<sup>th</sup> in Ottawa has been cancelled. In its place will be a virtual Eastern US Canada Forum that GSO is calling USCAN. Unfortunately, the Forum is scheduled for December 5<sup>th</sup>, the same day as our Area Committee Meeting. If you would like a copy, please send me your postal address and I will mail you one.

Area 83 was one of ten Areas of Eastern Canada who contributed financially to the hospitality suite for the International Convention. The hospitality suite chair had already purchased 3000 regional pins and 5000 maple candies to hand out at the suite before the convention was cancelled. The pins have been tucked away for the 2025 International Convention and the candies were sent to the CERAASA Committee as they won't last 5 years. The balance after these expenses was around \$1500 so each Area received a \$150 refund.

I look forward to the time when we can meet in person. Until then I wish all good health and hope to see you online.

#### 13. NEW BUSINESS

#### A. Area 83 Zoom Usage Report

Kimberley M – Alternate Delegate

Hello again, I'm an alcoholic, currently serving as Alternate Delegate for Eastern Ontario International, and my name is Kimberley.

When it comes to account usage, the reports disappear after one year. If we don't grab the data now, we will lose it! Here you can see that over that first year (<u>Appendix B<sub>1</sub></u>), we averaged 8.5 meetings per month that were on average 96 minutes long with an average of 11 participants.

Here is the data usage starting in on year two (Appendix B<sub>2</sub>), which so far includes June, July and August of 2020. We have had an average of 7.7 meetings per month with an average of 108 minutes per meeting and an average of 26 participants per meeting. The service days and round table discussions took place in this time period. There were 121 participants in the Round table discussion that took place on June 30<sup>th</sup> and 110 on the July 21<sup>st</sup> Round table discussion.

The account has been used for a variety of events; see the list on bottom of Appendix B<sub>2</sub>.

# B. Discussion: "Should Area 83 Eastern Ontario International accept contributions from individual members of A.A.?" JoAnn P – Area Treasurer

Good afternoon, I am an alcoholic and a member of Courtice 12 & 12 in District 28 and serving as your Panel 69 Treasurer and my name is JoAnn. I asked James to add this discussion item to new business today. This topic arose from the questions that were asked during our last Area Committee meeting and contributions that have been sent by e-transfer to Area 83 without a Group or District affiliation. As I mentioned in June, the Area 83 contributions page on the Area website (area83aa.org) indicates Group and District contributions are accepted. There have been 4 contributions to Area 83 this year from individuals with no indication of Group or District affiliation. This leads to investigative work to ascertain where the contribution should be recorded and reported. The ease of e-transfers will undoubtably lead to more individual digital contributions.

The core issue is the confusion regarding what is allowed and what is not. GSO accepts individual contributions from AA members (max \$5000.00 per year) as well as bequests of \$10,000.00. Our Area 83 Operating Procedures – Section 7 Expenses – item 04 states: Bequests in Wills are acceptable only from members of Alcoholics Anonymous. The limit for such bequests is five thousand dollars (\$5000.00) and must be on a one-time-only basis and not in perpetuity. There is nothing in the Operating Procedures stating that we accept individual members contributions.

As far as I know, there has not been a reason stated as to why Area 83 does not accept 7<sup>th</sup> Tradition contributions from individuals outside of the 7<sup>th</sup> Tradition collected at Area 83 events (Assembly and Area Committee Meetings). Perhaps it is due to the interpretation of Tradition 6 - *An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose.* 

Also, Concept 12 which reads "The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action".

Some further investigation was called for. I visited all 93 Area Websites and found the following:

- 60 Areas accept online contributions (Group, District, Special Event, Individual, Birthday are some of the categories).
- 50 Areas accept individual contributions as well as Group and District.
- Of the 50 areas that accept individuals' contributions, 4 Areas indicate a maximum for individuals (3 \$5000 and 1 \$3000).
- Only one Area in Canada (BC / Yukon) accepts member contributions.

Long Form Tradition 7 states "The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority".

The short and long form of Tradition 7 are quoted on many Area Websites. <u>Self-Support: Where Money and Spirituality Mix</u> (F-3) pamphlet is often quoted as well. Many websites have a simple statement "I am a member of Alcoholics Anonymous" which can be selected for individual contributions.

#### Why accept personal contributions outside of Area events where the 7<sup>th</sup> is collected?

- Member's Group or District does not contribute to Area 83
- Any excess contributions can be forwarded to GSO to continue supporting the services that we have asked GSO to provide to assist in Twelve Step work
- The principal of participation at an individual level
- Spiritual intention is participation
- ...collective obligation that rests upon all of us A.A. Guidelines Finance (MG-15) Bill W October 1967 Grapevine.

Either way, accept or decline, we should indicate that we do or do not accept individual contributions outside of Area 83 events for clarity sake.

Case for not accepting personal contributions outside of Area 83 events where the 7<sup>th</sup> is collected.

- Big shot ism humility issue
- Accumulating a large amount of money is contrary to traditions and concepts.

What would need to happen if a motion to accept individual member contributions outside of Area events with a maximum yearly limit stipulated were proffered here and accepted at the Area Assembly?

- Operating Procedures would have to be amended
  - Change Heading Section 7 to Finances / Expenses
  - Add individual Contributions before Bequests 7.04
  - o Renumber Bequests and General Service Conference
- Revise Treasurer Financial Spreadsheets add category and tracking method
- Website would need to be updated with a declaration statement and some form of tracking.

What would need to happen if a motion to accept member contributions outside of Area events was defeated? Disclaimer added to contributions page.

#### QUESTIONS FOLLOWING THIS REPORT:

- QUESTIONS: JACK R. DCM, DISTRICT 36: in the past, pre-etransfers, Area Treasurers received personal cheques, and what did they do in the past? Did they accept, deposit, tear them up or what?
- Answer: I have no information about what previous treasurers have encountered in the past. Sometimes groups will use a member's personal check, but they indicate in the memo field on the cheque the group and service number. I don't know if and when it was brought up in the past.
- Question: Did this topic come up in the past at an ACM or Assembly in the past? I seemed to remember quite a few years ago, this came up when people were sending cheques mail. A decade or two ago.
- Answer: I have no information about what previous treasurers have encountered during their term. We have 3-4 previous treasurers attending this meeting today, if they would like to share. Sometimes members of a group will use a personal cheque to contribute when the group does not have a banking account. They will indicate on the memo field of the cheque which group and district this contribution should be assigned. I haven't run into much difficulty with the cheques, but it is the e-transfers that are coming with no information. I brought this question up at the June ACM and no one was really sure if it has come up or not.
- QUESTION: Glenn G., DCM d18: The e-transfer option is a bit more anonymous and tracking down group and district details more difficult for the treasurer. If that is what is behind this topic, then I would support a limit of 3-5,000 like other areas have done.
- Answer: that is part of the issue. This was brought up in the June ACM, and if you read the 3-page discussion thread that ensued. For me, for clarity sake and for the next treasurer that we need to decide that either we do accept individual contributions, or we don't. We do have a category titled "Unspecified" but I don't think it has been used. This category is, in accounting practices is used as a suspense account, where you temporarily put things where you don't know where they go. That would be in worse case scenario the contribution would show up there. Usually I can track it down to a district, to a group and have a conversation that I need to attach the contribution to Group/District. It is up to you guys. This is your decision and discussions. I would just like to see some clarity on the issue.
- Question: Jo D., DCM D54: If you receive an e-transfer and there is no indication that it is from a particular group. Are you suggesting that you will take it-henceforth as an individual contribution-and credit it to the person?
- Answer: it would not be classified as an individual contribution, because we have not decided that yet. If someone sends an e-transfer and they don't indicate the group details, I need to do the back and forth etc.... I had a group that closed, that wanted to submit the balance of their funds, so I had to track that down and assign it to the District.
- Question: if we approve what you are suggesting, when you receive an e-transfer in the future, from somebody with no indication that it is coming from a group, district or individual- are you going to accept it as an individual.
- Answer: That is why I mentioned that we need to have some sort of tracking on the Area 83 Contribution website page. They would have to indicate that they are a member of AA., and their would have to be some form of tracking accounting. I wouldn't just automatically presume, that when someone does not include the memo of group/district that it is an individual contribution. We have to have a mechanism in place. It would be reported as individual (anonymous-no names would be listed). Individuals can contribute to GSO, and very few people actually do this. I cannot imagine that Area 83 will any different than GSO. This is more for clarification and not to try to boost our 7<sup>th</sup> Tradition contributions.
- Terry N., DCM d26: I feel that an area we should accept contributions from groups. During our Area committee meetings and Assemblies, we collect from individuals a 7<sup>th</sup> Tradition. Groups are having a hard-enough time as it is today to collect 7<sup>th</sup> tradition today. If we start this, I don't know how much the Area will get, but I don't think it is a precedence we should set now.
- Mike B., Area Self-Support chair- If I can remember from the PowerPoint presentation from the GSC Individual contributions to GSO in 2019 was approximately 1.3 million. How would this affect Concept 7- the power of

the purse if individuals are allowed to contribute directly to the Area. I am seeing more and more ideas for individual contributions and fund-raising campaigns within our Fellowship instead of talking about who contributes and why contribute at the Homegroup. That is the one place that money and spirituality are supposed to mix. Having said that, I absolutely respect the group conscience and the process. I wonder if we are making informed and educated decisions about what avenue your contributing your 7<sup>th</sup> tradition as members. The more I contribute to my homegroup, that is where the decision are made. I believe individual contributions should remain at the group level, as it strengthens our service structure, keeping the groups at the top of the triangle.

- Glenn B., DCM d82: As an area, I think we should allow individual contributions to be made, to the area. From history, and experience with my own group-Sometimes through group conscience, group members may argue over what to do with group funds (choosing to keep it local) and there might be some people who want to see their money go to the District and Area. I think it would be good to have that option.
- Amy L., Area Secretary: In this day and age, and zoom, and many of us are still participating in home groups, I think we might be on the cusp of something revolutionary where some might not be affiliated with a physical group. Online meetings at this time do not fit within the General Service Structure and I do know that Area 83 does a lot of great work for AA in Eastern Ontario. Supporting that good work that we are doing, that maybe if I don't belong to a group, I would never be able to share my gratitude. I would entertain allowing individual contributions to be made to the Area. We are on the edge of something new that will need to be dealt with soon.
  - Eileen S., DCM d28: many in-person groups we do not know how they will fair during these weird times. I am in favour of accepting individual contributions. Perhaps like GSO, when I click Am I member or Am I not a member, we could easily put something on the Area 83 website that asks, are you contributing as a District? As a Group? As an individual member? And you have to click on one option to proceed.
  - Ted R., DCM d42- we are not talking about a lot of money here, and it would save some work for the area treasurer to track down the contribution to group or district.
  - Jack R., DCM d36- make a motion, if only to simplify JoAnn's life, since nothing in our Area operating procedures stipulates that the Area accepts individual 7<sup>th</sup> traditions.

**Motion**: that Area 83 accept contributions from individual members outside of Area 83 functions with appropriate safeguards to ensure contributions are from AA members only and do not exceed a maximum of \$1000 per year.

#### C. Report from the Chair regarding the Area 83 virtual Fall Assembly James O'D – Area Chair

The Final Assembly of our term is coming up very soon and we are in good shape and in good hands. Area 83 has hired a company called Check2 AV to run our event – the same company that facilitated the recent virtual General Service Conference. They have a deep understanding of our Traditions and respect for our anonymity concerns. Over the past few weeks they have managed several Area Election Assemblies and will also be in charge of the Forum in December.

Our Assembly falls into three distinct sections: registration, body and elections. What follows will be a very general breakdown of some of the creative ways we are approaching these items.

Registration: When a member logs into the meeting they will be immediately brought to one of our 20-25 breakout rooms where they will be greeted by one of our registration volunteers. This is where you will be renamed using our naming convention to indicate if you are a voting member or a guest. After this process you will then be sent to the main room. This will assist in our voting process for any motions and elections but also acts as one of the many security features that are in play. We may, for example, put a "1" in front of voting members and a "2" in front of non-voting members. Visitors may have a "V". Attendees will not be able to change their name once in the main room. If a voting member swap needs to take place (ie. a GSR that was voting for their group has to leave and the Alt GSR now becomes the voting member) the attendee will advise one of the Zoom techs and will be moved to a waiting breakout room to be renamed.

**Body**: In the body of the Assembly we will be addressing the various agenda items where only voting members will have a voice and a vote – exactly like in our regular Assembly. I would strongly suggest that all voting members read or reread all the background information pertaining to the recommendations made by the Area Committee so that we can make the most of our discussions and therefore come to a truly informed group conscience. In agenda item #2, our Registrar Dave will provide us with the number of voting members and will provide a more detailed roll call later on in the meeting when all of the numbers have been checked and verified.

<u>Elections</u>: At this point of the meeting all the non-voting members (those with anything but a "1" in front of their names) will be moved to a breakout room where they can watch the elections take place but will be unable to vote.

Our elections ringmaster this year is Area 83 Panel 61 Delegate Robb W. Please take the time to review "APPENDIX FOUR Procedures for Election of Area Officers" to be found on pages 31-41 in our Area Operating Procedures. Some of the procedures have been adjusted for a virtual environment.

N.B. To ensure the smooth running of our historical first online Assembly (and an election Assembly to boot!) we have organized two <u>training sessions for all members of Area 83</u> – especially voting members. The following dates have been confirmed by Check2 AV – please mark them in your calendar:

- 1. Saturday October 10, 2020 Registration opens at 6:30pm Meeting at 7pm
- 2. Monday October 12, 2020 Registration opens at 6:30 Meeting at 7pm

We encourage the membership to come to at least one but would appreciate it if you could support both. By attending both meetings you will solidify your own confidence in the unfolding of the Assembly process but also you will be assisting our Registration and Elections teams to practice on living, kind and patient test subjects. Just imagine your heavenly rewards!

I will now open the floor for any questions.

#### QUESTIONS FOLLOWING THE REPORT:

QUESTION: Ray R., Area PI chair: in the event we are not able to make the practice session, what can we do.

Answer: If you don't make it, you will just have to figure it out. We picked two different days of the week to not force a person to miss their group twice. We made it early enough so that we can address any systemic problems.

QUESTION: Neil P., DCMd66: When will we get notice of the meeting IDs for these training sessions:

Answer: We will be meeting with the company, and we will be using their account. As soon as we have them we will send them out.

QUESTION: De R., DCMd02: Who will be issuing the meeting IDs? The company or The Area.

ANSWER: The company will be sending us the meeting IDs and we will go through the secretary to distribute to the Area.

QUESTION: Eileen S., DCM d28: will it be sent as a link or as a flyer. That is Thanksgiving weekend (Saturday and Monday), I am sure you have considered that.

Answer: I think we will probably just send out the ID and Password because when you send out a link it is possible to scrape all of the information. That said, it is not confirmed yet. Yes, we have considered its proximity to the holiday.

QUESTION: Tim F., DCMd86: what was the cost for the tech company AV?

ANSWER: \$3,765.00 USD.

QUESTION: Glenn G., On Saturday there is going to be reports and speaker. So, we are participating on 24<sup>th</sup> and 25<sup>th</sup>.

Answer: there has been some mention on Zoom fatigue. We have some pretty big items to cover and allowing two days for the meeting was necessary to not feel like the discussions are rushed.

QUESTION: Bev H., DCM d34: How are we handling those who do not have internet access and phoning in? I have a GSR that does everything by landline.

Answer: We will be having a meeting with Dave L., Kimberley, and company to work on the Registration portion of the Assembly. As for the body of the meeting, we will have to figure that out with the company. Then later, there will be a meeting with Kimberley, myself, Robb W. Panel 61 Delegate and his election and the company. For the elections, we will see how members can phone in.

ROB M. PANEL 69 DELEGATE added- this company did an outstanding job at the GSC and had a good handle on the event. They will have facilitated a few area elections before ours and they will have any bugs worked out by the time they get to ours.

We are hoping ALL members of Area 83, especially those with a vote will attend the Assembly practice sessions. Even if you don't have a vote, you can attend the practice session(s). It helps us all.
