# Area Assembly - October 24, 2021

# 1. OPENING

Meeting opened at 9:10 am.

Let's start this meeting with a Moment's Silence followed by the Serenity Prayer. May we have that moment now.

Welcome everybody to the Fall Assembly. Did everyone enjoy the Service Information Day yesterday? And how about the speaker meeting last night? Perhaps we can give a hand for the Service Information Day Committee and for the great line up of workshops. And thank you Mary for your wonderful talk last night.

## Introduction

This is our second Assembly of four in this term. During the remainder of the 2-year term, we will be working together to provide continued strength and direction to A.A. in Area 83. Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together with open lines of communication is the key for continued Unity in our Area.

The A.A. Service Manual defines an Assembly as follows: "The Area Assembly is the mainspring of the Conference structure – the democratic voice of the movement expressing itself." Just as most District tables meet monthly to oversee the affairs of A.A. in the District, and home Groups usually have regular business meetings, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83.

Area 83 stretches from Oakville in the West to Ottawa in the East, down to upper New York State and up to Algonquin Park and the Ottawa Valley. At last count, we have 584 Active Groups.

Some of us have been here before as General Service Representative or Alternate, as District Committee Member or Alternate, or as visitors. For some, it will be their first Assembly and from personal experience it can seem overwhelming! How many of you are here today attending your first Assembly? Could you raise your virtual hand please? I see quite a few hands raised. That's great!! Welcome.

Being in service is a great way to give back to AA. You will not be expected to learn or understand everything the first time or even second time. It takes time but it will make sense. Many of us didn't understand what was going on at meetings at first, but in time, we started to understand. Service is much the same way. So please keep coming back – welcome and enjoy the rest of the Assembly.

Over these two years, we will make decisions on a variety of topics. The Area Assembly, like the General Service Conference, strives for substantial unanimity through ample discussion. Before a vote is held, plenty of time is taken for full discussion and questions.

It is my hope that you will return to your Groups and Districts with the feeling that you have done your part in keeping Alcoholics Anonymous strong and vibrant in your area and that you have had a strong voice in Area 83. With a spirit of love and cooperation, we will be able to get things accomplished and have some fun while we're doing it.

At the end of today, I hope that each of us will sign off of our computers with a renewed belief that A.A. is alive and well in our Area and that our message of hope is being well carried to the still-suffering alcoholic.

**NOTE:** At the last Area Committee Meeting on September 11<sup>th</sup>, under Agenda Item 15- the Area Committee voted to have the Next Area Committee Meeting on January 8<sup>th</sup> and the format to be hybrid (virtual and in-person). At present, the Westminster United Church would not allow us to meet in their facility. I will be in touch with our Liaison at the end of November to determine if an in-person component will even be possible. So please watch for communications at the end of November regarding the ACM meeting format.

#### **SEVENTH TRADITION**

The 7<sup>th</sup> tradition will be collected today by digital means. Over the course of the Assembly our Treasurer will be posting in the Chat window the available methods of making a digital contribution to Area 83.

#### **WHO VOTES?**

Only members of the Assembly may vote.

#### These are:

- All Area Officers, including the Immediate Past Delegate, but not the Chair.
- All Area Sub-Committee Chairs
- Area Webmaster, or in their absence, the Alternate Webmaster may vote.
- All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.
- All General Service Representatives of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups. There is one vote per person.

## **VOTING**

For anything requiring a vote we will be using the polling feature. There will be three options: For, Against and Abstain. You may notice some people have 2 devices in the session (Secretary and Webmaster), this is strictly because they will be sharing their screen at times and that can only be done by a co-host. Everyone who has a second device in the session will have their second device designated as a co-host, so they do not have the ability to vote on that device.

## **DISCUSSION/RAISING HAND**

If you would like to address the committee (as though you were approaching the mic) to make a motion, second a motion, share a new perspective or ask a question, please raise your virtual hand using the RAISE HAND FUNCTION. Zoom will keep people in a queue in the order in which the hands are raised. If you are connecting with us by a landline telephone, to raise your hand it is \*9.

When you have been recognized by the chair, please identify yourself by Name, Service Position and District. Please come to the virtual mic with your thoughts formulated and refrain from extraneous comments.

Reminder: if your idea or comment has already been presented, please lower your hand. Your humility and cooperation in this regard is appreciated.

## **VOICE OF THE MINORITY**

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the original motion.

## **CALLING THE QUESTION**

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in any discussions, and if discussion is prematurely cut off, we will not get to hear them.

#### WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
  - It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
  - o And it maximizes the time available for those members to voice their Groups' opinions and needs.
  - All who are attending may say their piece during sharing time. I would ask for your cooperation on
    this. If you don't have a vote, as I just described, please keep your input for sharing time, which is
    scheduled as Item 13 on the Agenda. At that time everyone is welcome to participate, and their
    opinions will be listened to.
  - On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize it may feel like a long day in front of your computer, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important will be said.
  - To allow me to facilitate discussions, when you are ready to speak and you have been recognized, please identify yourself by name, position, Group and District number.

#### **Floor Motions**

If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary, JoAnn, before addressing the Assembly.

#### **HOW DO WE VOTE?**

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority which is 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll-call as the basis for the 2/3 calculation.

I believe that the first part of the agenda today can be handled under simple majority -1 vote more than 50%. The items under old and new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

At times, I may ask for a show of hands to get a 'sense of the meeting'. This is not a vote. We will do this by clicking the green Yes button or Red No button. We will use these buttons to gauge the feeling of the voting members.

For any items requiring a vote we will be using the polling feature. Going forward, to vote on a motion there will always be three options: For, Against and Abstain. I will be sure to give enough time for all voting members to cast your vote. The poll will be visible to everyone, but please, only vote if you have a vote.

Again, if someone is calling in by phone or needing assistance, we will move you into a breakout room and one of our ZoomOps will collect your vote. This may take a little time, but it is important that everyone can participate equally in this meeting.

We hope that we can begin meetings with them when they settle into their new environment. CAMH had canceled but is now re-introducing meetings again, and Maxwell Meighan is still in start-up. Each month we have one to two contributions from our groups and with very few expenses, we are in good financial shape. The District 10 Operating Procedures ad hoc committee is about 90% done, with almost all of the proposed changes passed through motions. Return to in-person meetings has been slow, as has been the reopening of their host venues. 23 of our 24 groups continue online, and some are running hybrid and/or in-person meetings. Thank you again to the Service Information Day committee for an exciting and informative Service Day yesterday and thank you to those who attended the Public Information Committee workshop as well. I attended several of the other workshops and learned a lot. The day was capped off with an awesome banquet speaker.

We had a meeting with some of the District Public Information committee chairs on September 22 after taking a hiatus in the summer. As expected, things have continued to be rather slow in the Public Information field in a number of the Districts over the last several months. Many facilities have not yet allowed members to leave literature or asked members to put on presentations due to pandemic restrictions. I anticipate that this will gradually change and opportunities to get the message out will open up over the next few months. Some good work is still being done including an outreach campaign to seniors / care homes in District 10 and a new Facebook page in District 26 with some positive feedback from that.

I have contacted members of the National PI & CPC working group and am gradually learning more about Search Engine Optimization for A.A. websites so our program can be more visible to the public on search engines like Google. # B. Cooperation with the Professional Community Jo D.

My name is Jo D. I am a member of the Search for Serenity Group in District 54, Ottawa Rideau. I am honoured to serve as the Area 83 CPC Chair. I am an alcoholic.

I think Fall 2021 is focus on CPC time. If you haven't already, please read the Fall 2021 edition of Box 459. There is a great article that summarizes some of the key research that has been done on A.A. over the years, including the most recent Stanford study/Cochrane Institute study which concludes among other things that "A.A. works as well or better than other scientific treatments for alcoholism." I really hope the GSO puts that summary of research into the newsletter for professionals. Wouldn't that be great!

When you finish reading Box 459, you can go listen to the Grapevine's very first podcast which features an interview with a member who served on a CPC Committee. He talks about the "demonstration meetings" that he was involved in. I can attest to the inspirational nature of that interview because the suggestion was raised at the Ottawa CPC Committee should do one!

Then you can read the October Grapevine contains a special section on CPC. There are six articles by members on their involvement in CPC work – including the story of the member who was interviewed in the Grapevine Podcast.

The fourth initiative involving CPC is that the GSO is updating the CPC workbook. To help with that endeavour, CPC committees are invited to share their creative ways of carrying the message to professionals. Just email cpc@aa.org by November 22, 2021.

I have been attending the Ottawa and the Toronto GTA CPC monthly meetings – except when they conflict. I like attending CPC meetings. If you invite me, I will come – even if you are a committee of one!

It seems that several Districts are reaching out to medical and health care professionals: I have had discussions over the summer with individuals in Districts 6, 54, 62 and 82 which are all contacting the medical professionals; I have been able to share resources and "best practices", correspondence and experiences of various Districts. I have communicated with a couple of other Districts about work they are doing as well.

On June 12, I attended the Ottawa area "The Hand of AA in Service". I was able to hear our Delegate Kimberley's report on the General Service Conference. I made a 15-minute presentation about the purpose of CPC Committees and the Ottawa Committee's upcoming work, including plans to correspond and deliver information packages to medical clinics.

On June 24, I chaired a quarterly meeting of Area 83 District CPC Chairs. In the Districts where there is no CPC Chair, I invited the DCMs. Eleven of us met to hear Steven from District 28 tells us about work his District is undertaking with Shoppers Drug Mart Head Office which, if successful, will allow Alcoholics Anonymous literature to be displayed in their stores in Ontario.

Also in June, I sat in on the Area 49 SENY CPC Conference Committee to hear their Delegate's debrief of the General Service Conference CPC Conference Committee. Same debrief as Kimberley, our Area 83 Delegate, but with the additional description of the discussion among Conference Committee members on the potential uses of CPC on the Stanford study video.

On July 26th, I sat in on a CPC workshop put on by District 13 in Area 36 in Minnesota. The two hosts shared their experience with putting on a workshop for professionals. Some of the information they shared was as basic as "a power point presentation is helpful" to more sophisticated information about how they used Psychology Today website to find addresses for psychologists across their District, how

they recorded the workshop and then sent the recordings to every one of the two hundred professionals they initially contacted. Also, not only did they create little business cards as many of us have done, but they went one step further and created business card holders too. On August 18, I joined the District 42 N. Surrey N. Delta B.C. informational workshop for professionals about A.A. Two Class A trustees were among the panelists: Dr. Mooney and Dr. Peter Luongo. Dr. Luongo in particular provided some practical guidance on what the medical profession needs to know about A.A. More importantly, that District PICPC chair shared information with me about their best practices in organizing such events. So, the Area is building some "best practices" for these kinds of events.

On August 11th I participated in the North American CPC and PI quarterly meeting. I don't have a date for the next one but I will post it in the Area 83 upcoming events calendar. I am still Secretary of the North American CPC and PI Conference Planning Committee; that conference is coming up on February 12th and 13th, 2022. The Committee is making progress filling panels; the committee would like more diversity among panelists and hopes to achieve this when filling the three remaining panelist spots. If you know someone in Canada who is or has done some interesting work in CPC, please pass on their name to me. Also, if anyone is interested in serving as part of technical support, we can use your help.

In September, Districts 54 and 62 which make up the Ottawa PI-CPC Committee participated in Ottawa Recovery Day with a live display table and literature to hand out. Recovery Day is a day when community groups involved in all kinds of recovery from all kinds of addictions come together to share information about their paths to recovery. There was some really positive feedback to the Committee by some A.A. members who attended: the display table was professional looking and there were more people around that display than most of the other displays.

I continue to participate in the Pre Conference Agenda Sharing ad hoc Committee that the Chair invited me to join. The Chair of that ad hoc Committee, our Immediate Past Delegate will report on the work of that Committee.

I encourage you to come to the quarterly CPC meetings that I hold. I'm planning the next one for November.

I recently received a box of Grapevine's for corrections from the GTA Archives (thank you David). I sent some to Maria; DCM for District 30 as well as Nicky; Corrections Liaison for Ottawa. If anyone else needs some for a prison or jail, I would be happy to share some with you.

The GTA Corrections committee continues to meet, but unfortunately the attendance is low. I hosted a sharing session earlier this month with District chairs and unfortunately, I had the same issue, not many attended.

I just want to put this out there; Even though we can't go into most of the prisons right now, there are things we can be doing to continue to carry the message.

- Speak to parole offices, perhaps put some literature in there.
- Reach out to halfway houses and offer literature or perhaps Bridging the Gap

Another thing is the Corrections Correspondence Service. I know that we have been trying to get this going in local prisons and to no avail for the most part. Most of us received the communication earlier

this month on from GSO General Manager Bob W. Bob announced the launch of the new Corrections Correspondence System (C.C.S.) on September 27th. "The new C.C.S. provides an expedient process whereby we can match volunteers and persons in custody automatically and manually, obtain statistics and reports, and generate personalized letters that can be sent via email to outside A.A. members and via postal mail to persons in custody." To sign up for the Corrections Correspondence, go to aa.org, type in ccs, download the form. Then email to corrections@aa.org.

On Wed. October 13th I attended a really great Zoom meeting, Carrying the Message in Correctional Facilities. This was hosted by Area 19 Delegate from Chicago Monica F. who is amazing. Her enthusiasm for service is infectious, she is a great chairperson. The guest speakers she chose from around the U.S. were awesome. I'm very glad I attended.

I want to say thank you to all who attended the Corrections workshop yesterday. Also thanks again to Maria and Yves for sharing their experience with attending meetings behind the walls.

I need to issue an apology. During my segment of the workshop, numerous times I referenced the term 'inmate'. I'm truly sorry for that. I know full well that at this year's General Service Conference, this was a recommendation that was voted on and it passed. Thus, resulting in a 2021 advisory action to change all A.A.W.S. literature directed to members behind the walls and to replace the terms "inmate" and "offender" with "person in custody." I quoted the literature verbatim, whereas I should have made the adjustment, my apologies. I was called on it, too, through the chat, which I humbly appreciated.

I received this update this morning. The Toronto South Detention Centre is starting to allow outside volunteers. They are starting with the Chaplaincy first in small numbers, then if all goes well, we should have A.A. in there before the end of the year or early 2022. That's exciting because it's the first provincial institution I have heard of allowing volunteers in. So far, it's only been the federal prisons in and around Kingston.

Before I close, please tell your corrections chairs that I would like for us to meet sometime in November. Stay tuned for the Zoom invite.

That's about it from me. Please everyone, stay safe and until we meet again in January have a happy and healthy holiday season. Take care.

The Area 83 AA website receives visitors from around the world with the bulk of them coming from Canada and the United States. We have had a total of 974 visitors between September and October of this year.


# 2. Officer & Chairs Pages

# 6. TREASURER'S REPORT Dave L.

Hello friends, I am an alcoholic, a member of Liverpool Group in District 26, and my name is Dave L. It is both an honour and a privilege to serve as your Panel 71 Area 83 Treasurer.

When a Group, District or Individual sends in a contribution, they will receive, in return, a thank-you letter of receipt. Emailing these to you costs the Area nothing, whereas mailing them requires a stamp, envelope, paper and ink. Please encourage your Treasurers to include an email address with your contributions, and I can email your letter of receipt. Please make your cheques payable to "Eastern Ontario International Area 83". You can find contact information on the Area 83 website: <a href="mailto:area83aa.org">area83aa.org</a> at the top of the Home Page click "A.A. Contributions". Then click "I am an A.A. Member".

There have been 39 contributions via e-Transfer so far in 2021. This method of contributing to Area 83 is proving to be uncomplicated for the Groups. Please consider this payment method when your Group or District discusses contributing to Area 83. As with all contributions, please reference your Group and/or District Name and Service Number in the memo field. Individual contributions to a maximum of \$1000.00 per year will also be accepted.

Please continue to remind groups who would like to contribute using PayPal to include their six-digit Group Service Number with any contributions using PayPal so that the group may get credit for their contribution. The place to enter the group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. There has been one contribution, so far, this year using PayPal.

Let's discuss the Financial Statements for the period ending October 15, 2021.

Page 1 ( $\underbrace{\mathsf{Appendix}\ \mathsf{A}_1}$ ) is a financial summary. It shows our Reserve Account, which is set aside for unforeseen circumstances, has a balance of \$20,000 in the form of a GIC which matures in September 2023.

Income for the period as at October 15, 2021:

- 7<sup>th</sup> Tradition collected at the January 5<sup>th</sup> Area Committee Meeting \$170.00, at the Spring 2021 Assembly \$1,592.00, at the June 5<sup>th</sup> Area Committee Meeting \$130.00 and at the September 11 \$185.00, for a total of \$2,077.00
- Grapevine Seasonal Income totalled \$639.00 for bulk orders from 4 Districts. Further Income and the corresponding Grapevine Seasonal Expenses are yet to be processed.
- Group, District and Individual Contributions \$24,836.10

Total Income for the period is \$27,552.10.

Expenses for the period as at October 15, 2021:

- Committee expenses are \$761.47
- Area 83 Contribution to GSO \$5,000.00
- General Service Conference Assessment \$2,897.40 (\$2,200 US)
- Bank Service Charges \$47.45
- PayPal Fee \$7.15

Eastern Canadian Delegates Orientation \$114.97

Total Expenses for the period are \$8,828.44.

The opening bank balance at January 1, 2021 was \$41,596.93. Total income of \$27,552.10 less expenses of \$8,828.44 leaves a balance in the operating account of \$60,320.59. As of October 15, 2021, our expenses were \$18,723.66 less than our income. Thank you to the 83 Groups, 10 Districts and 1 Individual for your generous contributions to Area 83.

Page 2 (<u>Appendix A2</u>) shows details of the expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member as well as all other expenses to date.

Some of the numbers you see here:

- The amount shown for the Delegate (\$227.99) relates to postage for sending Area 83 pins to General Service Conference participants.
- The amount shown for the Alternate Delegate (\$282.54) relates to ZOOM account costs.
- The amount shown for the Treasurer (\$250.94) relates to postage, printing and stationery.
- A contribution to GSO from Area 83 of \$5,000 has been paid.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to attend the General Service Conference". The full assessment for our Delegate to attend the 2021 Virtual GSC was \$2,200.00 USD, or \$2,897.40 CDN, which has been paid in full.

To summarize, our financial position as at October 15, 2021 compared to October 2020 is as follows: Income for 2021 is \$1,708.04 more than the same period in 2020. Expenses to date for 2021 are \$14,557.74 less than the same period in 2020. The net change to the Operating Account is an increase of \$18,723.66.

The increase of contributions in 2021 versus 2020 is \$3,090.75.

Page 3 (<u>Appendix A3</u>) shows contributions by District. These amounts include contributions from Districts, as well as Groups.

We will be collecting a 7<sup>th</sup> Tradition throughout the Assembly weekend. Please e-transfer your contribution and reference Assembly in the memo field.

I will group the 7<sup>th</sup> Tradition contributions and report the total at the January Area Committee Meeting.

In the Spring 2020 an amount of \$1,288.25 was levied by the Ambassador Hotel as a cancellation charge for the cancelled Assembly. We will receive this amount as a credit in a future period when we are able to gather in person.

Without in person meetings for the rest of 2021, expenses will remain low. As contributions continue to be made to Area 83, it is possible to consider a further Contribution to the General Service Office for this year. There is a motion under New Business to make a further contribution to the General Service Office.

Thank you to those who attended the Secretary / Registrar workshop yesterday during the Service Information Day. I hope you found it informative.

When a District fills a service position, please continue to send me roster updates. This information is used in 12th step work only.

To have a kit or workbook provided to District Chairs (Accessibility, Archives, Cooperation with the Professional Community, Corrections, Grapevine, Public Information and Treatment) and District Committee Members, Fellowship Connection requires a mailing address, phone number and email address. I know that some members have been hesitant to share this information and I can assure you that, if provided, it is held in utmost confidence.

Also, Fellowship Connection has implemented a kit selection method (mail or email) and opt-out selection in response to requests from Area Registrars. District Change forms will be updated in the next few weeks. If you are waiting for a mailed kit, you can access digital copies by going to area83aa.org, and under the resources tab, select Secretary and you can familiarize yourself with the kit contents.

I want to thank everyone who has summitted their reports prior to today. The preferred format is Word so that I can simply pop your report into the minutes and do a bit of formatting. If you have not hit send yet, please forward your report at your earliest convenience. A quick reminder to submit your report with your position, first name and last initial to help me protect your anonymity. The Area Operating Procedures state that minutes should be circulated by the Secretary within 6 weeks after an Area Committee Meeting or Assembly. So far, I have been able to produce the minutes well under the target date. Thank you for helping me with the turn around time.

Also, I sent an email out to a few Districts yesterday afternoon regarding personal email addresses. Personal email addresses are one of the searchable fields for Fellowship Connection. Like your social insurance number or social security number, it is unique and it will follow you through your service record with the General Service Office. There's a few Districts that have position emails and that can be recorded as well, but it is your personal email address that is the most important. A request to the Districts that I sent the emails out to, please get that information back to me as soon as possible. Bill and I will work together and make sure that your information is input correctly and then you'll be able to have a history with the General Service Office, as opposed to just a two-year window.

# 8. Roll Call and REGISTRAR'S REPORT Bill C.

Good afternoon friends. I'm an alcoholic, a member of the West End Group in District 74 and my name is Bill. I have the honour and privilege to serve as your Panel 71 Registrar for Area 83, Eastern Ontario International.

Welcome to the Area 83 Fall 2021 Assembly. As Registrar, I have been entrusted with the responsibility for updating Area 83's 577 (and one pending) group records and serving as the liaison with the General Service Office for matters concerning registration and records.

Since our Spring Assembly in March, I have had the opportunity to participate in a North American Registrar's workshop organized by Craig W, Group Services Coordinator at the General Service Office, on the evening of 26 May 2021. At this workshop we reviewed how Fellowship Connection was working for the various Areas and provided suggestions to General Service Office staff based on our collective experience to date. This database keeps track of all our North American Members, Groups, Districts and Areas. This new system allows the Area Registrar to make real time updates to the Area database.

Since this meeting, a new version (3.0) has been released. There have been many enhancements, but the one that impacts us most directly is the ability to request that a physical General Service Representative kit be sent

- or not. If the choice is to receive a kit, it can be requested to be sent electronically or as a physical package to new GSR's. Many GSR's have been requesting that they do not need a physical kit. This is in-line with the overall digital trend at GSO. Electronic versions of the GSR kits are available immediately <u>Click to Access GSR</u> <u>Kit</u>

District Committee Members and the Delegate were sent invitations to be able to access Fellowship Connection. The access is for read-only. This means that the DCM's and the Delegate can see the current records as well as download reports. A training session for the DCM's was organized and held at the monthly DCM meeting in July.

Data stewardship is a vitally important aspect of any database and Fellowship Connection is no different. To ensure that Area 83 is as up to date and accurate as possible, the current listing of Groups and their DCM and A/DCM contacts for each District was sent to the respective Registrar (&/or Secretary) of the District in April. I would like to thank each District who has responded with updates. For those who are still working on their updates, please send them along when they are available. This is an ongoing process and another example of where the DCM access to the Fellow Connection can be used to ensure that the records in Area 83 are as current and accurate as possible. In December, I will send out to the District Registrars the current listing in Fellowship Connection so collectively we can update the Groups and representatives in the Groups.

Forms are available to notify the Registrar Group Change information or to add New Groups. These forms are available on our Area 83 website, under "Resources" then by choosing the "Registrar" tab. It is important that all information is filled out. Highlighting all changes make it so much easier for me. I ask that, if the District Registrar is not sending the form directly to me, that they are copied so that accurate District records can be maintained.

I would like to give a HUGE "Thank You" to the Virtual Registration Team and Ushers who were most generous with their time and assistance leading up to this weekend and for their cool and calm work this morning to get everyone registered. Thank you!

Before I give the roll call, I would like to give a brief explanation of the process of compiling the tally. When compiling the tally, consideration is given to the vote and ensuring that those who are entitled to vote, have that right. The result being that the numbers will often look different than what you may expect for your Group or District. The goal is to ensure that the maximum number of voices and votes are represented during the Assembly.

For example, a District might have five people signed in as visitors, but when I announce the roll call, I might say there was only one. The reason is that I check each visitor against their group, and if the group does not have a GSR that has signed in, I assume that the visitor will be voting on behalf of their group. They are, therefore, not counted as a visitor, but as a GSR.

Also, if an Alternate District Committee Member is the only person representing their group, I will count them as a GSR as well, since Alternate DCM's do not have voting rights, but Group Service Representatives do. Their role in the District may be that of Alternate DCM but their function, for the purposes of voting at the Assembly, is to serve as their group's representative.

In closing, I will make myself available to Districts and Groups to assist you with Registrar-related issues where I can, and please remember that communication is most important.



There was one item brought forward on behalf of an Inuit woman who has found recovery in AA. She is very grateful for her new life but would like to have the word "Eskimo" updated in the Big Book as she and many she represents find this offensive. We had a lively discussion about how to bring this forward to the GSC for discussion.

Lastly, the North/South event that was scheduled for December has now been moved to June 2022. Our Trustee at Large Canada reported that it was felt that this event should be more of a member/group driven event than a GSO event. These are our Concepts at work.

## **Zoom Account**

Our Area account is being used by many of our trusted servants: Remote Communities, Districts, Area Sub Committees, ad hoc committees and more. If at any time you would like more detailed information please fee free to contact me. This is and has been a great return on our investment to carry our message of hope.

come has arrived. Let us continue to inspire those around us with the joy of service. Thank you for the opportunity to serve.

### QUESTIONS FOLLOWING THE ALTERNATE DELEGATE'S REPORT:

QUESTION: Changing the wording in the Big Book – how does that happen?

ANSWER: If a group or a member or a District would like to make a change in the literature, it needs to be Conference approved. There's a form, which I don't know if you're at the plenary yesterday, I showed the form and went over the form and I'd be happy to send it to you or the person who's interested in making this change. They would need to fill out the form to indicate what is the recommended change with the motion that they discuss at a group, a District and area. Also, who has been in participation with the discussion and what group conscience levels have found to pass that motion, and any other material that they would like to submit and what they'd like the outcome to be what wording would they prefer to see and then that gets submitted to the conference coordinator at the General Service Office. And then at some point, it would probably get assigned to a conference committee and be an agenda item at a future conference.

QUESTION: I'm going to be honest, and I've heard this throughout this term. And frankly I don't really like it, but I'll share what the problem is. The DCM sharing sessions. I think you forgot to mention in your report that the DCM and the alternate DCM are only invited. It doesn't allow visitors to come in and see what's going on and learn and grow. So that, and I know it was a was a vote by the DCM, not to have visitors. That's a problem, because then it's only exclusive, and we're not exclusive. Only at the General Service conference. Let's just have it open for everybody.

QUESTION: Making reference to members of Alcoholics Anonymous as frontline workers, does not sit well with me. A frontline worker is a frontline workers and members of Alcoholics Anonymous, who serve in a service position, are trusted servants.

QUESTION: Are we able to use the Area zoom account for a meeting?

ANSWER: if your District, or if your District would like to use the area account you absolutely can. If you want to contact me offline, we can look at the schedule and see what's available.

QUESTION: Could you bring up my concern to the, DCMs for discussion and then report back?

ANSWER: If you'd like to do this, you can speak to your District committee member who can bring that to the group.

FOLLOWUP: I did, I did but nothing happens. I'd like you because you're the chairperson of that meeting. Could you bring it up under new business, and then report back in your report?

### Here's what I've been doing since the Spring Assembly:

The assembly was followed by Pre-Conference Agenda sharing (PCAS) sessions on March 30, 31, April 6th and 7th which I attended.

On April 9th our Conference Agenda Committee met virtually.

The 71st General Service Conference was held virtually from April 18 – 24th.

One final opportunity to hear the GSC report was arranged for June 19th.

With assistance from Amy, the Delegate's Exchange newsletter was published in early July and is available on our website. It included some additional details about the Conference advisory actions. The next edition should be out in early November.

The 71st GSC Final Report was emailed out on August 9th. I still have some hard copies. If you would like one, please email me at delegate@area83aa.org.

CERAASA stands for the Canadian Eastern Regional Alcoholics Anonymous Service Assembly which takes place every 2 years. In 2021, the 10 delegates and alternate delegates of Eastern Canada have been meeting every 2 months as a steering committee. In the last few months, the minutes and financials of CERAASA going back to the first one in 2013 have been gathered for archival purposes. Our next meeting is on November 22nd.

On September 11th, I attended our virtual Area Committee Meeting.

On September 13th, our Conference Agenda Committee met to receive an update from our committee chair following the July Quarterly meeting.

My name is Milner G. I'm an alcoholic, DCM 42 and I made this motion originally in the context of we had granted a voice and a vote to the Webmaster at the Area Assembly in the Spring Area Assembly. And because that's an appointed position I thought it would be fair to also give a voice to the Archivist. I have been archives chair and when I was archives chair, I learned a lot about archives, first of all, but I also, there was a lot I didn't know and I had to rely upon the archivist for answers so I put forward this motion. I think the benefit of it is that if we have questions about archival matters, the archivist and the Archives Chair don't have to do a quick dancing okay what about this, what about that. What do you want to say to this, what do you want to say to that? it goes straight to the expert that we have, and who we've put a lot of resources into helping get training, to be able to answer a question directly if requested by the Archives chair or the Area Chairperson. I believe that it would be a benefit to the assembly to have this motion pass.

#### Discussion

Marty M., CF Chair: Last term, I was the Area Archives Chair. And I can attest firsthand the frustration what was felt by the Archivist at the time because they're expected to be at the Assembly, yet they don't have a voice. Although the situation didn't come up while I was there, I could just imagine if that comes up, what Milner just described during the assembly and during the archives chairs report, and someone has a question regarding archival matters, whether it be digitizing material or any technical matters regarding archives that the Archives Chair is not really qualified to answer so I'd be speculating or it'd be like well I'll get back to you on that. Or you have to run over and ask the Archivist what the answer is. And then you can go back to the mic. We can just avoid that by letting the Archivist have a voice so I'm definitely in favor of that motion.

Shane H., Archives Chair: It isn't in Robert's Rules of Order that the chair, if they so choose can call on a non-voting member. It's not in the Operating Procedures yet but generally, it can be up to the Chairperson so I think that the motion is worded well. I think it's fair. I don't think it's overstepping any bounds or anything. There are questions the current Archives Chair will not be able to answer especially digitizing with technology. If you talk about archiving certain materials, I know how to do that with papers and not understand the acids and stuff but we talk about technology, there's a lot of technology in archives. I would not know what to do. I'd would ask, "Mr. Chairperson Madam Chairperson, can we please call upon the Archivist?" which would seem natural, so I think this is a natural course of things.

**Bruce M., D10 GSR Twelve Traditions Group:** This is something I was confused about last year when we were going over this with the Webmaster. The Archivist is an alcoholic who is volunteering to do that job. Am I correct?

Milner G., DCM D42: That is correct, yes.

**Eddy G., D22 Beaches Group**: My experience with this motion is when I was the area Archives Chair, an ad hoc committee was formed to review the positions of the Archivist, and the Archives Chairperson. And when there was a discussion, I asked the Area Committee meeting if the Archivist could participate in the discussion. And the table allowed. Having said that, I believe that this this emotion is very good because I don't have to. If I was the archives chair, I wouldn't have to ask the table, if, if the archivist could have a voice. So, with that, I'm going to ask the assembly if the Archivist could have a voice in this discussion.

James O'D., Acting Chair: That seems really appropriate so I will allow the Archivist to share. David T., Area Archivist: In the past, what has happened if there were questions being called up that I knew things that the current tables didn't know. They knew I'd have to sneak around to the Archives Chair and give them a note and say, ask these questions ask these questions. I have been around a long time now, over 50 years now and there are things that the current committee isn't aware of which may have happened in the past. And so sometimes it behooves me to say yes maybe you should consider such and such. There's many times when you go into the Archives, I've had questions from Delegates and such to look up certain information. So, it's only natural and we used to ask the committee to send forward all their emails from their closing of the committee chairs position and rarely did I get anything, but we get all the minutes for now digitizing the minutes so we're making things easier for research so we're not destroying documents. Most of the Archives Chairs when they take the job know very little about what the archivists do. Its only right that they be able to allow questions either from the Chair or the chairperson or whomever wish to say could you clarify something for us. I think that's the intent behind this particular motion.

**Christine F., DCM D18:** David just mentioned about having questions and having to pass notes, this motion that we're going for right now would give the Archivist voice to answer direct questions. Not a voice to come of their own volition, to the mic. If the Archivist had a question, they can't approach the mic but if we, if the committee had a question for the Archivist it could be asked of the Archivist. Correct?

**Milner G., DCM D42:** Yes, that is the motion as it is written.

A. Election for Area 83 nominee for Eastern Canada Regional Trustee...........James O'D, Acting Area Chair Under 4.03 Election of Trustee Nominee for the General Service Board, our Operating Procedures say:

### 4.03 ELECTION OF TRUSTEE NOMINEE FOR THE GENERAL SERVICE BOARD

- o The Election of the Trustee Nominee is by the Area Assembly.
- o Those voting are those eligible to vote at this meeting of the Assembly.

That means: If a District Committee Member is absent from this meeting of the Assembly, the Alternate District Committee Member may vote. If a General Service Representative is absent from this meeting of the Assembly, the alternate General Service Representative may vote. If both the GSR and Alternate GSR are absent, another member of the same group may vote.

- There is one vote per group, including the General Service Representatives of recognized Correctional Facilities groups.
- Nominations of candidates shall be from the floor.
- Nominations may be made by any member <u>eligible to vote</u> at the Assembly.
- If a candidate is not present, permission must have been granted by the candidate in writing for the name to stand.
- o If a candidate is not present a written resume shall be provided and read by the nominator.
- o If there is only one candidate, that person is automatically elected by acclamation.
- Candidates shall be requested to say a few words.
- Third Legacy procedure shall be used.

I have asked a good friend of Area 83, Percy G., Panel 62 Delegate from Area 86 to assist with the Third Legacy tally sheet. Thank you Percy for Helping us out. Just a quick review of how the 3<sup>rd</sup> Legacy voting is carried out. From our service manual, page S22.

- The first candidate to receive two-thirds of the total vote is elected.
- Withdrawals start after the second ballot. If any candidate has less than one-fifth of the total vote, his or her name is automatically withdrawn except that the top two candidates must remain. (In case of ties for second place, the top candidate and all tied runners-up remain as candidates.)
- After the third ballot, candidates with less than one-third of the total vote will be withdrawn automatically, except the two top candidates remain. (In case there are ties for second place, the top candidate and all tied runners-up remain as candidates.)
- After the fourth ballot, if no candidate has two-thirds of the total vote, the candidate with the smallest total is automatically withdrawn, except that the top two candidates remain. In case there are ties for second place, the top candidate and all tied second place candidates remain. At this point, the chairperson asks for a motion, second, and a simple majority of hands on conducting a fifth and final ballot. If this motion is defeated, balloting is over and the choice is made by lot "going to the hat" –immediately. If the motion carries, a fifth and final ballot is conducted.

- If after the fifth ballot no election occurs, the chairperson announces that the choice will be made by lot (from the hat). At this point, the top two candidates remain. In case there are ties for first place, all tied first place candidates remain. In case there are no ties for first place, the top candidate and any tied second-place candidates remain.
- Lots are then drawn by the teller, and the first one "out of the hat" is Area 83's Nominee for Regional Trustee.

The Chair called for any nominations from the floor?

Rob M, Joyce S and Robb W. were nominated by voting members from the Assembly floor.

On behalf of lan C., District Committee Member for District 26, we both thank our current Treasurer, Dave L. for the opportunity to participate and requesting that I present the final report. The three of us felt confident enough to meet in person since we have all been double vaccinated. We did social distance as much as possible under the circumstances.

The committee was very pleased with the impeccable filing system of the previous Treasurer, JoAnn P., who fulfilled her commitment to the fullest.

The object of the review was to satisfy ourselves and to be accountable to Area 83 members that the revenue and expenses were property recorded and balanced. Also, that there were no major discrepancies in the practices that were in place.

Specifically, the Audit Committee focused on the financial documents covering the period January 1, 2019 to December 31, 2019 and for the first two months in 2020. The reasoning was due to the lack of in person services beginning March, 2020 because of COVID 19 restrictions.

This was done in order to evaluate:

- 1) Completeness and accuracy of the recorded transactions.
- 2) Completeness and accuracy of the reporting.
- 3) That all recommendations from previous audit Review Committees were implemented.

Each committee member reviewed for 2019, an entire month's transactions to reflect various types of situations such as: a month with an assembly, a month with an Area Committee meeting and the last month at random. During this process; large transactions like General Service Office Assessments, Ontario Delegates Committee Meeting expenses, Ambassador Hotel bills, and Grapevine seasonal's were reviewed.

Bank reconciliations were reviewed, with income transactions traced back to bank deposits and to group and District contribution files. Expenses in random months were reviewed and traced back to the cheque register.

The expenses for the following Trusted Servants were reviewed for accuracy, reasonability and completeness: Archivist, Archives, Public Information, Cooperation with the Professional Community, Treatment/Accessibility, Grapevine, Self-Support, Corrections, Treasurer, Secretary, Chair, Alternate Delegate, Delegate and Immediate Past Delegate.

This sample covered the widest array of expenses. To the best of the Audit Committee's ability, all records which were reviewed were found to be in order, with no discrepancies noted.

The Audit Committee was unanimous in not making any recommendations.

CERAASA is held the last weekend of February every two (2) years, on a rotating basis among the ten (10) areas in the Eastern Canada region. The purpose of this regional service assembly is to develop greater unity among the members, groups and areas of the Eastern Canada Region and to encourage the exchange of ideas and experiences. The overall content of the weekend agenda includes panel meetings, open microphone sharing sessions, service presentations and speakers. CERAASA also provides an opportunity for all A.A. members to discuss related issues and concerns affecting A.A., as a whole, as well as some General Service Conference agenda items.

Throughout 2019 and 2020, the 10 delegates and alternates, along with our ECRT met bi-monthly as an ad-hoc committee to review the CERAASA guidelines. Once that was concluded, we continued to meet in 2021 as a steering committee for CERAASA and to receive updates from our Regional Trustee. These meetings have been bilingual. We have a member translating for which we are grateful, but it is very cumbersome since everything is being said twice. One in English and once in French. Therefore, discussions take double the time. We would like to arrange interpretation for these meetings. The interpretation would be simultaneous.

The General Service Conference, World Service Meeting and the Virtual Regional Forums used a company from Quebec. The interpreters are French Canadians and familiar with our AA terminology. The Conference members were very happy with their interpreting. We would like to use these same interpreters.

For simultaneous interpretation on Zoom, there are two requirements:

- 1) You need to purchase an add on feature in zoom that allows multiple channels one for each language.

  This feature can be added on a month-by-month basis to an already existing Pro Account.
- 2) You need a professional to do the interpreting.

The cost to meet these 2 requirements split evenly between the 10 areas is currently \$186.43 per Area for one year. This would provide interpretation for 6 CERAASA steering committee meetings and four meetings where our ECRT can provide the delegates and alternates with quarterly updates.

As you may know, the costs for Zoom does increase once in a while which is why the amount was rounded up to \$200.

 Recommended by the Area Committee that "Area 83 pay up to \$200.00 for interpretation at Eastern Canada Regional meetings for one year."

Area 83 is in very solid financial shape. A contribution of \$5,000 was sent to the General Service Office in April following the approval of the proposed spending guidelines at the Spring Assembly.

In 2020, the General Service board approved 4 withdrawals from the reserve account totalling \$4 million dollars which were transferred into their operating account. The target of the level for the general Service Office for the reserve fund and established by the General Service board, and the General Service Conference was to have 9 to 12 months worth of expenses covered with the transfer about \$4 million.

At the end of December 2020, the funds in the reserve equaled 7.9 months worth of expenses. In August of 2021 at the board weekend, the General Service Board did approve a transfer of \$250,000 back to the reserve fund which brought the reserve fund up to 8.4 months worth of expenses. They still remain in need of further funds to replenish the reserve fund.

Contributions have continued to flow into Area 83 this year at a pace a little above last year. When I made this motion at the September Area Committee Meeting, I worded it to say up to \$20,000 at that date I indicated, I would have been comfortable. On September 11<sup>th</sup> I would have been comfortable recommending \$14,000 being sent to the General Service Office, but contributions that have continued to flow in. Today I would be comfortable recommending \$20,000 be sent as a contribution. The motion as it stands covers up to \$20,000.

This is in addition to the \$5000 that was already sent. Mark P., GSR D62 Stittsville Second Chance Group: How does that track against our yearly contributions? Is this a portion of a yearly contribution, and if so, how does that track against the previous years contributions? Dave L., Treasurer: We've already contributed \$5000 so this would be an additional \$20,000. We have never historically come anywhere close to these amounts but this year, we've had contributions flowing in at the same rate as last year, but expenses are very limited, so we do have a very large surplus. Even after making this contribution, we'd have even today approximately \$40,000 in our operating account plus another \$20,000 in our reserve account. We are in very strong financial position. And last year, from the fall assembly to the end of the year and additional \$6,000 in contributions were made and I have no reason to doubt that that wouldn't be similar this year. Recommended by the Area Committee "That Area 83 make a contribution of \$20,000 to the General Restate Service Office." the Motion Point of George W., DCM D22: This is not a recommendation of the Area Committee, this is a recommendation of the Area Assembly. The recommendation, hence, the wording, and now a decision by the Assembly is Order to make it a specific amount, the full \$20,000. James O'D., Acting Area Chair: So, hearing what you just said we could change this to the amended recommendation by the Area Committee. Would that suffice? George W., DCM D22: I suppose so. F. Report from the Pre-Conference Agenda Sharing (PCAS) ad hoc Committee......Rob M., Immediate Past Delegate

Hi everyone. I'm an alcoholic, a member of the Motorcity Group in District 28, and my name is Rob M. It's an honour to serve as Immediate past Delegate for Area 83 Eastern Ontario International.

In 2020 and again this year Area 83 facilitated a series of Pre-conference agenda sharing sessions. These sessions were designed to provide our Delegate with the viewpoints and experiences of Area 83 on agenda items for the General

Service Conference. They also provided members throughout Area 83 an opportunity to participate in AA as a whole and have their say in how their fellowship moves forward.

The first year of its rollout, the viewpoints gathered were considerably more than previous efforts. In 2020 much work went into training Area 83 members how to use the online meeting software. The committee developed scripts and templates to ensure smooth presentations to the membership and that presenters had a good understanding of the topics for which they were responsible.

In its second year, it was hoped that Area 83 members would be more receptive to the online format which may have precluded some from participating in 2020. Overall attendance increased almost 80% from the previous year. The increase in attendance still represents a small fraction of the total membership in Area 83.

Presenters for the 2021 PCAS sessions met on May 2, 2021 and reviewed the results of the PCAS survey and shared what they thought were successes and areas for improvement. The consensus of the meeting was that the sharing sessions represent a good vehicle for discussions, but the engagement and general awareness of the Conference process could be better cultivated among the membership.

On May 6, 2021, our Area Chairperson Amy L asked me to chair an Ad Hoc Committee for Pre-conference Agenda sharing 2022. Our committee Secretary is Bill C, Area 83 Registrar. Also serving on this committee is Kathie T, DCM District 28, Jonathan CJ, DCM District 36, Joyce S Area 83 Panel 65 Delegate, Jo D Area 83 CPC Chair, JoAnn P Area 83 Secretary, and James O, Area 83 Alternate Delegate.

### The function of this ad hoc committee is to consider:


- 1. Solutions to the deficiencies identified in the meeting on May 2
- 2. A communication and engagement strategy that would encourage members to follow the Conference process and participate in the dialogue on matters under consideration at the General Service Conference.
- 3. A reoccurring model of this organizing committee alleviating the need to strike ad hoc committees on an annual basis.
- 4. Roll out of the Preconference Agenda Sharing session in advance of the 72nd General Service Conference (April 24-30, 2022).

### The procedure is:

- 1. To meet as a committee with enough frequency to carry out the scope of the committee's work.
- 2. To identify ways to improve the level of awareness and participation in the Pre-Conference Sharing sessions.
- 3. The chair of this ad hoc committee will provide a progress report to the Area Committee at the September ACM including any recommendations that may alter the Area 83's Operating procedures.

Our committee has met eight times via zoom and made much progress. We have several meetings scheduled in the coming months, will be prepared to roll out the 2022 sessions in early January, and hope to have a final report at our January Area Committee meeting.

In February 2021, CERAASA was cancelled and instead there was a virtual Eastern Canada Delegate's Orientation (ECDO). The event was modelled after our Ontario Delegates Committee (ODC). Quebec has the QDC, an event similar to our ODC, however Area 81, New Brunswick and Prince Edward Island, and Area 82, Nova Scotia, Newfoundland and Labrador, do not currently have this form of orientation for their delegates/alternates.

Following the success of ECDO, and other discussions about regional unity, a Quebec Delegate put forward the idea of a virtual Eastern Canada Delegate's Orientation to be held on the even years. After further discussions the following motion is being presented to the 10 Areas of Eastern Canada.

"A Virtual Delegates Orientation for Eastern Canada be held on the opposite years to CERAASA/ASTECAA commencing in 2024. The expense of translation would be divided between the 10 Areas."

On September 14<sup>th</sup>, the past delegates of the 4 Ontario Areas met to discuss this motion.

What I took from that meeting seemed to touch on 5 key points:

- 1) The downside shared by all is that we will miss the social aspect, the face to face connections, one on one conversations as well as all the other experiences an in person event offers.
- 2) All of the past delegates agreed that the orientation provided by the ODC over the years was invaluable. With the technology now available, most of them felt that a reasonable progression would be to make this experience available to all 10 delegates.
- 3) Many of them shared that having attended the Conference and observing how close many other regional delegates were, it would be wonderful for our 10 areas to continue to build relationships and come together as a region whenever possible.
- 4) Inclusion of Area 81 and 82 is very important and beneficial to us and them.
- 5) Financial considerations
  - o In 2020 we hosted the ODC which cost around \$5600. It would be cost effective for all areas to attend virtually rather than in person.
  - o In person events are especially difficult financially for northern Ontario and the East coast areas.
  - With respect to translation, the set up, quality and cost is much better over zoom.
- Motion: A Virtual Delegates' Orientation for Eastern Canada be held on the opposite years to
   CERAASA/ASTECAA commencing in 2024. The expense of translation would be divided between the 10 Areas.

Does that include the transportation costs of northern communities or is that a separate item in there |

So that was for Area 83 to host the event so renting the facility, as well as reimbursing the Delegate, the past delegate and the alternate delegate to attend the event, as well as the organizers of the event and Eastern Canada Regional Trustee so those are the costs just for Area 83. That was our portion of that event.  Rob M., Immediate Past Delegate: Just a little clarification. The four areas of Ontario take turns hosting the Ontario Delegates' Committee, and it's only held every two years so Area 83 actually would only host every eight years. We hosted in 2020 and the costs were that \$5000 and something dollars that Kimberley mentioned. But in years that we don't host, the expense would be a lot less. It would just be the travel  |

and hotel for the Delegate and Alternate Delegate to attend. But expenses aside, I think in Area 83 that we've always been able to afford the Ontario Delegates' Committee. And I don't believe that a decision has been made yet on whether that would continue to happen or not. But regardless of that I'm still in favour of Eastern Canada Delegates' Orientation because it's a great vehicle to bring all 10 areas of Eastern Canada together. In the last few years, the Eastern Canada Region has become much more united than it used to be. Not that there was lack of unity in the past, but we just didn't do a whole lot as a region. But we've really started to do more as a region and the Delegates and Alternate Delegates have attended various online events together that has helped to promote unity in the Eastern Canada region. And this year I was at, the first virtual delegates orientation that we had and I think it was a really good event to prepare all 10 Delegates from Eastern Canada region to attend the General Service Conference with sort of a united Eastern Canada, front, if you will. 

### Q1.

This question is for CPC – Could we consider issuing a new piece of literature based on Appendix III, the medical view on A.A. My thought is that Appendix III would remain unchanged, but we could trace back the history and get professionals and others to and even include the cost of untreated alcoholism, or the Doctor's opinion, or on all three?

A – Jo D. – Wow, well if you recall what Kimberley was saying earlier today, on how to take an agenda item to the General Service Conference, maybe a good start would be to have a conversation at one of our CPC Area –District Chairs meeting. The next one is coming up in November...I'm thinking that's the first step. I'd really like to see that written out, the whole thing, Trevor, maybe you could send that to me? Maybe we want to go through the process of pushing that through as an agenda item, so come to the next CPC Area 83 - District CPC Chairs meeting in November. That's my answer for now.

### Q2.

This question is for Safety and Safely in A.A. - I wanted to ask about bullying, because it's been a topic of conversation at a few meetings I've been attending. For example, crosstalk at a meeting, speaking while someone else is speaking, being critical of someone, or speaking about someone else's share, or saying why someone else is wrong. I'm told some groups encourage crosstalk, and I'm not sure what to think about that. Is it bullying, if one person comments on another person's share in a zoom room, and that person is still there?

A - Kim S. - I would consider that bullying, yes, if people are commenting about a share. I wouldn't say it's "hard core bullying", but anything like that, while the person is in the room, it goes beyond gossip. Some groups have a thing that doesn't allow anyone else to say anything about another person's share, so your group could talk about that. I know if someone spoke to me about my share, it would make me feel really small, and I don't like to feel small.

### Q2a

Peter G. Is it OK to talk one-on-one with someone? Is that offensive?

A – It's not offensive, I would rather someone spoke with me one-on-one if I mis-spoke or said something they didn't agree with. I wouldn't like it if they said it in front of everyone else.

### Q3.

Roland - How often do you have business meetings?

A - Trevor – I don't have anyone particular to answer this, but my group meets once a month for its business meeting, and if a group conscious is needed, we'll ask people to stick around after the meeting to discuss.

Gail - "The AA Group" pamphlet suggests regular business meetings and is really helpful.

David T. - Business meetings need to be regular — my group meets monthly, but my wife's group meets regularly every 6 months. If they need a decision, they poll the group and they have a special meeting after the meeting... so, it depends on the group, and how often issues come up. Roland, you could talk to your DCM, or Delegate, and ask them what their experience is. I know some groups have trouble in this area, but we need to encourage them to have regular business meetings. Thanks, all.

Mike B. - Business meetings: If we have a GSR who attends monthly District meetings, they have a lot of information to bring back. That's the two-way communication between the Group, the District, the Area, and the General Service Office. You may also have an Intergroup office, and an Intergroup rep, who attends monthly Intergroup meetings. So, there's always information being passed back and forth. And it's not just decisions at your group that need to be discussed; it's also the transmission of the two-way communication between your home group all the way down the ladder to the General Service Office. I would add that "The AA Group" pamphlet is the group bible for my home group.

Karen - as far as crosstalk, we have written, right in our preamble, that there is no crosstalk in the meeting, our chairperson will enforce it (should it happen). We'll bring out the group safety policy or ask the person's sponsor to help out. We have on-the-spot sponsors, too, that can help them work through it if someone feels unsafe. As far as business meetings go, we have a regular monthly group and District meeting, and as a GSR, it's my responsibility to attend these and bring the information back to my group so that they can make informed decisions.

Mel C. - We have a few members around still, that call these business meetings "Responsibility Meetings", that's another term for it. The A.A. group has a lot of different jobs, too, other than just the 12 Steps for the alcoholic... there's the 12 Traditions for the group, they have obligations to different service arms, providing a meeting space, and so on. What I'm getting at, is, if you're not having a business meeting, it's very possible that there are other things that need looking at, and maybe what you need is a Group Inventory. You usually get somebody that's outside your group to facilitate it, and very often they use the 13 questions in The AA Group pamphlet. If it's run right, you'll get a good sense of what needs to be done in your group, and where you might have to pull up your socks.
