Who votes?

All Area Officers, including the immediate past Delegate, but not the Area Chair. All Area subcommittee chairs and the Area Webmaster. All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote on behalf of their District. There is one vote per person.

How do we vote?

Procedure:

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority. I believe that the first part of the agenda today can be handled under simple majority. The items under old and new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

At times, I may ask for a show of hands to get a 'sense of the meeting'. This is NOT a VOTE, and those with a vote may indicate they are in favour or against by either raising their hand in-person or online.

DISCUSSION/RAISING HAND:

If you would like to address the committee (as though you were approaching the mic) to make a motion, second a motion, those **in person**, please approach the phone on the floor and wait until you have been recognized.

For those of you **online**, please raise your virtual hand using the RAISE HAND FUNCTION and wait until I have recognized you before unmuting.

When you have been recognized by the chair, please identify yourself by <u>Name</u>, <u>Service Position</u> and District.

Reminder: IF YOUR IDEA OR COMMENT HAS ALREADY BEEN PRESENTED PLEASE LOWER YOUR HAND. Your humility and cooperation in this regard is appreciated.

Minority Opinion:

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the *original* motion.

Calling the Question:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early — many goods points and opinions will come out in discussions, and if discussion is prematurely cut off, we will not get to hear them.

Who may address the committee meeting?

It has been the *practice* at the Area committee to use the same *principle* as we do at the Assemblies: only voting members of the Committee have a voice. This is important for two reasons:

- It keeps the focus on the fact that this Committee is in effect the steering committee of the Assembly members are representing their District's positions or the Area's in the case of our Officers, rather than their own.
- It also maximizes the time available for members to voice the opinions and needs of their District. All who are attending may say their piece during sharing time.

I respectfully ask for your cooperation with this. If you do not have a vote, as I mentioned, please keep your input for sharing time which will take place under Agenda Item 14. At that time, all in attendance are welcome to participate and their opinions will be heard.

District 22 Scarborough

Currently, District 22 has 23 groups on its roster. Of these groups, one is a seasonal group started in the first summer of the pandemic; the Sunday Scarborough Group is listed as inactive; the Bellamy group is struggling but continues an online meeting; the Wanstead group has officially folded; one former service meeting, the Saturday Main Street is now an unofficial group, not yet registered as such; there is one on-line group that has listed itself in our district, Full Catastrophe Sobriety. The Rouge Valley Group, at the Rouge Valley Centenary Hospital, is now holding meetings again. This hospital is the only one in Scarborough with a mental health facility. There are a number of active service meetings, mostly daytime, in our district.

In terms of representation at the district table, there has been a fairly regular representation of 8 to 12 groups. There are GSRs, but few groups have alternates, a few have only a contact person. Several groups have not been at the district table in some time. Those who do attend are enthusiastic and actively participate in district meetings and affairs. I was pleased to see the representation of our district at the Fall Assembly.

In spring this year, Bert J (Silverbirch) was elected incoming DCM. We are pleased that Joe A (One Paragraph at a time) was elected as alternate DCM. Both are strong Three Legacy members of AA. The positions of secretary and treasurer for the coming term remain vacant. Thanks to Robb M (Immediate Past Delegate) for chairing the election. We will be having elections for sub-committee chairs at this November's meeting.

The district meets virtually on the second Sunday of each month at 1pm. Our meeting typically run 2.5 hours. While there have been discussion of meeting in-person/ hybrid, no consensus amongst the current GSRs exists to move forward on this. Agreement exists that in the event the meeting ought to be a hybrid format for reasons of accessibility and convenience; some express the view that business is conducted efficiently on-line, and at much less cost. Still, the low turnout and difficulty of filling and keeping service positions filled might suggest otherwise.

The district has approved a new set of operating procedures and guidelines. Some revisions have already been put forward, but the new document is much clearer. Thanks to the ad-hoc committee of past DCMs for their diligent work.

The district held its first in-person Service Day in two years. Many thanks to all those who pitched in, presented, and showed up. Thanks to Kimberly M., our Area 83 delegate for her talk. The potluck lunch, tradition skit performance, and evening social added colour to the event.

The past two years have been a challenge to keep on top of group meeting status, group representation, and sub- committee representation at the GTA district committee meetings. The district has managed to maintain a flow of information and connection between the groups, and between groups and the larger General Service structure. Our District22 Newsie is a two-page newsletter of district and general service announcements which has been helpful in this regard. Thanks to Darlene D (GSR 12 Steps) for taking this on.

The heartbeat of AA is the home group, and as Bert and I travel around the district we experience and fell that beat. It will only be by patient attention and constant nurturing of this that the 12th Step of recovery can blossom. Thanks to all those who filled a service position and represented their group this term.

C. Correctional Facilities......Marty M.

Hello everyone, I am a grateful alcoholic my name is Marty. I'm privileged to serve as your area 83 panel 71 Corrections chair.

Again, I reached out to our district Corrections chairs for a final update for the year and here's what's going on around area 83 Corrections.

District 42 St. Lawrence International: Nothing much has changed in district 42. We have the county Jail cover with one volunteer doing the women once a week and one volunteer doing the men once every two weeks. The men's volunteer is considering changing to weekly.

For the State Prisons we have one volunteer going into Ogdensburg once a month and no one going into the Gouverneur Prison. There was talk of some one from Jefferson County going into Gouverneur, but that never happened.

Districts 54 & 62 Ottawa: We have been able to a bring a few meetings to the Ottawa-Carleton Detention Centre (OCDC) which is located in Ottawa (District 54 & 62).

OCDC has changed their volunteer screening process and it has been a very slow process. Myself and another female member have been cleared to go once a month on the women's side of the institution since June. Sometimes we cannot go in due to lack of staff and sometimes the meeting is cut short due to routines such as role call or other things but when we do get to sit down together the women express gratitude for our visits.

We have been able to bring in some literature which is well received as other than the monthly visit there is no other contact with AA. This is something we have been announcing regularly and our districts have been donating old GV magazines and other soft cover literature. OCDC does not allow hard cover books, so if we do get those we have been donating them to the Ottawa Withdrawal Management Centre (OWMC aka Detox)

OCDC just completed another orientation (which is part of the screening process) with some male members and they hope to have them set up soon to visit the male side and bring AA meetings to that side of the institution.

We have also received a few BTG requests from OCDC which is great to know that the staff at OCDC are trying to help the inside members step out of the institution and into AA when they re-enter into the community.

District 36 Kingston: Activities inside walls has slowed down due to partial medical lockdowns in District 36 Corrections. Here are the latest updates:

The CSC Volunteer program clearance is centralized at Federal level and those that have taken the new online course are able to be cleared for both institutions. New applications will be progressed this way as previously each institution had its own process. Lists and renewals for approvals are being reviewed for current status.

- 1. Inside Walls AA meetings have been progressing well through the month of November in both CBI (Medium/ Minimum) and JI (Minimum) but a recent medical lockdown is now impacting meetings and attendee numbers with the last Tuesday 13.00 hours medium down to 3 members due to medical constraints.
- 2. CBI Saturday morning meetings are on hold as unattended by several weeks in a row. A suggestion was made by a CBI staff member to hold meetings later in afternoon and this is in review by volunteers to see if possible.

- 3. Collins Bay Scott Pringle (CBI Min) has been approached for an update ETA's and only one person is cleared for ETA. There are several others in progress but the process to get inmates cleared is lengthy.
- 4. CBI Min Sunday night meeting still well attended led by AA volunteers. Numbers starting to be impacted by medical lockdowns.
- 5. Some clearances have lapsed and the list is currently in review. There are no meetings allowed at the assessment unit. Trisha and Ashley Kipper JI run the Joyceville Minimum social programs.
- 6. Thursday Joyceville is currently being impacted by a medical lockdown and will not proceed December 1st and will be reviewed if for the following week.
- 7. Area 83 Corrections Chair will be updated following this meeting. District 36 was thanked for all for great service and updates.
- 8. AA area assembly was held in October and well attended by D36 members. The corrections portion was well managed attended and coordinated with a strong message. Well done all who participated.
- 9. Literature is available in good quantities and your chair will meet with any members that have needs for big book, 12&12 and chips etc. Some materials have been distributed.
- 10. New volunteer application and access forms are available. Please contact corrections chair Trevor O. and will forward as needed.

Groups Reps. Please announce at next meeting please. Corrections urgently needs your help please! Night Driving is becoming a challenge. We are down to one person. If you are able to announce at your meetings that we are looking for drivers to assist with ETAs this would be appreciated. Please contact Trevor O. corrections chair' If any of your members feel comfortable driving inmates to meetings, we could definitely use more volunteers for ETA's. (ESCORTED TEMPORARY ABSENCES)

So grateful and he has had a huge kick start to his sluggish recovery after moving to our area. Service is the answer to so much for so many! My new female Sharyn B. and I went in for her first time to Napanee and she was surprisingly confident and the women accepted her right away. We tried to go back the last two weeks however they have had a Covid outbreak. The chips we ordered for Millhaven were vetoed by the guards so Les is looking for plastic ones. District 22 Scarborough: Still no face-to-face meetings at Toronto East Detention Centre. They are stocked with Softcover Big Books Grapevines and pamphlets.

The Web pages are up, running and healthy. Please take the time to explore them.



As Registrar, I have been entrusted with the responsibility for maintaining and updating Area 83's 600 Group records (582 Regular Groups and 18 Virtual Groups) and serving as the liaison with the General Service Office for matters concerning Group registration and Group records.

The Fellowship Connection is used for all the 93 Areas Canada and the United States of America. The database keeps track of all our Service Members, Groups, Districts and Areas and allows the Area Registrar to make real time updates to the Area database.

The pace of Group and District changes has picked-up considerably in the last few weeks as the Groups and Districts complete their elections. Please continue to send the changes to me so the database can be as current as possible for the Panel 73 Registrar and Secretary. In terms of other things going on, the 93 Area Registrars will have a meeting on 18 December 2022.

I would like to personally thank all the District Registrars, Secretaries and District Committee Members for your support over the past 2 years. As well, there is a whole team who helped with the Area Assembly registrations and need to be acknowledged for their Service. It has been an amazing growth opportunity for all of us.

Hello friends, I am an alcoholic, a member of Liverpool Group in District 26, and my name is Dave L. It has been both an honour and a privilege to serve as your Panel 71 Area 83 Treasurer.

I am grateful that Area 83 Eastern Ontario International has navigated through the pandemic and continues to serve the still suffering alcoholic. My tasks as Treasurer were slower than normal. Most Groups pivoted to meeting on video conferencing applications. Many groups started e-Transfer for their home Group.

Contributions to Area 83 dropped off dramatically in 2020, showed some increase in 2021 and have strengthened significantly in 2022. Obviously, expenses also dramatically reduced with little in person Area activities. These combined factors allowed Area 83 to send Contributions to the General Service Office of \$40,000 over the last 2 years.

There have been 63 contributions via e-Transfer so far in 2022. This method of contributing to Area 83 is proving to be uncomplicated for the Groups. Please consider this payment method when your Group or District discusses contributing to Area 83. As with all contributions, please reference your Group and/or District Name and Service Number in the memo field. Individual contributions to a maximum of \$1000.00 per year will also be accepted.

Let's discuss the Financial Statements for the period ending November 25, 2022.

Page 1 is a financial summary. It shows our Reserve Account, which is set aside for unforeseen circumstances, has a balance of \$20,000 in the form of a GIC which matures in September 2023.

Income for the period as at November 25, 2022:

- 7th Tradition collected to date is \$2709.55, including \$795.00 at the Fall Assembly
- Flow Through Contributions to GSO were \$475.00
- Grapevine Seasonal Revenues were \$1,199.25
- Group, District and Individual Contributions \$43,848.95, which significantly exceeds the total year Guideline amount of \$30,339.60

Total Income for the period is \$48,232.75

Expenses for the period as at November 25, 2022:

- Committee expenses are \$3,002.72
- Area Contributions to GSO were \$15,100, including an in Memorium contribution of \$100 for Bruce
 B, DCM District 86
- Area Committee Meeting costs of \$951.55
- General Service Conference Assessment \$10,445.60 (\$8,000 US)
- Bank Service Charges \$56.20
- Paypal Fees \$25.08
- Regional Forums costs of \$2,183.78 for our Delegate and Alternate Delegate to attend
- Grapevine Seasonal expenses were \$941.93
- Flow Through Contributions to GSO were \$475.00
- Ontario Delegates' Committee \$1,093.69
- CERAASA / Eastern Canadian Delegates Orientation \$301.82

Total Expenses for the period are \$34,577.37

The opening bank balance at January 1, 2022 was \$46,492.09. Total income of \$48,232.75 less expenses of \$34,577.37 leaves a balance in the operating account of \$60,147.47. As of November 25, our expenses were \$13,655.38 less than income. Thank you to the 110 Groups, 14 Districts and 2 Individual for your generous contributions to Area 83.

Page 2 shows details of the expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member as well as all other expenses to date.

Some of the numbers you see here:

- Travel expenses of \$2,367.00 for several committee members includes travel expenses to the June
 & September Area Committee Meeting
- The amount shown for the Delegate include \$296.48 for costs relating to presenting the General Service Conference recap.
- The amount shown for the Chairperson as Miscellaneous of \$208.00 relates ZOOM account costs for larger attendees for PCAS, Spring and Fall Assemblies. The budget for the ZOOM account is now with the Chairperson, rather then the Alternate Delegate.
- The amount shown for Treasurer, includes \$229.79, relating to postage, and printing
- The amount shown for the Corrections Facilities (\$67.12) relates to postage got Grapevine magazines to Institutions.

• The amount shown for the Grapevine (\$99.93) relates to postage for Grapevine Calendars and Pocket Planner orders for 2021.

Regarding the General Service Conference (GSC) Assessment, at the Spring Assembly in 2007, a motion passed stating that "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to attend the General Service Conference". The full assessment for our Delegate to attend the 2022 In Person GSC was \$8,000.00 USD, or \$10,445.60 CDN, which has been paid in full.

Since there is an additional or bonus ACM in 2022, I do not have a corresponding period to compare our financial position. A year end comparison will be reported at the ACM in January 2023 by our Panel 73 Treasurer, Jack R.

Page 3 shows contributions by District. These amounts include contributions from Districts, as well as Groups.

Please rest assured that Area 83 Eastern Ontario International is financially stable and ready to withstand any challenges as they appear.

9. SECRETARY'S REPORT James O'D. (Interim)

This is a very busy time for the Area secretary as so much happens in just a few short months. Minutes have just gone out from our recent Assembly, prepping for the this ACM (printing, emailing, reports, etc.). It has been a pleasure to serve for my third and final time in this position. Twenty printed agendas have been made available to guests or those unable to access their digital copy. These are located to my right amongst the paper Conference reports available in English, Francais & Espagnol — I know our Delegate would appreciate it if she went home with a lighter vehicle. If you would like a digital agenda please give me your email and when I sit down a copy can be sent to you.

Thank you to those who have already sent me your reports and also to those who are doing it right now as I'm speaking. It is very much appreciated when reports come in early or very soon after so that no one has to be hunted down for their report. You just gave it so why not send it in?

New District Panel 73 slates are slowly coming in with approximately 4 Districts having sent them — and already one update. By now most Districts have had their elections for the new term so when you get back home please lovingly encourage the District member responsible for sending it in to do so as soon as possible.

Jill & I have been in contact since the Assembly to run over a few things that this position entails. We will now be diving in to a smooth transition for January 1st. With your help we will have the data ready to enter to complete the new Panel 73 Area 83 roster. My trunk was full when I got here and it will be empty when I leave. DCM Sharing Sessions

They have both been part of this experimental journey of inter District sharing from the very beginning and will be prepared to chair the meetings, prepare and distribute the monthly agenda and review and distribution of minutes. These minutes are available from your DCM if you would like to know more about what discussions and presentations are taking place.

At our session coming up this week our incoming Panel 73 Alternate Delegate, Amy, will be discussing monthly GSR workshops that could be offered by the Area. This is a major movement forward in closing the gaps in communication that were identified in the Communications Audit Report. Looking forward to seeing how we can reach out to and support the top of our service structure.

Remote Communities

The Inter Area Remote Communities Work Group will be hosting an amazing RC Forum on Saturday December 17th. I am attaching the posters in English, Spanish, and French.

Panel 73 – Agenda Items

Our very own Joyce S – Eastern Canada Regional Trustee – compiled a very detailed summary of the Trustee Board Meeting that took place in October. It is the Trustees that continue to carry out the wishes of the fellowship throughout the year that were expressed through the group conscience of the whole fellowship via the Conference. The report was sent out to all Area committee members on November 12th. We are the chosen few who have regular access to our ECRT. The following are a few items I wanted to share with you to whet your whistle on some of the exciting agenda items that were discussed.

The Preamble:

The Grapevine Board thoughtfully reviewed each request below regarding the Preamble and took no action. The 72nd General Service Conference Committee on Grapevine and La Vińa reviewed and discussed this issue thoroughly in April 2022 and took no action. The Grapevine Chair and the 72nd Conference Committee on Grapevine and La Vińa met in October 2022 and reviewed these proposed agenda items. It was determined there was no new information which required further discussion.

Moratorium of 5 years before addressing this item again.

Plain Language Big Book PAIs: The trustee's' Literature Committee agreed to forward to the 2023 Conference Literature committee all new proposed agenda items related to the Plain Language Big Book as one grouped item. The committee also discussed requests from some members regarding access to the draft of the Plain Language Big Book. After legal consultation, the committee agreed to provide a monitored closed reading room for Conference members only during the 2023 General Service Conference, where Conference Literature Committee members will be given first viewing of draft chapters in a controlled environment.

Delegates will be given access to the document before voting.

PAI#23: The committee discussed a request to create literature (pamphlet, card, or other) addressing Registered Sex Offenders in AA, their privacy and the importance of anonymity to these members, and what acceptance means for these people and their recovery from alcoholism and took no action. The committee noted that the topic is addressed in existing service material regarding safety and anonymity in A.A.

PAI#95: The committee discussed a request regarding changes made by Advisory Action of the 72nd General Service Conference to the wording in the pamphlet —"Questions and Answers on Sponsorship" (P-15) and took no action. The committee noted that until other projects are completed a decision has been made to forgo new pamphlets or revisions at this time.

Progress report: The committee reviewed a progress report regarding development of a Fifth Edition of the book Alcoholics Anonymous that provided updates on the story selection process including the consideration of Fourth Edition existing stories. To date 1,000 submissions have been received. The committee appreciated the ongoing work and looks forward to a progress report at the January 2023 meeting.

Progress report on plain and simple language Big Book: The committee reviewed a report regarding the translation of the book Alcoholics Anonymous (Fourth Edition) into plain and simple language that included the progress and challenges of the work being done by the writer and the subcommittee. The committee expressed their gratitude for the ongoing work and looks forward to a progress report at the January 2023 meeting.

The 2022 AA Membership Survey is in the Delegate Data Collection project phase. All sampled groups survey submissions are due by the recently extended deadline of October 24, 2022. Submissions of video content created by young people on how they carry the message to other young people who may benefit from our life-giving solution has been requested, with a deadline for submissions of November 7, 2022.

Once the survey is completed, an evaluation will be provided seeking input of the survey process. Every A.A. Membership Survey has been a current snapshot of a limited number of the total A.A. group population, based on a moment in time.

I continue to work closely with our Delegate to prepare for the upcoming Conference in April and especially look forward to the PCAS sessions taking place in early 2023. It is an amazing way to hear how our fellowship feels on certain issues and also to share our Area's vision for the future. Thank you for your faith in me and I look forward to serving Area 83 and Alcoholics Anonymous as a whole for the next two years.

11. DELEGATE'S REPORT Kimberley M.

Good afternoon, I'm an alcoholic, a member of the Ajax Area Group in District 26 and my name is Kimberley. It has been an honor and privilege to serve as Panel 71 Delegate for Area 83 Eastern Ontario International.

Here is what I have been up to since our Fall Assembly

On November 8th and 22nd, I attended the PCAS planning meeting. Our next meeting is December 13th.

On November 12th, I attended the District 50 Conference in Cornwall.

On November 13^{th} I met with James, Jill and Christy to further discuss the 2013-2015 Conference Inventory Results. Our next meeting is on December 4^{th} .

On November 15th Panel 71, 72 and 73 Delegates were invited to a Delegates only meeting where the outgoing delegates could share tips and suggestions with the incoming delegates around the Conference experience. What to expect and how to prepare and so on. James and I both attended.

13. OLD BUSINESS

Hello, my name is Mel C. and I am an alcoholic,

In January of this year, I was asked by Amy L., Area 83 Chairperson, to chair an ad hoc committee to examine the digital resources of Area 83.

This is the final report of our committee.

Along with myself, Amy asked:
George M., our current Area Webmaster
Kimberly M. our P71 Delegate
Bill C. our P71 Area Registrar
Jack R. our P71 Area Public Information Chair
& Ryan D. of the Courtice 12&12 Group

We were asked to have a look at our website and email structure to see if improvements could be made. It had been posited that many of our members are becoming more comfortable with online Alcoholics Anonymous activities and that our digital footprint could be improved. It was felt the static webpage such as the one we have now, which went live in 2008 and was updated in 2014 was not serving our audience optimally. Our committee was formed to assess our situation to see if that was indeed true.

Our terms of reference/mission were to examine 4 basic questions and come back to the Area Committee with recommendations. Our ad hoc committee is not concerned with construction and rollout of a new digital presence, just assessment and recommendations respecting our current one.

The four questions we were asked to consider were:

- #1) What are the needs of Area 83 for digital resources including, but not limited to Website, Email and Cloud-based storage?
- #2) How could these digital assets be used to improve our communication to the still suffering alcoholic, our membership, including those with accessibility needs, and to friends of AA?
- #3) Identify possible service providers & relevant costs for the needs identified in item 1.
- #4) Include in your deliberations whether a third party should be hired to create a website for Area 83.

We added a 5th question in anticipation of an assessment that an upgrade in our digital resources might be required:

#5) What budget might we require/request should we feel a third-party ought to be involved? Findings & Decisions

In the course of our investigations, we examined the other 92 Areas in North America and assessed each site for their success at addressing the three main important audiences we identified: 1) The alcoholic that still suffers 2) the member ship of AA and those interested in it and 3) the needs of our Area 83 members in service. We also looked at costs to create a new digital footprint, resources on who we could call upon to help us and finally and perhaps most importantly, whether or not we NEEDED to go down this road.

At this stage we had made good progress investigating what the other 92 Areas in N. America where doing. How their websites and indeed their whole method of addressing technology were organized as well as how they dealt with email, cloud storage and ability for our AA service workers to access digital tools. We went on to identify possible service providers, best practices, assessment of future needs & relevant costs and we got a good feel for what a revamp might entail.

As a committee we decided fairly quicky that we <u>ought</u> to freshen our Area's digital footprint with a more user friendly, clean and intuitive site. Also, as important, with an Area organizational structure that more realistically meets the needs and challenges of Area 83 moving forward.

A surprising upshot of our research was that we observed many Areas were now going with having a Technology Chair, the Webmaster but one component of an integrated digital approach, the Technology Chair overseeing, among other things, technology as it relates to our Traditions in this new digital age. As well as separate resources on organizing and coordinating virtual Area Committee Meetings, Assemblies and Service Information days.

RECOMMENDATIONS

After informed discussion, our committee concluded that Area 83 needed to revamp its digital footprint as well as our internal organizational structure.

We recommend a Chairperson strike the <u>second ad hoc</u> committee envisioned by our current Chair Amy and task that committee with designing and implementing a new digital strategy for Area 83.

In our deliberations, we collected much data from all the other 92 Areas as well as guidance from GSO; data from outsider service providers, web designers and people in the IT industry connected to AA, as well as some detailed data around projected costs and time frames. We also took the liberty of writing some draft operating procedures for consideration. Should an implementation committee be formed, I will be pleased to pass all this intelligence onto the new committee.

I know I speak for all of us as I say thank you for your confidence in us, it has been a pleasure to serve Area 83.
