OPENING

Good morning everyone. I'm an alcoholic, a member of the West End Group in District 74, and my name is Bill. I have the honor and privilege of serving Area 83 as your Chairperson.

Let's start this meeting with a Moment's Silence followed by the Serenity Prayer.

Welcome everybody to the 2023 Spring Assembly. Did everyone enjoy the Service Information Day yesterday? Let's give a hand to the Service Information Day Committee for the great line up of workshops, and to all the presenters- you did very well. Thank you.

Did you hear the speaker meeting last night? Trish what a powerful message. You really touched our hearts. Thank you.

I would ask that you please address the committee by stating your name, position, and district before presenting your point. This is immensely helpful for anyone relying on Closed Captioning.

Introduction

This is our first Assembly of four in this Panel 73. During the remainder of this term, we will be working together to provide continued strength and direction to A.A. in Area 83. Our common goal during this term is to keep Alcoholics Anonymous in Area 83 vibrant and strong. Working together with open lines of communication is the key for continued Unity in our Area.

The A.A. Service Manual refers to the Assembly meeting as the heart of each area "where the democratic voice of our Fellowship expresses itself." Just as most District tables meet monthly to oversee the affairs of A.A. in the District, and home Groups usually have regular business meetings, to handle matters that require a group conscience decision, the Assembly is the business meeting of Alcoholics Anonymous in Area 83.

Being in service is a great way to give back to A.A. You will not be expected to learn or understand everything the first time or even second time. It takes time but it will make sense. Many of us didn't understand what was going on at meetings at first, but in time, we started to understand. Service is much the same way. So please keep coming back – welcome and enjoy the rest of the Assembly.

Over these two years, we will make decisions on a variety of topics. The Area Assembly, like the General Service Conference, strives for substantial unanimity through ample discussion. Before a vote is held, plenty of time should be taken for full discussion and questions. It is my hope that you will return to your Groups and Districts with the feeling

The 7th tradition will be collected today by digital means as well as by "passing the basket". Over the course of the Assembly our Treasurer will be posting in the Chat window the available methods of making a digital contribution to Area 83.

I know it seems that the coffee and drinks provided this weekend are free, but St Lawrence College charges us a flat rate of about \$10.00 - \$12.00 per person for the weekend. We had a 7th Collection at the banquet last night and we will have another one today. Please keep these costs in mind when you are making your 7th contribution.

WHO VOTES?

Only members of the Assembly may vote.

These are:

All Area Officers, including the Immediate Past Delegate, but not the Chair.

- All Area Sub-Committee Chairs and the Webmaster.
- All District Committee Members of Districts in Area 83; in their absence, the Alternate District Committee Member may vote.
- All General Service Representatives of Groups in Area 83, in their absence, the Group's Alternate General Service Representative. In their absence, a member of the registered Group may vote. This includes the General Service Representatives of recognized Correctional Facilities groups.
- There is one vote per person.

VOTING:

As you know our Assembly today is being conducted as a hybrid meeting. We have members with an eligible vote who are attending via the online meeting.

DISCUSSION/RAISING HAND:

If you would like to address the committee to make a motion, second a motion, share a new perspective or ask a question, please approach the microphone, or raise your virtual hand using the RAISE HAND FUNCTION if you are participating online and have a voice and vote.

When you have been recognized by the chair, please identify yourself by Name, Service Position and District. Please come with your thoughts formulated and refrain from extraneous comments.

In the interest of time and to give all those with a voice an equal opportunity to speak to a motion, I would ask that you only come to the microphone once on the motion being discussed. After everyone has had a chance to share, we can do round 2 if necessary.

Reminder: if your idea or comment has already been presented, please lower your hand. Your humility and cooperation in this regard is appreciated.

VOICE OF THE MINORITY:

A.A. has always protected the voice and opinion of the minority. When we have a vote, unless the voting is unanimous, or if the vote was to cover items such as acceptance of minutes, I will ask if anyone wishes to speak to the minority. To be able to do this, you must have voted with the minority on the motion. If, after the minority has spoken, someone from the majority side of the vote wishes to change their vote, that person may make a motion to reconsider. If this is seconded and passes by a simple majority, we start discussion again on the *original* motion.

CALLING THE QUESTION:

During the discussion on a motion, a member, once recognized by the Chair, may move to "call the question". This is a motion to end discussion and move to the vote. This motion needs to be seconded, is not debatable, and requires a 2/3 majority to pass. If it passes, we go directly to the vote of the motion or amendment we were discussing. I would caution you not to use this privilege too often or too early – many goods points and opinions will come out in discussions, and if discussion is prematurely cut off, we will not get to hear them.

WHO MAY ADDRESS THE ASSEMBLY?

- Only voting members of the Assembly have a voice. This is important for two reasons:
 - It keeps the focus on the fact that the Assembly is the business meeting of the Area Assembly members are carrying and presenting their Groups' wishes, rather than their own.
 - And it maximizes the time available for those members to voice their Groups' opinions and needs.
- All who are attending may say their piece during sharing time. I would ask for your cooperation on this. If you don't have a vote, as I just described, please keep your input for sharing time, which is scheduled as Item 13 on the Agenda. At that time everyone is welcome to participate, and their opinions will be heard.

- On the topic of sharing time, please, if you can, stay until the end of the Assembly. I realize it may feel like a long
 day, but the Assembly truly isn't over until it's over. We have asked our guests and visitors to have their say during
 sharing time, and as hosts, it's polite to stay and hear their views. It's also quite possible that something important
 will be said.
- To allow me to facilitate discussions, when you are ready to speak and you have been recognized, please identify
 yourself by Name, Position, Group and District number.

If you are making a floor motion for the Assembly to consider today, it would be much appreciated if you would write your motion out and give it to our secretary, Jill, before addressing the Assembly.

HOW DO WE VOTE?

Alcoholics Anonymous has traditionally made decisions by 'substantial unanimity'. In practice, this has translated to 2/3 majority which is 2/3 of the votes cast each time. As we cannot control who is in the room at the time of each vote, it is impractical to use the roll call as the basis for the 2/3 calculation.

I believe that the first part of the agenda today can be handled under simple majority—1 vote more than 50%. The items under old and new business are of such a nature to be under 2/3 majority and I will ask for a motion when we get to that point in the agenda. If, at any time, you think that we should move to a 2/3 majority, please make the motion.

At times, I may ask for a show of hands to get a 'sense of the meeting'. This is NOT a VOTE. We will do this by a show of hands for the in-person participants or by clicking the green Yes button or red No button for the online participants. We will use these buttons to gauge the feeling of the voting members. Going forward, to vote on a motion there will always be three options: For, Against and Abstain. I will be sure to give enough time for all voting members to cast your vote. Please, only vote if you have a vote.

If someone needs assistance, we will make arrangements to ensure that your voice is heard, and vote is cast. This may take a little time, but it is important that everyone can participate equally in this meeting.

The district is financially secure, and all our financial obligations are being meet.

Our commitments to our service meetings in Treatment are being fulfilled thanks to the extraordinary efforts of our Treatment chair Candis W.

Shane H has taken the Accessibility position new levels with the introduction of a semi-annual Accessibility virtual info panel on zoom. With International participation we are looking forward to the April 22, 2023, session taking place 1 to 3 pm Eastern Standard Time. Kudos to Shane and his committee bringing information to the forefront.

In Corrections we have been taking the meeting behind the walls with the reopening of the Men's Action Group operating in Ontario Correctional Institute. District 06 Mississauga

Good Morning,

I am an alcoholic, member of the Streetsville Group in Mississauga, and am privileged to serve as the District 6 District Committee Member, and my name is Marrey P.

District 6 stretches roughly from Highway 401 in the north to Lake Ontario in the south, and from Six Mile Creek in Oakville in the west to Royal York Road, Etobicoke to the east.

There are 36 groups in the district, 1 being inactive. We have had quorum at all our district meetings this Panel 73 term and our meetings are held virtually.

The district is financially stable with groups generously contributing and in turn, disbursements have been made to Area 83.

More and more meetings are in-person but there are still many hybrid and virtual meetings. One of our groups, Markland Wood, is having trouble finding a location for in-person meetings and as a result, may discontinue as a group.

Covid has been a challenge and coming out of the strict measures phase, some groups struggle as not all members want the same platform. This has caused a fracture in the unity of group members; this is a result of the virtual faction and the in-person faction meeting on the same night but being totally separate, not hybrid.

Our 4 table officer positions of DCM, ADCM, Secretary/Treasurer and Registrar/Webmaster have been filled as well as the chairperson positions of Public Information, Self-Support and Accessibility. The Archives Chairperson was going to fulfill her role virtually from out of the district, Haliburton (something new for us), but resigned after a few months. We have no Corrections Chairperson, but a trusted A.A. servant, Dan H, has ensured that meeting commitments at the Toronto South Detention Center are being met. Likewise, the Treatment Chairperson role is being covered by the previous chair, Rebecca V, who has moved to Orillia. She is fielding treatment emails, Bridging the Gap (GAP) requests, and coordinating volunteers at the 2 shelters we service. District 6 is blessed to have 2 such dedicated individuals that are committed to reaching the still suffering alcoholic!

The Grapevine and Cooperation with the Professional Community chairperson and Intergroup Liaison positions remain vacant. We trust in the Higher Power and with the process that all the district positions will soon be filled.

Dorothy A, the Public Information Committee (PI) Chairperson has recently been in contact with the Toronto Transit Commission (TTC) and they want A.A. to provide posters in subway stations, stairways and bus shelters throughout the Greater Toronto Area (GTA). Her committee has also been busy working with the Area 86, District 19 CPC/PI Committee

on several initiatives; they have put Grapevine e-pubs in Oakville libraries and attempted to put on virtual meetings for the University of Toronto, Mississauga Campus students (not so successfully during this school year but their hearts were in it, and they are providing posters to make students aware of A.A.).

Much time at our district meetings in the last 2 months has been spent on a General Service Rep (GSR) Workshop given by the ADCM, Rob D, on covering Agenda Items for the Pre-Conference Agenda Sharing Session (PCAS), and on discussion of the recommendations of the PCAS Ad-Hoc Committee (to be voted on as part of the business agenda today).

A motion was passed, allowing the district treasurer to make e-transfer payment of up to \$500, with the approval of either the DCM or ADCM. We truly are becoming a part of the digital age.

District 6 is part of the 8 districts in the GTA that are hosting the GTA Information A.A. Day on Saturday May 27th from 9pm to 3pm, at Bloordale United Church, 4258 Boor St. W. in Etobicoke/Toronto. My name is Allen and I am an Alcoholic. I have the pleasure to serve as DCM for District 78 on Panel 73.

We have seven meetings in our District which are all open as in-person meetings. District Meetings are regularly attended by 86% of Groups.

I have met with each Group and will continue to do this on a semi-regular cycle. Topics discussed were: Financial Reporting, District Budget (new for us), Operating Regulations (new), the Comprehensive Media Plan, our District's Outreach Plan (new) and the need to drive awareness in our communities.

As previously reported, Finances for our District are 'weak' - but improving. We have moved our bank account so it is readily accessible, introduced a formalized Financial Statement and have established a budget. We identified two major areas for cost reductions (using Area Zoom Account and VOIP for 800 service) - resulting in an overall decrease of approx. 25% (\$560). Thanks to Area for the use of their Zoom Account!

Revenues are increasing. It has been mentioned that when groups see District taking action to support the Groups they are more inclined to contribute.

As many of you know, we are developing an Outreach Programme by re-invigorating our PI/CPC work through increased 1:1 communication with police, medical & relevant professionals across the District.

Established a Cte. - people were 'asking' to join (new for us!)

- engaging younger members
- non-GSRs engaging the District

Special thanks to Jane S. for spending valuable time with our District to help this along.

New Operating Regulations. Thanks to the other Districts & Area for sharing their Regulations - it allowed us to move quickly. We have developed, what is for us, a new and very comprehensive set of Operating Regulations for District 78. These were adopted at our April District Meeting.

It's been a busy few months yet I look forward to continuing this journey and getting to know each of you better.

C. Correctional Facilities......Rob F.

Good morning, everyone. I'm honoured and privileged to serve as your Area 83 Corrections Chair and my name is Rob F.

I want to begin by expressing my gratitude for the passion, dedication, and enthusiasm our District Chairs have shown in serving their districts and assisting me throughout my term. Yesterday District 14 donated 48 Big Books for use by our Corrections Chairs.

We have been holding virtual monthly meetings and the participation has been amazing. We share updates and news from the General Service Office, Area 83 and our Districts. I'm really enjoying them and feel like we are a cohesive team moving towards a common goal...the carry the message the inside of our institutions.

Regardless of whether a district has any facilities, there are ways for every district to be of service. One option is to volunteer in person at a local facility or become an "outside" contact for the Bridging the Gap program. This program connects individuals under community supervision with outside AA members, helping them attend local AA meetings during their first few days of release.

Currently, our Area has 22 facilities, as restrictions ease, more of them are welcoming outside volunteers to host and attend meetings. A recurring theme is the need for additional volunteers to help with these meetings. Each facility has its own volunteer approval process, so please encourage your members to contact their corrections chairs for help to get started.

Elaine A, the Corrections Chair at the General Service Office, is organizing a joint virtual session with Corrections Canada and Area Corrections Chairs from across the country. Topics will include implementing a more formal Corrections Correspondence Service (CCS) program like the one in the United States, the potential use of tablets in institutions, and virtual meetings. Please note that if tablets are approved, it's expected to take at least 3-5 years before they're allowed in facilities.

Being part of our Area Service structure is incredibly exciting, and I am committed to serving to the best of my ability. Thank you.

QUESTIONS FOLLOWING CORRECTIONAL FACILITIES REPORT:

QUESTION: Is it true we can't bring Grapevine into the correctional facilities anymore?

ANSWER: It was true in the past that when Grapevines went into the facilities, the staples needed to be removed. It would be on facility-by-facility basis. For example, there are some facilities that will allow metal sobriety chips to be brought in, but there are some

that will not allow that. If there's a particular facility that you are interested in, please see me after the meeting and I'll do my best to find out the information for you.

QUESTION: Have you heard anything from the facility in Ottawa. Is the facility opening and if so, when?

ANSWER: Deferred to someone in the Ottawa area. Kevin O, DCM District 54 – OCDC is now holding 2 men's meetings per week and 2 women's meetings per week. Currently the Corrections Committee is looking for more volunteers. There is an extensive process to go through to get the approval. Ottawa Withdrawal Centre meeting is starting up twice per week. To submit applications, send names to cft@ottawaaa.org they can provide you with more details.

QUESTION: Curious about the Penpal program, was that going to be 3-5 years down the road?

ANSWER: That's more of an immediate thing. Once more information is obtained after the conference, I'll ensure to spread the information around to all the district chairs and be bettered prepared to start the service.

QUESTION: How much sobriety do you need to go into the facility?

ANSWER: It is suggested as a guideline to have around 2 years of sobriety. You will require a CPIC.

QUESTION: How long is the CPIC good for?

ANSWER: I don't know how long they last but would suggest that if it was don't quite a while ago, then inquire if you need to re-apply.

D. Treatment FacilitiesMaria M.

Good morning, I'm an alcoholic, a member of the Live and Let Live Group in Colborne my name is Maria. I have the honour and privilege of serving Area 83 Eastern Ontario International as your Panel 73 Treatment chair. I'm grateful to be here at an in-person Assembly to experience connections with people that I have met and to contact people I've met from online meetings. I am enjoying the opportunity as Treatment chair and intend to fulfill the duties to the best of my abilities. In January I arranged a Sub-committee meeting to meet the Treatment and Bridging the Gap (BTG) chairs of the Districts, it was an informal meeting, I will be scheduling meetings more frequently to eliminate scheduling conflicts, this will be helpful to further advance initiatives to carry the message to facilities/institutions in Area 83. I would like to thank those Sub-committee chairs that attended the meeting, and also to the District Secretaries that send me their monthly District minutes, I enjoy reading them, it has helped to keep me informed of what is going on in the Area and where I may be of service. I would like to thank the presenters and everyone who attended the Treatment workshop yesterday, I look forward to seeing the feedback, I would like to also thank the Service Information Committee and all the volunteers for their efforts this weekend to make the Assembly run as smoothly as it did.

I have received and passed on to Treatment/BTG chairs approximately 30 Bridging the Gap requests since January, such a vital role in introducing newly discharged members to local meetings in their District. There have been various requests made about treatment facilities in the area, from members of A.A., family members looking for help of a loved one and, Law enforcement. Districts report of facilities (treatment, shelters, ½ way houses, hospitals, and detox) reopening the doors to A.A. for meetings, some are limited to frequency and/or number of members allowed in each time to put on a meeting. Unfortunately, some hospitals have closed the door to meetings. Committees continue to work together and have a target list of facilities to be approached.

April 1st, I hosted a pre-conference sharing session with Theresa L. Area 83 Accessibilities Chair, the members in attendance engaged in great discussion. I'd like to thank the Service Information Committee and the volunteers for each session for their efforts to make the event a success.

Ask, Discuss, Share, or Chat with me about Grapevine and your wishes and needs from Grapevine – and I will follow up to the best of my ability.

The Chairs from the Area Districts and I meet on the first Friday of each month, from 7-8 pm, virtually. We discuss GV news and share about GV in your Districts. Thank you to those who attend and please do not be shy - come on out and join us if Grapevine is of interest or if you are filling in for a vacancy. I publish a brief monthly newsletter that you are all welcome to receive if you do not already. This is available on the Area 83 website, under the Resources tab, select Grapevine. It is to that Resources tab that you can access the page for each of the Area Sub-committees, not just Grapevine.

Grapevine, like many service positions, has vacancies at the District level. Grapevine has five (6?) vacancies as of the Assembly. If you are a District Committee Member please help me by keeping me up-to-date on changes to your roster and to help by sharing the GV material I included in each DCMs folder. If your District has a GV chair I ask that you give them the information I put into your folder if your GV chair did not attend this weekend.

All of the material we have shared thus far in those monthly meetings is loaded onto the Area website under the Resources tab and select, Grapevine.

I am trying out a new idea – using QR codes to interest those comfortable with social media and smart technology to engage immediately with GV content and content that is specific, such as the Daily Quote, or the Sobriety Counter and card maker, or the weekly podcasts, or the YouTube channel, or the Instagram page. The poster, "Grapevine Beyond Paper" is available in your folders, on the GV Display table, or from me. Please check it out. I would love your feedback.

I would also like to thank the team who put on the Pre-conference Agenda Sharing Sessions – Grapevine shared a session with Corrections, Rob F., and we both had, as a result of the Equitable Distribution of Workloads additional items from Public Information and Treatment. During our portion we discussed two Grapevine Advisory Items, the book titles we would like to see printed by GV as well as review the progress made on the GV Instagram account.

The Instagram account (alcoholicsanonymous gv) has over 10 000 followers and over 1000 posts, making at least one post per day. Each day you can read daily quotes, see gorgeous photos (anonymity protected), and events. Speaking of which, Trish L., our Trustee at Large for Canada, posted a photograph of our GV booth to Instagram yesterday. Already we have hundreds of likes. Thank you Trish for sharing our love of Grapevine with the Grapevine virtual family.

During the first few months of this term I have an unusual learning curve. I was exposed to a vast amount of material that was not a printed Grapevine Magazine. I was one of the many who believed Grapevine to predominately be a printed paper magazine. I now realize the extent of platforms, devices, formats, and forms Grapevine is available to us.

Instagram, <u>Podcasts, Youtube videos</u>, and other forms of digital content is being created daily by the staff GV for us. This is a direct response to the need for Grapevine to be where alcoholics are – and for so very many, that is on-line and virtual. Statistics: North Americans spend 3 h on-line and 1 minute reading paper documents (periodicals) each day. The on-line folk look at their devices every 5.5 minutes. Within the first few months of launching on those platforms thousands joined, watched, followed, and interacted with the content. And please know that the content is created by alcoholics for alcoholics – the staff themselves are also alcoholic.

Grapevine is self-supporting. In light of the 4% per year decrease in paper printed items and a 21% increase in digital content items Self-Support is increasingly important. Much of the digital content is free. Yet, it cost money to create. Our subscriptions and purchases are what pay the bills and enable the message be shared digitally to those seeking us.

We can subscribe in many ways and to many formats of content, and for many reasons – one of which is a vital 12th Step tool, <u>Carry the Message Project</u>. I suggest that each of us consider asking the members of which ever Service level grouping you are part of to look for ways that Grapevine can be used to carry the message – Grapevine partners up well with so much of what we do as our Fifth Tradition work – Corrections and Carry the Message is one, so are digital content links for the Professional or the 'Sober-curious'.

To celebrate the publication of the recently revised and updated book **The Home Group, Heartbeat of AA, 30th Anniversary Edition**, the May issue of Grapevine Magazine features beautiful stories by members about why they love their home groups.

In other news; the soon to be launched Grapevine Application is coming September 2023. We Grapevine folk across the 99 Areas were invited to take it for a test spin this Spring, I have indicated our desire to be included in this test run. Stay tuned!

QUESTIONS FOLLOWING GRAPEVINE REPORT:

QUESTION: What is the Grapevine planning to do to be available for the deaf alcoholic? Nothing from Grapevine is available to the deaf alcoholic. Is there anything that you have heard about that possibility? Closed Captioning is not useful to most deaf people.

ANSWER: Christy will follow up on more accessible versions of our literature options. Podcasts and all these other events you need to sighted, but there is closed captioning if you happen to be deaf. And that is the limit, it can get better. There ASL interpretation of all our recovery material, but not for Grapevine. That's a great question, and something I'm very passionate about. ASL is a language not a translation.

QUESTION: Are the handles for YouTube, Podcasts & Instagram, all just Grapevine?

ANSWER: No, they are not. It's alcoholicsanonymous_gv for Instagram; for Podcasts it's aagrapevine. Links are on all the literature. There is a QR Code at the bottom to get main Grapevine site. Podcast is available on all your normal streaming platforms.

QUESTION: Can Grapevine receive monetary contributions via subscriptions for using social media.

ANSWER: That would not fit our traditions. You can refer to the slide which gives you ways to contribute to Grapevine.

QUESTION: Speaking of Corrections, are hard copies of the magazines still available?

ANSWER: Yes, the Carry the Message is taking the subscription into someone who is incarcerated, or otherwise homebound or institutions we can't reach.

QUESTION: Where do we submit stories?

ANSWER: Your DCM received an editorial submissions guideline in their folders. You can also Grapevine's website, under "get involved".

QUESTION: Where can I get Grapevines for my meeting specifically? Do I go through my Intergroup or from the website?

ANSWER: All of those. Your District may do bulk orders. In some cases, Intergroup may carry it. Or from the website just from group only.

TREASURER'S REPORT Jack R.

Good morning, friends, I am an alcoholic, a member of Step Stop Group here in Kingston in District 36, and my name is Jack R. It is both an honour and a privilege to serve as your Panel 73 Area 83 Treasurer.

Since the January Area Committee Meeting, I have been involved in the Pre-Conference Agenda Sharing session for Finance and partnered again with Kathie T. for the Treasurer/Self Support Workshop yesterday.

When a Group, District or Individual sends in a contribution, they will receive, in return, a thank-you letter of receipt. Emailing these to you costs the Area nothing, whereas mailing them requires a stamp, envelope, paper and ink. Please encourage your Treasurers to include an email address with your contributions, and I can email your letter of receipt. Please make your cheques payable to "Eastern Ontario International Area 83". You can find contact information on the Area 83 website: area83aa.org at the top of the Home Page click "A.A. Contributions". Then click "I am an A.A. Member".

There have been 21 group and district contributions via e-Transfer so far in 2023. This method of contributing to Area 83 is proving to be uncomplicated for the Groups. Please consider this payment method when your Group or District discusses contributing to Area 83. As with all contributions, please reference your Group and/or District Name and Service Number in the memo field. Individual contributions to a maximum of \$1000.00 per year will also be accepted.

Please continue to remind groups who would like to contribute using PayPal to include their six-digit Group Service Number with any contributions using PayPal so that the group may get credit for their contribution. The place to enter the group number is the screen after entering credit card information. PayPal charges a fee of 2.9% plus 30 cents per transaction. There have been 2 contributions so far this year using PayPal.

Let's discuss the Financial Statements for the period ending March 31, 2023.

Page 1 Appendix A1 is a financial summary. It shows our Reserve Account, which is set aside for unforeseen circumstances, has a balance of \$20,000 in the form of a GIC which matures in September 2023.

Income for the period as of March 31, 2023:

- 7th Tradition collected at the January Area Committee Meeting \$400.00
- Group, District and Individual Contributions \$17,778.22
- Banquet ticket sales of \$6,617.70; a few more have come in since then

Total Income for the period is \$24,795.92

Expenses for the period as of March 31, 2023:

- Accommodations includes \$5967.20 payment to the Holiday Inn for rooms and parking for 18 committee members
 and our banquet speaker for 1 or 2 nights. I included \$1008.36 for hotel accommodations for the 3 committee
 members who attended the CERAASA meeting when in fact I should have instead added it to the CERAASA field
 under other expenses.
- The meals cost of \$334.34 from CERAASA will also be moved there.
- Travel costs of \$1255.40 for committee members to travel to the Area Committee Meeting in January and CERAASA
 in February.
- General Service Conference Assessment \$12,456.95 (\$9,000 US)
- Bank Service Charges \$67.75
- PayPal fees of \$49.76
- Area Committee meeting expenses of \$702.66 which includes snacks and rental and insurance.
- Under Spring Assembly, the miscellaneous cost of \$3905.25 is a deposit for the St. Lawrence College venue paid in March. This is only a fraction of the total cost which will be paid after the Assembly.
- It has been brought to my attention this weekend that the miscellaneous costs should not be a significant percentage of the total expenses and should be categorized to prevent confusion. The problem this time is that the old templates lumped all the accommodation and Assembly venue costs (at the Ambassador) into one column whereas now the accommodation and Assembly venues are separate. For the next assembly I will add a column for Assembly / ACM venue.

Total Expenses for the period are \$26,034.22.

The opening bank balance at January 1, 2023 was \$60,739.52. Total income of \$24,795.92 less expenses of \$26,034.22 leaves a balance in the operating account of \$59,501.22. As of March 31, 2023, our expenses were \$1,238.30 more than our income. Thank you to the 54 Groups, 8 Districts and 1 Individual for your generous contributions to Area 83.

Page 2 <u>Appendix A2</u> shows details of the expenses. Here we see an itemized breakdown of expenses for the period for each Area Committee Member as well as all other expenses to date.

Some of the numbers you see here:

- The amounts shown for accommodation and meals for the Delegate, Alternate Delegate and Immediate Past Delegate are for CERAASA expenses. The amounts shown for travel include the Area Committee meeting expenses.
- The General Service Conference (GSC) Assessment. At the Spring Assembly in 2007, a motion passed stating that
 "provided it doesn't affect our prudent reserve, Area 83 will pay to GSO the full annual expense for our Delegate to
 attend the General Service Conference". The full assessment for our Delegate to attend the 2023 In Person GSC
 was \$9,000.00 USD, or \$12,456.95 CDN, which has been paid in full.

To summarize, our financial position as of March 31, 2023 compared to March 2022 is as follows: Income for 2023 is \$17,535.55 more than the same period in 2022. Expenses to date for 2023 are \$14,128.66 more than the same period in 2022. The net change to the Operating Account is a decrease of \$1,238.30.

The increase of contributions in 2023 versus 2022 is \$10,682.85.

Page 3 <u>Appendix A3</u> shows contributions by District. These amounts include contributions from Districts, as well as Groups.

We will be collecting a 7th Tradition throughout the Assembly weekend. Please e-transfer your contribution and reference Assembly in the memo field.

Roll Call and REGISTRAR'S REPORT Trevor F.

Good afternoon, friends. I'm an alcoholic, a member of the Stittsville Second Chance Group in District 62 and my name is Trevor F. I have the honour and privilege to serve as your Panel 73 Registrar for Area 83, Eastern Ontario International. As Registrar, I have the responsibility of maintaining and updating Area 83's 601 Active Group records and serving as the liaison with the General Service Office for matters concerning Group registration and Group records.

The Fellowship Connection Database is used for all the 93 Areas in Canada and the United States. The database keeps track of all our Service Members, Groups, Districts and Areas and allows Area Registrars to make real time updates to the Area database. District Committee Members as well as the Delegate have read-only access to the Fellowship Connection Database.

One of the features of the Database is that it has an expiry date for any new entries, which defaults to two years, the normal term length. This helps make sure our records are up to date, but unfortunately, once the expiry date arrives, it removes the person from the service position in our records, which, in the case of GSRs, automatically changes the group status to "unknown". We currently have 38 groups with unknown status in Area 83, which is down from 66 in January. I will be contacting DCMs and District Registrars regularly to try and get that number much lower.

The number of Virtual groups has grown considerably in the last few years. Area 83 currently has 24 Virtual Groups. We also have 9 Correctional groups in addition to the 568 Regular groups. When I reach out to the Districts to find contacts for the Unknown groups, I will also be sending lists of registered groups in each District and will be asking for confirmation that they are still active. There are many groups that have not come back since the pandemic, and I would like to have our records be as accurate as possible. Any groups not currently meeting can be changed to Inactive status and can be reactivated if they choose to begin meeting again. Some groups have also chosen to continue using a virtual format, and I would like the group listings in the database to reflect that as well.

Pre-registration for the Assembly was something new for this Assembly, and there are a few things to work out, but I think it will be great moving forward.

Thanks to all who came out to the Secretary/Registrar workshop yesterday, and thanks to the Service Information Day team for putting together a great day. Special thanks to District 36 Secretary Amanda for organizing volunteers for registration and greeting, and for Karen A and Rob D for online registration - a great job done by all.

New Group and Group Change Forms are posted on the Area 83 website, under Resources, Registrar. New GSR's are encouraged to get the electronic GSR kits – these are available immediately – digital content is the trend for GSO, but physical kits can be ordered.

In closing, I will make myself available to Districts and Groups to assist you with Registrar-related issues where I can. Thank you for continuing to send District minutes to me – they help keep me informed and thank you for the opportunity to serve.

I was grateful to attend the Canadian Eastern Regional A.A. Service Assembly (CERAASA) in February. I was asked to present the History of CERAASA. I enjoyed digging through the digital archives to piece it all together. The event was really informative, and so great to meet the other Delegates and their Alternates from Eastern Canada Region. I was so proud of Area 83. There were a number of us there, and several were chairing or facilitating workshops and we had many past Delegates, including our very own Joyce S. as Eastern Canada Regional Trustee.

l attend the PCAS sessions on April 1. Thank you to all who prepared the material, zoom teched, and acted as secretaries. We could not have done it without you. I was glad to be sitting in on the discussions. There is so much to learn above and beyond the poll questions. Since there were two streams James and I split the workshops and updated each other with our notes the following week.

As alternate Delegate I am to liaise with the Intergroups in Area 83. I attend the monthly meetings for the Ottawa and Toronto intergroups. OLD BUSINESS

A. Report with recommendations from the Pre-Conference Agenda Sharing (PCAS) ad hoc committeeRob M., Panel 69 Delegate

The following Agenda Item was voted on and approved at the June 4, 2022, ACM. In accordance with our Operating Procedures, Section 2.01, Motions sent to the Assembly from the Area Committee for vote at the Assembly are automatically treated as motions on the floor of the Assembly and do not need to be moved or seconded.

Hi everyone. I'm an alcoholic, a member of the Maynooth Group in District 78, I was your Panel 69 Delegate, and my name is Rob M.

In 2020 Area 83 began facilitating online Pre-Conference agenda sharing sessions. These sessions were designed to provide our Delegate with the viewpoints and experiences of Area 83 on agenda items for the General Service Conference. They also provide members throughout Area 83 an opportunity to participate in AA as a whole and have their say in how our fellowship moves forward.

The first year of its rollout, the viewpoints gathered were considerably more than previous efforts. In 2020, a committee developed scripts and templates to ensure smooth presentations to the membership and help presenters achieve a good understanding of their specific agenda items. These scripts and templates have been updated since then as we've tried to improve on the original model.

In its second year, Area 83 members were more receptive to the online format and overall attendance increased almost 80%. In 2022 and 2023 attendance remained consistent. However, this still only represents a small fraction of the total membership in Area 83.

On May 02, 2021, presenters for the PCAS sessions met to review the results of the PCAS survey and shared both successes and areas for improvement. The consensus was that the sharing sessions were great opportunities for discussion, but the overall engagement and awareness of the Conference process could be improved.

On May 6, 2021, our Area Chairperson at the time, Amy L, asked me to chair an ad hoc Committee for Pre-Conference Agenda Sharing. Our committee Secretary is Bill C, Area 83 Chairperson. Also serving on this committee were Jonathan CJ, DCM District 36 last term, Jo D Area 83 CPC Chair last term, James O, our current Delegate, JoAnn P Area 83 Secretary last term, Joyce S Area 83 Panel 65 Delegate, and Kathie T, our current Self Support Chair.

The function of this *ad hoc* committee was to consider:

- 1. Solutions to the deficiencies identified in the meeting on May 2
- 2. A communication and engagement strategy that would encourage members to follow the Conference process and participate in the dialogue on matters under consideration at the General Service Conference.
- 3. A recurring model of this organizing committee, alleviating the need to strike ad hoc committees on an annual basis.
- 4. Roll out of the Pre-Conference Agenda Sharing session in advance of the 72nd General Service Conference.

The ad hoc committee began last term and gave reports and recommendations to the Area Committee and Assembly. The recommendations were accepted at the June 4th, 2022 ACM. Because the Fall 2022 Assembly was an election Assembly, it was agreed to defer discussion and voting to this Assembly.

Our committee has met twenty-seven times via Zoom. With a broad range of service experience, many hours of discussion and research, much thought and consideration has been put into performing these tasks.

Item 1 Solutions to Identified Deficiencies - The committee reviewed and discussed the minutes of the 2021 debrief meeting. It was apparent that some Session Chairs required further direction and assistance to create background summaries. Documentation for Session Chairs was updated to offer assistance from the PCAS Chairperson, the Delegate, District Committee Members, and District Chairs. These individuals may help with proofreading, and ensuring poll questions are reasoned, concise and coherent. It was noted that, although participation increased in its second year, there is still much room for improvement.

There was discussion at the debrief meeting about offering PCAS sessions live on Saturday of Spring Assembly weekend, and the need to form this ad hoc committee.

After much thought, consideration, and research of other Areas' Pre-Conference procedures, this ad hoc committee concludes the best way to reach the broadest audience, provide maximum feedback to our Delegate, and engage the fellowship in the General Service Conference process is to hold PCAS sessions live on Saturday of the Spring Assembly weekend.

Service Information Day workshops can be offered virtually by the end February. This would allow those new to their service position an opportunity to receive important information earlier in the term.

Item 2 Communication and Engagement Strategy - Our ad hoc committee proposes an ongoing PCAS committee with a pool of people familiar with the process, to build a tradition of input from Area 83, and improve awareness and participation. A permanent PCAS Committee can be established at the beginning of every panel, chaired by the Immediate Past Delegate, and composed of Area Officers and District Committee Members. DCMs would be elected using the same format as the Service Information Day Committee at the January Area Committee meeting and serve for the two-year term.

The PCAS Chairperson will provide progress reports including updates from the General Service Board, and ongoing General Service Conference items at the Area Committee Meetings and Assemblies.

The PCAS Chairperson may present workshops at our Service Information Days, and at District meetings on request. The PCAS Chair can also submit articles for the Delegate's newsletter.

We would like a permanent PCAS tab added to the Area 83 website, with a repository for all previous PCAS information. We realize the vital role District Committee Members and General Service Representatives play to help the fellowship understand the PCAS process.

To that end we have developed a PCAS Public Service Announcement. The PSA will be narrated by our Delegate, sent to District Committee Members, and posted on the Area 83 website. It was requested that DCMs share this brief announcement at their District meetings and make it available to GSRs to be shared with their group members.

Item 3 Recurring Model - We have composed PCAS guidelines, similar to the Service Information Day guidelines, that can be added to our Area Operating Procedures. The proposed guidelines were recently sent to DCMs with a request to share them with GSRs.

These guidelines outline the purpose of the Pre-Conference Assembly, describe the committee composition, suggestions for committee meetings, and the timeline and schedule lay out what needs to be done when. A timeline flowchart gives a visual of the planning process. We have developed position descriptions, and a suggested agenda that can be passed on to the next committee.

Much time and consideration, along with several drafts, went into composing this suggested agenda. We originally considered 50-minute sessions, with 3 sessions per block, similar to the Service Information Day agenda. We realized this would mean members could only attend 1/3 of the sessions, and that 50 minutes may not be enough time to thoroughly discuss agenda items. Our committee suggests 4 blocks with 2 Sessions per block be adopted. The time allocated per block would be 1hr 20min, with a 10min break between sessions. An "Ask it Basket" would be held before the banquet.

Our final item was to roll out the Pre-Conference Agenda Sharing sessions in advance of the 72nd General Service Conference. Since this *ad hoc* committee was still active we planned and presented PCAS 73 this year on April 1st. This was our first attempt at a one-day event, mirroring a possible in person event, rather than nine evening sessions. Feedback to this format was positive. Overall, the day was well received, participation was slightly higher than last year, but still a small turn out, considering the number of members in our Area. In summary, this *ad hoc* committee recommends the following:

- 1. That Pre-Conference Agenda Sharing Sessions be offered on Saturday of the Area 83 Spring Assembly weekend.
- 2. That Service Information Day Workshops be offered virtually in January or February.
- 3. That the Immediate Past Delegate automatically becomes Chairperson of the PCAS committee.
- 4. That the Chairperson of the PCAS committee provide progress reports including updates from the General Service Board, and ongoing General Service Conference items at all Area Committee meetings and Area Assemblies.
- 5. That Pre-Conference Agenda Sharing guidelines be added to "Area 83-Committee Operating Procedures" "Section 9: Appendices".
- 6. That a PCAS tab including a repository for all previous PCAS information be added to the Area 83 website.

Bill, Jonathan, Jo, James, JoAnn, Joyce, Kathie, and I thank you for the opportunity to be of service to Area 83.

Barbara T, GSR District 86: Would the PCAS then be only face to face with no online component? So, the service workshops would be online and the PCAS would no longer be available online.

Rob Mc, PCAS Committee: Yes, that is the proposal for it to be face to face. It would up the Assembly moving forward whether this is going to be hybrid or not. If it's a hybrid weekend, then the face-to-face PCAS could also be hybrid. Our committee didn't make any decisions around hybrid as we felt it wasn't in purview to do that. It's going to up the Area Chair and Assembly moving forward if we are going to offer hybrid or not.

Steve B, GSR & ADCM District 62: We had a discussion at our District meeting about this and it was a closed discussion so I won't go into that. As a GSR, I did attend that April 1st online and also the self-support chair. On that agenda was the changes to the 12 & 12 including the change brought up by the Delegate. What I found is that I did the research beforehand and had a discussion beforehand. But what I found on April 1st, was that people who attended didn't know this was on the agenda. People brought their own opinion, which was fine to bring to the Delegate. But as GSR's we were also to bring the views of our group. Having it on the Saturday, here in person, I would like to think that a lot of us would meet with our groups before we come here and have a bit of our group conscience.

Chris, GSR District 12: Being my first session here and a new GSR, keeping in mind our primary purpose, I got so much out of yesterday's Service Information Day and wondered what we can do from a group level and found it invaluable. Karen, GSR District 62: My group went into a lot of discussion about this proposal and the main point of concern was how was this helping the still suffering alcoholic. A number of members of my group have attended many Assemblies and they are really good at bringing along the new people. The new people go to the Service Information Days, and they learn about it and go back and volunteer for service. My group did come to a group conscience where they are in support of maintaining the current structure. That is to have the Service Information Day, in person, on each Saturday of Assembly.

Eileen S, GSR District 26: The planning committee has spent some hours and hours working on this and they are our trusted servants who have made some suggestions based on informed decisions. The purpose of the PCAS is to provide the Delegate with different opinions of all Area 83 GSR's. I also served as Secretary for one of the meetings on April 1st, and what I did was I took extensive notes, and I wrote out all those notes and provided them to the committee. The purpose of the PCAS is to help the Delegate make informed decisions based on our informed decisions. And I think all the work the PCAS Committee has done has been exceptional. So, I'm for the motion.

Christy F, A83 Grapevine Chair: I'm very much in favour of this, but I feel very torn. So, I want to thank everyone for giving me new perspectives to consider. But prior to hearing what those were, I liked the idea that we would spend a day on the Pre-Conference Agenda Sharing. I feel the momentum and fellowship component. There's an aspect where service beyond the home group were fractured. That there's a whole bunch of home group stuff and there is a big disconnect. What is this General Service Conference where they are doing the business of AA, our business. I think this will help bridge that

huge gap that exists. People will start feeling a little more involved in that decision making process which I think is an important thing within the fellowship and building the fellowship amongst ourselves. And for that reason, I very much support it and because the Service Information Day will be a month and a half earlier, our GSR's are getting the information they vitally need. They don't have to wait until the Spring, they get it in February albeit in a different format, but earlier.

Rob Mc, PCAS Committee: The last person online who asked this question, "how does this help the still suffering alcoholic". For me general service is about facilitating the 12th step efforts. It helps to ensure that we are effectively carrying the message of recovery and our General Service Conference makes important decisions that the shape the future of Alcoholics Anonymous as a whole. So, the more informed our Delegates are attending the General Service Conference, the better. We talk about the upside-down triangle in AA, where the groups are on top making the decisions. The groups can't make the decisions if they aren't aware of the process of what's coming up. I don't want to sound like I'm trying to talk you into it; this was an ad hoc committee of experienced AA members that spent a lot of time discussing it and these are the recommendations. Now it's up to you to decide.

Michael D, District 62: Thank you to the committee for your work and what was presented. My group is in favour. What's not to like about this motion? Members will be more involved in the decision-making process and informing our Delegate to go to New York to express our wishes. Where better to inform than to have a discussion amongst members in person on where AA is going based on the General Service Conference. And without eliminating anything, people wanted to attend workshops will be able to do it online at the end of February and then again in the Fall. This will just add to the quality of our experience, and we are very much in favour.

Bart B, GSR District 06: I highly support the PCAS motion simply because I think it's important that we reinforce the democratic process so we can send our Delegate to New York fully informed on what's living in our community. And I think that's extremely important. Yesterday was a great day, and I don't want to knock what happened yesterday, it's extremely useful. But I think it's maybe even more important that we fully inform the Delegate, and we need that platform to make that happen.

Adam, GSR District 10: Will the workshops that go strictly to online, will they be able to be recorded and available for us to use or utilize if we can't make it on that Saturday?

Rob Mc, PCAS Committee: That may be something for the Service Information Day committee to consider. Currently we don't record the workshops. The Sub-committee chairs make their presentations available online but the workshops themselves aren't recorded.

Wilf Q, GSR District 82: Will the Fall still have a Service Information Day? **Rob Mc, PCAS Committee:** Yes, that's correct.

Jack R, A83 Treasurer: Will there be a SID Committee and a PCAS committee, because the SID Committee would be running the Fall Saturday and the PCAS Committee would be running the Spring Saturday. Would this SID committee be running the Service Information Day in January/February. How does that work?

Rob Mc, PCAS Committee: Yes, that's correct. The proposal is for 2 separate There would still be the typical Service Information Day committees. Committee that we are used to. And then a Pre-Conference Agenda Sharing Committee. The proposal of the make up of the Pre-Conference Agenda Sharing Committee is Area Officers and District Committee Members. So, they would already be here, so no added expense.

Chris M, GSR District 54: I find it is excellent the way it went this year because I'm new to being a GSR. What really helped me in learning about the GSR was doing the GSR workshop and having the PCAS on April 1st. That was an excellent experience, and the Spring Assembly. I learned all kinds of information virtually, as I can't attend in person. I'd recommend having the PCAS on April 1st or first Saturday of April and having the service day in April and then the Assembly on Sunday. Recommend keeping with this strategy.

Mark H, GSR District 22: Clarification question. Is the PCAS going to be hybrid on the Saturday? There are accessibility issues for people wanting to attend that can't make it to Assembly.

Rob Mc, PCAS Committee: The ad hoc Committee has not made a recommendation around hybrid. We don't feel that was a part of our purview. That would be up to the Area Assembly moving forward if we continue to offer hybrid Assembly weekends. I understand the concern, and it's a valid point about accessibility. That is a decision the Area Assembly is going to have to make moving forward. And it's not a part of our ad hoc Committee.

Gib, GSR District 48: I didn't understand what was going on in the beginning on how this was working. The more I hear the more I agree with PCAS because it's going to help the groups give more information to the Delegate and will help things grow. I think it needs to work this way. I'm not a computer guy but I think we need that hybrid the following spring.

Sue G, GSR District 10: Speaking as trusted servant, I'm familiar and have been a former GSR here before. I missed the PCAS this time but if it was imbedded into the structure as the proposal says, I would say this is a wise proposal from past delegates. This makes a lot of sense. And what this does is really assists our Delegate with a great deal of input by just coming here on the Saturday. I think there's a lot of questions still, but I really like the amendment of the 3year trial. So as a trusted servant, we are supporting this proposal.

Bert J, DCM District 22: I'm in favour of this motion. It will make more interaction between the GSR and the Fellowship. That's what this is going to bring to have the PCAS in person.

Rob J, GSR District 34: Just to pick up on a couple of comments made earlier. Item # 2 states Spring Service Information Day workshops be offered virtually by the end of February, however it's silent on the question of what happens at the Fall Assembly? Is that normally a service information day as well?

Rob Mc, PCAS Committee: The Fall Assembly would stay as the typical service information day. The Pre-Conference Agenda Sharing would be offered on the Saturday of the Area Spring Assembly. The proposal is for the Spring Assembly. James S, DCM District 28: I'm curious as to what the attendance difference was between the last Assembly for the Service Information Day and this Assembly for the Service Information Day. Also, the PCAS online attendance.

Rob Mc, PCAS Committee: I don't have numbers for Service Information Day. I'm not sure if they typically keep numbers. I asked about last term, for all four Service Information Days, and there were no numbers kept for that. I can tell

you that when it comes to Pre-Conference Agenda Sharing numbers, in 2020 there were 152 participants; in 2021 there were 271 participants; in 2022 there were 241 participants. And this year was 267. It's hard to say how many of those were unique participants because many members attended more than 1 session.

Randy B, GSR D28: Thank you to the committee who put a lot of work and time into this. I've also attended all the PCAS all 4 years and have seen the numbers increase slowly. My group does not feel that by bringing the PCAS into the assembly weekend that your numbers are going to increase. In fact, they may decrease to what you are getting now for your Spring Assembly. And it's a large financial obligation that you are putting onto the groups, districts and to the area to put this on. I believe and my group believes, as it stands right now, they like it that way. Maybe we can improve upon the information highway so that more people get involved with the PCAS online.

Matt C, GSR District 66: This is my first assembly, so I don't have a preconceived opinion about how this is supposed to be. I know change is always a contentious thing, but I also know that change happens that is necessary and is fluid, can be reverted or adjusted as required. NEW BUSINESS

B. Auditors Report...... Rich K., DCM District 36

Auditors Report for the Term 2021-2022

Our Operating Procedures require that the current Area 83 Treasurer and two appointed auditors approved by the Area Committee shall audit the previous term's financial documents. The committee performed this obligation for the years 2021 and 2022 on Saturday, January 28, 2023. The committee was impressed with the organization and several layers of redundancy maintained by the previous Treasurer Dave L. All documents were easy to access and the process was intuitive and went smoothly and quickly.

The object of the review was to satisfy ourselves and to be accountable to Area 83 members that the revenue and expenses were properly recorded and balanced. Also, that there were no major discrepancies in the practices that were in place.

Specifically, the Audit Committee reviewed the financial documents covering the period January 1, 2021 to December 31, 2022 in order to evaluate:

1) Completeness and accuracy of the recorded transactions.

- 2) Completeness and accuracy of the reporting.
- 3) That all recommendations from previous audit Review Committees were implemented.

Each committee member reviewed for each of 2021 and 2022, an entire month's transactions to reflect various types of situations such as: a month with an assembly, a month with an Area Committee meeting and the last month at random. During this process; large transactions like General Service Office Assessments, Ontario Delegates Committee Meeting expenses, and Grapevine seasonals were reviewed. As much of the last term was conducted during the pandemic, there were unique aspects to the income and expenses to reflect the virtual nature of much of our proceedings both at the group and area level. Bank reconciliations were reviewed, with income transactions traced back to bank deposits and to group and district contribution files.

Each committee member reviewed an entire month's transactions from each year, covering 7 of the 24 months in the term. Expenses in random months were reviewed and traced back to the cheque register. The expenses for both years, for the following Trusted Servants were reviewed for accuracy, reasonability and completeness: Archives, Treatment, Accessibilities, Grapevine, Self-Support, Corrections, Treasurer, Secretary, Chair, Alternate Delegate, Delegate and Immediate Past Delegate.

This sample covered the widest array of expenses. To the best of the Audit Committee's ability, all records which were reviewed were found to be in order, with no discrepancies noted. Of note, 2 discrepancies were detailed and reconciled at the time they occurred including a bank error which actually gave us reassurance that everything was double checked. The following are the recommendations of this Audit Committee:

- 1) When dealing with cash transactions a detailed explanation of the source of funds should be reflected in the records.
- 2) Whenever possible, receipts should be attached to all expense reports. This recommendation has been made by several previous Audit Committees.
- 3) It continues to be the recommendation that when literature is purchased that Area 83 support our General Service Office rather than local Intergroup Offices.
- 4) Before contributions are forwarded to our General Service Office, a motion should be made, discussed and voted on at Area Assemblies, if the Treasurer deems the Area has sufficient funds to pass on.

C. 2023 Financial GuidelinesJack R., Area 83 Treasurer

The purpose of the proposed spending guidelines is to give members of Area 83 a general idea of what the expenses for the year might be and the income required to carry out the services provided by Area 83. As with any projection, some amounts will turn out to be higher or lower than the proposed spending guideline.

Typically, the proposed spending guideline has been forecasted using the average expense for the past four years. This process has been complicated by 3 years of pandemic disruptions to most of our in-person meetings at every level. The expenses and guidelines have been out of step with the rapidly changing situation during this time. I have had to look back at the last 4 pre-pandemic years of 2016-2019 bearing in mind the significant cost increases of every item especially travel and meals and rental costs at our new assembly venue. Step one in this process is to use these average figures as a starting point. Next, I adjust some of the category amounts that I am sure of (General Service Conference (GSC) Assessment, CERAASA expenses). The difficult part is estimating costs that may vary from one term to the next, with no recent benchmark to use as a guide.

On Page one Appendix C1 under Income:

- Beside Contributions from Groups and Districts is an amount that is NOT based on the four-year average. The amount here is the Contributions from Groups and Districts that would be required to cover the proposed expenses to effectively carry the message to the still suffering alcoholic throughout Area 83.
- Grapevine Seasonals this year will be paid in Canadian dollars for Pocket Planners and Calendars. There is an Income figure here offset by an Expense item for the same amount.
- Banquet ticket sales are a new category as they have been coming directly in to the bank account instead of being sold at the Assembly as has happened in the past.
- 7th Tradition include the 3 Area Committee Meetings and the 2 Assemblies.

Under Expenses:

- Committee expenses are grouped together by category a detailed breakdown is on page 2.
- Miscellaneous Expenses include significantly increased costs for the Area Assembly venue and accommodations for the Area Committee and the SID committee at the Holiday Inn. Note that the meal costs are much higher than previous but are offset by the banquet fees now listed as income. Zoom costs have been moved to the chairperson.
- Expenses under Delegate reflect travelling to the 5 zones in Area 83 to present the GSC Report. Also, the cost to mail the 72nd General Service Conference annual reports to Districts and Area 83 pins to other Area Delegates.

Under Other Expenses:

- The General Service Conference (GSC) Assessment is an actual amount. As voted on by the Area Assembly in the spring of 2007 that we become fully self-supporting in sending our Delegate to the GSC. I remitted, on behalf of Area 83, the total amount of \$9,000.00 US which at the time came to \$12,456.95 CDN.
- CERAASA expenses are final as the event took place in St. Catharines, ON February 24 26, 2023. Expenses were for the Delegate, Alternate Delegate, and Immediate Past Delegate to attend.

On Page two Appendix C2 under Accommodation, Meals and Travel:

For the various positions, it is difficult to predict accurately. Area 83 covers a large area and Area Committee Members and Committee Chairs reside in all outlying outposts. Some actual amounts will be higher and or lower than the guideline. Districts may absorb some of these costs by financially supporting Area Officers and or Committee Chairs they invite to Service Days, etc.

- The Spring Assembly and potentially the Fall Assembly, have expenses for rental of the large venue, the upper concourse, the AV equipment and setup, the stage, signage and a fee for a coordinator to work with the Area Chair to ensure a seamless event day.
- Accommodation costs also include parking for the committee that was not an issue at our previous venue. My understanding is that we may get a credit back for that expense which was already paid.
- The original meal cost for the Spring assembly was \$7000 for the banquet which was originally forecast for 200 attendees so I do expect a lower cost for the total of 150 last night.

Total Other Expenses:

• Area Contribution to the General Service Board has been estimated at \$5,000.00, subject to sufficient contributions to Area 83. In 2022, Area 83 contributed \$15,000.00 due to cost savings from virtual assemblies. Some years Area 83 has not made a contribution to GSO and that may be the case this year.

QUESTIONS FOLLOWING 2023 FINANCIAL GUIDELINES REPORT:

QUESTION: You said that the banquet ticket was an income, but then you just said that you're going to have to spend out, because the number was lower. So is the price that we were paying for that banquet ticket an upcharge from the cost of what the food would have been. If it's income, shouldn't it even out, no matter what we paid for the food ourselves out of pocket. I want to understand the banquet ticket sales.

ANSWER: It's reported as income and as an expense.





AREA 83 - EASTERN ONTARIO INTERNATIONAL THE PRE-CONFERENCE ASSEMBLY GUIDELINES

PURPOSE OF THE PRE-CONFERENCE ASSEMBLY

In 2007, Area 83 began holding a Pre-Conference Assembly in the spring. The purpose of this Assembly is to discuss the agenda items for the upcoming General Service Conference. This informs our Delegate of the Area 83 A.A. groups' conscience, thoughts and experience on the various agenda items. The area's voice assists our Delegate in sharing the views of A.A. members from Area 83 when they attend the General Service Conference.

Area 83 holds assemblies twice a year, in March and October. The Saturday of the Spring Assembly weekend is designated as Pre-Conference Agenda Sharing sessions.

The Delegate is scheduled for the Plenary Session from 9:00 am to 9:50 am.

THE PRE-CONFERENCE AGENDA SHARING (PCAS) COMMITTEE

The PCAS Committee will be chaired by the Immediate Past Delegate. It will be composed of the Alternate Delegate and (2) Area Officers invited by the Committee Chair (one of whom will be the Secretary of the Committee) and (3) District Committee Members who will be elected in the same format as the Service Information Day Committee at the January Area Committee meeting. District Committee Members who are elected to the Service Information Day Committee are not eligible to let their name stand. This committee will serve for the two-year term.

The PCAS Committee Chair will consult with the current Delegate to obtain the background information required.

The PCAS Committee Chair will provide progress reports to the Area Committee and the Area Assembly.

SUGGESTED MEETINGS

The committee will meet with sufficient frequency to allow the proper execution of their defined duties within the time frame allotted.

The PCAS Committee Chair shall confirm with the appointed Session Chairs their availability prior to publication of the agenda.

An initial agenda for the PCAS will be sent to the Area Chair for distribution 6 weeks prior to the Spring Assembly.

One hour and 20-minute blocks, per session, (80-minute session plus 10-minute rotation time) are optimal.

TIME LINE AND SCHEDULE

By mid-February the PCAS Committee Chair assigns the agenda items to the appropriate Session Chairs. Full background information is forwarded only to the Session Chairs who will then produce the summaries. Upon request members may receive full background information by contacting the Delegate directly.

The Delegate highlights items that are likely to be discussed by the full conference body. These items will be addressed during the PCAS sessions. A template for drafting background summaries will be supplied to the Session Chair who will then forward the completed summaries to the PCAS Secretary.


The PCAS Committee pre-assigns districts to agenda sharing sessions. The PCAS Secretary then sends the preassigned completed summaries to each District Committee Member. The District Committee Member then forwards the material to each group within their district. All background summaries will be available online. Each group is encouraged to discuss these agenda items so that when they attend the PCAS weekend they are prepared to share their informed voice.

At the PCAS each committee holds a session where all assigned to that committee meet and discuss agenda items. Each committee will have a Session Chairperson and Secretary who will take notes during the committee session. The goal is to reach a general consensus of recommendations on each agenda item along with thoughts on why the recommendation was made. Anyone may attend the various committee meetings, however members are encouraged to attend the session to which their district was assigned. They should also be prepared to discuss and vote on the agenda items for that session. The vote will be a sense of the room and will be a show of hands.

Within 3 days following the assembly, the Session Secretary submits their committee's recommendations and thoughts on each specific agenda item to the Session Chair. The Session Chair reviews and forwards them to the PCAS Secretary, who will compile all session documents and distribute them to the Delegate and to the Webmaster who will post them on the Area 83 website by the Friday following the assembly weekend.
